1. SECRETARY HAIG MADE THE FOLLOWING STATEMENT UPON ARRIVAL
TO EZEIZA AIRPORT IN BUENOS AIRES AT 10:20 P.M. ON THURSDAY,
APRIL 15, 1982:

2. GOOD EVENING LADIES AND GENTLEMEN. I AM VERY PLEASED
THAT PRESIDENT REAGAN HAS INSTRUCTED ME TO PROCEED HERE
ONCE AGAIN TO BUENOS AIRES AT THE INVITATION OF YOUR GOVERNMENT
TO CONTINUE THE EFFORTS IN SEARCH OF A POLITICAL SOLUTION TO
THE CRISIS HERE IN THE SOUTH ATLANTIC. AS I SAID IN WASHINGTON
YESTERDAY BOTH THE GOVERNMENTS OF ARGENTINA AND THE
UNITED KINGDOM HAVE ASSURED THE USG THAT THEY WISH TO
CONTINUE THE EFFORTS WE ARE MAKING TOWARD A POLITICAL
SOLUTION TO THIS CRISIS. IT IS BASED ON THOSE ASSURANCES
THAT I HAVE RETURNED TO BUENOS AIRES THIS EVENING, AS I
ALSO SAID YESTERDAY, A SOLUTION WILL REQUIRE FLEXIBLE
APPROACHES BYBOTH SIDES - NOT AN ABANDONEMENT OF PRINCIPLE
BUT RATHER AN IMPORTANT DEGREE OF DEFENSIBLE FLEXIBILITY,
IT IS CLEAR TONIGHT THAT THE TASK WILL NOT BE EASY BUT
THE STAKES ARE SO GREAT THAT THEY DEMAND THE ULTIMATE
EFFORT ON THE PART OF ALL PARTICIPANTS IN THESE DISCUSSIONS.
