1. THE SENSE THAT TIME WAS RUNNING OUT BEFORE HOSTILITIES COMMENCE CAME THROUGH WITH PUNGENCY IN BA PRESS MORNING HEADLINES. "NACION" BANNERED THE GALTIERI CALL TO PRESIDENT REAGAN AS LAST-DITCH EFFORT TO AVOID ARMED CONFLICT. "PRENSA" SAYS THAT THE SECRETARY ARRIVED CALLING FOR FLEXIBILITY ON BOTH SIDES. MASS CIRCULATION "CLARIN" REPORTS THAT THE ARGENTINE FLEET WEIGHED ANCHOR APRIL 15 TO SAIL OUT AND MEET ROYAL NAVY, WHILE THE ARMY HIGH COMMAND CONCLUDED INSPECTION OF TROOPS INVESTED IN ISLAND TO MAKE THEM READY FOR WHATEVER EVENTUALITY.
