BEGIN TEXT: IN LIGHT OF EVENTS IN SOUTH GEORGIA THE  
ARGENTINES HAVE ASKED FOR A POSTPONEMENT OF THE MEETING  
WITH MR. HAIG. THE SECRETARY HAS HAD LENGTHY CONVERSA-  
TIONS BY TELEPHONE WITH THE ARGENTINE FOREIGN MINISTER  
THIS AFTERNOON. HE HAS ALSO BEEN IN CONTINUOUS COMMUNI-  
CATION WITH THE PRESIDENT. DURING THE SECRETARY'S CON-  
VERSATIONS WITH THE ARGENTINE FOREIGN MINISTER, THE  
SECRETARY MADE IT CLEAR THAT PRESIDENT REAGAN BELIEVES  
EVERY EFFORT SHOULD BE MADE TO FIND A PEACEFUL SOLUTION.  
THE SECRETARY WILL DISCUSS THE SITUATION WITH THE FOREIGN  
MINISTER TOMORROW MORNING. END TEXT. HAIG
