SUMMARY: JAPANESE MEDIA GAVE PROMINENT COVERAGE
TUESDAY TO REPORTS AND COMMENTS ON THE FALKLANDS CRISIS
IN THE WAKE OF THE BRITISH RECAPTURE OF SOUTH GEORGIA
ISLAND. EDITORIAL COMMENTS EXPRESSED REGRET OVER THE
BRITISH MILITARY OPERATION AND STRESSED THE IMPORTANCE
OF A PEACEFUL SOLUTION BEFORE THE DISPUTE BECOMES
INTERNATIONALIZED.

1. NHK COMMENTATOR AONO SAID BRITAIN IS NOW IN A
FAVORABLE SHORT-TERM POSITION MILITARILY BUT ADDED,
"IF THE CRISIS DRAGS ON, IT WILL CREATE A HEAVY
MILITARY AND ECONOMIC BURDEN ON BRITAIN BECAUSE OF THE
DISTANT LOCATION OF THE FALKLANDS."

AFTER POINTING OUT ARGENTINA'S ECONOMIC DIFFICULTIES,

AONO SAID, "THE BEST WAY TO SETTLE THE DISPUTE IS THROUGH DIPLOMATIC NEGOTIATIONS WITH A LONG-RANGE VIEWPOINT."

2. AMONG THE NEWSPAPERS, THE TUESDAY MORNING EDITIONS OF THE TOKYO DAILIES CONTINUED TO GIVE PROMINENT FRONT-PAGE COVERAGE TO REPORTS ON THE FALKLANDS, WITH THE MAINICHI HEADLINING THE STORY.

THE MAINICHI SAID THE BRITISH ATTACK ON SOUTH GEORGIA HAS STIFFENED THE STAND OF LATIN AMERICAN NATIONS TOWARD BRITAIN AND THAT ATTENTION IS NOW FOCUSING ON THE OAS MEETING IN WASHINGTON,

THE MAINICHI ALSO CARRIED A REPORT FROM LONDON CORRESPONDENT KURDIWA WHICH SAID PRIME MINISTER THATCHER HAS EMPHASIZED THE NEED FOR EARLY SETTLEMENT OF THE FALKLANDS PROBLEM THROUGH NEGOTIATIONS. OTHER PAPERS ALSO CARRIED REPORTS POINTING OUT THE PRIME MINISTER'S CALL FOR DIPLOMATIC TALKS TO RESOLVE THE PROBLEM.

3. AMONG THE EDITORIALS, THE MAJOR DAILIES COMMENTED TUESDAY MORNING ON THE RECAPTURE OF SOUTH GEORGIA BY BRITISH FORCES AND CALLED FOR A PEACEFUL SOLUTION OF THE FALKLANDS CRISIS.

- THE YOMIURI SAID, "BRITAIN CANNOT BE CONDEMNED FOR RETAKING SOUTH GEORGIA ISLAND BECAUSE ARGENTINA COMMITTED ARMED AGGRESSION FIRST AND THEN REFUSED TO COMPLY WITH A U.N. RESOLUTION TO WITHDRAW ITS TROOPS." HOWEVER, THE EDITORIAL ADDED, "WE ARE CONCERNED THAT THE BRITISH ACTION MIGHT ESCALATE THE FIGHTING AT A TIME WHEN IT IS MORE IMPORTANT THAN EVER FOR BOTH SIDES TO PRACTICE RESTRAINT," THE EDITORIAL COMMENTED, "THE FAILURE OF MEDIATION EFFORTS BY SECRETARY HAIG WAS DUE SOLELY TO THE FACT THAT BRITAIN AND ARGENTINA WERE AFRAID OF LOSING FACE." THE YOMIURI CONTINUED, "IT IS SAID THAT ONLY THE SOVIET UNION COULD PROFIT FROM A PROTRACTED CONFLICT, BUT DOES IT SERVE SOVIET INTERESTS TO THROW ITS SUPPORT BEHIND A MILITARY REGIME NOTORIOUS FOR OPPRESSING LEFTISTS? IN ADDITION, ARGENTINA WOULD BE THE LOSER IF IT SWITCHED ITS ALLIANCE FROM THE U.S. TO THE SOVIET UNION."

IN CONCLUSION THE EDITORIAL ADVISED, "BOTH BRITAIN AND ARGENTINA SHOULD SUPPRESS EMOTIONAL PATRIOTISM AND USE THEIR GOOD SENSE TO END THE FALKLAND ISLANDS DISPUTE."

- THE MAINICHI SAID, "THERE IS A STRONG VIEW THAT THE BRITISH MILITARY ACTION WAS AIMED AT PUTTING PRESSURE ON THE DIPLOMATIC NEGOTIATIONS. BUT THE USE OF ARMED
