SUMMARY: JAPANESE MEDIA GAVE MAJOR COVERAGE FRIDAY  
TO REPORTS ON THE FALKLANDS CRISIS CENTERING ON  
THE MOUNTING TENSION OVER THE IMMINENT ENFORCEMENT OF  
THE BRITISH SEA AND AIR BLOCKADE. THE REPORTS SAID  
A MILITARY CONFRONTATION BETWEEN BRITAIN AND ARGENTINA  
APPEARS IMMINENT BECAUSE THE ARGENTINE SIDE HAS ALSO  
DECLARED A 200-MILE MILITARY ZONE IN PREPARATION FOR  
TAKING ACTION AGAINST BRITISH SHIPS AND PLANES.  
1. NHK-TV, TBS-TV AND FUJI-TV GAVE TOP COVERAGE IN  
THEIR MORNING AND NOON NEWS BROADCASTS TO REPORTS ON  
SECRETARY HAIG'S LAST-MINUTE MEDIATION EFFORTS AMIDST  
WAR PREPARATIONS BY BOTH SIDES.

MESSAGE / ANNOTATION:

FUJI-TV REPORTED THAT ARGENTINA IS DISSATISFIED WITH THE HAIG PROPOSAL BECAUSE IT CALLS FOR A LOWERING OF THE ARGENTINE FLAG IN THE FALKLANDS EVEN IF ONLY TEMPORARILY. THE NETWORK COMMENTED THAT IF WAR BREAKS OUT IT WILL BE DIFFICULT FOR THE BRITISH TO RETAKE THE FALKLANDS BECAUSE ACCORDING TO MILITARY EXPERTS IN ORDER TO SUCCEED THEY MUST GAIN CONTROL OF THE AIR AND SEA AROUND THE FALKLANDS.

FUJI NOTED THAT THE BRITISH WOULD HAVE TO COPE WITH LAND-BASED ARGENTINE PLANES AND THAT THE 5,000 BRITISH MARINES LANDING IN THE FALKLANDS WOULD FACE 10,000 ARGENTINE TROOPS. ACCORDING TO THE NETWORK, ATTACKING FORCES NORMALLY NEED THREE TIMES THE STRENGTH OF THE DEFENDERS.

ON THE OTHER HAND, FUJI SAID IT WOULD BE DIFFICULT FOR THE ARGENTINE FORCES TO ATTACK THE BRITISH FLEET BECAUSE OF ITS SUPERIORITY IN ANTI-SUBMARINE AND MISSILE WARFARE.

FUJI-TV ALSO REPORTED THAT PRIME MINISTER THATCHER STATED IN A TELEVISION INTERVIEW THAT TO SETTLE THE DISPUTE IT WOULD FIRST BE NECESSARY FOR ARGENTINE FORCES TO WITHDRAW FROM THE FALKLANDS. THE NETWORK SAID THE PRIME MINISTER STATED THAT THE PROBLEM SHOULD BE THEN TAKEN TO THE U.N. FOR DISCUSSIONS ON A PEACEFUL SOLUTION.

FUJI ALSO REPORTED THAT PRIME MINISTER SUZUKI EXPRESSED HOPE THAT SECRETARY HAIG'S MEDIATION EFFORTS WOULD SUCCEED.

AFTER REPORTING ON THE MILITARY PREPARATIONS BY BOTH SIDES NHK-TV SAID, "THERE IS A STRONG VIEW THAT A MILITARY CONFRONTATION BETWEEN BRITAIN AND ARGENTINA CANNOT BE AVOIDED."

NHK ALSO BROADCAST STATE DEPARTMENT SPOKESMAN FISCHER'S STATEMENT THAT "THE SITUATION REMAINS VERY SERIOUS... THERE IS NO MOVEMENT TOWARD A PEACEFUL RESOLUTION AND THERE IS VERY LITTLE BASIS FOR OPTIMISM. HOWEVER, WE REMAIN IN TOUCH WITH BOTH PARTIES."

2. AMONG THE NEWSPAPERS, THE FRIDAY MORNING EDITIONS OF THE TOKYO DAILIES GAVE PROMINENT COVERAGE TO REPORTS ON THE FALKLANDS SITUATION, WITH THE SANKEI AND THE TOKYO SHIMBUN HEADLINING THE STORY.

- THE SANKEI SAID THE DISPUTE BETWEEN BRITAIN AND ARGENTINA OVER THE FALKLANDS HAS BECOME SERIOUS WITH

MESSAGE / ANNOTATION:

THE PEOPLE TO PREPARE FOR A MILITARY CONFRONTATION AND ORDERING THE FALKLAND ISLANDERS TO STAY INDOORS AND CARRY OUT A COMPLETE BLACKOUT. THE TOKYO SHIMBUN POINTED OUT THAT NEITHER BRITAIN NOR ARGENTINA HAVE RESPONDED POSITIVELY TO SECRETARY HAIG'S FINAL MEDIATION PLAN.

- THE MAINICHI CARRIED A FRONT-PAGE REPORT FROM BUENOS AIRES CORRESPONDENT TAKIMOTO WHICH SAID THE ARGENTINE MILITARY JUNIA HAS STRENGTHENED ITS VIEW THAT FULL-SCALE MILITARY CONFRONTATION WITH BRITAIN IS UNAVOIDABLE. THE REPORT SAID THE GOVERNMENT HAS ENTERED "A STATE OF EMERGENCY TO MAKE IT POSSIBLE TO LAUNCH IMMEDIATE ATTACKS."

- THE MAINICHI REPORTED THAT THE MAJORITY VIEW IN BUENOS AIRES IS THAT FIGHTING WILL START AFTER THE BRITISH FLEET ENFORCES ITS BLOCKADE AND THAT THERE EXISTS A GRAVE ATMOSPHERE IN THE ARGENTINE CAPITAL.

- AMONG INSIDE-PAGE REPORTS, THE YOMIURI AND THE ASAHI ALSO GAVE PROMINENT COVERAGE TO THE FALKLANDS WITH EMPHASIS ON THE IMMINENT ENFORCEMENT OF THE BRITISH BLOCKADE AND SECRETARY HAIG'S LAST-MINUTE PEACE EFFORTS.

3. THERE WAS NO EDITORIAL COMMENT ON THE FALKLANDS IN THE FRIDAY MORNING EDITIONS.
