UN RESOLUTIONS ON THE DECOLONIZATION OF THE FALKLAND (MALVINAS) ISLANDS, BEGAN BRANDISHING WEAPONS AS SOON AS THE ARGENTINE FLAG HAD BEEN HOISTED OVER THOSE ISLANDS. THE IMPERIAL AMBITIONS OF THE BRITISH RULING CIRCLES HAVE BEEN PARTICULARLY MANIFEST DURING THE PAST FEW DAYS, WHEN THE ROAR OF GUNS OF THE BRITISH ARMADA, PLYING THE WATERS OF THE SOUTHERN ATLANTIC, HAS BEEN HEARD ALL OVER THE WORLD AND WHEN THE BRITISH FOREIGN SECRETARY PYM HAS BEEN THREATENING 'TO TEACH A LESSON' TO SOVEREIGN ARGENTINA, WHILE IN LONDON, ACCORDING TO THE 'DAILY TELEGRAPH,' PREPARATIONS ARE IN FULL SWING FOR THE DECISIVE STAGE OF THE CRISIS WITH THE LANDING OF TROOPS ON THE ISLANDS.
