1. THE COORDINATING BUREAU OF THE NON-ALIGNED MOVEMENT
MET MAY 5, 1982, AT ARGENTINE REQUEST, TO HEAR A STATEMENT
BY ARGENTINE PERMREP EDUARDO ROCA,
IN LIGHT OF THE REACTION TO THE SINKING OF THE BELGRANO,
A STRONGER STATEMENT FROM THE NACB WAS EXPECTED.

BEGIN TEXT:

A MEETING OF THE COORDINATING BUREAU OF THE MOVEMENT OF
THE NON-ALIGNED COUNTRIES HELD ON MAY 5, 1982 WAS CONVENED
AT THE REQUEST OF THE PERMANENT REPRESENTATIVE OF
ARGENTINA.

THE PERMANENT REPRESENTATIVE OF ARGENTINA INFORMED THE
BUREAU OF THE DEVELOPMENTS IN THE REGION OF THE MALVINAS
ISLANDS SINCE THE BUREAU LAST MET ON APRIL 26TH, GRAVELY
INCREASING THE TENSION IN THE AREA AND ENDANGERING PEACE
AND SECURITY IN THE REGION AND IN THE WORLD.

UNDER THE CIRCUMSTANCES DESCRIBED ABOVE, THE COORDINATING
BUREAU:

- 1) EXPRESSED REGRET AT THE MOUNTING LOSS OF HUMAN LIFE
IN THE MALVINAS ISLANDS CONFLICT,
- 2) REITERATES IN ALL ITS ASPECTS THE COMMUNIQUE ADOPTED ON
APRIL 26TH, 1982,
- 3) REITERATES THE COMMUNIQUE'S REAFFIRMATION THAT THE USE
OF FORCE OR THREAT OF THE USE OF FORCE IN THE RELATIONS
BETWEEN STATES ARE ACTS CONTRARY TO THE PRINCIPLES OF THE

1, ARGENTINE PERM REP ROCA MADE A STATEMENT MAY 5 TO THE NON-ALIGNED COORDINATING BUREAU GIVING THE ARGENTINE PERSPECTIVE ON THE DEVELOPMENTS IN THE FALKLANDS/MALVINAS AND, INTER ALIA, STRONGLY CRITICIZING THE UNITED STATES AND ITS ROLE. ROCA FOCUSED PARTICULAR ATTENTION ON THE "ATTITUDE OF THE US GOVERNMENT" WHICH HE STATES ASSUMED THE ROLE OF MEDIATOR ONLY TO "GAIN TIME" FOR THE UK FLEET TO REACH ITS DESTINATION.

2, ROCA CHARGED THAT ONCE THE BRITISH FLEET HAD ARRIVED, THE US "TURNED ITS FACE" ON ITS OWN PROMISES OF IMPARTIALITY, FOOLED ITS OWN PUBLIC OPINION AND NOW IS ASSISTING THE COLONIALIST AGGRESSOR ECONOMICALLY AND MILITARILY. HE FURTHER STATES THAT THE FACTS CLEARLY SHOW THAT THE U.K. DID NOT WANT TO OPEN FIRE UNTIL IT HAD THE ANNOUNCED, COMPLETE, AND DIRECT SUPPORT OF THE US GOVERNMENT AND THAT AS A RESULT THE LATTER WAS AS RESPONSIBLE AS THE FORMER.

3, ROCA WENT ON TO QUOTE "A FEW OF THE NUMEROUS COMMENTS OF LATIN AMERICAN LEADERS" ON THE US ATTITUDE,

- PRESIDENT CARAZO OF COSTA RICA: "THE PARTIALITY OF THE US IN THE CONFLICT OVER THE MALVINAS HAS SPLIT HEMISPHERIC SOLIDARITY AND REPRESENTS A HARD BLOW TO THE INTERAMERICAN SYSTEM."

1. ANTIGUA AND BARBUDA, CURRENT CHAIRMAN OF THE LATIN AMERICAN GROUP, ISSUED THE FOLLOWING COMMUNIQUE DATED 5 MAY, ON THE FALKLANDS CRISIS:
COMMUNIQUE OF THE GROUP OF LATIN AMERICAN MEMBER COUNTRIES OF THE UNITED NATIONS

BEGIN TEXT:

THE GROUP OF THE LATIN AMERICAN MEMBER COUNTRIES OF THE UNITED NATIONS HELD A MEETING ON 4 MAY 1982 AT THE REQUEST OF THE PERMANENT REPRESENTATIVE OF ARGENTINA. THE PERMANENT REPRESENTATIVE OF ARGENTINA INFORMED ON ALL ARMED ACTIONS THAT HAVE TAKEN PLACE IN THE REGION OF THE MALVINAS ISLANDS BETWEEN ARGENTINA AND THE UNITED KINGDOM SINCE 25 APRIL 1982, AND WHICH HAVE SERIOUSLY AFFECTED PEACE AND SECURITY IN THE REGION AND IN THE WORLD. IN THESE CIRCUMSTANCES, THE GROUP OF LATIN AMERICAN MEMBER COUNTRIES OF THE UNITED NATIONS IN A SPIRIT OF ASSISTANCE IN THE SEARCH FOR A PEACEFUL SOLUTION DECLARES:
1) TO CONDEMN ALL ARMED ATTACKS THAT HAVE TAKEN PLACE IN THE SOUTH ATLANTIC, IN PARTICULAR THE ONE CARRIED OUT ON 2 MAY 1982, BY A BRITISH NUCLEAR SUBMARINE AND WHICH RESULTED IN THE SINKING OF AN ARGENTINE WARSHIP WITH 1042 MEN ABOARD OUTSIDE THE 200 MILE BLOCKADE ZONE ILLEGALLY ESTABLISHED BY THE UNITED KINGDOM AROUND THE MALVINAS ISLANDS, THEREBY PRODUCING A CRUEL AND GRAVE ESCALATION OF THE ARMED CONFLICT THAT AFFECTS THE REGION,
