TIMES POLITICAL EDITOR JULIAN HAVILAND: "A PLAN FOR A CEASEFIRE IN THE SOUTH ATLANTIC FROM 5 PM LONDON TIME TODAY, TO WHICH THE BRITISH GOVERNMENT HAD PROVISIONALLY AGREED, COLLAPSED YESTERDAY WHEN THE ARGENTINE GOVERNMENT REFUSED TO CONTEMPLATE WITHDRAWING ITS FORCES FROM THE FALKLAND ISLANDS.

THE OFFICIALS ARE NOW URGENTLY TRYING TO DEVISE A DIPLOMATIC FORMULA WHICH WILL HELP TO EXTRICATE BRITAIN FROM A TIGHT CORNER AND, AT THE SAME TIME, LIMIT THE DAMAGE WHICH THE CRISIS THREATENS TO CAUSE TO AMERICAN INTERESTS IN LATIN AMERICA AND EUROPE.

THERE IS REAL CONCERN IN STATE DEPARTMENT CIRCLES THAT THE UNITED STATES COULD EMERGE FROM THE FALKLANDS DISPUTE IN WORSE DIPLOMATIC SHAPE THAN EITHER BRITAIN OR ARGENTINA. ITS RELATIONS WITH LATIN AMERICA HAVE BEEN SEVERELY DAMAGED ALREADY AS RESULT OF ITS DECISION TO SIDE WITH BRITAIN. THERE IS NOW A DANGER THAT IT COULD FIND ITSELF ON THE SIDE OF THE "LOSER" UNLESS A DIPLOMATIC COMPROMISE CAN BE FOUND."
