SUMMARY: JAPANESE MEDIA GAVE PROMINENT COVERAGE MONDAY
TO REPORTS AND COMMENTS ON THE FALKLANDS CRISIS. AN
EDITORIAL APPEARING IN KYUSHU'S NISHI NIPPON SHIMBUN
SAID THE U.S. HAS SUFFERED A DIPLOMATIC SETBACK IN THE
FALKLANDS CRISIS BECAUSE OF THE DANGER THAT ANTI-
COMMUNIST ARGENTINA COULD GO OVER TO THE SOVIET SIDE.
1. NHK-TV, TBS-TV AND FUJI-TV CARRIED REPORTS ON THE
WAR CABINET MEETING HELD BY PRIME MINISTER THATCHER
TO DECIDE ON BRITISH POLICY IF U.N. MEDIATION EFFORTS
FAIL TO MAKE PROGRESS. ACCORDING TO THE NETWORKS,
ALTHOUGH THE SUBSTANCE OF THE CABINET MEETING WAS NOT
DISCLOSED, THERE IS A GROWING VIEW IN BRITAIN THAT
BRITISH FORCES WILL LAUNCH AN ALL-OUT ATTACK IN THE

NHK-TV CARRIED A REPORT WHICH SAID FOREIGN MINISTER PYM, WHO IS ATTENDING THE EC FOREIGN MINISTERS MEETING IN LUXEMBOURG, HAS CONFERRED WITH SECRETARY HAIG. THE NETWORK NOTED THAT PYM STATED AFTER THE TALKS THAT HE COULD NOT PREDICT WHETHER THE U.N. MEDIATION EFFORT WOULD BE SUCCESSFUL.

FUJI-TV REPORTED THAT DEFENSE SECRETARY NOTT STATED THAT THERE IS A TIME LIMIT FOR NEGOTIATIONS SINCE BRITAIN CANNOT COMPLY WITH ARGENTINA'S DELAYING TACTICS. THE NETWORK SAID THE DEFENSE SECRETARY WARNED ARGENTINA THAT THE U.N. NEGOTIATIONS MUST BE CONCLUDED THIS WEEK.

2. THE MONDAY MORNING EDITIONS OF THE TOKYO DAILIES GAVE PROMINENT FRONT-PAGE AND INSIDE-PAGE COVERAGE TO REPORTS ON THE FALKLANDS CRISIS, WITH THE TOKYO SHIMBUN HEADLINING THE STORY.

- THE TOKYO SHIMBUN PUBLISHED A REPORT FROM LONDON CORRESPONDENT KANEKO ON THE BRITISH HARRIER ATTACKS ON MILITARY FACILITIES IN THE PORT STANLEY AREA. THE TOKYO SHIMBUN ALSO CARRIED A REPORT FROM CORRESPONDENT ITO ON THE WAR CABINET MEETING WHICH SAID THE MEETING DISCUSSED BRITISH COUNTERMEASURES IN THE FALKLANDS CRISIS, WHICH HAS REACHED A SERIOUS STAGE.

- THE YOMIURI, ASAHI AND THE MAINICHI ALSO PUBLISHED PAGE-ONE REPORTS ON THE CABINET MEETING NOTING THAT THE RESULTS WERE NOT DISCLOSED.

- THE YOMIURI GAVE INSIDE-PAGE COVERAGE TO A REPORT FROM LONDON CORRESPONDENT ISHIKAWA WHICH SAID THE COMMANDO RAID ON PEBBLE ISLAND INDICATES THAT BRITAIN HAS COMPLETED PREPARATIONS FOR LANDING OPERATIONS ON THE MAIN FALKLAND ISLANDS. ACCORDING TO THE YOMIURI, "THERE IS A GROWING FEELING WITHIN THE BRITISH GOVERNMENT THAT ARGENTINA MAY BE 'PRETENDING' TO COMPROMISE ON BRITISH SOVEREIGNTY DEMANDS."

THE YOMIURI SAID BRITAIN'S U.N. AMBASSADOR PARSONS, WHO PARTICIPATED IN THE CABINET MEETING, WILL RETURN TO NEW YORK MAY 17 TO CONVEY THE VIEWS OF THE BRITISH GOVERNMENT ON THE MEDIATION PLAN. BUT THE REPORT CAUTIONED, "THERE IS A GROWING VIEW THAT BRITAIN WILL GIVE THE GO SIGNAL FOR A LANDING OPERATION WITHIN A FEW DAYS IF THERE IS NO DRAMATIC CHANGE IN

THE YOMIURI PUBLISHED A SEPARATE REPORT WHICH SAID,

THE YOMIURI SAID THE LEADING SITE FOR A BRITISH
LANDING IS FALKLAND BAY IN WEST FALKLAND WHERE THERE
WOULD BE LITTLE LIKELIHOOD OF FAILURE SINCE ONLY
A SMALL NUMBER OF ARGENTINE TROOPS ARE STATIONED
ON THE ISLAND. HOWEVER THE REPORT NOTED THAT LONDON
MILITARY SOURCES HAVE POINTED OUT THAT THERE IS ALSO
A POSSIBILITY OF A LANDING ON EAST FALKLAND, WHERE
THERE ARE 7,000 TO 8,000 ARGENTINE TROOPS, BECAUSE
WEST FALKLAND IS JUST WITHIN REACH OF THE ARGENTINE

SUCCESSFULLY LAND ON EAST FALKLAND, "THE BRITISH SIDE WILL HAVE A STRONG NEGOTIATING CARD," BUT POINTED OUT THAT BRITAIN WOULD FACE MANY DIFFICULT PROBLEMS AFTER LANDING -- SUCH AS SUPPLYING AND MAINTAINING ITS TROOPS -- BECAUSE OF HARSH WINTER WEATHER.
3. KYUSHU'S NISHI NIPPON SHIMBUN CARRIED AN EDITORIAL SUNDAY MORNING WHICH POINTED OUT THE FAILURE OF U.S. DIPLOMACY IN LATIN AMERICA AS A RESULT OF THE FALKLANDS CRISIS.
