3. DESIGNATION BY THE UN SECRETARY GENERAL OF A PROVISIONAL ADMINISTRATION FOR THE ISLANDS, WITH COMPLETE POWER, WHICH WILL MAINTAIN CONSULTATION WITH REPRESENTATIVES OF THE INHABITANTS TO BE DESIGNATED BY THE GOVERNMENT OF THE REPUBLIC OF ARGENTINA AND THE GOVERNMENT OF THE UNITED KINGDOM.

A) THE UN ADMINISTRATION WILL BE ESTABLISHED IN THE ISLANDS SIMULTANEOUSLY WITH THE BEGINNING OF THE WITHDRAWAL OF THE ARGENTINE AND BRITISH TROOPS;

B) THE UN MEMBER-STATES WILL PROVIDE THE SECRETARY GENERAL WITH ALL THE SUPPORT NECESSARY FOR THE ESTABLISHMENT OF THE PROVISIONAL ADMINISTRATION AND FOR THE SUPERVISION OF THE IMPLEMENTATION OF THE PROVISIONS OF THIS RESOLUTION.

4. ESTABLISHMENT, AS PER ARTICLE 29 OF THE UN CHARTER, OF A COMMITTEE HEADED BY THE UN SECRETARY GENERAL AND OF WHICH THE PARTIES AND FOUR OTHER MEMBER-STATES WOULD BE MEMBERS, TO CONDUCT URGENT NEGOTIATIONS AIMED AT OBTAINING A PERMANENT SOLUTION FOR THE QUESTION. THE COMMITTEE SHOULD INITIATE ITS WORK ON THE FORCES FROM THE AREA AND PRESENT ITS REPORT TO THE SECURITY COUNCIL BY JANUARY 31, 1983.

GETHER, CONSTITUTE AN HONEST, JUST, AND EQUITABLE BASIS TO STOP THE BLOODSHED AND THE TRAGIC LOSS OF LIVES. THE BRAZILIAN GOVERNMENT STRONGLY APPEALS TO THE GOVERNMENT OF THE REPUBLIC OF ARGENTINA AND THE GOVERNMENT OF UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND TO PLACE THE INTERESTS OF PEACE AND HUMANITY ABOVE EVERYTHING, AND TO ORDER THE IMMEDIATE END OF HOSTILITIES AND TO BEGIN NEGOTIATIONS.

LET US RENEW OUR DEDICATION TO THE OBJECTIVES AND PRINCIPLES OF THE CARTER AND LET US SHOW EFFECTIVELY THAT THE PLEDGE WE ALL MADE AT THE TIME OF THE CREATION OF THIS ORGANIZATION - "WE, THE PEOPLES OF THE UNITED NATIONS, DETERMINED TO SAVE SUCCEEDING GENERATIONS FROM THE SCOURGE OF WAR..." - WAS NOT EMPTY RHETORIC.
