2. (LOU) THE TEXT OF GALTIERI'S RESPONSE WAS GIVEN TO THE PRESS SHORTLY AFTER MIDNIGHT AND APPEARED IN THIS MORNING'S PAPERS. APPARENTLY IT OCCURRED TO SOMEONE THIS MORNING THAT THE MESSAGE HAD NOT BEEN COMMUNICATED TO US IN WRITING. THUS THE UNUSUAL PROCEDURE. WE ARE POUCHING THE SIGNED ORIGINAL OF GALTIERI'S NOTE TO ARA/SC.
