- 1. FOLLOWING ARE EXCERPTS FROM THE NOON PRESS BRIEFING OF MAY 27. DEAN FISCHER WAS THE BRIEFER.
- Q: THE FALKLANDS. YOU GOT ANYTHING YOU CAN CONTRIBUTE?
- A: AS I MENTIONED, THE SECRETARY IS SPEAKING TO THE WAS MEETING THIS AFTERNOON.
- Q: HE'S GOING THERE JUST TO MAKE HIS SPEECH BUT NOT TO LISTEN TO ANYRODY ELSE?
- A: NO. I THINK HE'S ALREADY GONE, UR, IF NOT, HE WILL BE THERE SHORTLY. HE WILL BE LISTENING TO OTHER SPEAKERS PRIOR TO HIS OWN. I BELIEVE HE'S FIFTH IN LINE.
- MINISTER. HE WILL BE THERE IN TIME TO LISTEN TO HIM AS WELL?
  - A: I CAN'T ABSOLUTELY CONFIRM THAT. MY UNDERSTANDING IS THAT HE WAS TO HAVE LEFT SHORTLY, IF HE HAS NOT ALREADY

- Q: HAS THE STATE DEPARTMENT SATISFIED ITSELF ON THE ECUADOREAN AIRPLANE THAT HAD MILITARY EQUIPMENT ON IT?
- A: MY UNDERSTANDING IS THAT THE LICENSE HAS BEEN APPLIED FOR BUT IT HAS NOT YET BEEN ISSUED.
- Q: BY WHOM HAS THE LICENSE BEEN APPLIED FOR?
- A: I PRESUME BY ECUADOR. I HAVEN'T REALLY LOOKED INTO THIS.
- Q: DEAN, THERE WAS A QUESTION ALSO, NUT SIMPLY --
- A: IT'S ECUATORIANA AIRCRAFT, DR AIR COMPANY.
- Q: THERE WAS A QUESTION ALSO, PART FROM THE ABSENCE OF A LICENSE, OF THE MANIFEST BEING DECEPTIVELY LABELED AS AIRCRAFT PARTS, DO YOU HAVE ANY UNDERSTANDING OF HOW THAT'S BEEN RESOLVED? IS THAT AGAINST THE LAW; IS THAT SOMETHING YOU'RE LOOKING INTO?
- A: IT'S SOMETHING THAT OBVIOUSLY WE'RE LOOKING INTO.
  MY UNDERSTANDING IS THAT WE HAVE NO INFORMATION THAT
  WOULD INDICATE THE CARGO WAS INTENDED FOR ANY ULTIMATE
  DESTINATION OTHER THAN ECUADUR. I DO NOT HAVE ANY DETAILS
  ON WHAT THE CARGO CONTAINS.
- LET ME ADD ONE OTHER THING ON THE QUESTION ABOUT THE ECUADOREANS. WE UNDERSTAND THAT THE ISRAELI GOVERNMENT HAS CATEGORICALLY DENIED THAT THE SHIPMENT WAS INTENDED FOR ARGENTINA AND THAT THE GOVERNMENT OF ECUADOR HAS STATED THAT NONE OF THE CARGO OF THE DETAINED PLANE WAS INTENDED FOR MILITARY USE DUTSIDE OF ECUADOR.
- Q: RELATED TO THAT, DO YOU KNOW WHETHER IT IS TRUE, AS REPORTED, THAT THE UNITED STATES IS NOW SENDING SIDE-WINDER MISSILES TO BRITAIN?
- A: AS YOU KNOW, WE HAVE NOT COMMENTED UPON ANY OF THE

- Q: WHEN THE SECRETARY SAID WEEKS BACK THAT WE WOULD BE PROVIDING MATERIEL, THAT WOULD BE A LARGE ENOUGH UMBRELLA TO PUT SOME SIDEWINDER MISSILES UNDER IT?
- A: AGAIN, I'M NOT GOING TO COMMENT ON THE SPECULATIVE STORIES ABOUT THE TYPE OF EQUIPMENT WHICH HAS BEEN DISCUSSED AND SPECULATED ABOUT.
- Q: THE STORY DIDN'T SEEM VERY SPECULATIVE AS WRITTEN.
- A: BUT I HAVE NO COMMENT TO MAKE ON IT.
- Q: FOLLOWING ON THAT, TWO NIGHTS AGO ARC'S NIGHTLINE REPORTED FROM BUENOS AIRES THAT THE ARGENTINE GOVERNMENT HAD SAID THAT IT HAD BEEN ASSURED BY ASSISTANT SECRETARY ENDERS THAT THE UNITED STATES WOULD PROVIDE NO OFFENSIVE MILITARY WEAPONRY SUCH AS MISSILES TO BRITAIN. CAN YOU CONFIRM WHETHER OR NOT ENDERS DID, INDEED, PROVIDE SUCH ASSURANCE?
- A: NO, I HAVE NOT HEARD THAT BEFORE.
- W: THERE IS A REPORT THAT THERE'S SUME U.S. GENERAL ON THE QE II.
- A. THAT IS INCORRECT. I BELIEVE THE --
- Q: HE'S LEFT OVER FROM A CRUISE. (LAUGHTER.)
- A: I BELIEVE THE REPORTS REFERRED TO A GENERAL JEREMIAS MOURE, AND WE'VE CHECKED WITH THE PENTAGON ON THESE REPORTS AND, AFTER HAVING CHECKED THEIR SERVICE RECORDS, THEY FIND NO ONE LISTED WITH THAT NAME OR ANYONE REMOTELY SIMILAR. I HAVE NO OTHER DETAILS OTHER THAN TO SUGGEST THAT IF YOU WANT TO FOLLOW UP YOU SHOULD CHECK WITH THE PENTAGON.
- Q: HAS THE UNITED STATES BEEN CONSULTING WITH OTHER LATIN AMERICAN COUNTRIES WITH RESPECT TO THIS DAS MEETING AND SEEKING GUARANTEES-THAT THEY WILL NOT SUPPORT ANY SANCTIONS THAT ARGENTINA MAY TRY TO INVOKE?

- Q: HAS THE STATE DEPARTMENT GIVEN ARGENTINA ASSURANCES THAT THE U.S. GOVERNMENT WILL NOT PROVIDE GREAT BRITAIN WITH OFFENSIVE WEAPONS?
- A: AGAIN, IT FALLS INTO THE CATEGORY OF THE SUBJECTS THAT I'M JUST NOT ABLE TO DISCUSS. WE MADE IT CLEAR, THE PRESIDENT AND THE SECRETARY REPEATEDLY, THAT THERE WILL BE NO DIRECT U.S. MILITARY INVOLVEMENT IN THE CONFLICT.
- Q: DDES THAT RULE OUT A REPORTED BRITISH REQUEST FOR AN AWACS TO FLY OVER THE SOUTH ATLANTIC?
- A: IT CERTAINLY WOULD.
- Q: HAS SUCH A REQUEST BEEN MADE?
- A: AGAIN, I'M UNABLE TO CUMMENT ON THAT.
- Q: THERE'S SOME DISCUSSION THAT SOME ALLIES IN LATIN AMERICA OR ARGENTINA MIGHT UNDERTAKE, NOT NECESSARILY THROUGH THE DAS OR THROUGH THE TIAK, BUT ON THEIR DWN, CERTAIN KINDS OF ECONOMIC SANCTIONS AGAINST THE BRITISH SUCH AS FREEZING ASSETS EN MASSE, NOT REPAYING DEBT TO BRITISH BANKS AND SO FORTH.
