HE ALSO STRESSES NEED FOR A PALESTINIAN HOMELAND.

2. BEGIN TEXT. MR. PRESIDENT: I WOULD LIKE TO EXPRESS TO YOUR EXCELLENCY MY MOST SINCERE CONSIDERATION FOR THE INTENSE EFFORTS YOU HAVE MADE TO HALT THE TRAGIC BUTCHERY PERPETRATED BY ISRAEL AGAINST THE PALESTINIAN AND LEBANESE PEOPLES.

MESSAGE (CONTINUED):

3. WHILE WE HIGHLY APPRECIATE THESE EFFORTS, WE MUST STRESS THE NEED FOR A SPEEDY INITIATIVE TO GUARANTEE THE SAFETY OF THE PALESTINIAN AND LEBANESE NOT ONLY IN BEIRUT, BUT ALSO IN ALL LEBANESE TERRITORIES NOW UNDER ISRAELI OCCUPATION. WHILE, YOUR EXCELLENCY, I RENEW MY THANKS FOR THE DEEP PERSONAL COMPASSION YOU HAVE SHOWN IN REGARD TO THIS TRAGEDY, WE LOOK FORWARD TO MORE URGENT AND SUSTAINED EFFORTS TO RESTORE THE PALESTINIAN PEOPLE'S NATIONAL RIGHTS.

4. WE ALSO HOPE YOU SHARE OUR BELIEF THAT THE ESTABLISHMENT OF A NATIONAL HOME FOR THE PALESTINIAN PEOPLE IS THE ONLY WAY TO END THE LIFE OF EXILE AND TRAGIC PERSECUTION THAT SEVERAL GENERATIONS OF PALESTINIANS HAVE BEEN SUBJECTED TO-EVER SINCE THEY WERE EXPELLED FROM THEIR LAND: PALESTINE.

5. WISHING, MR. PRESIDENT, THAT YOUR EFFORTS TO PUT AN END TO THE TRAGIC ORDEAL LONG INFLICTED UPON THE PALESTINIANS AND LEBANON, AND TO ACHIEVE A PEACE BASED ON JUSTICE AND INTERNATIONAL LEGALITY, PLEASE ACCEPT, YOUR EXCELLENCY, THE ASSURANCES OF MY HIGHEST CONSIDERATION.
