Shcherbitskiy, candidate deputy to the Ukrainian Supreme Soviet, CPSU Central Committee Politburo member and Ukrainian Communist Party Central Committee first secretary, at the 12 February meeting with his voters in Bagleyskiy constituency, Dneprodzerzhinsk]

[Text] Esteemed comrades: First of all, allow me to express great and heartfelt gratitude for the high honor and confidence invested in me -- my nomination as candidate deputy to the Ukrainian Supreme Soviet (applause).

Your confidence is a unanimous support for our party's policy, of approval for its practical activity aimed at further strengthening our state's potential, at raising the people's prosperity, and at preserving and consolidating peace on earth. (Applause). Our party has no loftier goal than to selflessly serve the people's interests and to display constant concern for their good and happiness.

The forthcoming elections to the supreme soviets in union republics and the local soviets of people's deputies will undoubtedly turn into a new brilliant confirmation of the monolithic unity of the inviolable bloc of Communists and non-party members, and of the close cohesion of the Soviet people around the CPSU and its Central Committee. (prolonged applause).

Our party's combat headquarters headed by Konstantin Ustinovich Chernenko, prominent statesmen and party figure, is purposefully and consistently pursuing the Leninist CPSU general line aimed at the consolidation of Soviet society's moral and political unity and unbreakable friendship among the country's peoples, and at the further blossoming of our great socialist homeland. (stormy, prolonged applause).

On the eve of my meeting with you, I had a conversation with Comrade K.U. Chernenko. Konstantin Ustinovich inquired about the work of national economic branches in the winter season, about the mood of the people, and received with satisfaction the information that the republic's working people were actively preparing for the next party congress, were making the efforts necessary to implement the CPSU Central Committee's directives for further improvements in production and in public life, and fully approved the complex of our party and state initiatives aimed at improving the international situation.

Comrade K.U. Chernenko expressed gratitude to all collectives who nominated him candidate deputy to the Ukrainian Supreme Soviet, and conveyed the best wishes to the inhabitants of Dneprodzerzhinsk and all the republic's working people. (Storms, prolonged applause). The distinguishing feature of the current electoral campaign, Comrade V.V. Shcherbitskiy continued, is the fact that it is taking place in the period of immediate preparations for a truly historic event in the life of our party and all people -- the 27th CPSU Congress.

It can only be performed by enterprising and industrious people convinced of the correctness of our cause and profoundly devoted to the socialist homeland, that is, selfless and competent people who know their job. (Applause)

It is a difficult and multiform process to educate such people. What educates them is, above all, our system itself and the nature of a socialist society and the Soviet way of life; what educates them is the family, school, and public organizations. And at the same time everyone participates in the process of education: people influence each other primarily through their own example, behavior, and attitude to work.

A cadre worker, even if he is not listed as an agitator or propagandist, educates people within his circle in the best way when he knows his job well, takes it wholeheartedly, and performs it conscientiously. On the contrary, the botcher, the absentee, and the self-seeker harms society not only by the fact that he shirks work himself, but also by corrupting people working alongside him, particularly young people.

For this reason any deviation from the norms of the Soviet way of life and morality frequently has the effect of a malignant virus. No doubt if all join forces and combine efforts; negative phenomena can be eliminated everywhere and high efficiency and quality of work can be ensured in every sector. (Applause).

It is to be admitted, Comrade V.V. Shcherbitskiy said, that the real advantages of socialism are not always being convincingly shown in our educational work. After all, socialism offers enormous opportunities for all-around development of personality and displaying one's abilities and talents.

At the same time, the goal of capitalism is radically different -- to obtain a maximum profit by any means, including the dirtiest and most criminal ones, and to keep the people of labor in oppression. There are countless examples of this. Just recall how many times you have seen the images of British miners who have been on strike for nearly a year. Under the conditions of the advertised, as they say, "oldest Western democracy," the vital human right to work is being trampled upon, and the miners' protest is being suppressed with unprecedented cruelty.

What disturbs the official authorities is not the disastrous situation of the miners, but the class solidarity manifested by other workers, support and assistance on the part of the international workers class. This is convincing proof that, for capitalism, the interests of the toiling man are worthless. The lofty and truly noble goals of socialism are even more visible against this background.

In the world arena, the Soviet Union comes out in a united and single formation with the fraternal socialist countries. Our common successes scored in the political, socioeconomic, and ideological spheres are significant and indisputable. CEMA member-states have a tangible advantage over capitalist countries into the pace of economic growth. They possess already nearly one-third of the world's scientific potential, and their combined economic potential is larger than that of the United States or the countries of Western Europe.

The influence exerted by the socialist world on the entire development of mankind's history is growing ever stronger and appreciable. Increasingly broader masses are coming to see that socialism is the mainstream of social progress! (Applause).

Imperialist reaction is unable to seriously impede, let alone stop, socialism.

But the deeper the general crisis of capitalism becomes and the more it is entangled in its contradictions, the more desperate and adventurist are the measures to which it may resort. The threat to peace has significantly increased in connection with the continuing deployment of new first-strike nuclear missiles targeted at the Soviet Union and other countries of the socialist community.

Highly disturbing are also, let us say it straight, the shameful attempts made by some circles in the West (and not only in the West) to revise the postwar structure in Europe and in the world as a whole, to let the fruits of the victory over German fascism and Japanese militarism go with the wind.

But no one is able to rewrite history! (applause). The preservation of peace and, above all, the prevention of nuclear war have become a task of importance for all mankind. History has imposed on socialism the difficult and responsible mission of parrying the threat of nuclear war hanging over mankind. And the world's peoples are seeing this ever more clearly.

This is why the Leninist peace-loving foreign policy pursued by the CPSU and the Soviet state has won deep respect on the part of all progressive mankind. (applause).

The purport of our state's peaceful initiatives is clear and dear to every sober-minded person; it meets the hopes of all peoples. Particularly important is the new initiative of the Soviet Union concerning talks with the United States on the entire complex of interconnected problems of precluding the militarization of outer space and the reduction of strategic nuclear weapons and medium-range nuclear means. The first step has been made toward a dialogue between the two countries; the situation in the world as a whole depends to a large extent on the state of relations between the two.

The principled novelty of the forthcoming talks lies in the fact that the problems of space and nuclear weapons are inseparable and should be discussed and settled comprehensively. The Soviet Union firmly insisted and continues to insist upon this point.

In his replies to questions from a correspondent of CNN television, Comrade K.U. Chernenko pointed out that the presence of goodwill, readiness for sensible compromises, and strict observance of the principle of equality and equal security were required from each side for the success of the forthcoming new Soviet-American talks.

I would like to hope that the United States will display realism and act precisely this way. The Washington administration and its NATO allies must take into account the enormous worldwide prestige of the consistent and principled position of the Soviet Union and the socialist community concerning the vital problems of war and peace. They also cannot wave aside the growing mass antiwar movement and the public demands in their own countries to prevent the threat of nuclear war not by words, but by deeds.

While protecting the peaceful toil of the Soviet people and taking steps necessary to improve the international situation, Comrade V.V. Shcherbitskiy continued, our party's Central Committee and government are at the same time taking trouble to maintain at due level the country's defense capacity. History has repeatedly confirmed and continues to confirm that the attempts to talk to our country in the language of moral admonitions and threats, from the position of strength, are an absolutely hopeless undertaking. (applause) And we are not afraid of any "crusade" against communism. (applause).

No one will ever succeed in shaking the close moral and political unity of the Soviet people, their monolithic cohesion around the Leninist party, and their devotion to the ideals of communism. (applause).

We are confident in the rightness of our cause, we are confident in our forces, we are capable of reliably defending our land, our system, and way of life -- and this is what we are effectively doing! (prolonged applause).

At the end Comrade V.V. Shcherbitskiy said: Allow me, esteemed comrades, to offer my cordial thanks to you, to Leonid Romanovich Komarov, my agent, to all those present, as well as to the speakers at the present meeting for the good and warm words directed to our Leninist Communist Party and its Central Committee. (applause).

For my part, allow me to assure you that I will make every effort to carry out my duty to the party and the people irreproachably and to justify the high confidence of the voters. (applause)

I wish you all, and through you all inhabitants of Dneprodzerzhinsk, good health, happiness, and prosperity (applause), I wish you success in completing the plans for the current year and welcoming our party's 27th congress in a worthy way. (stormy, prolonged applause).

DPA: CIVIL RIGHTS CAMPAIGNER ARRESTED IN KALININ

LD251732 Hamburg DPA in German 1620 GMT 25 Feb 85

[Text] Frankfurt, 25 Feb (DPA) -- The Frankfurt-based International Society for Human rights (IGFM) reports today that the Soviet civil rights campaigner Vyacheslav Bakhmin (37) from Moscow has been rearrested in Kalinin. He is a cofounder of the working group for the investigation of the misuse of psychiatry for political purposes and was arrested on Friday [22 February]. A physicist by profession, he was first arrested in 1969 and held for 10 months for distributing leaflets. In 1980 he was arrested and sentenced to 3 years in a labor camp because of his membership in the working group to investigate the misuse of psychiatry. In the camp he was sentenced to a further year in custody and released only in 1984 when he was forbidden to live in Moscow with his family. He then settled in Kalinin.

SHCHERBITSKY CALL ON PRESIDENT

Q - Why did President grant appointment.

A - Since Mr. Shcherbitsky is a senior member of the Soviet Politburo, the President wanted to meet him to express his views of the U.S.-Soviet relationship.

Q - What will the President bring up?

A - Obviously I can't say what exactly will be covered in the conversation, but the President will of course express his thoughts on how we can improve US-Soviet relations.

Q - Why was Shcherbitsky invited?

A - Mr. Shcherbitsky is head of a delegation from the Supreme Soviet, invited by Speaker O'Neill. He is therefore a guest of the Congress.

Q - Will the President mention human rights abuses in the Ukraine?

A - As I said, I'm not going to predict specific topics, but you can be sure that the President intends to have a frank conversation dealing with the key issues in the relationship.

Q - Is this visit connected with the Geneva negotiations?

A - No. But I'm sure the President will let Mr. Shcherbitsky know that he wants to move as rapidly as possible toward an agreement to reduce nuclear weapons.
