2. YOU WILL HAVE RECEIVED TEL AVIV 9463 AND SHOULD GET BACK TO QADDQUR STATING THAT WE HAVE RAISED QUESTION OF CLASH NEAR BHAMDUN WITH ISRAELIS, AND THAT ISRAELIS HAVE SAID THEY WILL REPORT TO US. YOU SHOULD ALSO NOTE FOR QADDQUR THAT ISRAELIS ARE PUBLICLY AT LEAST GIVING DIFFERENT VERSION OF EVENTS CITING PROVOCATIONS BY SYRIAN FORCES AS REASON FOR OUTBREAK OF FIGHTING. YOU MAY TELL QADDQUR THAT WE CONTINUE TO URGE THE ISRAELIS TO MAINTAIN CEASE-FIRE AND THAT ISRAELIS CONTINUE TO REAFFIRM TO US THEIR COMMITMENT TO THE CEASE-FIRE WITH SYRIA. IN THIS CONNECTION, YOU MAY SAY THAT INSURANCE OF ISRAEL'S OBSERVANCE OF CEASE-FIRE WAS HIGH ON THE AGENDA OF BEGIN'S VISIT HERE AND THAT THE ISRAELI ANNOUNCEMENT YESTERDAY OF THE CEASE-FIRE WAS RESULT OF STRONG EFFORTS WITH BEGIN TO SUPPORT OF THE CEASE-FIRE ON ALL FRONTS.

3. YOU SHOULD ALSO SAY THAT WE FIND IT DIFFICULT TO DISCERN FACTS IN CASES LIKE THAT AROUND BHAMDUN AND THAT OUR KEY CONCERN IS TO ENSURE THAT THE CEASE-FIRE HOLDS.
