Please sign and mail the enclosed postcards to President Reagan and to Jean Kirkpatrick, our United Nations Ambassador.

If you're the kind of Bible-believing American I believe you are, you'll do this immediately in support of Israel's right to remain a Jewish state...

...and you'll join me in support of Christians for Israel, a God-sent, non-profit organization firmly rooted in the Word of God--promoting, supporting, and advancing good relations between nations like America and Israel.

You see, I'm Rev. Jerry Falwell, a close friend of Israeli Prime Minister Menachem Begin, and a strong supporter of the Bible-based plan of action Christians for Israel (CFI) is taking.

For one thing, CFI knows that the conflict in the Middle East over Israel is not a political controversy, but rather a scriptural one, and it goes back 4,000 years ago.



Dear Rev. Falwell:

Mr. Edwin Meese has asked me to respond to your communication of December 3, 1982, concerning the Lubbock Independent School District case.

As you may already know, it is extremely rare for the United States to participate as amicus curiae at the petition stage in Supreme Court cases in which it is not a party. Where, as here, the petitioner has fully apprised the Court of the relevant considerations bearing on the "certworthiness" of the case, we traditionally refrain from filing anything. Let me emphasize that the Justice Department's silence at this stage of the proceedings should not be misunderstood as any lack of interest in this case. Should the Court grant the petition, the filing of an amicus curiae brief on the merits will receive immediate attention by the Department.

IT HAS COME TO MY ATTENTION THAT THE ADMINISTRATION IS CONSIDERING WHETHER TO INVOLVE ITSELF AS A FRIEND OF THE COURT IN THE LUBBOOK INDEFENDENT SCHOOL DISTRICT CASE. AS YOU KNOW, THE CASE INVOLVES WHETHER STUDENTS WITH A RELIGIOUS BELIEF WILL BE AFFORDED THE SAME FREEDOM OF SPEECH AND ACCESS TO THE PUBLIC SCHOOL GROUNDS AS CLUBS, ORGANIZATIONS, AND INDIVIDUALS WHO EXPRESS ANTI-RELIGIOUS BELIEFS OR TAKE POSITIONS ON ISSUES THAT SUGGEST A RESPONSE FROM RELIGIOUS PECPLE.

I BELTEVE IT IS IMPERATIVE THAT THE ADMINISTRATION ENTER THIS CASE AS A FRIEND OF THE COURT ON THE SIDE OF THE LUBBOOK SCHOOL DISTRICT. THE SUFFEME COUPT'S DECISION EARLIER THIS YEAR IN WHICH IT ALLOWED RELIGIOUS GROUPS TO MEET ON COLLEGE CAMPLSES ON GROUNDS OF FREE SPEECH GLARANTEFS IN THE CONSTITUTION IS JUST AS APPROPRIATE FOR HIGH SCHOOLS, SO LONG AS THE CLUES, GROUFS, OR INDIVIDUALS ARE MEETING EFFORE OR AFTER SCHOOL HOURS AND NO ONE IS COMPELLED TO ATTEND. THE COURTS MUST NOT BE ALLOWED TO RULE ON THE CONTENT OF SPEECH, EXCEPT IN CASES OF LIBEL OR SPEECH THAT LEADS TO PHYSICAL HARM (CRYING "FIRE" IN A CROWDED THEATRE WHEN THERE IS NO FIRE).

WE CONGRATULATE THE JUSTICE DEPARTMENT FOR ITS EXCELLENT ARGUMENTS BEFORE THE SUPREME COURT ON THE ABORTION QUESTION AND HOPE THAT A DECISION WILL BE MADE IN FAVOR OF ENTERING THE LUBBOOK CASE. IT IS A LASE WITH GRAVE CONSEQUENCES FOR ALL OF US. THE COURTS MUST NOT BE ALLOWED TO DETERMINE THAT THE CONTENT OF FREE SPEECH MAY BE LIMITED.

HR 1647 MAKES 128 SENTENCING CHANGES - 112 REDUCTIONS AND ONLY 16 INCREASES IN MAXIMUM PENALITIES. THESE BILLS ARE NOT A NEUTRAL RECODIFICATION, RATHER THEY ARE A MAJOR SUBSTATIVE LIBERALIZATION OF EXISTING LAW.

IT IS IMPERATIVE THAT YOU PERSONALLY REVIEW THE

ATTORNEY GENERAL'S TESTIMONY TO INSURE THAT THE ADMINISTRATION DOES NOT IN ANY WAY EXPLICITLY ENDORSE IR IMPLICITY ENDORSE IN THE NAME OF RECODIFICATION LEGISLATIVE CONCEPTS THAT WOULD LIBERALIZE TITLE 18 THEREBY RENEGING ON THE ADMINISTRATION'S "TOUGH ON CRIME" CAMPAIGN PROMISES AND POLICY POSITIONS.


