MEMORANDUM FOR LUCIAN HEICHLER
INR/IC

SUBJECT: Active Measures

In reference to your report of 26 October, I would underscore that I think continued attention to Active Measures is a vital responsibility of the inter-agency community and I welcome the leadership your office has provided.

The NSC should be represented, if possible, during your projected day-long discussion. I would urge you to invite John Lenczowski (NSC staffer) and Roy Godson (NSC consultant). If I can attend, I will. We need to explore ways to increase the understanding on a worldwide basis of the increased Soviet dependence on this form of political action. By sensitizing target audiences to the potential for Soviet active measures we can develop joint or parallel activities to counter Soviet political operations before the fact rather than after they have taken place. In other words, let us see where we can take the offensive rather than be principally reactive.
