

THE CRABTREE COLLECTION OF MINIATURE SHIPS



THE MARINERS' MUSEUM

NEWPORT NEWS, VIRGINIA

THE COVERS

Stern of the French Galley of Louis XIV "Madame" built in 1690. From early Greek and Roman the galleys, with their gorgeous carvings aft, were the dominant vessels in the Mediterranean.

THE VENETIAN GALLEASS

The most elaborately carved vessel in the collection with 359 carved figures that even extend to the blades of the sweeps.



The Crabtree Collection is a group of 16 miniature ships revealing the progress of water transportation from earliest times to the decline of the sailing ship. It represents a 28-year effort by artist and craftsman August F. Crabtree. He has created scale ships in miniature built from the keel up, piece by piece, just as fullsize ships were constructed. Those with complete hulls have also been tested to float in water.

The Collection is exhibited in a special gallery in The Mariners Museum in a dramatic jewel-like display unsurpassed by any other in existence. The visitor, upon entrance into the darkened room, views only the exquisitely carved models bathed in beams of soft light. The models are shown in individual dustproof cases extending to the ceiling. The atmosphere is further enhanced by the dark brown carpeting covering the floor and walls of the gallery.

The unusual lighting on the models is achieved by the placement of from two to six theatrical type lights in the ceiling above each display case. Individual rheostats in every light permits adjustment for the control of the exact amount of illumination on each model. The lighting is further controlled through the use of nylon screen filters located directly above the models.

Mirrors have been positioned in each of the cases for the dramatic reflection of the proper lighting on the hulls of the models. Magnifying glasses, especially ground for the exhibition, are placed in strategic locations in the thirteen cases to enable the viewer to appreciate the detail of the hundreds of exquisite carvings on the vessels.

For the important control of humidity within the cases, small cups of water have been placed beneath the gold-covered crushed velvet platforms on which the models are supported.

The Venetian Gondola of the Doge weighing only 14.6 grams with sixty carved figures, because of its size, represents the greatest amount of labor in the Collection. This ornate vessel which was kept for state occasions and distinguished guests is located in a vantage point in the semi-circular entrance where it can be viewed both at the entrance and from the interior of the gallery.

Two of the smaller models, the raft and dug-out which begin the theme, progress of water transportation, are located in the half-circle exit. Included in this exhibition entitled "Crabtree the Man" are depicted some of the custom made tools, procedures of construction and carving, as well as many of the exotic woods and other materials used in his almost

life-time endeavor.

The models represent the period 1480 B.C. through 1840 A.D. The viewer sees in three dimensions the most primitive means of water transportation on to the earliest seagoing vessels, through Bible times to the Columbus period and to the extremely ornate vessels of the Renaissance.

August Crabtree supported himself during the years of his work on the models by carving miniature figures for motion picture studios, by some model work and sometimes by providing technical advice. He used many sources of research and thousands of hours of effort to assure that the models would be as authentic as possible.

The first vessel in the Collection is the tiny primitive raft. Whether the first rafts were of reed or logs and if tied with rawhide thongs or vines will never be known. The dugout was the next development and whether the first of these were hued out or burned out, or a combination of both remains a mystery.

The Egyptian seagoing vessel of 1480 B.C. is of the XVIII Dynasty. This era of ships are the earliest seagoing vessels of which any important information exists. The Egyptians, while not a seafaring nation, had constructed seagoing vessels long before Bible times. Two large decorated steering oars were secured at each quarter and a lotus shaped decoration at the stern was common practice for a long period.

The Roman Merchant Ship was of the period of about 50 A.C. A passage in Lucian from the Scriptures provided the only known written au-

thority on the matter of the proportion of the ships of the Roman Empire. A swan at the stern was typical of Roman ships of the time. There had been much conjecture on the use of a "creature glorifying in death" being used in this fashion.

The Mora of William the Conqueror of 1066 A.D. is a large open boat having a marked similarity to the whale boats used in the era of the sailing whalers. One large sail was used but the design of the vessel was primarily for the use of oars with the oarsmen rowing in a standing position. A dragon figurehead which appears on the bow was common practice in Northern Europe in that period.

Two ships of Columbus, the Santa Maria and Pinta, are also in the collection. Even the diligence of Crabtree's research failed to uncover knowledge of their construction. They are, however, authentic reproductions from information on Mediterranean and South European ships of the period.

The Venetian Galleass of the period of about 1650 is probably the outstanding model in the collection. The prosperous Venetians loved to show their power and opulence. Almost any other working galleass would have much less ornamentation. These vessels were rowed by paid rowers and not slaves as were those of a number of other nations.

The Dutch Yacht Model is similar to the ornate vessels attached to the fleet for use of the Admiralty on State occasions and often as pleasure vessels. Many of these yachts were reproduced on canvas by some of the great marine painters of Holland.



ROMAN MERCHANT SHIP

This vessel from the period of about 50 A.D. was used to transport grain from Egypt to Rome. As with the Egyptian vessels these ships were steered with large steering oars on the quarter.





THE DUTCH YACHT

From remote times the people of Holland have been noted for their skill and industry on the sea. The lee-boards at the sides were lowered to reduce sidedrift on a beam wind, serving the same purpose as the later centerboard. From the period of about 1660.

The English Royal Yacht is a model of the type of vessel that sovereigns of any maritime power had at his disposal for the ceremonial and official duties of his high position. Built in 1674, like all Royal yachts she was lavishly decorated. The model has 120 carved figures.

The English 50-gun ship of James II is the hull model of a typical ship of the period of 1687. There is a total of 270 carvings on this colorful vessel. It was not unusual for one-quarter of the cost of a warship to be spent on this elaborate decoration.

The stern portion of the "Madame" French Galley of Louis XIV is shown on the covers of this publication. The beauty of these sleek vessels, with their gorgeous carvings, were in marked contrast to the unfortunate slaves who toiled at the sweeps. This model was built from an original French manuscript on the construction of galleys which revealed every piece that went into a galley.

The United States Brig Lexington is the only American type vessel in the model collection. She was one of the small fleet of merchant vessels that were hastily converted at Philadelphia in 1775. She was a flush-decked Brig with a figurehead of Hercules and the traditional American eagle at the stern.

The British East Indiaman model of 1805

has only a partially completed hull in order for the viewer to see the method of construction. Figure-heads were usually Lords or Ladys. By this time, ship ornamentation is greatly reduced. This type, aside from their lack of speed, were equal or superior to any of the merchant ships of the time.

The last model in the theme of history of water transportation is that of the Britannia of 1840. The first ships of the great Cunard Company shows the viewer a ship of the transition period when sail was giving way to steam. She was a fine ship and ahead of her time.

A visit to The Mariners Museum to view these magnificent creations of August F. Crabtree in the exciting atmosphere of this especially designed gallery will be an experience that will never be forgotten.



THE ENGLISH ROYAL YACHT

The Katherine II was the second yacht of that name built for Charles II of England about 1674. He was the first monarch to engage in yacht racing which gained him the title of "the Father of Yachting."

Train, on a recent visit to the Museum to see The Crabtree Collection, presented Mr. Crabtree with a very handsome walnut plaque in the form of an 18-inch ships wheel "In appreciation of your contributions to preserving Maritime History". The occasion was also Mr. Crabtree's 76th birthday.

White House answers Jamie

Jamie Singerman is no ordinary 5-year-old when it comes to politics.

He "voted" twice in last fall's presidential election — in a mock balloting in his kindergarten class and in the voting booth, where he stood on a chair and punched the ballots for his parents, Ronald and Joan Singerman. On election night, he stayed up well past his bedtime to help his parents cheer Ronald Reagan on to victory.

So when the president was shot in late March, Jamie was upset. He took a newspaper clipping about the assassination attempt to school to talk about it, and two days before the president got out of the hospital, the boy, who lives on West Las Lomitas Road, sent a letter to the White House.

"I'm sorry you were shot," said the letter. "I hope you feel better. Please write to me."

This month, an unexpected reply with only "White House" as a return address arrived in the mail. It caused Jamie to jump for joy and make plans to frame it.

"How delighted I was to receive your get well message," said the letter, which had Reagan's signature. "I know with so many young people rooting for me it won't be long before I'm feeling much better. From the bottom of my heart, thank you for caring."




Dear Senator Thurmond:







I know very few letters get past your secretaries, but I certainly hope this one does.

Recently, while I was in Washington, D. C., visiting with Senator Nancy Kassebaum and Congressman Larry Winn, my legislative representatives, I was discussing a new venture of the Association of Community College Trustees. Archie Gets Honors For Youth Activity



Scheduling

Archie Moore, former world's light heavyweight boxing champion who has become one of America's most effective opponents of juvenile delinquency, was honored at a dinner in Sacramento last night for founding and promoting his "Any Boy Can" (ABC) program for young people.

But he took time off from a day-long round of events in the state capital for a quick visit to Vallejo to pick up part of "my original student body" — seven local boys who joined Moore's ABC movement here when he started it in August, 1965.

The group, who performed the ABC ritual at the legislative and civic dinner in the Hotel El

Dorado, includes Dwight Callaway, junior instructor; Ferrell Whitfield and his twin brother, Derell; Anthony Jackson, Jeffrey Carbin, Overton Claiborne and O'Neal Claiborne.

CAPITAL VISIT

The occasion for Moore's visit to Sacramento was the second annual "Barnes Capital Chapter" sponsored by Assemblyman E. Richard Barnes, R-San Diego, in which the legislator was host to some 100 of his constituents who traveled by airplane to Sacramento for the occasion.

The group's day in the capital included a visit with Governor Reagan, visits to both houses of the Legislature and to various committee sessions and government offices, tours of other points of interest and last night's banquet.

Lt. Gov. Robert Finch was principal speaker at the banquet and the master of ceremonies was Gordon C. Luce, the governor's secretary for business and transportation.

One of the highlights of the evening was the presentation to Moore of a framed copy of an Assembly resolution commending the former boxing champion. It was unanimously

adopted in the Legislature last fall.

Pointing out that Moore won his world's championship in 1952 and successfully defended it seven times, the resolution notes that in 26 years of boxing he, Moore, had "learned the values of sportsmanship, clean living and hard work."

The resolution relates that Moore has dedicated his time since retirement from boxing to organizing the ABC program to teach youngsters the values that made him a great champion and a great human being.

"By his many endeavors," the document continues, "he has brought his home town of San Diego to national and international attention as a community where people live together in religious and civic harmony."

Further, it points out that Moore was recognized for his enormous contributions to his home city by being named "Mr. San Deigo of 1968" by that city's Grant Club.

And it placed the legislators on record as commending "this great man from the world of sports, who has proved his immense worthiness in the world of civic betterment."



Dear Terry:

I am in receipt of your letter of October 30 regarding arranging a meeting for the President with the National Conservative Policy Advisory Council of NCPAC.—

As you correctly note, some time ago I indicated to you that I felt it would be quite appropriate for the President to meet with these people, many of whom were very helpful in raising monies in support of his campaign effort. However, I do not think now is an appropriate time for us to proceed on such a meeting.

As you know, one of the key battles that President Reagan fought this fall was to defeat a resolution of disapproval for his proposed sale of AWACS to Saudi Arabia. As National Chairman of the National Conservative Political Action Committee, you actively campaigned against the President on this matter. You lobbied in a variety of ways, including your October 13 letter to a number of Senators attacking the President's position. Fortunately, notwithstanding your efforts and those of many others, the President succeeded in that tough fight.

We certainly appreciate that reasonable people can disagree reasonably. We appreciate that some of our supporters at times will disagree with the President's decisions. However, we don't think it would be appropriate to set up a meeting for you right after you have actively campaigned against the President's AWACS sale.

I'm sure you can appreciate the reasons for our position on this matter. For the same reasons, it is appropriate to reward your friends, it is counterproductive to help those who have so actively worked against you, especially so soon after the battles.

Nonetheless, in light of past and future support on other matters, I do look forward to talking to you at some point down the road regarding arranging such a meeting.

In New York yesterday, Bob Ingersoll passed me this copy of a letter to Jim Baker, which he understands has been referred to you. Ingersoll said he recognized that getting Mr. Matsushita in to see the President was a "long shot" but that he felt it would be a great honor and worthwhile doing if at all possible. November 12 to 17 is the timeframe.

RECOMMENDATION

I cannot in good conscience press the Matsushita case, although there may be some domestic reason for doing it in view of Matsushita's takeover of part of the Motorola Company.

Mr. Ingersoll has asked that I let him know the response to his inquiry so that he can relay the word to Matsushita. I thus request that I be told "yes or no" as soon as that decision is made. I will then inform Ingersoll.

P.S. Ingersoll asked if it might be possible to see the Vice President. I was noncommittal to him and do not recommend such a meeting to you.

Dear Jim:

A representative of Mr. Konosuke Matsushita, Founder-Chairman of Matsushita Electric Company, has asked me to determine whether it would be possible for him to meet President Reagan while he is in the United States between November 10 and 20. He would prefer an appointment between November 12 and 17 but would adjust to the President's schedule.

I realize that the President's time is at a great premium and that it is probably presumptuous for any foreign businessman to think that he can readily get an appointment with the President, who has so many responsibilities on his shoulders. However, this is probably the last trip that this 86-year-old entrepreneur will be making to the United States. When Mr. Matsushita hosted a luncheon for me during my tour as Ambassador, I found him to be a most engaging man and one who thinks much more broadly than most businessmen. His interests span social and political, as well as trade and economic, issues. Since he is so revered in Japan for his contribution in the field of electronics, an appointment for him would be a very friendly gesture to the Japanese nation.

You are undoubtedly aware that Matsushita Electric bought out the Quasar Division of Motorola Company, headquartered in Chicago, and made it quite successful.

In talking to Bill Brock about such an appointment, he suggested that I write to you to determine what the chances might be for such a meeting. I realize it is a very long shot but know that you will give it serious consideration.

It was great to see you the other day, if only for a moment, when I stopped in to see George Bush to deliver the final report of the Japan-United States Economic Relations Group.

This letter is an urgent request for a meeting with you on behalf of the Black and Hispanic businessmen of Progress, Incorporated. The matter of urgency involves our grave concern for the continued success and popular expansion of Republican Policy, programs and voter confidence and influence in minority communities nation-wide. We wish to discuss our plan for image building in the minority community. As Ambassadors of Goodwill to minority communities, we feel that our ability to represent and defend administration policies is severely hampered by (1) a lack of direct and substantive information dissemination, (2) lack of a designed and effective network including minority Republicans, and (3) an ill defined program of inclusion and participation by minority Republicans in the political, economic, and legislative decisions of this administration.

Mr. President, you are aware of our organized support of your administration and its policies through Progress, Incorporated. Since November of 1980, Progress, Incorporated through its national membership of active Republican Black and Hispanic businessmen have given you support through:

1. Our voting influence
2. Active campaign participation
3. Recommendation of literally hundreds of qualified minority professionals to be considered for Presidential appointments
4. Delivery of "The Progress Report, Vol. I, Economic Policy Issues and Alternative Perspectives:" recommendations on policy and programs to be considered by the Reagan Administration.
5. Publication and national dissemination of "Signals from the White House": highlighting Presidential support of minority business and economic development
6. Publication and national dissemination of "A Case for Government Support of Minority Enterprise"

7. Design and submission of "The White House Office of Minority Economic Impact (OMEI)": viable options for visible and effective Presidential support of minority economic development, and
8. Continuous support of administration policies through speeches before national business and community organizations.

We are deeply disturbed by the outcome of the Virginia State elections and the flagrant disregard for Republican minorities and the lack of orientation towards issues as opposed to voting party lines. We fear that this attitude and trend will be reflected nationally and internationally causing severe credibility damage to the Republican Party influence. The members of Progress are already being hurt by national perceptions of the lack of caring and sincerity of Republican policies. As Republican businessmen, we are the first to feel community rejection which severely limits our positive influence.

At Progress, Incorporated we are preparing for the national 1982 elections by charting states, elections, and candidates where Black and Hispanic minorities will have a significant and deciding vote. We have made plans to begin now to take a leadership role in impacting and directing the outcome of these elections.

Mr. President, what we need from you is (1) a face to face briefing and elaboration of administration policies and directions over the next three years, (2) definition of the role we can play to support your initiatives and party goals, (3) reassurance and demonstration of access to and active support from the White House, and (4) directives that will bring responsible and active minority participation in the mainstream of governmental and Republican party affairs in the 1980s.

The time for tokenism in minority representation and participation is over. In the decade of the 80's we are determined that our influence will be felt throughout all sectors of domestic and international government programs and national political concerns. We support you and ask now that you support us. Your audience and vote of confidence and direction is the fuel we need to continue our positive influence in our communities as ambassadors for Progress through support of Reagan administration programs.

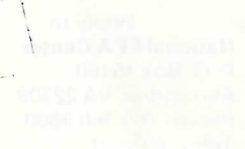

Dear Mr. Brown:

Thank you for your letter to the President concerning a joint personal appearance at the UN Special Session in 1982 by President Reagan and Chairman Brezhnev.

Your nuclear disarmament proposals are interesting, but many complicated and controversial issues must first be resolved between our two countries before such agreements could realistically be envisioned. We are now engaged in negotiations with the USSR on intermediate-range nuclear forces, and we expect to begin strategic arms reductions talks (START) as soon as possible next year.

At the same time, only by maintaining a military balance can we be confident of deterring aggression and creating the conditions which will give the Soviets an incentive to negotiate genuine arms reductions.

Thank you for your suggestions.

I am sorry to report that I have not yet received a response to two letters sent you:

(a) My letter received by your office on Sept 24 (together with a copy of a Russian version to Mr Brezhnev), constituting a proposal for a joint appearance of yourself and Mr Brezhnev at the upcoming UN Special Session on Disarmament, June 7--July 9, 1982;

(b) An update of November 7 with special reference to the nuclear arms reduction talks in Geneva.

I have now received a courteous and substantive response to our proposal from Mr Oleg Troyanovsky, a copy of which is enclosed. It strikes me as anomalous that, when we designed the proposal with what we judged to be strict neutrality, the first official response has come from a representative of the other Great Power rather than from our own elected or appointed officials.

Once again I enclose the original letter to you. I should appreciate very much either your response to it, or your comments on Mr Troyanovsky's response, or both. I will find it awkward in the extreme to try to explain to our church constituency why we have been able to elicit a Soviet but not an American response. Please remedy this situation as soon as possible!

Dear Mr. Brown,

I would like to begin by expressing my appreciation for your concern for the preservation of world peace. That feeling of concern is very familiar to the people of my country which is sparing no effort to consolidate peace, end the arms race and start the process of disarmament.

The problem of containing the nuclear arms race and of nuclear disarmament which you refer to in your letter has been before the UN for many years. It will, doubtlessly, be the focal point of the forthcoming Second Special Session of the UN General Assembly on Disarmament. In the course of that session the Soviet Union will continue to seek practical decisions on these vital matters.

I would like to draw your attention to the fact that recently the Soviet Union has come forth with important new initiatives in the field of restricting the arms race, prohibition of the use of nuclear weapons and their total elimination.

In February of 1979 the Soviet Union together with the other Socialist countries tabled in the Disarmament Committee a document On the Negotiations concerning the Cessation of the Production of Nuclear Weapons of all Kinds and on the Gradual Reduction of the Stocks of those Weapons including their Total Elimination. That document contained specific proposals regarding negotiations on this subject. It is regrettable that owing to the position of the USA and its allies no such negotiations have taken place.

Recently the problem of warding off the threat of nuclear conflict has become particularly pertinent. The new stage of the arms race is fraught with particularly grave dangers in view of the fact that accumulation of the means of mass destruction is accompanied by the emergence of doctrines which provide for the first strike use of those weapons.

That being the case the USSR holds the view that adoption of a firm and unambiguous statement opposing the first use of nuclear weapons is the minimum action that the United Nations should take in order to exert a restraining influence on the present dangerous development of world events.

At the present 36th Session of the UN General Assembly the Soviet Union took the initiative in putting forward a proposal to that effect. Our country believes that the United Nations should clearly state that there will never be

any justification or pardon for statesmen who would make the decision to be the first to use nuclear weapons. The Soviet Union has also proposed that any doctrines allowing the first use of nuclear weapons and any actions pushing the world towards a catastrophe should be condemned as being incompatible with human moral standards and the lofty ideals of the United Nations.

All these ideas are contained in the draft Declaration which the USSR has put forward for consideration by the 36th Session of the UN General Assembly.

I was gratified to read in your letter, that you too are proposing a solemn commitment that neither the USA nor the USSR will be the first to use nuclear weapons while nuclear arsenals still exist.

The Soviet Union is, of course, prepared to consider other constructive proposals aimed at containing the arms race and eliminating the threat of nuclear war.

Dear President Reagan:

On September 24 your office acknowledged receipt of a letter to you (with a copy of a Russian-language letter to Mr Leonid Brezhnev) urging you two to make a joint personal appearance at the U.N. Special Session next year and there to announce the first steps in nuclear disarmament. So far I have not received a response, and it would be still most welcome.

On November 30 arms limitations talks will begin in Geneva. Please find enclosed a copy of a letter to Mr Haig--a nearly identical letter has gone to Mr Gromyko. You will see that I and a number of others are renewing our earlier requests: namely, that at the joint personal appearance of the two heads of State at the Special Session, you announce:

- (1) An immediate total freeze on development, production, testing and deployment of nuclear weapons and delivery systems;
- (2) A schedule for total nuclear disarmament within a decade;
- (3) A pledge of no first use in the interim.


The form which your response to both these letters could most fruitfully take would be an indication that you are instructing Messrs. Haig and Nitze to make preparations for the joint announcement.

It is not threat or bravado when I say that I believe there is a good chance the world response to the Special Session will be irresistible. Beginning with the tip of the iceberg in the European rallies, I see the forces at work which will bring that about. So once again this is urging you to a prudent act in the national interest and in that of all peoples.

I look forward to your response.

Dear Mr Haig:

On September 24 your Washington office acknowledged receipt from me of copies of letters to Mr Reagan and Mr Brezhnev, urgently requesting them to make a joint personal appearance at the United Nations Special Session on Disarmament in 1982, and there to take certain actions; together with a cover letter to yourself requesting confirmation that our request was being studied. Similar requests have gone to the two heads of state from numerous other persons, and in particular from Dr Kenneth Greet, Secretary of the Conference of the Methodist Church in Great Britain, in the name of "fifty million Methodists."

I have not yet received the confirmation from your office that our proposal is under study and would very much appreciate having it.

Now in the arms limitation talks beginning in Geneva on November 30 the delegations headed by Mr Nitze and Mr Kvitsinsky will have an opportunity to study various proposals. In union with numerous international organizations--in particular the Women's International League for Peace and Freedom and the International Peace Bureau--I am urgently requesting that you instruct Mr Nitze to work so that Mr Reagan will be able jointly with Mr Brezhnev at the U.N. Special Session to announce concrete progress in nuclear disarmament.

You will recall from the enclosures to my previous letter that we are requesting the two heads of state in their personal appearance at the Special Session to do three things:

- (1) Announce an immediate total freeze on the development, production, testing and deployment of nuclear weapons and delivery systems;
- (2) Present a schedule for total nuclear disarmament within a decade;
- (3) Pledge no first use of nuclear weapons in the interim.

I enclose a copy of the English-language version to Mr Reagan; the arguments presented there retain their force. Since then more than a million Europeans, of varying political persuasions, have marched in Bonn, London, Paris, Madrid, Oslo, Brussels, Rome and elsewhere to express their insistence that the nuclear weapons of both parties be taken out of Europe.

Plans are now under foot that during the Special Session every church bell in the world will ring daily and that there will be a nonviolent vigil daily at every nuclear site in the world. My firm belief is that, if once people around the world catch a glimpse of an actual possibility that nuclear disarmament can begin at the Special Session, there will be an unprecedented outpouring of sentiment around the world which the Gov-

ernments of the U.S. and the Soviet Union will find it impossible to resist. I believe it would be mere prudence for Mr Nitze to take that likelihood as his essential datum in Geneva. Will you please convey this letter to him with your recommendation?

An exactly parallel letter is simultaneously going to Mr Gromyko.

The eyes of tens of millions will be on the Geneva talks--not to speak of the Special Session. Please bear our requests in mind!

Dear Mr Reagan:

This letter brings you an urgent request for an action to be carried out jointly by yourself and by Leonid I. Brezhnev (or by some equally appropriate Soviet representative) at the Second Special Session of the United Nations for Disarmament in May, 1982. A Russian-language version of this letter, identical except for this first paragraph, is simultaneously being sent to Mr Brezhnev (copy attached). It concerns the most critical issue of our time, ending the nuclear arms race, where failure to act in time will render irrelevant any success in other issues. Please read it carefully and with an open mind!

I am writing this in my own words as a father of four independent children. I am also writing it on behalf of the Northern California Ecumenical Council, the most representative Church body in this part of the state, which has formally endorsed the first request I am bringing you. Further I am writing it to express as best I can the hopes and insistence of many friends around the planet, most recently gathered in Tokyo at the World Assembly of Religious Workers for General and Nuclear Disarmament in April of this year.

This comes to you two as heads of state of the principal participants in the nuclear arms race. You each have expressed the desire to work for the elimination of nuclear armaments as the deepest hope of both our peoples. Equally I write it to you as the fathers of independent children with their own families and having the same stake in the continuance of the planet.

On behalf of those friends, known and unknown, in many countries I am urgently requesting you two to make a joint appearance in the name of your Governments at the United Nations Special Session and to take three actions.

(1) Announce an immediate total "freeze" or cessation of development, production, testing and deployment of nuclear weapons of all sorts and their delivery systems.

(2) Present an agreed-on schedule between your two Governments for the reduction of the nuclear arsenals of both nations to zero within the next ten years.

(3) Undertake a solemn commitment that neither State will be the first to use nuclear weapons while those arsenals still exist.

What these actions would mean

(1) The "freeze" would mean for example that plans to develop new missile-systems and nuclear-armed submarines would be halted as of the date of signing. It would mean that the assembly-lines in both countries of nuclear weapons (strategic and tactical, including neutron bombs) would be halted; as well as of missiles and nuclear-armed submarines and strategic aircraft. It would amount to the largest part of the much hoped-for Comprehensive Test Ban, and strong leverage for the remainder. And it would mean that no additional or novel strategic weapons would be directed at the two homelands, and for example that no new batteries or types of tactical weapons would be added to those now facing each other across Europe.

(2) The schedule would require an initial disclosure by both nations of their nuclear arsenals as of the date of the freeze, and a statement of across-the-board percentage reductions for the next nine years culminating in the total abolition of nuclear weapons in 1992. Certain remaining matters would have to be worked out in good faith subsequent to the initial disclosure. Acceptable means of verification of the disclosures and of yearly reductions would have to be agreed on while both arsenals remained of deterrent size. In the last phases of the reduction the other nuclear powers would have to be brought in. Adequate treaty safeguards for the stockpiles of fissionable materials would have to be provided. The question would have to be squarely faced whether a nuclear-power industry anywhere in the world was consistent with denuclearized military forces.

(3) The undertaking of no first use is the indispensable pledge of commitment to push through on the freeze and the reductions to the end. While all three actions presuppose each other, in particular the pledge of no first use (as being unverifiable) by itself would be an unacceptable substitute for the total package.

Why you two should undertake these actions

The nuclear arsenals are a crippling burden on the economy of both nations. Recent severe cutbacks in social services in the United States are counterbalanced by military increases; no quick reduction in the rate of inflation or unemployment appears likely. The Soviet Union, with a per capita gross national product substantially under that of the United States, can ill afford a diversion of irreplaceable resources to products which cannot be eaten, worn or lived in.

Even more so are the nuclear arsenals on both sides an affront to poor nations seeing the onset or actuality of starvation. The environmental damage involved in their production and maintenance--not to mention their use--is inconsistent with our duty of turning the planet

over to our children as we received it. The status of both the great powers would be greatly enhanced in the rest of the world, not in image but in reality, if the money, brains and materials now locked up in the nuclear arms race were released for actual human needs.

Both our countries are suffering from severe alienation. Many observers--including my own son in the fall of 1979--testify to the gross human and economic damage due to alcoholism in the Soviet Union. The crime rate and drug abuse in the United States are an increasing burden on every part of ordinary life. I respectfully submit that both our peoples are suffering from a numbing and hopelessness of which the one greatest cause is the threat of nuclear warfare.

The development of nuclear weapons keeps entering more dangerous phases. The next generation of weapons threatens the mutual verifiability on which all else depends--through miniaturization, through weapons aimed at the satellites which are the eyes of the other side. Five years from now a freeze and mutual reductions would be more difficult to negotiate than today.

Each of our nations is built on the affirmation of fundamental rights. The United States has held to the right of freedom of speech, assembly and religion; the Soviet Union has held to the right of all citizens to be free from want. Each, in spite of many inconsistencies in practice, has a genuine commitment in principle to extend those rights both internally and to other nations. Now is the time for you two jointly to extend those rights to the most fundamental of all: the right once again to believe in the reality of the future.

Why you should not refrain from these actions

Many people around the world have a deep mistrust of the Strategic Arms Limitation Talks. The provisions, whether current or projected, are both so complicated and so partial that large segments both of the defense establishments and of the peace community have lost trust in them. Actions are required of such great clarity and simplicity that the most unpolitical person anywhere in the world should not for an instant doubt what they mean.

The two nuclear arsenals are never perfectly symmetrical. Each party to the arms race over the years has persuaded itself that by new developments it can gain a decisive advantage translatable into conventional political and economic gains. The accumulation of such initiatives has brought us to the present intolerable situation. I have read with care Mr Brezhnev's collected statements on peace, and Mr Haig's address to the Foreign Policy Association of July 14 of this year. I am fully persuaded that nobody in the Soviet Union, the United States, Europe or anywhere else in the world has greater true security as a

result of the weapon deployment on either side. Quite the contrary! Currently each of our nations--I write with reluctant conviction--controls grudging clients by means which include a large portion of fear. If fear were replaced by hope, a far greater volume of human aspirations would be released. In the most pragmatic and conventional political calculations, both the United States and the Soviet Union would gain immeasurably by the actions I propose.

In these requests we are not advocating unilateral disarmament or pacifism for the two great powers. If they so choose, they could undertake these three actions in good faith and continue to compete with each other; continue to maintain control over client states in East Europe, Central America, and elsewhere; continue the old way of militarism as it existed before August of 1945. We hope they will not. We believe that a much more fundamental break with the past than we propose here would enhance the true influence of both nations--above all would enhance the influence of yourselves and your successors as world leaders. We think that the three actions we propose are both the necessary and the sufficient first step for a much deeper shift in the way the world's affairs are run. But at present we are asking only for the first step.

Supporting events

The Tokyo Assembly laid the plans for a world peace walk ending at the United Nations in May. Californians, Native Americans, Buddhists are committed to walk across the United States, beginning this October. Incalculable spiritual energy will be generated by that commitment, and the international media will cover it. We ask you both to keep your television tuned and your hearts open.

Already you both are getting letters and petitions asking for one or more of the actions I here request. The United Nations Special Session will be preceded by months of educational events for awareness, by great rallies and religious gatherings, by fasts, both in New York and around the world. You both have inherited political systems with a genuine claim to represent the aspirations of your people and of all peoples. This Special Session will not, like the last, be largely passed over in silence. Very large numbers, from your nations and elsewhere, will be indicating what they are asking for. Part of your job is to listen.

Jails and correctional institutions in both countries are taking in more and more protesters and dissidents who have felt it necessary to oppose with their bodies the preparations for nuclear warfare. Each of those women and men is the tip of a pyramid of ten thousand supporters. Their primary demand, like ours, is not amnesty but an end to the nuclear arms race. We ask you for an instant to try to see them not as opponents or criminals but as responsible human beings, and to ask what their action is saying to you.

Neither I, nor those who will carry out these supporting actions, listed and unlisted, come to you as suppliants. We come to you as representatives of those governed people on whom in the end your power rests; as spokespersons for those traditions, religious and humanistic, from which your legitimacy eventually derives. We do not want to circumvent the reign of law, even such as it is, painfully built up over the years. For the next months we are going through channels. But I would be less than truthful if I did not report that I see worldwide forces at work which in the end will take that legitimacy back in their own hands.


I see states and cities rejecting the nuclear weapons industry and refusing the deployment of nuclear weapons. I see populations first and foremost refusing any supposed protection by a nuclear umbrella, and only after that turning to conventional politics and defense. I hear the Catholic Archbishop of Seattle solemnly declaring that "Trident is the Auschwitz of Puget Sound," and I know that the Orthodox Bishops share his faith and his powers of observation. Everywhere I look or listen, I see people building nuclear-free zones around themselves, their families, their communities, their associations, in the firm expectation that those zones will persist, grow, coalesce, and one day cover the planet.

You two have an unparalleled opportunity to associate yourselves with that worldwide movement at the Special Session. Nothing could more commend your vision and statesmanship. I cannot confidently predict that another equally good opportunity will be given you. I can confidently predict that the peace-loving forces of the world will continue on their present path. It will be easier and safer for us all if you associate your Governments with them now rather than later, willingly rather than unwillingly.

If a woman can have a baby in nine months, I believe that you two, Mr Reagan and Mr Brezhnev, can come up in nine months with an agreement to carry out these three actions. You are in correspondence; you have skilled negotiators at your right hand; you can talk to each other on the telephone. From time to time during these months I will report back to you and to my friends what communications I have received from both parties. In the end, I believe, you or your successors will have no choice but to respond. I have tried to make a response on your part as easy and uncomplicated as the situation permits. If anything I have said is inaccurate I stand ready to be corrected. During the next six weeks I at least need to hear from you both that this letter is being studied by appropriate persons on your staff.

Great burdens lie on you both. The world wishes to stand beside you under those burdens. Your predecessors--Messrs. Kennedy and Khrushchev in particular--were able to maintain communications and keep the peace. History is offering you the opportunity to take the next step. My earnest hope and expectation is that you both will perceive the role in world history that has been offered you and will step into it.
