Your letter of November 6, 1986, requesting information under the Freedom of Information Act about Wedtech Corporation, recently was referred to this office for response by the Office of Media Relations. Kissinger v. Reporters Committee for Freedom of the Press, 445 U.S. 136, 156 (1980).

of FOIA Ombudsman Proposal

Pursuant to our conversation on Friday afternoon, I spoke today with Kevin Jones, Deputy Assistant Attorney General, Office of Legal Policy, about the proposed creation of a FOIA Ombudsman in the Department of Justice. The proposal is being considered by the Judicial Review Committee of the Administrative Conference of the United States ("ACUS"). Jones informed me of two factors that I believe make substantial White House involvement in this issue unnecessary at this time: (1) the matter will not come before ACUS for formal consideration until next June; and (2) Deputy Attorney General Burns will write to ACUS Chairman Marshall Breger to voice the Justice Department's opposition to the proposal before the December 4, 1986, meeting of the Judicial Review Committee.

The last ACUS Council meeting before the Conference's December 4 plenary session was today. Because the proposed establishment of a FOIA Ombudsman in the Justice Department was not considered and approved by the Council for formal action, it will not come before ACUS until the next plenary session, in June. Of course, the Administration should continue to oppose the proposal in the committee, particularly because it may be an attempt by proponents to obtain independent support for a planned legislative initiative.

General Burns has discussed this proposal with Marshall Breger and Tom Sussman (the Chairman of the Judicial Review Committée and, as an aide to Senator Kennedy, a principal draftsman of the 1974 FOIA amendments). While Burns originally expressed interest in the idea, which was presented to him as a public relations opportunity to respond to criticism about government secrecy, further consideration has revealed the potential problems we discussed Friday. With advice from the Civil Division, the Office of Legal Policy is preparing a letter for Burns' signature, expressing Justice's reservations about the plan. The

draft letter will be presented for his signature after it has been reviewed by Steve Markman, who will return from the Soviet Union at the end of this week.

My review of the attached documents confirms the concerns we discussed. I believe that the establishment of a position in the Justice Department to perform independent investigations of its FOIA determinations, and provide a record of its findings to the requester, would add an additional layer of bureaucracy and introduce an adversarial aspect to the early stages of FOIA review that would slow down the process. If ACUS finds that the Justice Department, or any other agency, is doing a poor job handling its FOIA responsibilities, there are other ways to improve that performance. Moreover, even if a pilot program is to be established, I think Justice would not be the best place to start in light of the volume of FOIA requests it receives directed to such law enforcement components as the FBI, the Bureau of Prisons, the Drug Enforcement Administration, and the Immigration and Naturalization Service.




