While we might not necessarily agree with the selling of arms to Khomeini's Iran as a "goodwill gesture," we maintain that under the Constitution of the United States the Executive Branch is charged with the conduct of foreign policy of the United States rather than Congress. As you know, only the Senate is given the right of "advise and consent" in international treaties. This view has been upheld by several United States Supreme Court decisions in 1920 and 1936. means that whatever anyone's opinion might be about the wisdom of the Iranian secret initiatives, the President cannot be faulted for undertaking them.

Thus, in our opinion as long as the Iranian initiative: had the approval of the President, it may be challenged. by Congress. We would agree with critics, however, that selling arms to Iran whether by Israel or the United States was not a wise idea.

The second part of the problem is the alleged diversion of the profits of the Iranian arms deal for the purposes of aiding the Nicaraguan freedom fighters. believe that too little is known publicly to make a final judgment on the legal aspects of the case. Certainly, if United States funds were used to support the Nicaraguan freedom fighters during the period of Congressional

ban over and beyond the \$27 million for nonlethal aid, it would be a breach of law and those responsible would have to be held accountable by the Special Counsel. There can be, however, no argument that soliciting funds for the Nicaraguan Freedom fighters, from the Sultanate of Brunei, and perhaps also from Saudi Arabia, was illegal. The policy of the Executive Branch of the United States was to support the Nicaraguan freedom fighters and this policy overrides Congressional resolutions except for the expenditure of money which is the prerogative of the Congress of the United States under the Constitution.

We believe that the media and some members of Congress, too, have gone to extremes on the situation. We have legitimate interest in establishing normal relations with Iran in the post-Khomeini period, and, we have now also a Congressionally approved \$100 million aid program for the Nicaraguan freedom fighters. If there are some former or present officials culpable of criminal wrongdoing, this is the task of the Special Counsel to investigate these allegations. Otherwise, let us go on with the business of other foreign and domestic issues instead of trying to make partisan points against the Executive Branch of the United States. We would have the same opinion if the initiatives had been taken by a Democratic Administration and investigated by a Republican Congress.

Our greatest fear is that because of the questionable diversion of the Iranian arms profit to the Nicaraguan freedom fighters by some well-meaning, but mistaken, Executive Branch officials, the Administration's new request for aid for FY 1988 would be in jeopardy by Congress. This would be a very serious mistake. The issue of assisting the Nicaraguan freedom fighters should be made on the merits of the case, and not, on extraneous issues. Are they contributing to the security of Central America and the United States? Is there a chance that they could either force the Managuan Sandinista government into a political compromise or even overthrow them? Is aid to the Nicaraguan freedom fighters a way of preventing the deployment of American forces against an aggressive Sandinista Nicaragua?

We believe that the answer to the above questions is "yes", and would like to suggest to you and to the members of your Committee to define the scope of investigation narrowly, and to support the cause of the Nicaraguan freedom fighters and of the population of Nicaragua for a free and democratic government for FY 1988, too.

KHOMEINIST ANTI-SEMITISM REACTIVATED by Seyyed Ali Mohammad Gha'emi, IRANA Director

On April 19, an open session of Iran's "parliament" heard its lone Jewish member, pharmacist Manuchehr Neekruz, state "All official religious minorities, including the Jewish one, are completely free to practice their religion and customs" (dispatch from the "Islamic Republic News Agency in Tehran Times, April 21, 1987, page 1).

And indeed the Khomeini regime boasts that the "Islamic republic" houses the largest number of synagogues in the Middle East--the synagogues of the "bastard state of Israel," of course, do not count.

Neekruz is the duly-elected representative of Iran's Jewish community. And yet he was suddenly arrested last November on charges of conducting "immoral activities" at a Jewish nursing home he owns. The Jewish elderly in the home were held hostage for several days by Khomeini's "revolutionary guards" (pasdaran), and Neekruz was released a few weeks later. It was rumored that the infamous speaker of the parliament, Rafsanjani, ordered Neekruz's arrest so that the Jewish MP would not disclose details about Rafsanjani's double-dealing with Israel.

Now, Neekruz is forced to say that: "all Iranian Jews are against... the Zionists" and that "Iranian Jews are cooperating with the Moslem combatants both on and behind the fronts" (Tehran Times April 21, 1987). Indeed, the parents of 2000 Jewish boys between ages 12-20 who are the target of the Khomeini regime's draft—and most of whom have been captured—can attest to this "cooperation." It must be remembered that these 2000 young Jews constitute almost 10% of the remaining Jewish population in Iran—and

these 2000 "yahudis" are used by the Khomeinists as cannon fodder.

These actions are not surprising coming from a fanatical Shiite cleric who in 1963 said of the Jewish people: "We have to learn cheating and stealing from them? We have to learn shrewdness and conspiracy from them? What is there to learn from them?" And during his Iraqi exile, Khomeini said, in 1969: "Because of our weakness, we may awaken one day to find a Jewish ruler ruling our country, God forbid." And today, his most famous statement is: "If every Moslem in the world pours a bucket of water on Israel, the Israeli murderers will be drowned."

There is no joke and no mere rhetoric in Khomeini's words, just as his apprentice, Rafsanjani, stated in a sermon on April 17: "For us it is sweeter instead of fighting a duped country like Iraq to directly fight America or Israel." (translation of quote front-page of Khomeini government-owned Kayhan Farsi airmail edition published in Woodside, New York [Kayhan, Inc., 50-11 Queens Blvd. Woodside 11377/P.O. Bpx 638, Oakland Gardens, NY 11364/Phone: 718 458-7777]. Perhaps Israel should grant Rafsanjani his sweet wish.
