SUBJECT: Possible Visit to Panama by President Ford

President Ford has been invited to Panama by the government party's business group. He is to meet with President Royo, and I gather a carefully chosen cross section of people agreeable to the government.

The former president is inclined not to go but will if the White House wants him to. I pointed out to Bob Kennedy that Senators Baker, Laxalt, and Hollings will be there in early January to give a high level American presence. But I promised to run it by you. (My own feeling is this trip looks like a government set up to give Royo a little Republican support.)

I would suggest I call Bob Kennedy and relay the above feeling.

Attached at Tab A is Bob Kennedy's background letter to me.

Attached at Tab B is the Panamanian letter of invitation to President Ford.

Dear Roger,

As I mentioned to you on the phone last week the Businessmen's Front of the PRD has invited former President Gerald Ford to visit Panama, speak to the business community, and meet with President Royo and prominent members of the National Guard. (See attachment #1 for the letter to President Ford.)

As background, the invitation is the result of an informal conversation that Dr. Gabriel Marcella and I had with Mario Rognoni, a prominent member of the Businessmen's Front in late July. Mr. Rognoni indicated an interest in having former President Carter visit. I suggested they consider President Ford, especially if there was an interest in quietly strengthening ties with Washington.

Since then the National Secretary of the Front, Roberto Gonzalez-Revilla, has called and written (see attachment #2) to confirm the Front's interest in a visit by President Ford, and to indicate that President Royo would be pleased to meet with President Ford in late January or early February.

I contacted Ms. Rowena Evans in the former President's office in Palm Springs several weeks ago and passed the information on. She indicated that President Ford's calendar was full until June. The quick response by President Royo to the Front's initiative and his apparent willingness to open his calendar so soon suggests an interest that goes beyond a casual lecture tour.

Given the nature of events in the region, the importance of Panama to the United States, and the recent expansion of contacts with the National Guard in the wake of Brigadier General Torrijos' death, I recommend the White House encourage former President Ford to accept the invitation for late January or early February.




Dear Mr. Meese:

LBJ LEGACY? Author Robert A. Caro, a Pulitzer Prize winner, has written another powerful book, "The Years of Lyndon Johnson." Caro writes that President Johnson accepted envelopes "stuffed with cash" when he was vice president and later used the power of his presidency to amass enormous personal wealth. Excerpts from the book, which appeared in the October issue of the Atlantic Monthly, said, "For years, men came into Lyndon Johnson's office and handed him envelopes stuffed with cash. They didn't stop coming even when the office in which he sat was the office of the vice president of the United States. Fifty thousand dollars in hundred-dollar bills in sealed envelopes was what one lobbyist for one oil company testified that he brought to Johnson's office during his term as vice president.".....Most government officials agree that Johnson's Great Society program was "as costly and self-defeated as his mis-adventure in Vietnam, according to the Boston Herald-American of several weeks ago.....Many economists believe Johnson is responsible for the tremendous inflation facing Americans today LBJ's sonin-law, Charles S. Robb, is the Democratic nominee for governor in Virginia, and has toed his party's line, supporting the candidacies of McGovern and Carter with vigor to the chagrin of old-line Virginia political leaders.....

A NEW MEANNESS? A headline in a national newspaper said, "Are We Really Turning Mean?" It was a defense of the Moral Majority column--a second one--by William F. Buckley Jr. The president of Yale University had taken a verbal. shot at Dr. Jerry Falwell and the Moral Majority (which was • detailed in the September issue of Moral Majority Report). And, now, the new meanness seems to be coming from other men of the cloth, most notably the Rev. Timothy Healy, president of Georgetown University. Healy compared the Moral Majority with Ku Klux Klanism and McCarthyism. Wrote Catholic Buckley, replying to the Rev. Healy: "If Sen. McCarthy ever Healy: spoke so categorically and so spitefully against any American group as Father Healy has spoken against the Moral Majority, I'd like to see that statement and blush for him. And oh yeah, when I quote Father Healy I'm on safe ground, since when he says Catholic (if

ever he does), I want everyone to know it doesn't mean me.".....And, in Indiana, Methodist Bishop James Armstrong has criticized Moral Majority's movement for "sexism and rigid legalism." He termed the Moral Majority as "unbiblical.".....Welk, friends, again, we must report that the Moral Majority is NOT a religious organization. It is a political organization.....

A FORGETFUL SENATOR? Columnist John Lofton, who also happens to be editor of the Conservative Digest, says Arizona Sen. Barry Goldwater has things backward when he says "religion has no place in public policy." Lofton quotes Alexis de Tocqueville, writing in "Democracy in America" (1951): Religion in America takes no direct part in the government of society, but it must nevertheless be regarded as the foremost of the political institutions of that country; for it does not impart a taste for freedom, it facilitates the use of free in-stitutions."....The spirit of religion and the spirit of freedom "were intimately united and they reigned in common over the same country.".....In the masthead of the Indianapolis Star, this public

Liberals Using PAW To Pave Way For Kennedy To Run For President

SAN FRANCISCO--People for the American Way, founded by television producer Norman Lear in 1980 as a strident, non-profit "educational" and supposedly "non-partisan" membership organization, is, it appears, nothing but a stalking horse for Senator Edward M. Kennedy of Massachusetts and a vehicle to be used by liberals for a return to power by 1984.

That is the conclusion drawn from a month-long investigation of Lear and his organization in California and in Washington D.C. where PAW now has its national offices.

People for the American Way was the brainchild of Richard Parker, a principal in Parker/Dodd and Associates, the national fund-raiser for Kennedy and other liberal and left-wing figures.

Richard Parker also started the underground and left-leaning "Mother Jones" magazine in 1975. Parker, a highly visible leftwing radical and political activist in the 1960's, established the Foundation for National Progress at the same time he founded "Mother Jones." The foundation is a non-profit, taxexempt organization which eventually took control of the magazine. Parker left "Mother Jones" in 1978 to establish Parker/Dodd. He remains publisher of "Mother Jones." PARKER'S ACCESS to a left-

wing constituency via the National foundation for Progress, along with his far left politics, brought him to the attention of the United Farm Workers Union leader Caesar Chavez. Parker was the key fundraiser and public relations director for Chavez and even helped to coordinate UFW activities.

Parker's growing involvement with big labor led him to his most significant client, Senator Ed-ward Kennedy, the favored 1980 Democratic Presidential candidate. Parker began fundraising for Kennedy in 1979. Kennedy strategists thought it best that Parker not be directly associated with such a radical, pro-labor publication as "Mother Jones," so Parker hired Jacques Marchand as publisher and severed any visible ties with the magazine, although he continued as a major contributor to its editorial policy.

American Way began in early 1980 when Kennedy began to slip in the polls and his approval rating among Democrats started to decline.

From interviews with staff members of Parker/Dodd and People for the American Way, it appears that the overriding purpose of the organization is to destabilize the Moral Majority and discredit its founder, Dr. Jerry Falwell, by whatever means possible. Parker devised the PAW scheme along with some Kennedy strategists when the election of Ronald Reagan seemed likely.

FROM CONVERSATIONS with insiders at Parker/Dodd and PAW, it appears that some leaders in the labor movement and the liberal establishment, in

reasoned that they must attack the Moral Majority and un-dermine its credibility in a way that they hope will erode enthusiasm for the organization. The strategy is not unlike that ascribed to former President Nixon who used Spiro. Agnew to undermine credibility in the press so that the people would not believe what they read concerning Nixon misdeeds.

THE STRATEGY involved undermining the credibility of the entire New Right by confusing the issues they address and ascribing issues and tactics to the movement which have nothing to do with their platforms.

The people for the American Way Washington office is under the direction of Anthony Podesta, a young, liberal at-torney and himself a staunch union activist. The entire PAW Washington staff appears to be made up of ex-Kennedy campaign workers and union and labor activists.

According to the Oct. 5, 1981 "Business Week" magazine, "the AFL-CIO has decided to shed any pretense of non-partisanship and embark on a plan to become the dominant financial and political force in the Democratic Party. Labor's goal: to block a Republican takeover of Congress in the 1982 elections and to grab a pivotal role in choosing the Democrats Presidential nominee in 1984."

Machinery such as that established by People for the American Way, with its liberallabor connections, ought to be an

agent for a number of liberal and left-wing causes including civil liberties, environmental activism, political solidarity and youtheducation groups.

Pike told me the Tides Foundation was formed as a means for certain clients to donate large amounts of money anonymously to these causes. Although PAW will ostensibly function as an independent organization now that its offices are established in Washington, D C., the Tides Foundation will continue to channel funds from "anonymous" sources to PAW.

The chief operating officer of Parker/Dodd is Jan Brandt, who was for many years the business manager of the Palo-Alto-based "Learning Magazine," a liberal, progressive educational advocacy

Right, clearly reveals PAW to be a carefully orchestrated political device of labor, the left, and the liberals.

An inquiry into the source of PAW funds indicates that most apparently come from groups and individuals who so closely identify with liberals and leftwing politicians: homosexuals and lesbians, labor factions, TV and film producers, feminists, environmentalists, anti-nuclear groups and some liberal racial groups. In other words, PAW support comes from those who would stand the most to gain (that is, a return to power and influence) through the demise of Moral Majority and the New Right.

Not surprisingly, all of Parker/Dodd's clients appear to be organizations which represent these groups, and whose members formed the base of the initial and subsequent PAW direct mailings. Some of Parker/Dodd's clients include, in addition to Senator Kennedy, Greenpeace, Alliance for Survival, The Kennedy Fund (the largest source of funds for the Democratic Party), Congressman Ronald Dellums (a liberal black from Oakland), Western Sun, International Food and Development Policy, and, at one time, George McGovern.

Although Norman Lear claims to have started PAW for purely noble and unselfish reasons, it appears that he agreed to become its spokesman and figurehead to protect his source of income and the income and prestige of his friends. The Hollywood community was stunned by the success of the Coalition for Better Television which had a hand in bringing at least some better programs to the 1981-82 television season. Lear's other motive appears to be the protection of his substantial financial investment in Ted Kennedy. Lear is credited by some political analysts as keeping Kennedy's Presidential ship afloat last year when he began to slip dramatically in the polls.

LEAR HAS also been quoted recently as planning to locate and place on the PAW payroll a "liberal charismatic minister of its own, who will be a visible spokesman against Dr. Jerry Falwell and a proponent of

HOUSE DENIES D. C. SEX BILL 4-69

Congressman Phil Crane Introduces Resolution To Halt Liberal Law

WASHINGTON--The House of Representatives on Oct. 1 voted to reject the District of Columbia's liberalized sexual assault reform law, D.C. Act 4-69, giving Moral Majority its greatest victory on Capitol Hill.

D.C. Act 4-69 had been in-troduced earlier by the District's City Council. Under the 1973 Home Rule Act, all City Council criminal code measures are sent to Congress which has 30 in session days to reject the bill - by disapproval of either house.

By a vote of 281-119, the proposed law fell victim to a fierce lobbying campaign by Moral Majority and many local Washington citizen's organizations.

The sexual reform bill, if approved, would have legalized sodomy, bestiality, adultery, homosexuality, and fornication; legalized seduction of a 16-yearold by a teacher, as long as no force was used; and reduced the penalty for rape from life im-prisonment to 20 years in jail.

Resolutions of disapproval against the bill had been introduced in the House by Rep. Philip M. Crane, R-III., and in the Senate by Senators Jeremiah Denton, R-Ala., Jesse Helms, R-N.C., and Orrin Hatch, R-Utah.

Rejecting the argument that Home Rule should be the overriding consideration, Crane said, "In something as sensitive and controversial as this, I feet that both the community and the

country should have ample opportunity to reflect on its consequences... The District of Columbia and the agencies of the federal government located

within its boundaries are the concern of every American." IN HIS REMARKS in the Senate, Denton said, "As the Nation's Capital, this city should not be the place where social experiments are performed, where centuries of legal tradition are thrown out the window. Rather, this city should be governed by standards which conform with the long-standing national consensus on these matters."

D.C. Act 4-69 had previously been reported favorably out of the House Committee on the District of Columbia. The committee rejected 8-to-3, the resolution of disapproval introduced by Crane. But Crane, acting according to a provision of the D.C. Home Rule Charter, of the proposed law being asked the House to ignore the enacted in a short time unless

resolution of disapproval before the full House for a floor vote. Rep. Ronald V. Dellums, D-

Calif., liberal chairman of the House District Committee and a supporter of the sexual reform bill, denounced rejection of D.C. Act 4-69 as a violation of the Home Rule Act.

Dellums had previously refused to hear any public testimony regarding D.C. Act 4-69, saying in a telegram to Moral Majority, Inc. that a committee hearing was only to determine if the District of Columbia had exceeded its authority or violated the Constitution and if the Federal interest was abridged by the measure.

Senate, the sub-In the committee on Governmental Efficiency and the District of Columbia did agree to hear testimony. Dr. Ronald Godwin. vice president of Moral Majority, Inc., George Frain, vice president of the Citizens Association of the District of Columbia and the Rev. Andrew Fowler, testified in favor of the resolution of disapproval of the bill.

D.C. Mayor Marion Barry and Councilman David Clarke testified in support of D.C. Act 4-69. Clarke had originally introduced the sexual reform measures to the D.C. city council as chairman of the D.C. Judiciary Committee.

ALARMED AT the prospect committee vote and present the prohibited by Congress, local

citizen's groups began an intensive lobbying effort to defeat the measure.

The Rev. Cleveland B. Sparrow, a black Washington pastor, and chairman of the D.C. Moral Majority, wrote a letter to District clergymen asking their support in defeating the proposed sexual reform law.

"If you agree that we should not legitimize and encourage adultery, sodomy, fornication, homosexuality, seduction and promiscuity, Congress needs to

hear from you," Sparrow wrote. Sparrow also appeared as a guest on Washington's WRC radio talk show to argue against the proposed law.

Letters were sent out from Arthur V. Meigs, president of the D.C. Federation of Civic Associations and the Rev. Carey E. Pointer, president of the D.C. Baptist Ministers' Conference in an effort to spark grassroots opposition to D.C. Act 4-69.

More than 10,000 signatures were collected from D.C. citizens opposed to the measure on a petition circulated by the D.C. Moral Majority. Following a nationwide alert by the Moral Majority outlining the potential

effects of D.C. Act 4-69, Capitol Hill legislative offices were flooded with calls and letters objecting to the highly liberalized sexual reforms. The Washington Post reported

that Rep. Stanford Parris, R-Va., 'received more than 700 phone calls and letters from constituents demanding that he vote against the bill." John Gnorski, minority staff director of the House District Committee called the response "unbelievable" and said, "...we never saw anything like it before," the Post reports. The Moral Majority had called

the proposed sexual reforms a precedent setting measure that would allow the nation's capital to become the gay capital of the world. (D.C. Act 4-69 had been backed strongly by gay rights groups in the Washington area.)

AT A SEPTEMBER 9 news conference, Dr. Jerry Falwell, president of Moral Majority, Inc. said, "The American people, through their elected officials, have a stake in what the laws of their capital city are--and they certainly do not want to legitimize or give the seal of

approval to perverted acts.

If D.C. Act 4-69 becomes law, it will be used as a reason or excuse for other local and/or national laws and regulations of a similar nature," Falwell said.

OUR MOST RECENT and unbelievable experience with lack of enthusiasm on the part of the national press can be seen--or not seen-- in how the media across the country failed to report Moral Majority's lobbying victory in Congress concerning D.C. Act 4-69, the so-called "sodomy bill." Mayor Barry and his city council passed an act which legalized sodomy, bestiality, fornication, adultery, homosexuality and reduced the penalty for forcible rape from life to only 20 years in prison in our nation's capital.

But, as shocking as this bill was, both the Senate and the House were loath to repeal it or to take any action whatsoever concerning it for fear of being labeled as racist or as being against the principle of Home Rule. Moral Majority put together a coalition of Washington, D.C. organizations, alerted our state affiliates, and lobbied against the "sodomy bill" so fiercely that, in fact, D.C. Act 4-69 was repealed 281to-119 on the floor of the House of Representatives. All five television stations in Washington, D.C. carried the story as their lead news item for several days. And yet, this "unique" victory went largely unreported throughout the nation.

In Alaska, the bar owners

decided to make Moral Majority of Alaska and its chairman, Dr. Jerry Prevo, the issue in their battle to keep bars open 21 hours a day up in our northernmost state. Using Madison Avenueproduced full-page ads, television commercials, and an over-\$100,000 war chest, the liquor crowd attempted to make Moral Majority, Inc. the scapegoat in a local referendum on whether or not bars should stay open 21 hours a day. When the voters went to the

polls on Oct. 6, the liquor crowd was defeated 65-to-35 percent. The one candidate for Mayor of Anchorage, friendly to Moral Majority, came within one-fourth of one percent of winning the election outright and is presently favored in the runoff. And yet, these victories are effort was ever made to explain strangely absent from papers across America.

On the other hand, when President Giamatti of Yale and Father Healy of Georgetown University pandered to radical liberals in separate speeches recently, every word of their McCarthy-like attacks on the Moral Majority was enthusiastically quoted in newspapers coast-to-coast. Every unsubstantiated allegation, every aspersion, every innuendo was printed. IN POINT OF FACT,

Giamatti and Healy remind one of the story about the drunk who, while asleep at the local bar, had limburger cheese smeared onto his mustache. Upon awaking, the drunk loudly told the first person encountered that he stank and should go home and take a bath. When someone finally retorted that the problem was under the drunk's own nose, he loudly denied it.

So it is with Father Healy and President Giamatti. (Though these liberal Democrats were partly right in what they said in their speeches, because there really is a "meanness of spirit" afoot in the land today.) The trouble lies under the noses of liberal accusers themselves. My own opinion is that liberal accusers like Healy and Giamatti are really just sore losers. And, if that opinion sounds simplistic, read the speeches in question again and you decide if you can smell the distinct odor of sour grapes.

But if Healy flunked demagoguery, give him an "A" for creativity. The good Father came down with a fit of meanness. and immediately began to accuse others of having his own malady, which brings me back to the question of how you and I can

sort all this out when we read our newspapers.

Notice please that Healy's tactic is a classic example of misinforming the public. The rules of misinforming are fairly simple. Simply de-emphasize that which your enemies stress as important. Then you stress every mistake your adversaries make and create mistakes to blame them with if none are readily available. In short, accuse the victim of being a predator.

A good friend of mine told me not long ago that the incessant pounding the Moral Majority takes from the press really could be best described as "psy-warfare." When I asked him what he meant by "psy-warfare," he said that I should "psyvisit a particular army base in North Carolina and talk to the army experts there who have carefully documented how Communists, terrorists, and dictators use the press to distort truth, and confuse the public. This friend said that, quite literally, the tactics being used in the American press against Moral Majority were identical to those used by the enemies of democracy in many other parts of the world.

SO WHEN YOU READ that the Moral Majority is "threatening the foundations of democracy," is guilty of some is guilty of some illogical or bizarre activity like burning books, or is reported near death by an astrologer under

contract to the Washingotn Post, please read your paper with a bit of caution. A good rule of thumb is to remember that, if a reporter appears to be enthusiastic when writing about Moral Majority, he is probably doing a "Giamatti" on us. However, if he has written only two paragraphs about us on the eighth page of Section D of your local paper, then the event being reported is probably of monumental importance to conservatives everywhere.

All this leads me to one final bit of advice to remember when reading your newspapers. Conservatives depend upon an informed electorate to accomplish their goals, while liberals depend upon their ability to manipulate the electorate in order to accomplish their goals.

Subcommittee Refuses To Cut Title X Funds

Ignoring recommendations from the Reagan Administration and the Government Accounting Office to reduce funding for the Title X family planning program, the Senate Subcommittee on Labor, Health and Human Services, Education and related agencies has voted to continue funding the program at \$130 million for fiscal year 1982. Ad-

REAGAN THE ministration had proposed that Title X be consolidated with preventive health services into a block grant with appropriations for fiscal year 1982 to be 75 percent of fiscal year 1981, or \$121.5 million.

A June 19 GAO report to Congress recommends that appropriations for Title X be reduced and fee collections be imposed on users of health clinics who are able to pay.

'The Department (of Health and Human Services) could reduce the costs of such programs and make services less costly and more attractive to clients without compromising quality care by eliminating unnecessary medical procedures or tests," the report says.

The report also criticized the HHS program guidelines for recommending "too many routine visits" to the clinics. According to the HHS guidelines, oral contraceptive clients should make two more visits yearly than recommended by the American College of Gynecologists and Obstetrics.

THE GAO report added that "officials at nearly half of the clinics we visited believed that HHS' guidelines called for too many revisits.'

Rep. Robert L. Livingstone, R-La., a member of the subcommittee on Labor/HHS called for cuts in Title X based on the GAO report.

In its Oct. 12 review of the new season, Newsweek says that this year's clear winners are the Moral Majority and the National Rifle Association. The Moral Majority wins because of an obvious absense of sex. The National Rifle Association wins due to increased themes of violence.

Television can take credit for a more family-oriented programming schedule. Newsweek admits it. In its fall. TV review Newsweek says, "In apparent deference to the Moral Majority, CBS scrubbed a steamy shower scene from one of the early episodes (of Simon & Simon).¹² In the pilot NBC movie "Sidney Shorr" Tony Randall was cast as a middle-aged homosexual. But in the new show "Love, Sidney" Randall is described as only "an artist ... who enjoys a platonic relationship with a girl half his age, and the girl's daughter.

The Washington Post, in its review of the new TV season adds this remark, "Or, who says Jerry Falwell hasn't had an impact?" If this year's programming turns out to be a bore, as some critics predict, the fault can be laid at the door of those writers and producers who have replaced jiggly sex for quality programming. As more of the sex is removed, it becomes obvious that quality has been lacking for some time.

Writing in the Philadelphia Inquirer, Tom Fox, a member of the newspaper's editorial board says he has become convinced that TV has needed a general clean-'I am aware that in this era of permissiveness that UD. television plots are not going to be purged, perfumed and rose-watered to my moral tastes," Fox writes. "But there is a matter of public decency involved here, and on that point, I'm overboard with the television preachers." Fox says he was "converted" when he read some of the plots in Norman Lear produced TV shows like "Maude" and "Mary Hartman, Mary Hartman." After reading just a sample of the Norman Lear plots, Fox says, "Lear's moral tastes are just a mite too sleazy for me." It seems that most Americans agree. They want the public airwaves to reflect their values, not just the values of Hollywood, Madison Avenue or Norman Lear. As Fox writes, "The First Amendment is a two-way street."

Tarzan Goes Ape. . . And So Does Jane

I have many fond memories of the Tarzan movies of the forties: we would all line up on Saturday morning to watch Johnny Weissmuller, the King of the Jungle, protect the safari from wild animals and headhunters, do battle with the poachers and generally use his incredible body to fight any evil that happened along:

We all left the theatre swaggering a little and dreaming of being just like Tarzan when we grew up, and I went to see the current movie with the idea of recapturing some of those glorious moments of the past. I found that the world has changed quite a bit since then and I suspect that it's going to change a lot more.

I don't suppose there's much to be gained by dwelling on the absurdities of the plot: Jane, on her way to join her father's safari, kills the boat captain and his assistant when they attack her, and then this delicate, frail girl from England simply pilots the boat down the river herself. Later she is left behind by the safari because she wants to take a bath and as a result is threatened

by a lion which is brought under control by Tarzan.

Learning nothing from this experience, the safari once again goes on without her because she wants a drink of water. This time she is abducted by Tarzan, but perhaps such incredible happenings could be written off as poetic license.

But there is nothing poetic about the nude scenes in the movie. Bo Derek's bare breasts contribute nothing whatever to the plot of this film and can be justified only by being completely honest and calling the movie what it is: an exercise in voyeurism. This film is little more than a peep show, and that brings up an interesting paradox: if I were to hang a sign on my door advertising nude pictures of my wife, my neighbors (and society in general) would certainly (and rightly) condemn this action as being morally reprehensible.

AND YET, this is precisely what John Derek does with his wife: the meaningless and wandering plot is merely an excuse to present her undraped body before the eyes of the American public.

And yet there are more disturbing elements in this film: the character of Tarzan, for some

reason, has greatly degenerated deciding to stay in the jungle as since the Johnny Weissmuller days. The old Tarzan was a hero that formed a link between the untamed jungle and the civilized world. Not so with the current model: our new Tarzan doesn't even have the power of speech, which places him in between the baboons and the natives on a cultural scale.

The old Tarzan lived in a treehouse and enjoyed cooked food; the new model lives in a tree and eats raw fruits just like the other animals and it is for this reason, this lack of human qualities, that I had difficulty in accepting him as a hero.

IT IS ALSO rather disturbing to note that whereas the Weissmuller character was constantly fighting the forces of evil and protecting the helpless, the current movie shows our "hero" fighting a giant snake and a tribal chief, both in order to save the endangered Jane. In short, he fights only to protect his sex object (with no vocal communication; being possible thisrelationship can hardly be called love) and does nothing at all while a number of other people, including Jane's father, die at the hands of savages.

The film ends with Jane

Tarzan's mate and this is the most distressing aspect of the movie: this young girl from the British Isles totally renounces art, learning and religion in order to live a life of blissful sexuality in the jungle with a creature that is little more than a gorilla.

Thus, the king of the jungle has been reduced to a lecher and Jane is portrayed as a sex-starved woman that will give up anything to satisfy her lust. The message of the film is that the world of the flesh is superior to the world of the spirit. Civilization and culture make a contact with savagery and it is savagery that emerges triumphant.

What will be the effect of such a movie on the youth of the country? Well, I doubt if human nature has changed very much in the past 40 years: children are probably just as impressionable now as they were then so I suppose they'll all leave the theatre the same way of tid back then: all the young bots will leave the theatre wanting to be just like Tarzan when they grow up and all the young girls will want to be just like Jane ... and in the future we can expect to see the story of Tarzan and Jane, the drama

celebrating the triumph of the animal passions over the intellect, being acted out within our society.

Who knows? In another ten or, 15 years perhaps the whole country will have gone ape and

people will be seeking physical pleasure to the total exclusion of all intellectual, artistic and spiritual values.

Goldwater and The Religious Right

NEW YORK--T.S. Eliot once wrote that "April is the cruellest month," but for members of the religious right, September can't be far behind.

First they were fallen upon by Yale President A. Bartlett Giamatti, who issued an encyclical to all Yale freshmen denouncing Jerry Falwell's Moral Majority for a whole list of alleged sins and condemning its beliefs as "dangerous, malicious nonsense." That was comparatively endurable, because Giamatti is known to be thinking of abandoning Yale for a United States senatorship (and ultimately, believe it or not, the presidency) and probably considered his attack a shrewd maneuver,

But now comes Barry Goldwater, American conservatism's oldest living totem, and holds a press conference on Capitol Hill cussing out the religious right with a generous assortment of "hells" and "damns." He shares many of their values, Goldwater says, but they are diverting attention from "the vital issues" in the field of economics. Besides, "from where do they claim the right to dictate their moral beliefs to me? ... I am warning them today: I will fight them every step of the way if they try to dictate their moral convictions to all Americans in the name of 'conservatism.'"

TO THE inattentive, Goldwater's position may come as a surprise, but actually he has always been an orthodox Republican economic conservative first and foremost, with grave doubts about the so-called social conservatives. He never really warmed to the movement that drafted him for the Republican presidential nomination in 1964. He vigorously supported Nixon over Reagan in 1968, and Ford over Reagan in 1976--getting into an open spat with New Right leader

Richard Viguerie as a result, in the latter year.

In 1980, when Goldwater's campaign for re-election to the Senate from Arizona was in deep trouble, the Arizona Right to Life movement refused to settle for his private promise to vote for a Human Life Amendment and insisted on a public commitment instead. Goldwater reluctantly gave it, and the subsequent support of the Right to Lifers may well have provided his razorthin victory margin; but he bitterly resented the coercion, and it has rankled deep ever since. Add to all this an unsuccessful hip operation that keeps the old gentleman in almost constant pain, and it is easy enough to understand his angry tirade.


But the religious right, like it or not, is on to something, and it is not going to be swept into the dust bin of history by mindless, lopsided blasts from Bart Giamatti, Barry Goldwater or anybody else. This simple truth hasn't yet been recognized by many political leaders of the first rank, and considerable credit-and perhaps more tangible rewards--await those who perceive it early.

The truth is that the confident humanistic assumption that a society can survive indefinitely without religious supports has been springing leaks all over the place. The fact was obscured for many decades by the immense inherited moral capital of the American society. But by 1960 that capital was exhausted, in many places and for many purposes, and secular humanism was on its own. What ensued was a fast moral toboggan-slide in which traditional family values were replaced by a sleazy set of "alternative life-styles," selfrealization degenerated into the Me Decade, and drug use exploded among the members of the younger generation to kill the resulting pain.


IT IS THAT state of affairs that the concerned millions of the religious right have mobilized to oppose, and the only wonder is that they waited so long. Among their number one can, of course, find individual extremists saying all sorts of ill-advised things; but the vast majority of these people are not at all unreasonable and don't for a moment seek to impose their own religious views, or any religious views at all, on individual fellow citizens of a different mind. But they are no longer willing to accept the humanist decree that the constitutional separation of church and state requires this society to adopt, as its official posture, a tacit but steadfast atheism; and woe betide any politician who so misunderstands the temper of these times as to suppose they can be ordered summarily to get lost.

A Look At Fuzzy Words And Fuzzy Logic

With all of the public debate going on about this policy or that policy, nobody really takes time to ask what this word or that word really means. We just muddle along — each speaking, in a sense, a different language one to another. Perhaps a look at just the words would be interesting and helpful.

SUPPOSE YOU ask the average American: are public drinking fountains, libraries, and theaters desegregated? Probably most Americans would look at you with some puzzlement and say, "yes." Then you could ask: are America's schools or jobs desegregated? There would probably be a loud chorus of yeas and nays. In any case, there would not be a broad consensus on the answer.

Why? Because segregation has one meaning when applied to water fountains and another when applied to schools. The test to determine whether a water fountain is desegregated is: can a black take a drink? On the other hand, the test used by courts and civil rights groups to determine whether schools are segregated is: are the number of blacks in the school equal to their number in the population?

If the number is wrong, the NAACP or the courts will order some remedy, such as busing. But nobody bothers to propose the same remedy in the case of water fountains, libraries, and theaters. Such an ambiguous usage of the term segregation leads to fuzzy thinking and policy. We should consider a school segregated if a black, who lives next door to a white, is denied attendance at the

attends.

Discrimination is another fuzzy word, as is the phrase equal opportunity. Many people ad-vocate anti-discrimination and equality of opportunity. Think about that.

When choosing a wife, 21 years ago, I engaged in the grossest discrimination and denial of equal opportunity. For example, fat women were not given a chance. Women of other races white, Oriental, Indian - that were just as qualified, did not receive an equal opportunity. Some will say that such discrimination is trivial and doesn't have important social implications.

Not true - marriage selection does have important social implications. For as long as higher-income, higher-educated people tend to mate with other higher-income, higher educated people, the more skewness (unevenness) will be found in the distribution of income in the nation. High-income and bettereducated persons marrying lowincome and less-educated persons would tend to even out the distribution of income. So should we have marital affirmative action?

WHAT ABOUT the word "entitlements." Entitlements refer to a host of government program expenditures which augment and subsidize the income. These entitlements, "Uncontrollables," comprise more than three-fifths of the nondefense budget. They include welfare, medical care, food stamps, public housing, and so forth. Rather than call these programs entitlements, which gives an air of respectability, we might call it plundering or looting. To loot or plunder means forcefully living off the labors of others. Entitlement implies some sort of quid pro quo, i.e., I work for you; I'm entitled to my pay. You pay me; you're entitled to my work.

Frederick Bastiat, the great political economist, gave us a rule to detect looting and plundering: "See if the law (government) takes from some persons what belongs to them, and gives it to other persons to whom it does not belong. See if the law benefits one citizen at the expense of another by doing what the citizen himself cannot do without committing a crime."



same public school the white Americans are mostly moral and would not engage in looting themselves. But because the government takes that which belongs to others and calls it entitlements, the immorality of it is disguised.

There are many other words and phrases which mislead us and confuse public policy. We should dig deeply into words and phrases that are a part of policy such as parity price, rate bureau, the social interest, and others to see

what they really mean and do. I suspect that many of us won't like what we find. At least we won't refer to ourselves as living in the "land of the free." Distributed by

New Liquor Ordinance Upheld Despite Left-Winger Campaign

ANCHORAGE, Alaska--Despite a \$100,000 media campaign designed to discredit the aims of the Moral Majority, citizens in the state's largest city voted Oct. 6 to uphold an ordinance that would force bar and liquor stores to shorten working hours.

The ordinance, originally passed by the Anchorage Municipal Assembly on April 16, had been opposed by bar and restaurant owners, who succeeded in .getting enough signatures on a petition to suspend the ordinance until it came up for the October referendum as Proposition 1.

After passage by the Assemblyin April, the ordinance was in effect for only two days, July 1 and 2, before the Committee for an Informed Choice suspended the measure by filing the 3,500 signatures necessary to place the issue on the October 6 ballot.

The Committee for an Informed Choice was organized in response to the 2-2-10 Coalition, a group of health, law en-

In ads appearing in the Anchorage Daily News the Committee for an Informed Choice said that Proposition 1 would be a chance for citizens to stop the Moral Majority. A Sept. 29 ad by the Committee said, "Alcohol is not the issue. The Moral Majority is the issue. Send the Moral Majority a message on October 6th. Vote YES on Proposition #1."

One especially vehement ad appearing on Sept. 30 had a large photograph of Dr. Jerry Prevo, chairman of Moral Majority of Alaska, with the headline "HEAVEN HELP US....if this man gets his way in Anchorage.' The ad said the aim of the Moral Majority was "to dictate the way we live" and asked, "ISN'T IT TIME TO STOP THEM?"

Nowhere in either ad is the issue of alcohol, bars or liquor stores raised. OBED NELSON, Chairperson

of the 2-2-10 Coalition is quoted in defense of Moral Majority in a

Majority of Alaska, soon became the center of controversy. In ads appearing in the Anrape rates and assault rates and accident rates. No other state in the Union but Nevada (keeps taverns open late) and it's the direct cause of alcohol and violence problems in the community.

Voting results on Oct. 7 showed Proposition 1 going down to defeat by a nearly 2-to-l margin. According to ther Anchorage Times, the final vote count was 29,275 to 15,289. The defeat of Proposition 1 upheld the Assembly's April ordinance. Starting Oct. 14 the bars would have to shut down at 2:30 a.m. Monday through Friday and 3 a.m. on Saturday and Sunday. Liquor stores must close by 1 a.m. during the week and 2 a.m. Saturday and Sunday. Under the new ordinance, bars and liquor stores will not be allowed to reopen until 10 a.m. Monday through Saturday and noon on Sunday

forcement, civic, church and social service groups, which had requested that the ordinance be passed. The 2-2-10 Coalition cited statistics indicating that crimes such as rape, assault and driving accident rates are related to the hours of alcohol sale.

IN THE CAPITAL city of Juneau, where a similar or-dinance was passed more than two years ago, police and ambulance calls dropped an average of 31 percent, the Coalition declared.

The Committee for an Informed Choice responded that shorter bar and liquor store hours would have a negative effect on the local economy, forcing many people out of work. They also argued that their rights as individuals were threatened by the measure.

However, as the campaign developed, the issues surrounding Proposition 1 became less clear cut, due to a heavy negative advertising campaign by the Committee for an Informed Choice. As a latecomer to the 2-2-10 Coalition, the Moral

Members of the 2-2-10 Coalition contended that the Moral Majority was being used as a red herring to cloud the issue of crime caused by increased alcohol sales.

Proposition 1 favored keeping bars and liquor stores open 21 hours a day. If passed, Proposition 1 would have required bars to close only from 5 a.m. to 8 a.m. under an existing law.

Court Upholds Case Against Church

The U.S. Supreme Court has refused to hear a case between the Nebraska Department of Education and Faith Baptist Church and School regarding padlocking of the church by the department.

Citing the lack of a "substantial federal question," the Supreme Court dismissed arguments this month that state regulations were unconstitutional as applied to the school.

THE SCHOOL was ordered closed last spring because it did not meet Nebraska³ Ad¹ ministrafioh³ For¹ School Management and Curriculum requirements.

Nebraska law requires the licensing of Christian schools by the state Department of Education. This includes the employment of certified teachers, curriculum inspections and the inclusion of additional books in the library.

In recent standardized testing, the Faith Christian School students achieved scores well ahead of the students in the Nebraska public schools.

Pastor Sileven had agreed to regular academic testing and attendance checks. This did not satisfy the state Department of Education. They were not interested in "quality" of education, but in "control" of education.

The state Department of Education feels that they, not the parents, should determine where the children are educated.

There are 20 such non-licensed Christian schools in Nebraska. There are thousands across America. Most Christian educators hold the conviction that their schools are part of the local church--and therefore should not be licensed by the state.

Nebraska is one of only eight states requiring such licensure. The remaining 42 do not.

Nov. 22, 1981. The school respend this fall despite a contempt of court citation against the Rev. Everett Sileven, director of the school and pastor of Faith Baptist Church.

Except for Sunday and Wednesday services, the doors of the Faith Baptist Church, in which the school was held, had been padlocked since Sept. 13 by order of the Cass County Judge Raymond Case.

According to Sileven, the students, who have been bused approximately 30 miles to a location in Iowa, will be brought back into the state for classes.

"We're going to force the issue," he said. "We want the state to know that we're going to test their resolve."

According to Sileven, the sheriff indicated the padlocks would not be replaced as long as the school wasn't operating inside.

SILEVEN SAID that he had promised to give authorities 48 hours notice before resuming classes in the church. Sileven's has filed a federal lawsuit seeking \$10 million in punitive damages from both Judge Case and Nebraska Attorney General Paul Douglas.

"The precedental damage nationwide and worldwide of the first padlocking ever of a free church in a free nation can never be undone, but may be restrained if the defendants are made to pay damages of a punitive nature," the complaint alleged.

Scientific Creation Vs. Evolution Is Not Religion vs. Science Debate

GISH, DOOLITTLE ARGUE POINTS

LYNCHBURG, Va.--A soonto-be nationally televised debate between two scientists representing the opposing viewpoints of evolution and scientific creationism, was held Oct. 13 at the campus of Liberty Baptist College in an effort to "put all the facts before the American people."

The hour-long debate featured evolution proponent, Dr. Russell Doolittle of the University of California at San Diego. Opposing him as a representative of the scientific creation viewpoint was Dr. Duane Gish of the Institute for Creation Research also in San Diego.

Recently, the inclusion of scientific creationism teaching in many public schools has caused an outcry from educators and evolutionists across the nation. But advocates of the creationism theory argue that both sides should be presented to school children in the interest of fairness. They contend that evolution is "the" basic & dogma for the philosophy of secular humanism, which, they say, is becoming the religion of the public schools.

This debate, organized by Dr. Jerry Falwell, will be presented to the American public on national television to "clear the air once and for all that scientific creation vs. evolution is not a religion vs. science debate," Falwell said.

IN HIS OPENING 18-minute statement, Dr. Doolittle used the majority of his time, not outlining a basis for evolution, but condemning the actions of an elementary schoolteacher in Livermore, Calif., who had used material from Gish's Institute for Creation Research in the classroom.

Doolittle said he came to the debate "against advice from his friends" who warned him against coming to the LBC campus. At the close of the debate, Falwell commended him for coming to "this auditorium, this audience."

Saying that he "believed only in hydrogen" as a basis for his origin, Doolittle expressed optimism that the unanswered questions of evolutionary theory would eventually be answered.

would eventually be answered. Doolittle said that "all scientists agree" that the earth is about 4.6 billion years old based on various methods of radio dating and repeatedly challenged Gish to give an age for the earth.

"The age of the earth is very important to the evolutionary argument," Doolittle said. He said that moon rocks brought back from the Apollo missions confirm the age of the earth. Gish challenged this argument,

Gish challenged this argument, saying that in the studies of the moon rocks, a wide range of dates were found, and scientists picked the one most convenient to their theory.

Gish, calling evolution an "atheistic theory," said that "the best available evidence says that life could not have come from lower forms."

"A CREATOR using special processes not operating today created the stars, planets and all life," Gish said.

life," Gish said. Criticizing evolutionary teaching in public schools as a "one-sided indoctrination," Gish said that neither theory qualifies as a scientific theory in the "strictest sense." School children should be allowed to examine data, weigh the evidence and choose from the alternatives, he said.

Calling evolution the "fish-to-Gish" theory, Gish said that after hearing the evidence cited by his opponent, it should be called the "too-fintle-ro-Doolittle" theory

Oish shid that to many gaps still existed in the evolutionary theory. He said that the Piltdown man, believed at one time to be a form of primitive man was found to be a hoax, constructed from a modern ape's jaw.

In his closing remarks, Doolittle again accused creationscience of being a "pseudoscience. To put it in the classrooms is to handicap America," Doolittle said. "Evolution is the only reason for our being here tonight." GISH SUMMARIZED his

GISH SUMMARIZED his arguments by repeating the need for "students to be exposed to all the evidence."

In a news conference after the debate, Doolittle acknowledged a

he had not defended his subject as he would have liked.

"I'm embarrassed about the way things came out," Doolittle said.

The debate will be presented as an unedited one-hour special program in most of the metropolitan television markets in the nation. Falwell said that expenses for the televising the debate would total at least \$500,000. The debate will be aired later this year.

Keeping government from fingering church pies has kept the Illinois chapter of Moral Majority busy of late. Gov. Thompson's recent veto of Senate Bill 524, exempting church-related programs for children under age 5 from Department of Children and Family licensure, has moved Moral Majority of Kentucky into action, according to State Chairman George Zarris.

Chairman George Zarris. "Senate Bill 524 passed committee, the state Senate and the House and was vetoed at the last minute by Gov. Thompson," Zarris said. "We are now working to override the veto."

Louisiana

Even with the passage of Louisiana's new creation bill. Moral Majority of Louisiana hus not cooled its heels.

In addition to membership drives, the Louisiana chapter is presently battling a compulsory school attendance law, requiring schools to submit the names and addresses of children who are attending public and private schools.

Michigan

Moral Majority of Michigan has recently established its first official chapter in Flint under the leadership of Dr. Edmond Dinant. The Flint chapter lists many community leaders and professionals as members. Local chapters are being organized in Gaylord, Kalamazoo, Grand Rapids, and Lincoln Park, as well.

"Potential for the young chapter is good with a new plan being developed," a Michigan spokesman said.

Current battles taken on by the Michigan Moral Majority include the formation of a Coalition Against Pornography last August.

Members of CAP include two mayors, nine conservative action groups and members of the state legislature.

A petition initiative has been developed, which in Michigan, would effectively circumvent the legislative committees. Proposals would be taken directly to the floor of the legislature for action.

Virginia

Local chapters in every city and county are being organized by the Moral Majority of Virginia, directed by Jerry Skirvia, County chapters, have been organized in Tazewelt and Henry Counties, with organizational meetings presently being planned in Halifax, Pittsylvania, Buchanan, Prince William, Fairfax and Chesterfield counties.

Anwar Sadat -- 1918-1981

Anwar Sadat, Egypt's president for the last 11 years, was one of the few truly great contemporary world statesmen. As leader of the largest Arab state, Sadat boldly and imaginatively re-shaped the history of the Middle East, completely redesigned his nation's foreign and domestic policies, and was the driving force behind the historic peace treaty that ended the state of hostilities between Egypt and Israel.

Ironically, but surely not by accident, he died on the eighth anniversary of the October war, the abortive surprise attack which psychologically revitalized the Arab world and gave Sadat the prestige and honor he would need later to make peace.

While it is as yet unclear who perpetrated the criminal attack that deprived the world of this man of vision, it is certain that his passing spells the end of an era in Egypt and a qualitative change in the political dynamics of the Middle East.

SADAT WAS born on Christmas Day 1918, the son of an Army clerk, in a crowded village on the Nile delta. From the first, he was a man of the people, and although he acquired an air of sophisticated elegance in his later years, he never forgot where he had come from or to whom he owed his loyalties. As an army officer he joined forces with the charismatic Gamal Abdul Nasser to overthrow King Farouk, and it was Sadat who



announced on Cairo radio the successful coup that brought Nasser to nower on July 23, 1952.

Nasser to power on July 23, 1952. Ridiculed as the "black donkey" because of his dark skin, Sadat was considered to be Nasser's errand-boy and a political lightweight. However, after the death of Nasser in 1970, Sadat astonished observers by cannily outmaneuvering his political rivals and decisively consolidating his control over the Egyptian power structure. In doing so, he displayed a highly developed sense of timing, acute political judgment, and a penchant for bold acitons that caught others off-balance - attributes which later served him in good stead in the arena of international, as well as domestic, politics.

When Sadat came to power, Egypt was a police state firmly lodged in the Soviet camp, and still smarting from defeat at the hands of Israel in 1967. Sadat set about freeing the Egyptian economy from the rigid socialism installed by Nasser and ridding the Egyptian people of the crushing weight of Nasser's police apparatus.

IN 1972 Sadat shocked Moscow by summarily expelling 20,000 Soviet military advisers and technicians from Egypt. The following year he stunned Israel by launching a surprise attack across the Suez Canal. Although his offensive was a military failure, it was a political success, for it restored Arab martial honor and dispelled the aura of military invincibility which had surrounded the Israelis up to that time.

In 1977 Sadat electrified the world by traveling to Israel to meet Israeli leaders face to face. This bold initiative led to the 1978 Camp David negotiations which paved the way for the Egyptian-Israeli peace treaty of 1979. Throughout the complex negotiations, Sadat exhibited a flair for public relations theatre which earned him the title of the "Third World's first media president." A dept at manipulating the foreign press, Sadat learned from Henry Kissinger how to score diplomatic points by granting interviews to key opinion makers, such as Barbara Walters and Walter Cronkite.

In recent years, Sadat became increasingly isolated from the Arab world because of his peacemaking efforts with Israel. Ignoring the shortsightedness of Arab leaders he dismissed as "dwarfs" and "goatherds," Sadat moved closer to the United States and became America's most loyal friend in the Arab world. Then in 1980, he demonstrated his loyalty to his old friend the shah of Iran by granting him diplomatic asylumdespite the fact that the Egyptian people considered the shah an enemy of Islam.

President Sadat's untimely death leaves a huge void in the Middle East at a time of growing regional tensions and external Soviet pressures. Anwar Sadat will be missed by Egyptians to whom he had become a benevolent father figure. He will be missed by Israelis to whom he had become a reliable negotiating partner. He wil be missed by Americans to whom he had become a loyal ally. And he will be missed by humanity as a whole to whom he had become a voice of hope and a man of peace. Distributed by

Battling Pornography Through Economy

Moral Majority hopes to rid the nation's bookshelves of pornography by using legal, economic and political means.

An anti-pornography conference, including 40 law enforcement officers and prosecuting attorneys from more than 30 cities, was hosted by Moral Majority in the Bahamas Sept. 23-25.

ACCORDING TO Moral Majority spokesman Cal Thomas, Moral Majority will push for prosecutions under existing pornography laws, which are not being strictly enforced.

"Our approach is not going to be puritannical, but economic," Thomas said. "The hard statistics show that where these businesses are allowed to proliferate, the tax base is eroded, the crime rate increases...and strictly from an economic and aesthetic viewpoint, we think it's in the interest of cities to eliminate these kinds of establishments."

Another plan of action encouraged by the Moral Majority is to encourage its members and supporters to boycott grocery, convenience and bookstores that sell publications it considers to be pornographic or obscene.

Moral Majority's annual summit meeting was held in conjunction with the anti-porn seminar. Discussion at both meetings concerned Moral Majority's 1982 pornography campaign. Anti-pornography conference topics included: How to Prepare and Implement Effective and Constitutional Obscenity laws, Effective Law Enforcement, as well as a call to action and mini-report of current activities.

PHASE II OF Moral Majority

and the Moral Majority Legal Defense Foundation were among topics highlighted in the Summit Conference. Other topics included: the Congressional Update Program, a National Legislative Issues Overview, the Powers of Positive Press Coverage, the Anatomy of a Successful Issue Campaign, Coping with Prosecutor Intimidation and How to Prosecute and Bring to Conviction, as well as a planning session. In addition, several

In addition, several resolutions, in conjunction with the summit and conference meetings, were drafted:

1. Be it resolved that the conference urge the Congress to enact a statute granting to private citizens the right to bring legal injunctive actions to prohibit distribution of obscenity that have been transported in interstate commerce; 2. That the conference urge the president and congress to direct the Department of Justice to actively enforce the federal obscenity statutes;

3. That the conference urge the president and Congress to direct the Federal Communications Commission to enforce the standards against "indecency" upon broadcast and cable television;

4. That the individuals return to their respective communities and urge the public to support the local and state prosecutors;




