Government: Capitalists in Socialist Clothing?

Attached are suggested talking points for the issue paper reviewing the recent decision by the French Government to promote greater entrepreneurship in the economy.

Talking Points: Capitalists in Socialist Clothing?

- Since the French Government unveiled its "Development of Economic Incentives" bill on March 29th, it appears that the Government had been developing its proposal before President Mitterrand made his trip to the U.S.
- However, widespread press reports suggest that Mitterrand's visit to Silicon Valley had a major impact in confirming Mitterrand's conclusion that France needs to develop more of an entrepreneurial spirit.
- It appears that the current French strategy of concentrating public resources on a few large "national champions" has not yielded sufficient benefits. By and large, these large companies have not been at the cutting edge of new technology.
- This new strategy will try to develop more small- and mid-size companies and encourage greater private investment in these companies.
- This entrepreneurial strategy is part of a larger program designed to wean France away from basic industries such as steel, coal, and shipbuilding to higher-technology industries.
- While we would prefer that the French Government allow the market to shift resources toward high technology industries rather than having the Government actively shift resources, we should be pleased by the direction it is taking.
- The Cabinet Council on Economic Affairs, in its discussion of preparations for a recent OECD Ministerial, suggested that Administration officials privately compliment French officials on their move to cut back on public funding of the steel industry, despite strong political opposition.
- The Socialist Government has been open enough to admit that its earlier policy of greater government intervention in the economy has not succeeded and is willing to try an approach that has greater emphasis on the market.

Attached is a proposed issue paper discussing the recent package unveiled by President Mitterrand designed to encourage entrepreneurship and private investment in France. Announced shortly after his tour of Silicon Valley in March, this package combined with recent cutbacks in public support of steel and other industries represents a major shift in French economic philosophy toward greater reliance on entrepreneurship and less government intervention in the economy.

Given the upcoming London Summit and the attempt by Mitterrand to duplicate entrepreneurial conditions in the U.S., an issue paper discussing the recent French actions would be both timely and valuable.

The French Government: Capitalists in Socialist Clothing?

President Mitterrand recently announced a package of incentives aimed at encouraging entrepreneurship in France. The French Socialist government is apparently committed to developing an entrepreneurial environment similar to the one Mitterrand saw during his recent trip to Silicon Valley in California.

The French Government has up to now tried to promote high technology industries by targeting public resources on one or two "national champion" firms in a particular industry. While this strategy may have succeeded in some high technology industries, Mitterrand has recognized that France is falling behind the U.S. and Japan in the high tech race.

After his recent tour of Silicon Valley, Mitterrand unveiled a package of economic incentives designed to stimulate the growth of small- and mid-size companies and encourage private investment. The package includes provisions such as: tax exemptions for long-term investments in small companies, below-market interest rate loans to individuals starting new companies, and acceleration of the depreciation schedule for research in computers.

The Socialist Government has coupled this new emphasis on entrepreneurship with a cutback of public support of "sunset" industries. The Government recently turned down a request from a large private construction and steel company for public funds. In addition, the Government initiated reductions in funding for the two state-owned steel companies. These actions signal Mitterrand's attempt to put French industry on notice that the Government cannot afford to continue providing handouts and bailouts. Despite some strong political opposition and near-term economic costs, Mitterrand has apparently concluded that continuing the status quo will only result in France missing the "third industrial revolution."

While the French have not fully accepted the basic tenets of your free market approach, they are gradually moving toward the direction of greater reliance on entrepreneurship and less government intervention in the economy. The Socialists have apparently learned over the last several years that stifling private initiative is counterproductive.

Cheysson called Shultz this morning to inform us that he is cancelling his visit to Washington. Ostensibly, he does not feel that he can be away from the Quai for as long as planned (New York, Washington and San Jose stopovers). In fact, I believe that Cheysson is cancelling since his Washington visit increasingly became devoid of substantive meetings -- the President refused to see him and the Vice President's schedule could not be reshuffled to arrange a meeting. Given the fact that Howe, Genscher and Andreotti have all seen the President in recent months, and given Cheysson's precarious perch at the FM position, it appears that he is cancelling as a save-face measure.

Because of these difficulties, we should do all we can to assure Cheysson has at least a photo op with the President during the UNGA.

Subject: FYI - In light of the Mitterand visit.

EC leaders yesterday failed to solve their serious budget differences bringing the EC to the edge of bankruptcy. At issue is the U.K.'s frozen budget rebate of \$750 million European Currency Units, which U.K. Prime Minister Thatcher had wanted. Officials say that this could precipitate cutbacks in the EEC's guaranteed farm spending.

Failure to agree also will prevent immediate implementation of other agricultural reforms. Some issues can be voted on a majority system, but others need unanimous decisions. It is not clear whether the issue of corn gluten feed falls in the former or latter voting category.

The summit meeting was suspended for a half hour so the U.K. could consider the latest offer of an annual 1-million Currency Unit rebate for 5 years. This offer appeared to be lower in cash terms than that which was offered earlier, but it was for a 5 year period rather than just 1984 and 1985.

President Mitterand last night blamed the U.K. for the summit's failure to agree on budget contributions and the subsequent delay in implementing various EEC reforms.

In another development, Irish Prime Minister Fitzgerald walked out of the meeting dissatisfied with milk production proposals. Proposals to reduce EEC milk quotas will not cut milk and butter production as quickly or sharply as governments had hoped. Analysts say that other factors will boost EEC stocks of butter to a record 1.1 million tons by the end of September, equal to about 87% of this season's total domestic consumption.



Thank you for your letter of August 30 to the President which was referred by the White House to this office for reply. I apologize that this response is so tardy.

The relationship between France and Monaco was initially set forth in a treaty between the two nations dated July 17, 1918. A copy of this treaty is enclosed. Since then, there have been numerous commercial agreements between the French and Monegasques further defining their economic relationship. I suggest you get in touch with an attorney familiar with the legalities of commercial activities with Monaco to get a better understanding of the particulars involved in doing business with the Principality.

I have also included a copy of some Background Notes for Monaco which may be of interest.


