In the name of humanity, freedom and for the purpose of eradicating Khomeini terrorism, I am submitting a plan of action for your's and the National Security Council's consideration which is attached herewith. I, like many other Iranians, who, in this country, have been accustomed to cherish the values of democracy, have a burning desire and strong tenacity to rid the present generation in Iran from the barbaric policies and inhumane propensities of the terrorist regime of Khomeini.

I have indicated in my paper entitled: "The Iranian Problem: A New Solution," that the ultimate goal of the Khomeini regime is to create a structure which is more repressive than the Soviet regime and as inhumane as the Hitler's Nazism. The regime of Khomeini, which has abolished the most elementary rights of individuals and created such a wide-spread discontent especially among the youth and the educated, has been a destabilizing force in the region, and provided an opportunity for the rapid spread of Communism. All indications point to the fact that the Iranian economy is in a shambles, while the Khomeini cronies financially support and instigate terrorism everywhere especially in the Middle East.

I have had 25 years of experience in the geopolitics of Iran in 14 different governmental as well as private organizations. I must add that I served within the confines of a top secret committee for four years to only combat and eradicate Communism in Iran. I am not attached to anyone of the old regime to legitimize my mission. But, I have been in contact with individuals of impeccable integrity and reputation in the U.S. and in Iran, who are prepared to forge ahead with a new mandate to emancipate the Iranian people from the yoke of Khomeini. This regime has been threatening the Western civilization from the base of Iran, which was once one of the strongest citadles for Western values and a staunch ally of the U.S.A.. My plan of action calls for the formation of a "youth" party, to be exact, The Young Iranians' National Unity Party, (YINUP), which would include most people with energy, perseverance and dedication to put Iran back on the road to democracy and in the inner circle of the U.S. friends.

I am writing not to ask for financial assistance. We have embarked on actions to officially announce the formation of the party in Iran. During the past three years, the establishment of the party nuclei has been continuously and systematically, but quietly accomplished and their limited preliminary operations have been under way. The rank and file of the organization will bear the cost in the U.S., Europe and in Iran. But we want your moral support to open a new chapter in Iran's his-

THE IRANIAN PROBLEM
A NEW SOLUTION

The long term plan of action of Khomeini is the creation of a Union of Islamic Republics that could be more subversive and destructive to Western values and democracy than both the U.S.S.R. and Hitler who mobilized German masses for Nazism. It has to be pointed out that terrorism is only the initial stage of the repressive regime of Khomeini which will be inimical to the long-term survival of the Western civilization. Just at the outbreak of the Russian Communist revolution, and Hitler's Nazism, few could imagine what would befall the Free World and human race, not very many can portend the consequences of the Khomeini barbarism. The ugly aspect of the Khomeini autocracy is in its utter disrespect for and hostility towards Universal human rights and Western civilization with all its cherished values.

The common belief is that the Khomeini regime is embedded in a religious foundation and to that extent, is anti-Communist and that such an order has either done away with the menace of a Communist takeover in Iran, or at least, diminished such a possibility. The fact of the matter is that the Khomeini regime has insidiously enhanced the rise of radicalism and accentuated the danger to the stability of other strategic countries of the region. Laying false appearances aside, the principal activities of the communists in Iran, under this regime, has been continuous, calculated and advancing.

Under the present regime in Iran, income has fallen, unemployment has risen, the excesses and corruption of administration under the Shah have been accentuated, demoralization of the youth is all-pervasive and the most elementary human rights have all but disappeared. Khomeini has betrayed the Iranian people, especially the youth and the experienced by reneging and unilaterally abrogating his solemn promises to them. It is usually under these circumstances that the seeds of Communism are sown. The youth and the educated people who brought Khomeini to power for the goal of a better life in the twilight of democracy, have developed such a desire for vengeance against the Islamic regime and its Mullahs; and are ready to avenge the wrongs done to them at the first available opportunity.



We, and the humanity, are at the crossroad of a major dilemma. To allow Khomeini to continue his repressive and demagogic regime intact will result in the establishment of a Union of Islamic Republics which will be erected upon the ashes of the present moderate governments in the area. It will also continue to generate resentment and hostility among the youth and the educated people to the extent that they may prefer, and welcome, out of desperation, a Red insurgency in Iran to rid themselves of the menace of the Mullahs and their evil and repressive ways. In a word, the present regime in Iran poses a vast peril to the long-term interests of the Free World and all its beautiful attributes for which the original architects of the Iranian Revolution challenged the administration of the Pahlavi dynasty.

It is important to recall that the insidious and ultimate aim of the fundamentalists, such as Khomeini and Kaddafi, is the establishment of a "Union of Islamic Republics," to be run on Marxist lines and in pursuit of the reactionary Islamic theology. The realization of such an aim would be more dangerous than the emergence of the Union of the Soviet Socialist Republics with its satellites. A Union of Islamic Republics envisaged by Khomeini and the leaders of his Islamic regime would include Iran, Pakistan, Iraq, Turkey, Kuwait, Bahrain, Qatar, United Arab Emirates, Oman, Yemen, Saudi Arabia, Jordan, Syria, Israel, Egypt, Libya, Tunisia, Algeria, and Morocco. If Khomeini, unlike Lenin, fails to establish his Union of Islamic Republics, his death would create a wide vacuum of power in Iran. If an acceptable and genuinely national force does not fill the vacuum, the threat of a successful Communist insurgency, or of a more obtrusively obnoxious terrorist group such as the Mojahedeen Khalig would be real for the usurpation of power. It is indubitably clear that the consequences of such a calamity would be irreparable for Iran, the Iranian people, and for the Free World under the leadership of the United States of America. Thus the vital interests of Iran and of the Free World call for the creation of an unimpeachable, nationalistic, able, and strong force among the Iranians-Pro-West, anti-Communist, anti-terrorist, and anti-reactionary-ready and able to take over immediately following the death of Satan Khomeini.

The opposition groups formed by the Iranians, thus far, have proved their inability to attract the silent majority of Iran. Hence, these opposition groups would not be in a position to play a decisive part in the coming years. Plans and projects, so far formulated and car-

ried out for the dismantling of the Islamic regime, have failed. They are neither long-term, comprehensive and all-inclusive, nor built on strong foundations. The results of these plans have been transitory and parochial leading to more despair and disappointment. Today, more and more people have concluded that one of the insidious tactics of the Khomeini regime is to isolate different layers of society. It aims at the final destruction of the educated, pro-west and democratic-minded classes of the Iranian society. Indeed the Mullahs are bent upon the long-term replacement of the democratic-minded entrepreneurial groups with an ignorant, obedient class of people. This very aim of the Mullahs has already created a great danger in Iran.

A SUGGESTED SOLUTION

What is proposed here is considered to be an effective, practicable solution, embracing the majority of the people of Iran, inherently long-term and at the same time in harmony with the principles of Western democracy and capable of safeguarding the vital interests of Iran and of the Free World. It is the establishment of an Iranian peoples political party under the name of the Young Iranians' National Unity Party. Such a party would be able to assume an effective, reliable role in the future of Iran, protecting the long-term interests of the Free World, with all its cherished attributes.

Here are the reasons:

- (1) For the first time in the Iranian history, a people's political party will be spontaneously emerging as called for by the necessities of time. So far, all political parties formed in Iran have come into existence on cues from those in power and for special and selfish interests of the rulers. The only well-disciplined and highly organized party so far, is the Communist Tudeh Party of Iran, which serves the interests of the Soviet Union.

- (2) The population of Iran is a young one. More than 70% of the total population is under thirty years of age. In the seven

years following the fall of the Shah and the imposition of the Islamic dictatorship, the youths of Iran have suffered the greatest casualty, have borne the heaviest material and moral losses, have been under the most unbearable physical, spiritual and emotional pressure and have had their human and other rights violated more than any other segment of the population.

Despite these misfortunes, they still constitute the majority of the population and are considered to be the most able and active national force in the country. Democratic justice demands that they should have the right and the opportunity to guide their own and their country's destiny and rule the land.

(3) This most dynamic and effective force, that is the youth of Iran, is at the present time living under the most distress conditions. As a result of the savage rule of the tyrannical Mullahs, the youth have reached the point of open revolt. Many of them are ready to embrace political dissension and fearlessly struggle either as individuals or in small groups. But, so far, they have not found a leader or a rallying point to join. They are desperately waiting for the appropriate hour and condition to unite, pool their efforts in a national political institution, announce their irrevocable opposition to the ruling regime and actively endeavor to depose it. Thus the establishment of a political party under their own name would be wholeheartedly hailed, infusing in the youths a new hope and a new spirit.

(4) Iran's future is pledged to the uniting of its youth and their formation of a national political party to be designated, the "Young Iranians' National Unity Party." Should the Iranian youths come to know that a political party has been formed in their name and for them, based on democratic principles, aiming at safeguarding their national and human rights, supported by the Free World and human rights organizations, they will, with ardent desire, join it—creating, for the first time, a strong bond of national unity that can, in itself, constitute a mighty force ready to fill the void upon Khomeini's death. This, especially as youths are incessantly attracted to the activities of a political party.

(5) The formation of a political party of this order shall be the first step toward the establishment of a true democracy in Iran. It will herald the spontaneous emergence of a national, dynamic political force called for by historical, political and social imperatives. It will base its structure and function on democratic principles and long cherished values of Western democracy. Such a party, and in fact, any genuine national political party- has been one of the permanently unfulfilled needs of the Iranian society. Most experts and authorities consider the lack of such a political party as a fatal error of the previous Iranian government and one of the main causes of the resulting vacuum of power following the fall of the Shah leading to the easy assumption of power by religious fanatics.

Such a political party following the formation of the Communist Tudeh party of Iran would indeed be the very first real national party with a political base-with this difference that the Tudeh is an anti-national organization openly holding allegiances to a certain foreign power, but the Young Iranians' National Unity Party is truly national drawing its powers directly from the people of Iran.

(6) The proposed Young Iranians' National Unity Party will have the all-inclusive quality of not belonging to, or representing the interests of any particular group. It will encompass all segments of the Iranian society-i.e., workers, farmers, high school and university students, government employees, store keepers and tradesmen, craftsmen, women, soldiers and students of divinity seminaries, even the revolutionary guards of the Khomeini regime. It will be free from internal and sectarian rivalries, quarrels and enmities. The adherence of the party to democratic principles and functions in practice in the countries of the West will, not only gain it the full support of the Iranian society, but also earn and attain international support. Such will be its functions:

- Active participation in and upholding of free elections.
- Rejection of terrorism and fostering of the rule of law.

- 
- Respect for individual and collective human rights, the civil code, political freedom, decentralization of power, freedom of the press, freedom of faith and religious belief.
 - Recognition of ethnic rights.
 - Observance of moral, humanitarian and national principles.
 - Condemnation of all forms of discrimination and fascism.
 - Protection of the sovereignty and independence of the country.
 - Adherence to international laws and regulations.
 - Establishment of cordial relations with neighboring countries and non-interference in their internal affairs.
 - Support for international peace.

Such a party will be a unique force to combat destructive organizations like the Hezb-ullah(Party of God) terrorists in order to either neutralize them or considerably supplant their perilous roots.

(7) Although the name of the party denotes exclusivity to the youths of the land who command a decisive majority in Iranian society, in its structure and function it will include people of all ages. It will be in constant and harmonious touch with groups like "the pioneers"(the elderly), children and teenagers. There will be close participation in arriving at all political, economic and other such important decisions.

(8) The party will also establish a military arm administered under the direct supervision of the party's political bureau and the secretary general. The function of the military arm will be to supply



military support and personnel when needed.

(9) The party will be active both in Iran and abroad. But it will mainly concern itself with the organization and unification of the youth of Iran. And with due regard for specific prevailing conditions, its operations will, of necessity, be in complete secrecy inside Iran. Its activities abroad could, however, be semi-secret. Its structural networks will be such as to ascertain the full security and protection of its internal jurisdictions. Should certain active party members be discovered and captured by the agents of the regime, other networks should, as far as possible, escape discovery.

(10) During the past three years, the establishment of the party nuclei has been continuously and systematically, but quietly accomplished and their limited preliminary operatives have been under way.

The young Iranians' National Unity Party anticipates urgent moral and humanitarian support of all prominent people committed to the safeguarding of high human values. It appeals to all patrons of liberty and human rights to come to its aid. A positive response to this appeal would be another effective step to enhance liberty and human rights and would earn the gratitude of the youth of Iran and of the whole Iranian nation.

Young Iranians' National
Unity Party
(YINUP)

The Young Iranians' National Unity Party resolved the following to constitute an outline of the proclamation of its basic beliefs, principles, goals and its prospectus:

PREAMBLE

These principles, goals, objectives, statements and prospects shall remain valid until such time when the first general congress of the party is convened, in which case, revisions, additions or deletions may be made.

- (1) The YINUP will recognize and appreciate all those individuals, groups or organizations who, recognizing the plight of the Iranian people in general and of the young people in particular, would wish to extend a helping hand. Such help, would be welcomed with gratitude.
- (2) The YINUP is of firm conviction that Iran must shed its current reputation as an outlaw nation and a haven for international terrorism, and must rejoin the international community as a civilized society. Iran must retrieve its good name and international stature as one of the oldest civilizations on earth.
- (3) The YINUP takes a dim view of those countries and nations, who due to political or ideological myopia or sheer self-interest, have aided and abetted the Khomeini regime. Such countries are, in the eyes of the Iranian people, indirectly responsible for the immense suffering, mayhem and destruction that the Khomeini regime has inflicted upon the people of Iran.

- 
- (4) The younger generation in today's Iran constitutes a decisive majority and therefore, the young consider it their natural right to play a determining role in the future of their homeland.
- (5) During the lifetime of the clerical regime in Iran, the young people have suffered the most and have been made victims in a variety of ways both at national and international levels; the young people, therefore, consider it their natural right to defend their integrity, their future and the future and honor of their homeland.
- (6) Given the circumstances in today's Iran, the young believe it is their right to try to retrieve their lost ground and consider it proper and necessary to employ all means, including a resort to arms, to fight against the Khomeini regime for the purpose of bringing its illegitimate and inhuman grip on their homeland to an end, and to strive to institute a legitimate and democratic government harmonious with the well-recognized democratic principles.
- (7) The YINUP considers Iran's independence, sovereignty and territorial integrity of utmost importance. Whereas the YINUP does not covet other nations' soil, at the same time, it considers it unthinkable to yield even an inch of its own territory to other nations.
- (8) The YINUP believes Iran belongs to all Iranians. As such, it is the responsibility of all citizens to strive to build and protect their homeland. By the same token, it is natural to expect all citizens to be equal under law and allow them to enjoy the fruit of their labor within the context of an equitable, meritorious and just society.
- (9) Whereas the YINUP would primarily be manned by the young,

yet it considers the adult society as the well-spring of its prospects and it respectfully seeks to utilize their valuable experience and expertise. Likewise, the YINUP shall pay special attention to children and adolescents as future leaders and shall strive to organize them in special affiliate groups.

- (10) The YINUP believes every citizen has the right to free health care and free education. The YINUP shall therefore, strive to educate the public and instill in them the nationalistic, moral and spiritual values as the fundamentals, and guide them toward seeking specialties and expertise, as the particulars.
- (11) The YINUP considers human rights to be fundamental to all humans and firmly believes such rights to be inalienable. Included in such rights, are freedom to worship, to assemble and to coalesce.
- (12) The YINUP believes society will flourish only when democratic principles, free elections, nationalistic political parties, freedom of the press, freedom of worship and freedom of expression are unshakably respected within the context of a people's government, rule of law and national interests and security. As such, the YINUP shall encourage and respect a multi-party system whose allegiance is pledged to the government of the homeland alone.
- (13) The YINUP believes the economic system of the country will prosper under a decentralized system. As such, less government would constitute a better government.
- (14) The YINUP, as a political organization, affirms its belief in God almighty, yet it believes the relationship between

the individual human and his God, is a matter of conscience, and as such, religion, organized or otherwise, shall not interfere in politics. Affairs of state and affairs of religion are two entirely separate realms of human activity and shall be kept as such. The YINUP, at the same time, believes moral principles and values, free from dogmatism, fundamentalism, and regressive tendencies, are positive elements both for the social and political health of the nation.

- (15) The YINUP considers dogmatism and superstitious beliefs disguised as religion, inimical to the best interests of society, but it considers atheism and materialism equally ruinous. The YINUP, as such, shall welcome and encourage the true spiritual leaders to disseminate the gospel of moral behavior.
- (16) The YINUP considers the behavior of those responsible for the destruction of Iran under the current clerical regime as treasonous as those under the past regime. The YINUP considers it a national priority to bring all such people to justice in open courts and have them tried under internationally acceptable standards of justice in full view of the public and with full participation of international observers.
- (17) The YINUP considers it of utmost importance to note and recognize the contributions of the true servants of the nation who, under duress and adverse circumstances, be it under the past regime or under the current clerical regime, might have served the best interests of the nation.
- (18) The YINUP shall strive to encourage the exile community, and in particular, those with technical or managerial expertise, to return to their homeland with dignity and honor.
- (19) The YINUP believes the warmongers as well as those whose

own self interest has propelled them to engage in fratricide and those who have engaged in terroristic activities, will have to be tried as war criminals in special tribunals. Such people have caused untold amounts of suffering for hundreds of thousands of Iranian families and taken , by coercion or brainwashing, the young lives. Such elements have brought international shame and infamy to the Iranian nation.

(20) The YINUP is of the opinion that the best way to counter the poisonous seeds the Khomeini government has deliberately sown to insure its survival , is not to respond in kind, but to employ its antidote. In other words, the YINUP shall strive to respond to fire with water, darkness with light, despair with hope, vengefulness and enmity with understanding and friendship, cruelty with compassion, disunity with unity, war with peace and reconciliation, anarchy and lawlessness with law and order, hypocrisy and deagouery with rectitude and veracity, ignorance and superstition with knowledge and enlightenment, mistrust with mutual trust, malice with good intentions, injustice with justice, destruction with constructiveness and fanaticism with openmindedness. In view of these principles, the YINUP shall fully support the true servants of thenation, regardless of their vocation or call, including the genuine spiritual leaders.

(21) The YINUP expects all young Iranians, including those deceived and brainwashed by the Khomeini regime, to free themselves from the fatal trap set by him and flock to their own true political party. They must rest assured that those who repent, will be welcomed back with open arms. But the true criminals; those who have deliberately committed despicable acts of crime against the Iranian nation, the warmongers and the murderers, will have to be dealt with separately, and their crimes shall be considered crimes against humanity.

(22) And finally, the YINUP affirms and subscribes to all re-

cognized international codes of behavior in the context of the nation's sovereignty and its independence, the independence and sovereignty of other nations, the principles of non-interference, the maintenance of international peace, mutual respect and good relations with all countries including Iran's neighboring countries, and firmly opposes all acts of terrorism by individuals or states.

The YINUP, having had the nation's young people's force coalesced, and having had Khomeini's anti-Iranian regime over thrown, shall pursue the following goals and objectives:

- (1) All anti-nationalistic organizations and institutions affiliated with the Khomeini regime shall be immediately abolished; the Iranian national army shall, simultaneously, be instituted. Police and gendarme (rural police) forces shall take shape, and all national heroes and all defenders of the national soil, including our soldiers, officers, NCO's and all those who have made sacrifices to defend and protect Iran, shall be publicly and officially recognized.
- (2) The involvement and interference of religion in the affairs of state shall be stopped at once, and the hands of the "illiterate" clergy shall be cut off from being involved in the shaping of Iranian people's destiny. In its place, the banner of spiritual and moral principles shall be hoisted on all walks of life as the nation's guide.
- (3) War and warmongering shall come to an end; so will destruction and genocide. A proclamation of general amnesty shall release all innocent people from Khomeini's gulags and dreadful dungeons.
- (4) Anarchism and lawlessness shall be stopped; in their place the rule of law shall be instituted.
- (5) The people's life, limb and property shall be placed under the full protection of law and the hands of the thugs, hood-

lums and hooligans shall be cut off from involvement in people's public or private lives.

(6) All national resources shall be placed under full protection of the government and utilized exclusively in the service of the people.

(7) All Iranian refugees in and out of the country shall come under the maximum protection of law, and so shall Iranians wounded in the war or handicapped as a result of same.

(8) Persecution and harassment of ethnic or religious minorities shall end at once and all ethnic or religious minorities will be enabled to resume their normal lives within the context and protection of national law.

(9) All terroristic acts, deeds or thoughts shall be permanently proscribed from the Iranian society.

(10) In place of hatred shall come love, in place of vengeance, magnanimity and forgiveness, and in place of division, unity and cooperation.

(11) With the institution of certain social programs, a national campaign shall start against and stand in the way of all kinds of corruption, including moral, material and social irregularities; the perpetrators of such corruption, the lawless individuals, the transgressors of public rights, the obsequious, the venal, and those engaging in cronyism, favoritism, demagoguery, materialism, waste, fraud, destructive competition, irresponsibility and in general, all those engaged in social and moral misconduct, shall be dealt with severely within the context of law. In place of all these social and moral ills shall be implanted respect for law, willingness

to serve public good, honesty and integrity, sincerity, altruism, trust, respect for the rights of others, public morality, and a love for freedom.

(12) All criminals and all those who have violated the rights of others, shall be publicly tried in appropriate tribunals and shall be punished as they may deserve within the rule of law.

(13) The wheels and the machinery of the nation's economy shall be set in motion and the public shall find the opportunity for full participation in the economic activities within the context of law.

(14) Raising the worker's and farmers' standards of living as well as those who have been less fortunate shall enjoy a top priority. So shall the institutions of programs to insure an equitable distribution of wealth and social welfare. Certain conditions shall be created to insure that in the future, the minds and the resources of the farmers and the workers shall never be allowed to be misused or exploited.

(15) Special attention shall be paid to encourage learning, erudition, scholarship, the study of arts, ethics and safeguards shall be erected to fight against ignorance, superstition and corruption.

(16) Family as the basic and the inviolable unit of our society and as the building block of our national aspirations shall be the recipient of all attention, and the children shall be considered the public trust. A successful discharge of our responsibility toward the family, however, requires the full and equal participation of a man and a woman bonded together in matrimonial unity. Such basic equality shall con-

stitute the basis of all other social and political endeavors in our society under law.

(17) All those individuals who have been unjustly wronged, and those who have been victimized under Khomeini or under the previous regime, all shall be rehabilitated and all those unjustly or wrongly dishonored shall be honored.

(18) Relentless effort shall be made to identify and locate the squanderers of public trust or property under any or all guises, and every and all national resources shall be employed to extradite those accused of such gross misconduct to stand trial in public tribunals under law.

(19) Those Iranians who have inadvertently partaken in Khomeini's anti-nationalistic activities under duress, provided that their deeds shall not constitute major or capital crimes and/or show sincere willingness to return to the comforting bosom of the motherland shall be forgiven and kindly treated.

(20) Efforts shall be made to reconstruct that which has been desecrated under the Khomeini regime. Such efforts shall require the full participation of the public and shall require patience, perseverance and years of hard and infatigable work.

(21) The legitimate rights of women, children and the young people shall be restored and conditions created to insure the full blooming and complete actualization of their potentials under healthful surroundings. Such surroundings shall ring with happiness, abundance and full opportunity to serve the public good.

(22) Once law and order is established, a constituent assembly represented by people's deputies, elected freely, shall write the Iranian constitution embodying guarantees of social, po-

litical and religious freedom for all. The new constitution, as the fundamental document of Iran's territorial integrity and independence and as an expression of the free will of its people, shall prescribe the type of government as deemed most suitable. The constituent assembly shall set dates for free parliamentary elections and the institution of a permanent government.

Once the new parliament, duly elected, is in place, the constituent assembly shall dissolve and the provisional government of the YINUP shall be replaced by a permanent government.

Mr. Iraj Arianpour was born in the southern Iranian city of Kerman in 1934. He attended Tehran University's College of Science and the National Teachers College where he received Bachelors' Degrees in Psychology and Educational Sciences and Geology. He also obtained a Master's Degree in Psychology and Educational Sciences.

Mr. Arianpour began his governmental services in 1958 from the National Teachers College and during the next twenty years served in the following positions:

- *Head of the Publication and Information Bureau of the National Teachers College, General Manager of the Printing Office, and Managing Editor of The Teachers College Weekly Magazine.
- *Executive Assistant to the Deputy Minister of Education in charge of technical and higher education.
- *Secretary General of the Teacher's Training and Educational Research Organization (later became the Teacher's Training University).
- *Executive Assistant to both the President of Tehran's Polytechnic Institute and the President of the National University of Iran.
- *Senior Expert Consultant to the ministries of Education and Economy.
- *Director of Public Relations and Communications Office of

the Institute of Standards and Industrial Research of Iran.

In 1967, Mr. Arianpour joined the Ministry of Information. There he was Deputy to Director General for the Press and Communications Affairs for more than three years. In this position, he oversaw activities of the press, printing shops, reporters, photojournalists, private advertising agencies and government advertising.

Later, Mr. Arianpour became the General Director of the Ministry of Information in charge of coordinating mass communications affairs of all the government ministries and agencies.

Then, for a period of eight months, he studied and researched public relations, mass communications, and advertising techniques in London, England.

Upon his return to Iran, Mr. Arianpour was named Senior Advisor to the Minister of Information and, in 1975, he was appointed Deputy Minister of Information and Tourism for Press Affairs.

After serving only one year in this position, he was

appointed Deputy Minister of Commerce for trade and commercial affairs. In less than one year, he was appointed Deputy Minister of Commerce for trade and commercial distribution affairs.

While Deputy Minister of Commerce, Mr. Arianpour also served as Chairman of the Board and General Manager of Trade and Commercial Services Development Company, where he succeeded in organizing the second largest government-owned company with a budget second only to the National Iranian Oil Company. Among the projects undertaken by this company were developing and regulating national marketing strategies, reservation, storage and distribution of essential goods throughout the country in accordance with the national security requirements.

In this position, Mr. Arianpour increased the capacity of national cold-storage rooms four-fold and storage rooms three-fold. At the same time he fought corruption and irregularities among highly placed individuals and entities in the previous administration.

Mr. Arianpour served in these positions for two years before returning to the Ministry of Information and Tourism to serve as Senior Advisor to the Minister of Information and Tourism.


One year before the revolution, Mr. Arianpour retired from government service and joined the private sector as Chairman of the Board and General Director of the Geshnad Manufacturing Corporation.

Then, in February 1979, Mr. Arianpour came to the United States and joined the Voice of America. Presently, he is the Cultural Editor for the Persian service of the VOA.

Aside from his official assignments and positions, Mr. Arianpour has been active in the following areas:

- *Membership in a top secret Special Committee to Combat Communism, attached to the National Defense and National Security Councils.
- *Membership in a highly classified committee for encountering leftist propaganda aimed at the Iranian labor force broadcast from some clandestine radios in countries such as East Germany.
- *Teaching at The National Defense University.
- *Participating in special politico-military mock war games.
- *Researching in the affairs of Iranian youth and preparation of special reports of various issues related to Iranian youth.
- *Participating journalist in the areas of arts and culture, parliamentary and military affairs for the Iranian newspapers and magazines.
- *Teaching at the National Teachers College.
- *Broadcaster for Radio Tehran.




