DURING LUNCH MEETING MAY 25, MOFA VICE MINISTER MATSUNAGA TOLD AMBASSADOR THAT WHILE GOJ UNDERSTOOD THE REASONS FOR THE THIRTY MINUTE BILATERAL AT THE SUMMIT BETWEEN THE PRESIDENT AND PRIME MINISTER, THEY STILL HOPED THAT IT MIGHT RUN A LITTLE LONGER, BUT REALIZED THAT NO SUCH COMMITMENT WOULD BE POSSIBLE. MATSUNAGA ALSO SAID THAT THE GOJ HOPED IT WOULD BE POSSIBLE FOR THE PRESIDENT TO MAKE A STATEMENT RECOGNIZING THE GREAT EFFORTS THAT BOTH GOVERNMENTS HAD MADE ON BILATERAL ECONOMIC ISSUES, PARTICULARLY TRADE, AND TO CONFIRM THE SUCCESSES THAT HAD BEEN ACHIEVED OVER THE PAST 18 MONTHS (I. E. NAKASONE'S TIME IN OFFICE). MATSUNAGA ALSO EMPHASIZED THAT HE UNDERSTOOD THAT THERE WERE STILL UNRESOLVED PROBLEMS THAT WE WOULD NEED TO KEEP WORKING ON IN THE FUTURE.

3. THE AMBASSADOR RESPONDED THAT THE VICE PRESIDENT HAD NOW WITHDRAWN FROM THE PROCESS BUT THAT INDEED WORK DID NEED TO CONTINUE, AND PROGRESS REMAINED NECESSARY ON A NUMBER OF ISSUES SUCH AS WOOD PRODUCTS. THE AMBASSADOR MADE NO COMMITMENT AS TO WHETHER THE PRESIDENT MIGHT MAKE THE TYPE OF STATEMENT REQUESTED BY MATSUNAGA. MATSUNAGA CONCLUDED THE DISCUSSION BY AGAIN STATING THAT WORK WOULD CONTINUE, AND THAT FOR THEIR PART THE GOJ HOPED THAT THE USG WOULD WORK TO GET THE SEMI-CONDUCTOR TARIFF ELIMINATED.

4. COMMENT: NAKASONE OBVIOUSLY IS APPROACHING THE SUMMIT WITH HIS NOVEMBER ELECTIONS IN MIND AND BELIEVES THAT AN ENDORSEMENT FROM THE PRESIDENT OF HIS SUCCESSFUL MANAGEMENT OF US-JAPAN ECONOMIC RELATIONS NOT ONLY SINCE THE PRESIDENT'S VISIT BUT OVER THE FULL 18 MONTHS OF HIS ADMINISTRATION WOULD BE USEFUL.

Embassy London has informed us that a group of 25-30 younger members of the Conservative Party's Parliamentary Group would like to meet with President Reagan during the President's stay in London to present him a letter of welcome and appreciation for the President's strong support of NATO. The Department recommends that if the President's schedule permits, this event be included. SUMMARY: FCO TELLS US THAT GEOFFREY HOWE STRONGLY SUPPORTS AN INITIATIVE FROM YOUNG TORY MPS TO MEET WITH THE PRESIDENT TO PRESENT A LETTER OF WELCOME AND APPRECIATION FOR THE PRESIDENT'S STRONG SUPPORT OF NATO. WE THINK IT COULD BE FIT IN ON D DAY JUNE 6 TO GOOD EFFECT. THIS IDEA HAS BEEN DISCUSSED WITH JIM HOOLEY.

2. CONSERVATIVE MP PETER VIGGERS HAS CONTACTED US TO PROPOSE THAT HE AND "25 TO 30" OTHER CONSERVATIVE MPS MEET WITH THE PRESIDENT DURING HIS VISIT TO PRESENT A LETTER OF WELCOME AND OF APPRECIATION FOR THE PRESIDENT'S STRONG SUPPORT OF NATO. HE SUGGESTS THAT A GROUP OF MPS COULD BE ASSEMBLED FOR THIS PURPOSE FROM LATE ON MONDAY, JUNE 4 TO LATE THURSDAY, JUNE 7. THEY WOULD COME TO THE PRESIDENT, FOR EXAMPLE TO WINFIELD HOUSE, AT A TIME OF OUR CHOOSING.

3. VIGGERS HAS JUST TAKEN OVER FROM WINSTON CHURCHILL AS HEAD OF THE TORY "CAMPAIGN FOR DEFENSE AND MULTILATERAL DISARMAMENT." HE ALSO COORDINATES BACK BENCH PUBLIC AFFAIRS EFFORTS TO COMBAT THE CAMPAIGN FOR NUCLEAR DISARMAMENT. HE TELLS US THAT HE AND HIS COLLEAGUES BELIEVE THAT PRESIDENTIAL MEETING WITH MPS WOULD EVOKE CONSIDERABLE MEDIA COVERAGE IN BRITAIN AND HELP OFFSET THE EFFECT OF ANTI-NUCLEAR DEMONSTRATIONS PLANNED DURING THE PRESIDENT'S STAY.

4. THE FCO HAS CONTACTED US SEPARATELY TO SAY THAT FOREIGN MINISTER HOWE STRONGLY SUPPORTS THE VIGGERS' INITIATIVE AND HAS ASKED THAT WE GIVE VIGGERS' IDEA EVERY CONSIDERATION.

SUBJECT: U.S.-Japan Energy Cooperation

It is important that we emphasize our continued support for expanded energy trade between the U.S. and Japan in order to convince Prime Minister Nakasone and the Japanese that we are serious about following through with the commitments made in the November 1983 Joint Statement. Attached is a copy of the Joint Policy Statement (Tab I).

We have made solid progress since November:

- o MITI has successfully assembled a group of companies to participate in a feasibility study for the joint U.S.-Japanese development of North Slope gas.
- o Contracts have been signed for the purchase of 11 million metric tons of metallurgical coal, thereby reversing the decline in Japanese imports of U.S. metallurgical coal.
- o The U.S.-Japan coal mission went well. The group established a Standing Technical Committee to follow up on the Joint Policy Statement.
- o An amendment to the Senate version of the Export Administration Act would create a Presidential advisory commission to study the export of U.S. crude oil, particularly Alaskan North Slope oil, and to make recommendations on such exports before January 1, 1985.

In your pre-brief with the President, you should urge that he call attention to the progress made to date and emphasize the importance of expanded coal trade.

Suggested Talking Point

- o Excellent progress has been made in implementing our November Joint Policy Statement, especially with respect to natural gas and the U.S.-Japan coal trade mission. I place great emphasis on carrying forward

with the spirit of that statement, especially in the area of expanded U.S.-Japan coal trade and joint development of U.S coal resources.

Gaston ~~Sigur~~ concurs.

RECOMMENDATION:

That you raise U.S.-Japan energy cooperation with the President and suggest he raise the issue with Prime Minister Nakasone.

JOINT STATEMENT BY THE PRESIDENT
AND PRIME MINISTER NAKASONE
ON JAPAN-U.S. ENERGY COOPERATION

Prime Minister Nakasone and President Reagan share the view that further progress be made in energy trade and cooperation in oil, natural gas and coal between Japan and the United States as outlined in the following Joint Policy Statement recommended by the Japan-United States Energy Working Group:

Taking account of the energy prospects for the entire Pacific basin, the two countries agree that the sound expansion of U.S.-Japan energy trade will contribute to the further development of the close economic and energy security relationship which exists between the two countries.

They will continue to discuss and find ways of developing this trade for the mutual benefit of both countries, noting the importance of long-term cooperation, the central role of the private sector, and the need for a balance between economic cost and energy security.

Both countries consider Alaska to be a particularly promising area for joint development of energy resources. Both governments will encourage private sector discussions regarding the possibilities for such development.

With regard to trade in oil, gas and coal, we have agreed on the following next steps:

- A. The U.S. and Japan recognize that if legislative barriers can be removed, the U.S. has the potential to ship substantial quantities of crude oil to Japan, thereby increasing economic incentives for U.S. oil production and helping to diversify Japan's energy sources. The U.S. will continue to keep under review the removal of restrictions on exports of domestic crude oil.
- B. The U.S. and Japan will encourage private industry in both countries to undertake now the pre-feasibility or feasibility studies necessary to determine the extent to which Alaskan natural gas can be jointly developed by U.S. and Japanese interests.
- C. The U.S. and Japan will encourage private industry in both countries to discuss the possibility of concluding long-term coal contracts and jointly developing mines and transportation systems to make American coal more competitive in the Japanese market.
- D. In this regard, the two countries welcome the examinations underway of the technical and economic aspects of several steam coal projects by private companies concerned on both sides. As economic recovery proceeds, Japan will encourage its industries to consider purchase of more competitively priced U.S. steam coal to meet future demands not already covered by existing contracts. In addition, Japan will invite the private sector concerned to explore the possibility of further increasing substitution of coal for oil in electrical generation.

- E. With regard to metallurgical coal, both sides noted that the depressed state of world steel manufacturing had reduced demand for traded coal. However, in view of the fact that the U.S. has been a major supplier to the Japanese market, both sides will endeavor to maintain the level of Japanese imports of U.S. coal. Japan expects that imports of competitively priced U.S. metallurgical coal will not continue to decline, and will encourage its steel industry to increase U.S. coal imports when conditions in the industry permit.
- F. As a first step toward developing U.S.-Japan coal trade, from a mid- to long-term prospective, a mission composed of representatives of major Japanese coal users and other appropriate interests will visit the U.S. to meet with major coal mining and transportation interests. The purpose of this mission will be to explore the possibility of expanding coal trade between the U.S. and Japan, and the possibility of conducting a major study of the opportunities for reducing the delivered price in Japan of U.S. coal.

-- But open to discussion of Sov non-use of force proposal as part of dialogue including concrete NATO package.

NON-PROLIFERATION

I. Comprehensive Safeguards

-- Gratified by decision of 7 and others to attend July Luxembourg meeting on ways to strengthen peaceful nuclear cooperation. Meeting should strengthen common commitment to non-proliferation goals.

-- Hope for good discussions, including on US comprehensive safeguards proposal.

-- Comprehensive safeguards requirement for significant new nuclear exports to non-nuclear weapon states would greatly improve non-proliferation regime.

II. Non-Proliferation Treaty

-- NPT one of most important barriers to spread of nukes; serves interests of all.

-- Have made clear willingness in principle to assist, but expect to be asked publicly and to be granted access for our forces. Would weigh carefully and quickly any request for help in protecting shipping in Gulf.

-- Consider attitudes of Allies and regional states important in determining our policy; will of course consult with you.

-- If asked, we intend to protect access to international waters in Gulf and to maintain security of friendly Arab states in region.

-- Appreciate participation and comments of observers from many Allied countries.

-- Nicaragua remains key. For lasting peace, must remove Sov/Cuban presence, democratize, reduce armed strength, stop supporting subversion.

OTHER REGIONS: Central America

-- US supports Contadora process, Document of Objectives promises to address our concerns over Nicaragua.

-- Skeptical that Nicaragua will accept necessary implementing measures, but pressure on Managua greater now.

-- November Nicaraguan election potentially important, but believe Sandinistas plan contest with democratic trappings which allows for no threat to regime.

OTHER REGIONS: Middle East

-- Peace settlement only achievable thru direct Arab-Israeli negotiations.

-- Our Sept. 1 proposal remains basis of our policy.

-- Israeli, US and Egyptian elections complicate next several months.

-- Must recognize negatives: Jordan key but Hussein not prepared to talk unless other Arabs/PLO support him; Israel has continued settlements; Syria opposed to negotiations.

OTHER REGIONS: Middle East

-- Ours low-profile approach, seek opportunity advance peace process late this year.

-- US commitment to Israeli security unwavering.

-- Also support Arab friends, under great pressure from radicals and Soviets; will help them meet legitimate defense needs.

-- We remain diplomatically active in Lebanon. Believe our endeavors there right thing in spite of frustrations/setbacks.

OTHER REGIONS: Afghanistan

- Insurgency unabated.
- Massive Sov offensive is escalation born of frustration.
- Sovs unable to increase popular base for regime; unable create effective Afghan army.
- Expect fighting to continue thru summer, perhaps heavy casualties both sides.
- Sov aggression must not succeed. UN talks blocked by Sov intransigence; we Pakistan's efforts.

OTHER REGIONS: Southern Africa

- Intensive US diplomacy aimed at bringing Namibian independence with continued security for region.
- Asst Sec Crocker just in region; met with parties to negotiations.
- Disengagement of forces in southwestern Angola continues relatively smoothly; scheduled to be completed very soon.
- Will remain steadfast in pursuit of settlement in Western interest. Value Allied support thru Contact Group or more broadly.

OTHER REGIONS: East Asia

-- Trip to China went well; Chinese clearly wanted success. Signed/initialed several agreements, including on peaceful uses of nuclear energy.

-- Apparently Chinese dual strategy - relax tensions with Sovs thru negotiations, trade and exchanges, while improving relations with US and countering Sov moves in areas of vital concern.

-- On Kampuchea, Vietnam should withdraw and allow Khmer self-determination thru internationally-supervised elections.

OTHER REGIONS: East Asia

-- On Korea, problems should be resolved peacefully by Koreans themselves.

-- Seoul govt must be full and equal participant in any talks on Korea.

-- If both Korean parties agree, we would support quadripartite talks involving two Koreas, US, China.

-- In interim, support confidence-building measures which would reduce tensions, such as telephone and postal links and family reunification.

Bill --

During Larry Speakes' 4:30 p.m. meeting today, he asked Bob Sims (and other assembled ears) whether there was a comprehensive compilation of Presidential statements on the necessity to keep the Gulf open. Larry thought a history of those statements would be useful in the event the Gulf situation worsens and becomes more of an issue during the President's trip.

Bob and several others mentioned that such statements could be culled from the files, albeit with some difficulty. I told Larry that you had tasked State to prepare a briefing book for contingency use, and perhaps could ask State to include the Presidential statements in its material. Larry nodded in agreement and I promised to follow up with you.

Given your departure early a.m. tomorrow, perhaps you could phone Wendt or Burns tonight and ask them to cable you the desired information while you are in Ireland ... or whatever. In any event, I wanted to reinforce to Speakes that this is your turf and you should be cut in from all aspects.
