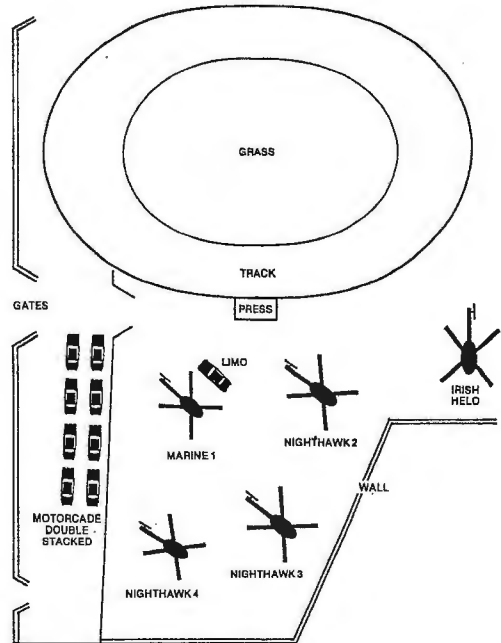

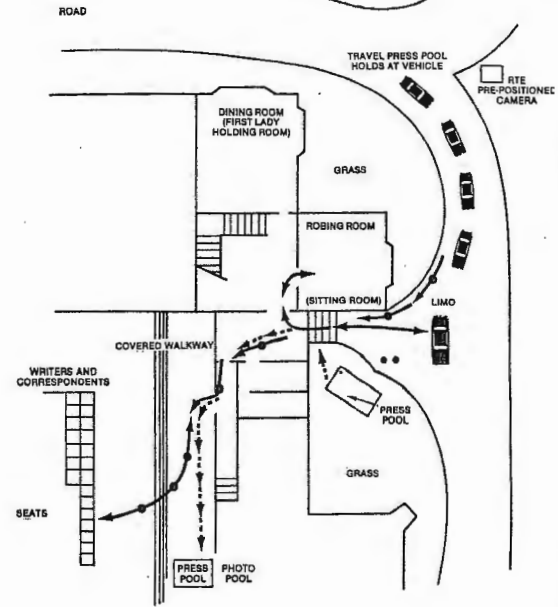

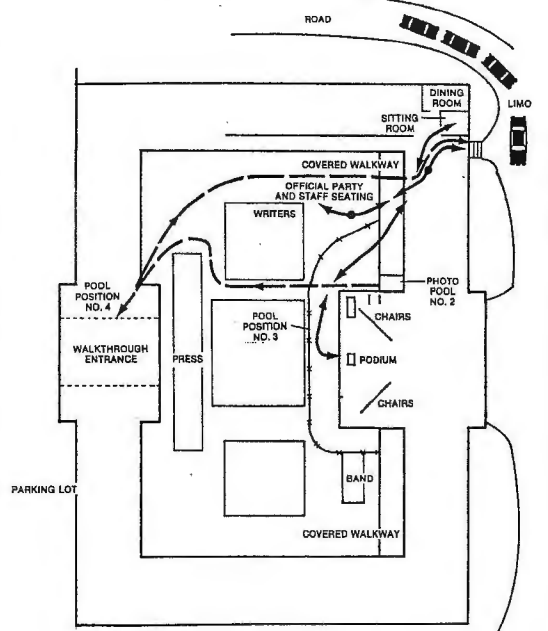

ARRIVAL/DEPARTURE



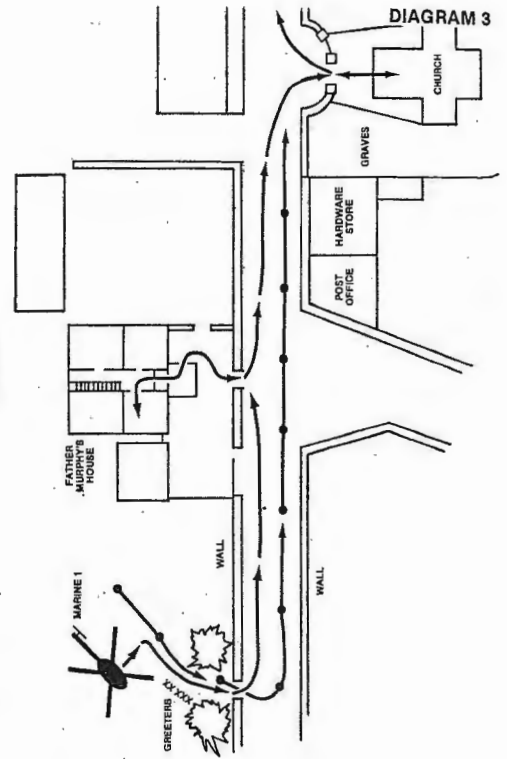

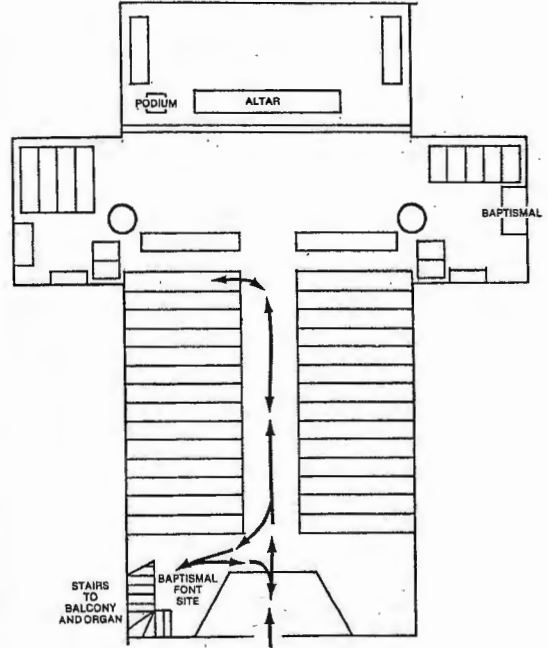

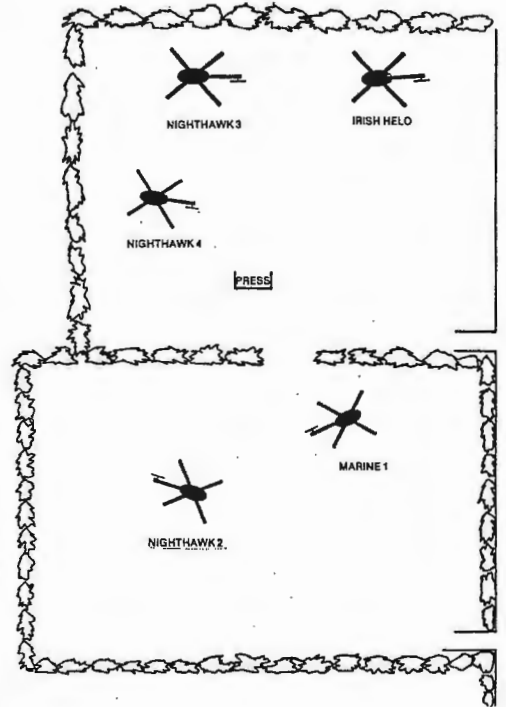

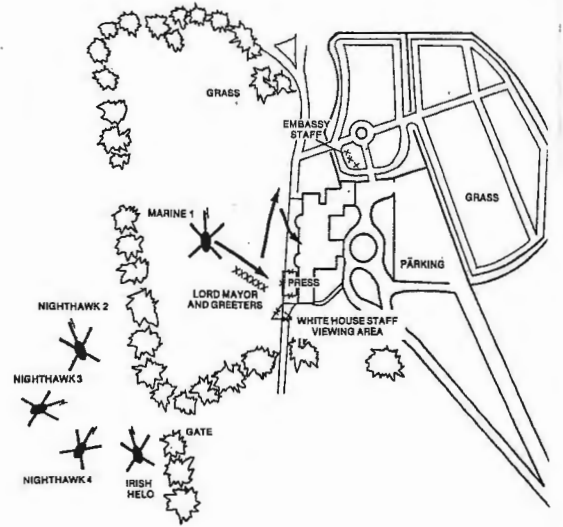

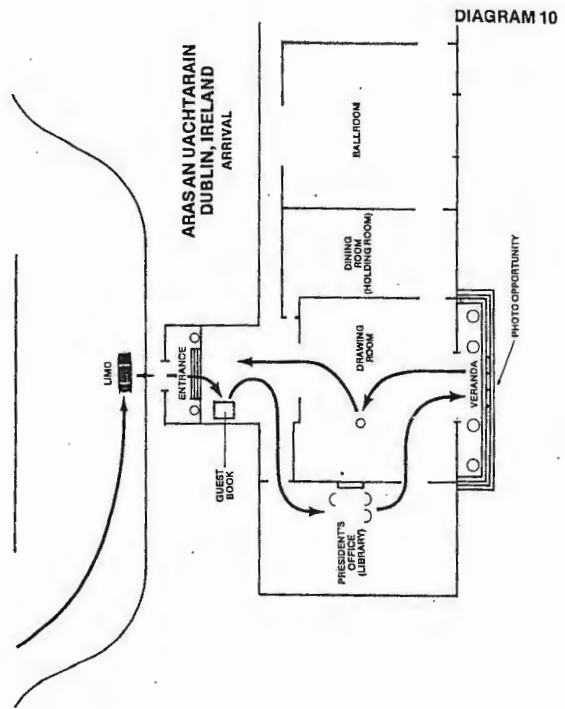

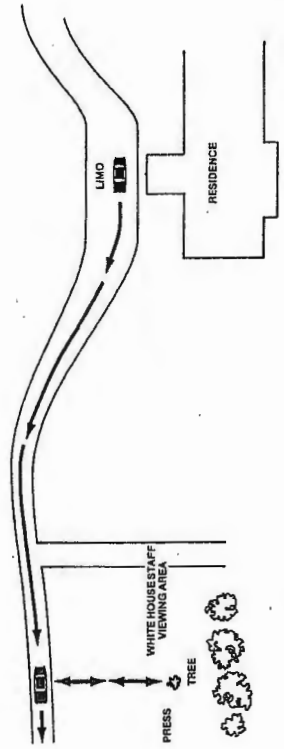

GROUND FLOOR

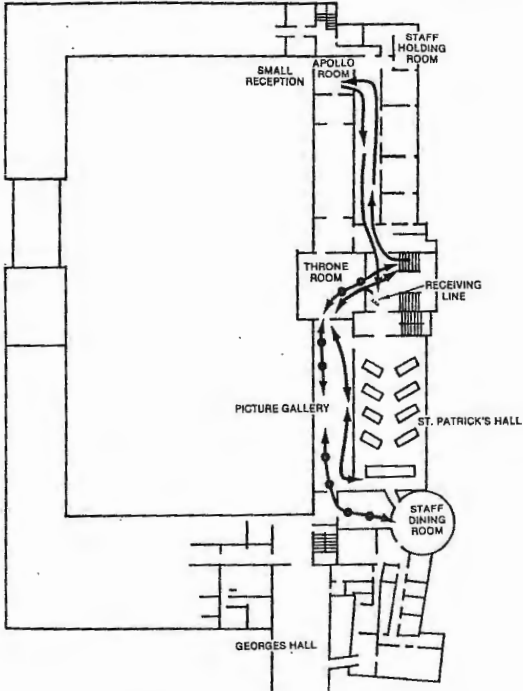

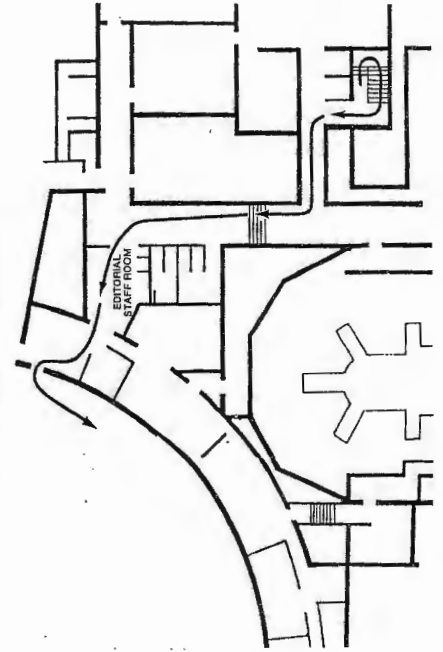
TAOISEACH BUILDING/LEINSTER HOUSE

FIRST FLOOR



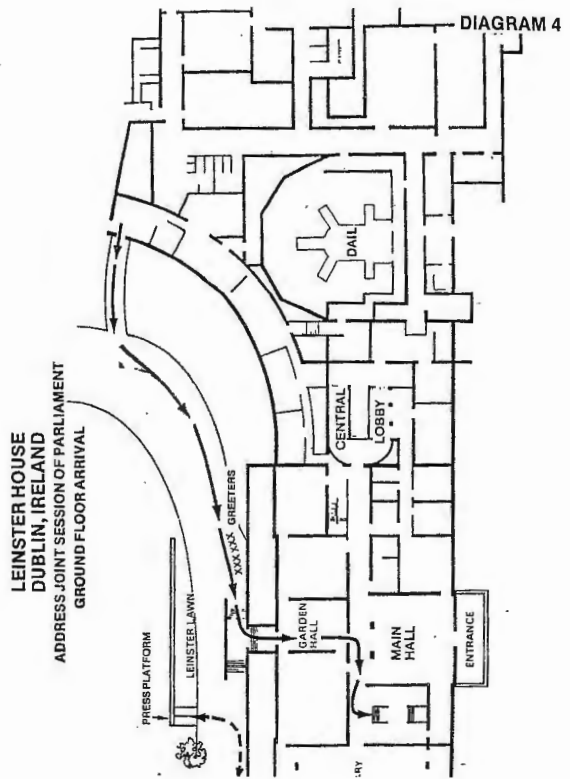

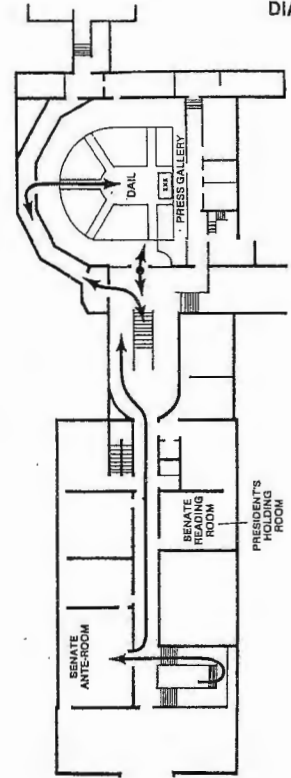

ADDRESS JOINT SESSION OF PARLIAMENT - THE DAIL

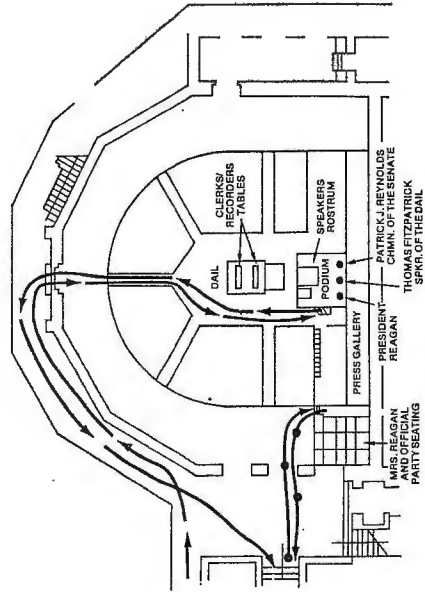
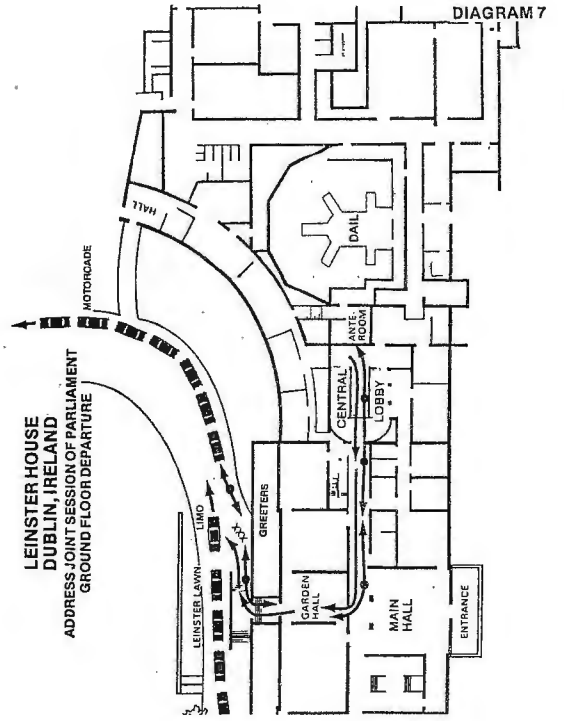


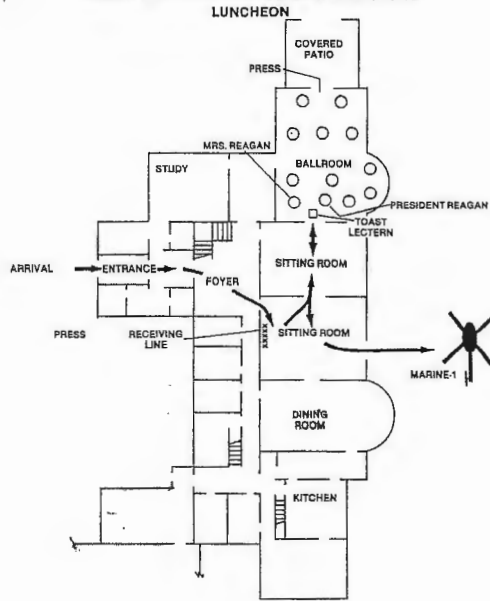

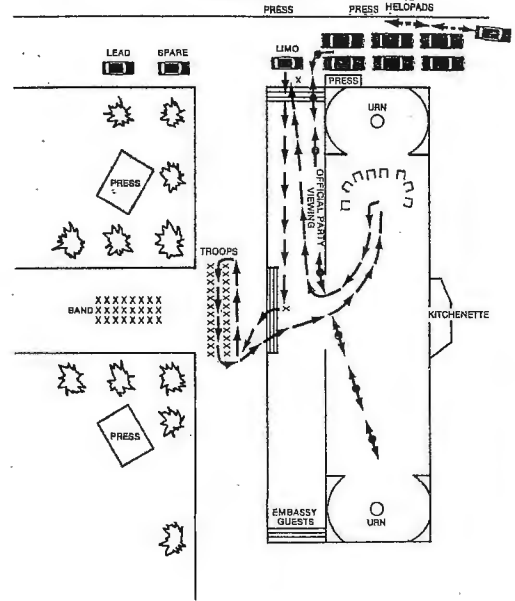

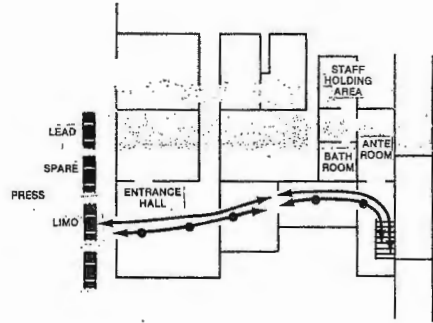

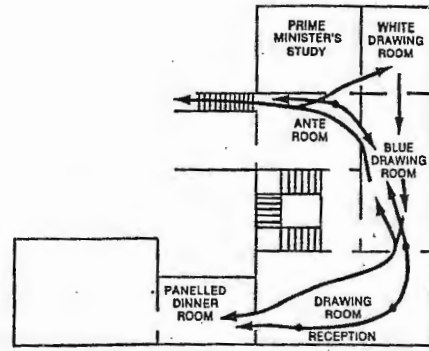
