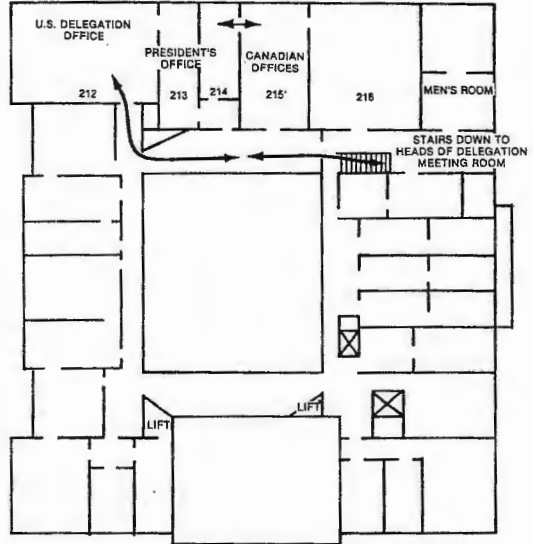

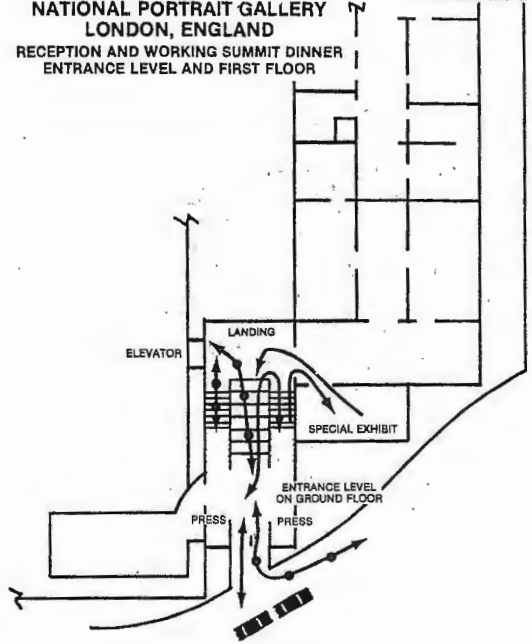

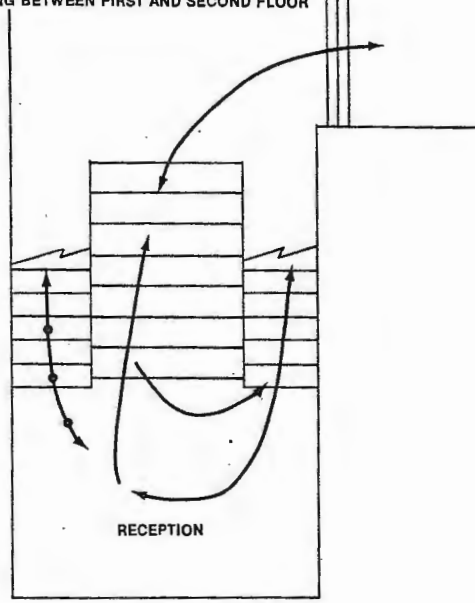

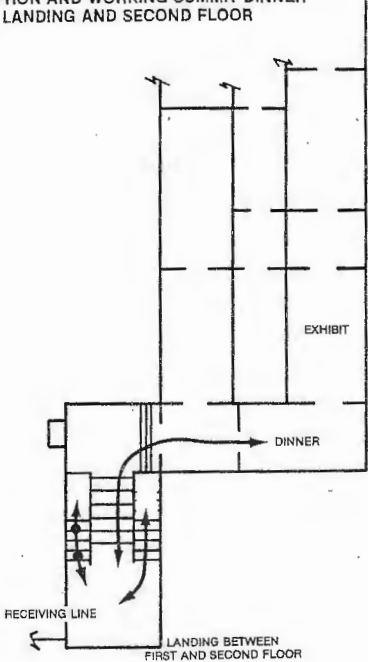

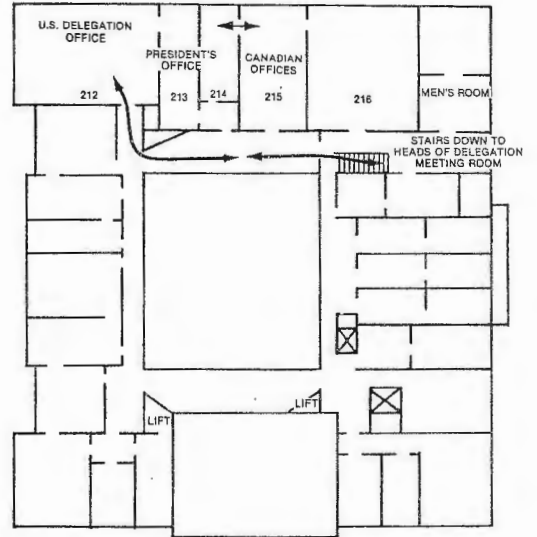

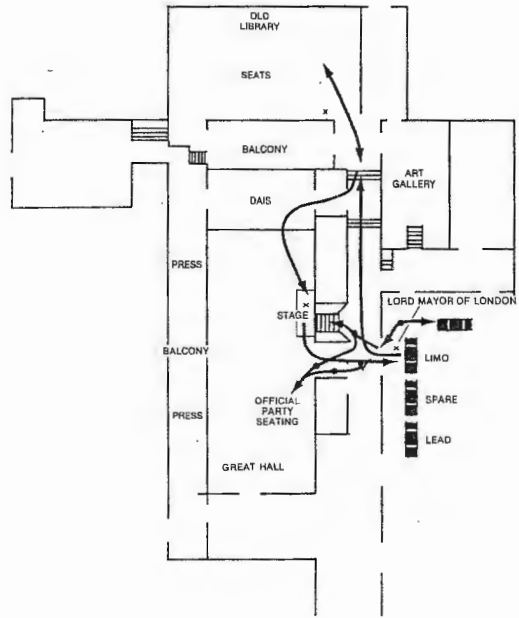

JOINT PRESS STATEMENT, GROUND FLOOR

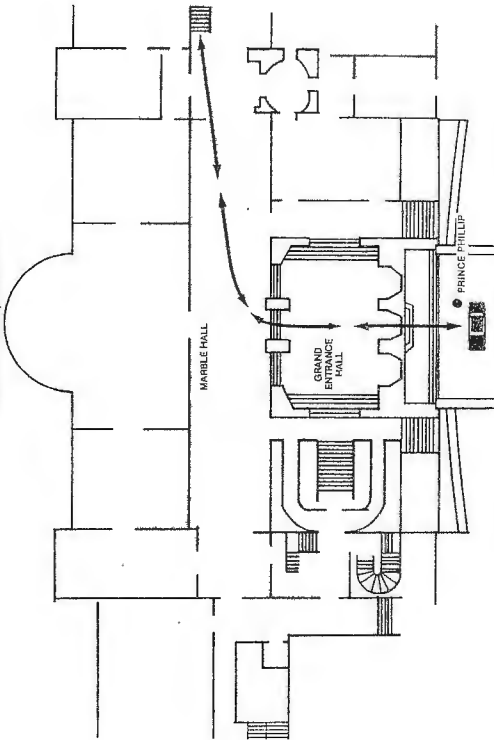

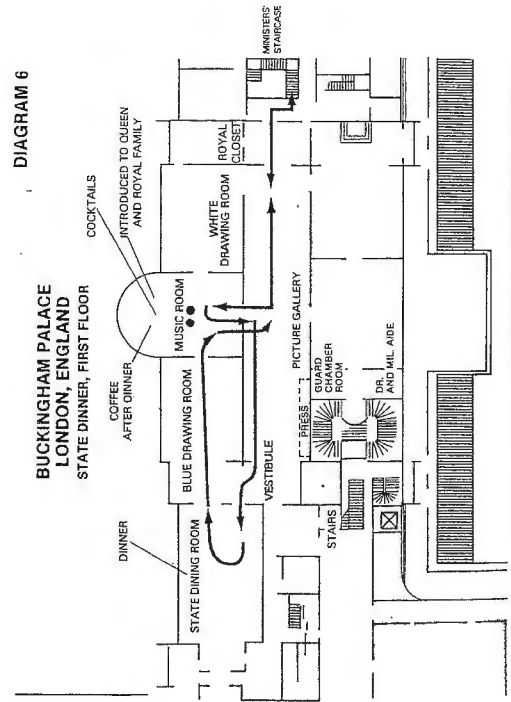

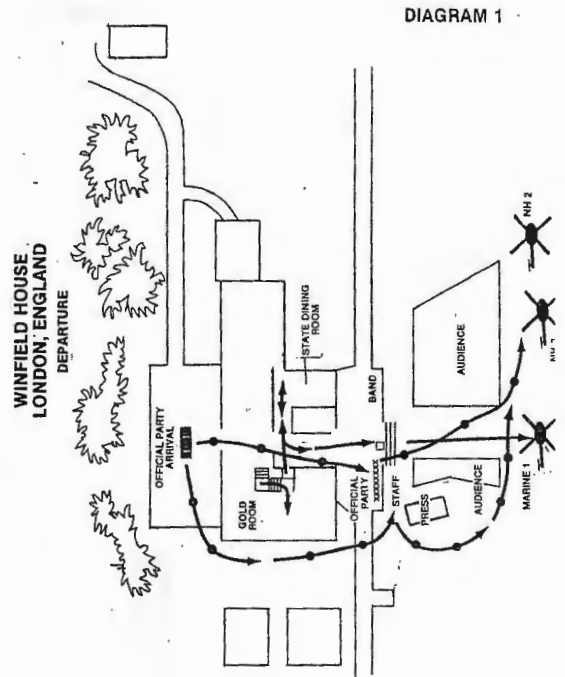
