1. ON DECEMBER 5, AMBASSADOR ATHERTON RECEIVED BY COMMERCIAL TELEGRAM THE FOLLOWING MESSAGE FOR PRESIDENT REAGAN.

BEGIN QUOTE: ALL PARTICIPANTS OBSERVING THE INTERNATIONAL DAY OF SOLIDARITY WITH THE PEOPLE OF PALESTINE, WHICH WAS ORGANIZED BY THE UNITED NATIONS ASSOCIATION OF EGYPT AND THE SOCIETY OF HUMAN RIGHTS SUPPORTERS IN CAIRO, AND WHICH WAS HELD ON NOVEMBER 29, 1982 AT AL-AZHAR UNIVERSITY, AND WHICH BROUGHT TOGETHER HIGH-LEVEL REPRESENTATIVES OF THE GOVERNMENT OF EGYPT AND THE PALESTINE LIBERATION ORGANIZATION, AS WELL AS MEMBERS OF THE FACULTY AND STUDENTS OF AL-AZHAR UNIVERSITY, AND MEMBERS OF THE TWO SPONSORING ASSOCIATIONS, AND PALESTINIANS LIVING IN EGYPT, AND REPRESENTATIVES OF THE EGYPTIAN AND FOREIGN INFORMATION MEDIA--ASKED TO CONVEY TO PRESIDENT REAGAN THEIR SUPPORT FOR HIS PEACE PLAN FOR THE MIDDLE EAST AND THEIR APPRECIATION FOR THE EFFORTS OF THE PRESIDENT OF THE UNITED STATES OF AMERICA AND HIS ADMINISTRATION TO RESOLVE THE PALESTINIAN PROBLEM

MESSAGE (CONTINUED):

AND TO SECURE THE PALESTINIANS' INALIENABLE RIGHTS TO SELF-DETERMINATION AND A SOVEREIGN STATE. WE ALL WISH YOU, MR. PRESIDENT, CONTINUED SUCCESS IN YOUR ENDEAVORS TOWARDS A JUST AND LASTING PEACE IN THE MIDDLE EAST FOR THE SAKE OF ALL ITS PEOPLES AND THE WHOLE OF THE HUMAN FAMILY. (SIGNED)

SUBJECT: AMERICAN CHAMBER MESSAGE TO PRESIDENT REAGAN

1. THE AMERICAN CHAMBER OF COMMERCE IN EGYPT HAS ASKED THAT THE FOLLOWING MESSAGE BE PASSED TO PRESIDENT REAGAN VIA HOWARD TEISCHER AT THE NSC.

QUOTE. DEAR MR. PRESIDENT,

THE AMERICAN CHAMBER OF COMMERCE IN EGYPT IS EXTREMELY CONCERNED WITH RECENT PROPOSALS TO REDUCE THE U.S. FINANCIAL COMMITMENT TO EGYPT. SUCH AN ACTION WOULD UNDERMINE IRREPARABLY THE EFFORTS FOR PEACE AND PROGRESS IN THIS PART OF THE WORLD. AMERICAN PRIVATE ENTERPRISE HAS ACCEPTED EGYPT'S INVITATION THROUGH THE OPEN DOOR POLICY AND HAS JOINED THE COMMITMENT OF THE AMERICAN PEOPLE TO THE PEOPLE OF EGYPT. THIS PARTNERSHIP FOR PROGRESS MUST NOT BE UNDONE. WE URGE YOU, MR. PRESIDENT, TO MAINTAIN OUR FULL COMMITMENT OF U.S. AID TO EGYPT.

MESSAGE (CONTINUED):

AMERICAN CHAMBER OF COMMERCE IN EGYPT. UNQUOTE.

2. THE AMERICAN CHAMBER HAS ALSO ASKED THAT THIS MESSAGE BE BROUGHT TO THE ATTENTION OF SECRETARY OF STATE SHULTZ, SECRETARY OF COMMERCE BALDRIGE, US AID DIRECTOR MCPHERSON AND US CHAMBER OF COMMERCE PRESIDENT LESHER. EMBASSY SUGGESTS THAT USDOC/ONE MCQUEEN HAVE THIS MESSAGE BROUGHT TO THE ATTENTION OF SECRETARY BALDRIGE AND AS WELL PASSING A COPY TO JOHN SARPA AT THE CHAMBER FOR FORWARDING TO DR. LESHER. EMBASSY WOULD APPRECIATE STATE/NEA PROVIDING COPY OF THE ABOVE MESSAGE TO MR. MCPHERSON, AS WELL AS USAID ASSISTANT ADMINISTRATOR ANTOINETTE FORD, WHO WAS ADVISED OF THIS MESSAGE DURING HER VISIT TO EGYPT.

3. THE AMERICAN CHAMBER OF COMMERCE IN EGYPT HAS TO DATE 88 CHARTER MEMBERS REPRESENTING MAJOR US COMPANIES AND

THOSE EGYPTIAN COMPANIES WITH SIGNIFICANT RELATIONSHIPS WITH AMERICAN COMPANIES. THE CHAMBER PLANS TO SEND FOLLOW-UP MESSAGES TO MEMBERS OF CONGRESS IN JANUARY AFTER THE CHRISTMAS RECESS. FYI. THE CHAMBER WILL HOLD ITS FIRST FORMAL ELECTIONS IN JANUARY. ALTHOUGH THE ABOVE MESSAGE HAS BEEN RELEASED BY THE INTERIM LEADERSHIP OF THE CHAMBER, THE MESSAGE CLEARLY REPRESENTS A STRONG CONSENSUS BY THE AMERICAN CHAMBER MEMBERSHIP. THE AMERICAN CHAMBER WILL CONTINUE TO ADVOCATE STRONG USAID ECONOMIC DEVELOPMENT SUPPORT TO EGYPT. ATHERTON
