Dear Mr. President:

We understand that the selection process is now well underway for the United States delegation to the International Conference on Population, to be held in Mexico City next summer.

A previous such conference, held in Bucharest in 1974, did much to lay the groundwork for aggressive promotion of abortion in the Third World. It is essential that the American delegation to the Mexico City conference fully reflect the Administration's pro-life policies. The delegation should be led by individuals who will firmly communicate the American government's position that abortion is not a method of "family planning," and who will strongly oppose any resolutions which advocate or promote abortion in any way.

We strongly recommend as delegation leaders Radio Free Europe President James Buckley and Surgeon General C. Everett Koop.


Dear Mr. Ogden:

Thank you for your letter of January 28, 1984, to President Reagan concerning your suggestion to have Congressional Medal of Honor recipients represented in the American delegation to the 40th anniversary observances of D-Day.

There are two parties scheduled to participate in the observance of World War II commemorative events in Europe this spring. The first, headed by General Mark Clark, U. S. Army Retired, and including the commissioners of the American Battle Monuments Commission, will serve as special envoys to Italy for the observance of the liberation of Rome on June 2, 1984, as the guest of Ambassador Rabb. This group will then move on to Paris and Normandy in their capacity as managers of our overseas cemeteries. Their travel arrangements were completed some time ago.

The Presidential party is tentatively scheduled to participate in Normandy ceremonies as a part of an extended European trip. The circumstances here too would not permit your inclusion.

SUBJECT: Proposed Presidential Delegation to the
Celebration of the Independence of Brunei

Brunei, an important mini-state on the island of Borneo in the South China Sea, will gain its independence from the UK on December 31, 1983. This event will be celebrated on February 23, 1984. The hereditary Sultan and Chief of State is inviting a number of heads of state or their representatives to attend the ceremony in February; we expect shortly to receive an invitation.

Brunei has substantial petroleum resources and has indicated an interest in expanding ties with the US; two American oil firms recently acquired exploration leases. Brunei offers significant opportunities for US business and investment; the US is already Brunei's third major source of imports. Additionally, Brunei is slated after independence to become the sixth member of ASEAN, as well as a British Commonwealth member. I believe it is important to send a high level delegation for the independence ceremonies to underscore the importance we attach both to ASEAN and to the integrity of independent nations in that critical part of the world.

A small state (about the size of Delaware), Brunei has commensurately limited visitor accommodations. Therefore, if the decision is to send a delegation, I would recommend one of no more than seven members. We are still pursuing the question of spouses' participation. There may well be no separate program for wives, and Princess Diana will not accompany the Prince of Wales who will head the British

delegation. For these reasons, we suggest that participation by spouses be limited to the wife of the head of our delegation.

The Bureau of East Asian and Pacific Affairs has suggested that the delegation be headed by the Deputy Secretary, who is already considering an Asian regional trip in the same time frame. Phil Habib as a prominent public figure well known in the area would also merit consideration as a delegation member. Deputy Assistant Secretary for Southeast Asia, John Monjo, would also be an appropriate member.

In terms of Congressional participation, you may wish to consider inviting Senator Murkowski, Chairman of SFRC East Asian Subcommittee, and Congressman Fascell, prospective Chairman of the House Foreign Affairs Committee.

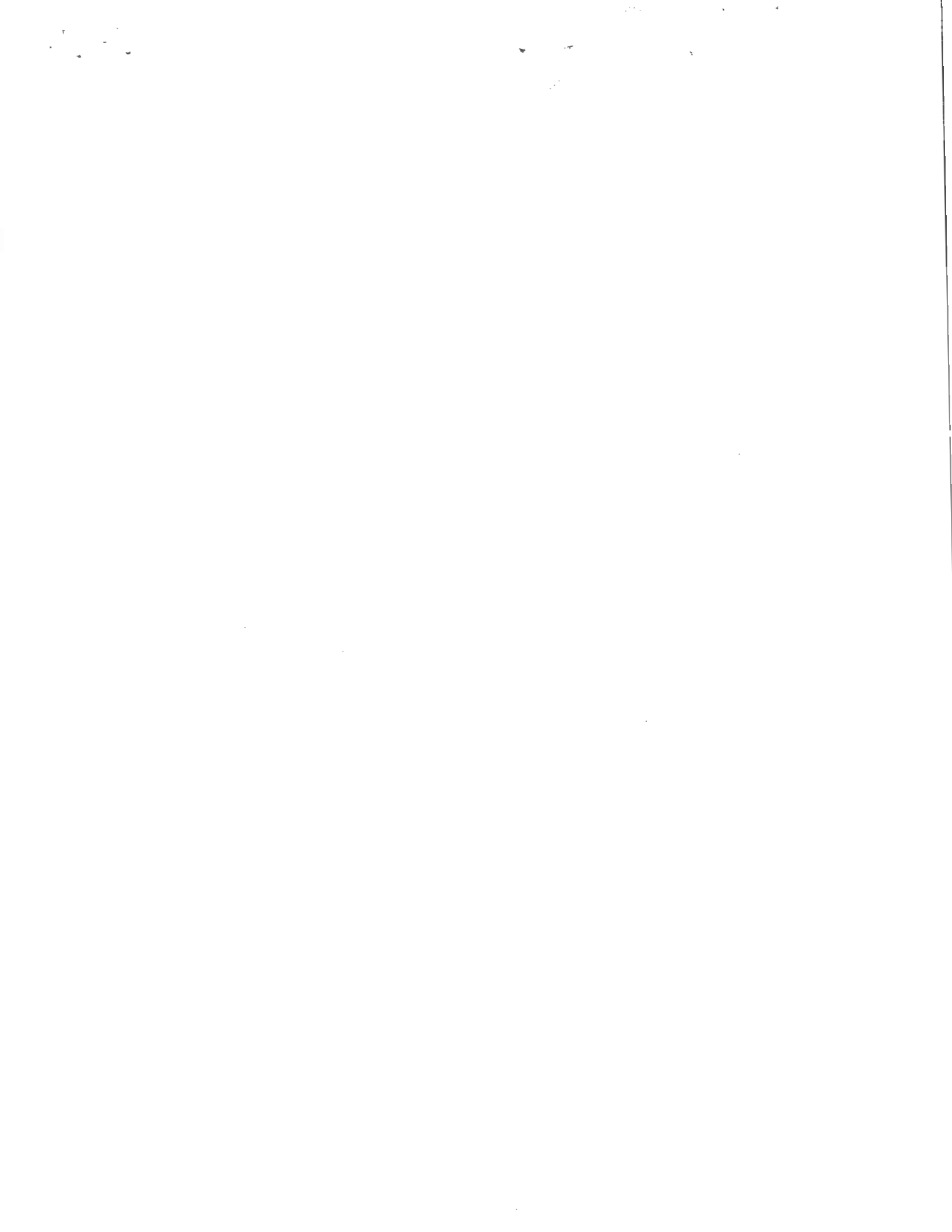


