SUBJECT: Weekly Report of Defense Activities

My NATO and French Trip Report: I gave you, yesterday, a separate memorandum covering my trip report. (U)

Visit with Republic of Korea (ROK) Minister of National Defense: On Thursday, I hosted a working lunch for ROK Minister of National Defense Yoon Sung Min. Minister Yoon came to the United States to be present for the Detroit Wednesday roll-out of a tank developed in conjunction with our Army to meet Korean requirements. Paul Thayer represented me at the roll-out ceremony because I was still at NATO meetings. Minister Yoon and I signed a Memorandum of Understanding on co-production in Korea of self-propelled 155mm howitzers. The new ROK indigenous tank and the selfpropelled howitzer will improve Korea's ability to counter the heavily mechanized North Korean forces. We also reviewed the status of other defense issues. I agreed to attend the next annual Security Consultative Meeting, which will be held in Secul next May. Minister Yoon expressed again his appreciation and that of President Chun for your November visit and your strong reaffirmation of the U.S. commitment to the Republic of Korea. (S)

Lebanese Security Assistance Program Update: November marked the first anniversary of the implementation of the Lebanese Army Modernization Plan (LAMP). During this first year we have shipped large quantities of materiel and implemented an ambitious training program.

We have delivered on or ahead of schedule 102 tanks, 275 tracked vehicles, 30 155mm howitzers, over 1,400 wheeled vehicles, approximately 9,000 tons of ammunition, and large quantities of communication equipment, uniforms, tentage, spare parts, and support equipment. Additional materiel is in the pipeline and new requirements continue to be identified.

We have deployed 29 Mobile Training Teams or Technical Assistance Teams. The 19 teams that have completed their missions provided more than 500 man months of training. The 10 teams currently

in country have 102 men assigned and will provide an additional 540 man months of training. Requirements for 14 additional teams have been identified; they will deploy during the next few months.

The LAMP is in a sound financial position at this point. With total requirements valued at nearly \$600 million, \$533 million have been collected and progress payments are current. The Lebanese have committed \$108.4 million of their available Foreign Military Sales (FMS) credits, leaving \$36.6 million in FMS credits that may be applied to future requirements. However, Lebanese funds may be nearly exhausted and, if major new materiel requirements are identified, funding may be difficult. The Lebanese may soon request increased FMS credits, forgiven credits, or Grant Aid.

The most active non-U.S. support to date has been from the They have provided ammunition and aircraft modifications French. and have contracted to provide 10 helicopters, 135 tanks, armored personnel carriers (APCs) and armored cars, and three landing craft. They have offered \$81.4 million of credit for these purchases. The Italians have contracted to sell 80 APCs. However, they have delayed delivery for unspecified reasons, and these APCs have not yet been released to the Lebanese. The Lebanese also requested an offer for Agusta Bell helicopters but have not yet received this offer. Jordan has agreed to provide, at no cost, 40 tanks. Twenty of these have been delivered and the remaining 20 have been delayed for unspecified reasons. Jordan has also agreed to provide training support. The Lebanese are purchasing recoilless rifles from Korea, assorted items from Romania, and are attempting to buy some used aircraft from Chile.

The tight delivery schedules and large quantities of materiel shipped during the past year have required intensive management by the OSD, JCS, and service staffs. Our success in meeting or beating LAMP schedules attests to the effectiveness of these efforts. There are still many items in the pipeline and several new offers have been issued recently. We are continuing to take all appropriate actions to ensure continued success in this program. (S)

Defense Industrial Cooperation with Pakistan: A draft Memorandum of Understanding for defense industrial cooperation with Pakistan has been staffed and provided to the Pakistan Embassy. We hope to complete negotiations within the next few months and begin the cooperation programs early next year. Separately, arrangements have been completed for a visit in January of the Pakistani munitions chief and a lease has been provided to them that will provide Pakistan with unused plant equipment for munitions production. (C)

Savings in Spare Parts Acquisition: In three recent actions, the Navy Ship Parts Control Center (SPCC) obtained voluntary refunds from contractors totaling \$94,128 in the procurement of spare parts.

In the first case, an SPCC purchasing agent noted that the latest quoted price for an oil purifier skimmer was considerably less than previous unit prices. The purchasing agent notified the manufacturer, who subsequently acknowledged an error on the earlier price and refunded \$6,365, the difference between the originally billed price and the corrected price.

In another action, a Navy supplier notified SPCC of a price correction on an order for the purchase of two valve caps. The original price of \$20,778 per cap was corrected by the supplier to \$5,029. An SPCC purchasing agent than routinely checked the past history of the item and found an earlier purchase for two of the same valve caps at the higher price. The supplier was notified and agreed to a refund on the earlier contract. This combination of actions resulted in a refund totaling \$62,996.

In the third case, the Defense Contract Administration Service advised SPCC that the most recent negotiated price of a turbine blade set was \$22,996, as compared to an earlier procurement of the identical item at \$47,763 per set. The contractor was notified of the price disparity and agreed to refund \$24,767 on the earlier purchase.

Both the aggressive actions by SPCC procurement personnel and the cooperation of the contractors involved were supportive of our Ten Point Program to improve the acquisition of spare parts. (U)

Shelter for the Homeless: In an effort to improve the effectiveness of this program, which we began last year, we have examined the ten cities identified by the National Citizens Committee on Food and Shelter (Atlanta, Georgia; Baltimore, Maryland; Boston, Massachusetts; Cleveland, Ohio; Detroit, Michigan; District of Columbia; Memphis, Tennessee; Pittsburgh, Pennsylvania; St. Louis, Missouri; and San Francisco, California) for ways we might be most effective. Specific Defense actions we have taken are:

 \$8 million has been included in the Defense Appropriations Bill to support this effort. This money will be used to pay for utilities and minor construction and renovation in support of the program.

Defense Assistance to New York City Police Department: In coordination with your staff, members of my staff met last month in New York with Police Department officials to discuss their needs.

As a result of the financial difficulties of the mid-1970s, the City finds itself with deteriorating infrastructure. The Police Department's current concern is with upgrading its equipment base in areas related to emergency service functions. Specifically, they have prepared a five-year plan to improve the equipment levels of Harbor, Tactical Patrol, Street Crime, Emergency Service, Aviation, and Mounted Units. They are hopeful that Defense can provide some of the needed equipment, on a loan or transfer basis, to hasten their re-equipment process and ease the burden on the city budget.

We will work with the Services to determine how best to connect the New York City Police Department with the GSA surplus distribution program to give them access to unneeded federal property. In addition, we will determine if the loan of active or reserve assets to the Police Department is a practical solution to some of their problems. We have promised them an initial response early enough to enable them to meet their budgeting and purchasing timetables. (U)

Chemical Weapons Destruction Verification Workshop: In mid-November Defense participated in a workshop on chemical arms control conducted at the Tooele Army Depot, near Salt Lake City. The workshop evolved from discussion earlier this year between Defense and ACDA and was sponsored by ACDA and supported by Defense. The major theme was verification of chemical stockpile destruction. This is one of several unresolved critical verification and compliance issues and the one for which there has been some recent progress at the Committee on Disarmament

talks in Geneva. The workshop was well attended (about 50 foreign participants from 30 countries), the presentations were of high quality, and the discussion was spirited and substantive.

The highlight of the workshop was a demonstration of verification techniques applied to a chemical weapons destruction process, and the participants (and press) observed the destruction of 155mm artillery projectiles containing nerve agent. The purpose was to demonstrate the verification measures discussed in a U.S. paper offered to the Committee on Disarmament earlier this year (a small number of continuous on-site inspectors supported by appropriate monitoring, sampling, and weighing equipment). For most of the delegates it was their first opportunity to observe such a process, and this experience should serve them well when they return to the more abstract environment of the negotiating table. The Soviet Union was invited but declined to participate. (U)

Defense Action Plan for Increased Voluntarism: In support of our efforts to maintain and strengthen good will and cooperation between military installations and communities, this week we published our Action Plan for Voluntarism. The key points in the plan are the establishment of a volunteer task force, the formation of a Departmental clearinghouse with a network of command or installation clearinghouses, the development of promotional materials, and the encouragement and extension of existing volunteer models (e.g., Health Fairs, Adopt-a-School). We will also be pushing for amendments to the U.S. Code, Title 31, to protect volunteers under the Tort Claims Act and to give them some tax credits for expenses they may incur. (U)

Report on Audit, Inspection, and Investigative Operations: Last week I sent to Congress this semiannual report for the period April 1 to September 30, 1983. Highlights of the report follow:

- In the area of internal audit and internal review, Department auditors and internal review personnel produced a total of 9,407 reports that recommended thousands of ways the Department could trim spending and increase efficiency. Over \$1 billion in total potential savings were identified in these reports. Defense managers have already agreed to implement actions that are expected to save \$253.4 million of this amount, and we are currently reviewing the remainder of the reports.
- The Defense Contract Audit Agency issued 30,688 reports, and the U.S. Army Corps of Engineers auditors issued 212 reports. These reports included

\$16.2 billion in costs that were questioned by auditors. Of these, \$5.9 billion of unjustified costs were agreed with by contracting officers. The reports also identified \$197.6 million that could be saved by contractors by implementation of recommendations to improve operations.

In the area of criminal investigations, we closed 8,920 cases during the period. There were 3,706 cases referred for prosecution or administrative action, and 391 convictions were obtained. Monetary results of these actions included: \$417 thousand in fines and penalties assessed; \$3.2 million in recoveries and restitutions obtained; and \$4.7 million collected in fines, penalties, restitutions, and recoveries through the military justice system.

ICBM Modernization: I gave you a preliminary report on the second PEACEKEEPER flight test in my Weekly Report of October 21 and indicated I would provide an update when our analysis of the test was complete. We have now completed the analysis, and I am pleased to report that all test objectives were achieved. All components performed as predicted and target accuracy met design specifications. I have attached a chart showing a scale diagram of the Pentagon superimposed with the results of flight #1 (circles) and flight #2 (squares). The stars represent composite accuracy for each set of the scheduled for the latter part of December.

This month the Air Force will award three contracts for Small ICBM development. The contracts include system definition and missile integration, propulsion, and an improved third-generation gyro.

Our most significant problem in ICBM programs is a result of Congressional action in cutting funding for our follow-on basing technology studies in half (appropriated \$125 million of \$250 million requested). We are currently restructuring the program to fit the funding.

Finally, the first annual report to Congress on ICBM Modernization is being prepared for the January 15, 1984 due date. (S)

Geothermal Resource Development: We recently completed negotiations to develop the Navy-owned geothermal resource underlying Coso Hot Springs at the Naval Weapons Center at China Lake, California. Under the terms of the contract, China Lake Joint Venture will construct a geothermal power plant at no

capital cost to the government, recouping its investment by selling electricity delivered to the Weapons Center and to other Defense sites.

Established in the contract negotiations was the rate to be paid for electricity delivered. The contract price is 56 mils per kilowatt hour compared to a March 1983 weighted average cost for electricity at China Lake of 66.87 mils per kilowatt hour. This will amount to an estimated cost avoidance at China Lake alone of \$1.4 million per year for its electricity demand. Assuming the same savings at the other Defense delivery points, the total savings for the 24 to 25 years for delivery of the contract limit of 75 megawatts will approximate \$4.2 million per year for a total of \$105 million, while decreasing our dependence on fossil and other non-renewable energy sources. The first electricity is expected to be delivered from the plant in 1985. (U)

Shelter for the Homeless: In an effort to improve the effectiveness of this program, which we began last year, we have examined the ten cities identified by the National Citizens Committee on Food and Shelter (Atlanta, Georgia; Baltimore, Maryland; Boston, Massachusetts; Cleveland, Ohio; Detroit, Michigan; District of Columbia; Memphis, Tennessee; Pittsburgh, Pennsylvania; St. Louis, Missouri; and San Francisco, California) for ways we might be most effective. Specific Defense actions we have taken are:

 \$8 million has been included in the Defense Appropriations Bill to support this effort. This money will be used to pay for utilities and minor construction and renovation in support of the program.

Defense Assistance to New York City Police Department: In coordination with your staff, members of my staff met last month in New York with Police Department officials to discuss their needs.

As a result of the financial difficulties of the mid-1970s, the City finds itself with deteriorating infrastructure. The Police Department's current concern is with upgrading its equipment base in areas related to emergency service functions. Specifically, they have prepared a five-year plan to improve the equipment levels of Harbor, Tactical Patrol, Street Crime, Emergency Service, Aviation, and Mounted Units. They are hopeful that Defense can provide some of the needed equipment, on a loan or transfer basis, to hasten their re-equipment process and ease the burden on the city budget.

We will work with the Services to determine how best to connect the New York City Police Department with the GSA surplus distribution program to give them access to unneeded federal property. In addition, we will determine if the loan of active or reserve assets to the Police Department is a practical solution to some of their problems. We have promised them an initial response early enough to enable them to meet their budgeting and purchasing timetables. (U)

Chemical Weapons Destruction Verification Workshop: In mid-November Defense participated in a workshop on chemical arms control conducted at the Tooele Army Depot, near Salt Lake City. The workshop evolved from discussion earlier this year between Defense and ACDA and was sponsored by ACDA and supported by Defense. The major theme was verification of chemical stockpile destruction. This is one of several unresolved critical verification and compliance issues and the one for which there has been some recent progress at the Committee on Disarmament



talks in Geneva. The workshop was well attended (about 50 foreign participants from 30 countries), the presentations were of high quality, and the discussion was spirited and substantive.

The highlight of the workshop was a demonstration of verification techniques applied to a chemical weapons destruction process, and the participants (and press) observed the destruction of 155mm artillery projectiles containing nerve agent. The purpose was to demonstrate the verification measures discussed in a U.S. paper offered to the Committee on Disarmament earlier this year (a small number of continuous on-site inspectors supported by appropriate monitoring, sampling, and weighing equipment). For most of the delegates it was their first opportunity to observe such a process, and this experience should serve them well when they return to the more abstract environment of the negotiating table. The Soviet Union was invited but declined to participate. (U)

Defense Action Plan for Increased Voluntarism: In support of our efforts to maintain and strengthen good will and cooperation between military installations and communities, this week we published our Action Plan for Voluntarism. The key points in the plan are the establishment of a volunteer task force, the formation of a Departmental clearinghouse with a network of command or installation clearinghouses, the development of promotional materials, and the encouragement and extension of existing volunteer models (e.g., Health Fairs, Adopt-a-School). We will also be pushing for amendments to the U.S. Code, Title 31, to protect volunteers under the Tort Claims Act and to give them some tax credits for expenses they may incur. (U)

Report on Audit, Inspection, and Investigative Operations: Last week I sent to Congress this semiannual report for the period April 1 to September 30, 1983. Highlights of the report follow:

- In the area of internal audit and internal review, Department auditors and internal review personnel produced a total of 9,407 reports that recommended thousands of ways the Department could trim spending and increase efficiency. Over \$1 billion in total potential savings were identified in these reports. Defense managers have already agreed to implement actions that are expected to save \$253.4 million of this amount, and we are currently reviewing the remainder of the reports.
- The Defense Contract Audit Agency issued 30,688 reports, and the U.S. Army Corps of Engineers auditors issued 212 reports. These reports included



\$16.2 billion in costs that were questioned by auditors. Of these, \$5.9 billion of unjustified costs were agreed with by contracting officers. The reports also identified \$197.6 million that could be saved by contractors by implementation of recommendations to improve operations.

 In the area of criminal investigations, we closed 8,920 cases during the period. There were 3,706 cases referred for prosecution or administrative action, and 391 convictions were obtained. Monetary results of these actions included: \$417 thousand in fines and penalties assessed; \$3.2 million in recoveries and restitutions obtained; and \$4.7 million collected in fines, penalties, restitutions, and recoveries through the military justice system.

ICBM Modernization: I gave you a preliminary report on the second PEACEKEEPER flight test in my Weekly Report of October 21 and indicated I would provide an update when our analysis of the test was complete. We have now completed the analysis, and I am pleased to report that all test objectives were achieved. All components performed as predicted and target accuracy met design specifications. I have attached a chart showing a scale diagram of the Pentagon superimposed with the results of flight #1 (circles) and flight #2 (squares). The stars represent composite accuracy for each set of **Constant and after 4,200** nautical mile flights. The third flight is scheduled for the latter part of December.

This month the Air Force will award three contracts for Small ICBM development. The contracts include system definition and missile integration, propulsion, and an improved third-generation gyro.

Our most significant problem in ICBM programs is a result of Congressional action in cutting funding for our follow-on basing technology studies in half (appropriated \$125 million of \$250 million requested). We are currently restructuring the program to fit the funding.

Finally, the first annual report to Congress on ICBM Modernization is being prepared for the January 15, 1984 due date. (S)

Geothermal Resource Development: We recently completed negotiations to develop the Navy-owned geothermal resource underlying Coso Hot Springs at the Naval Weapons Center at China Lake, California. Under the terms of the contract, China Lake Joint Venture will construct a geothermal power plant at no

capital cost to the government, recouping its investment by selling electricity delivered to the Weapons Center and to other Defense sites.

Established in the contract negotiations was the rate to be paid for electricity delivered. The contract price is 56 mils per kilowatt hour compared to a March 1983 weighted average cost for electricity at China Lake of 66.87 mils per kilowatt hour. This will amount to an estimated cost avoidance at China Lake alone of \$1.4 million per year for its electricity demand. Assuming the same savings at the other Defense delivery points, the total savings for the 24 to 25 years for delivery of the contract limit of 75 megawatts will approximate \$4.2 million per year for a total of \$105 million, while decreasing our dependence on fossil and other non-renewable energy sources. The first electricity is expected to be delivered from the plant in 1985. (U)
