KAMAL HASSAN ALI:

WELL, AT THE END OF THIS USEFUL ROUND OF TALKS ON THE

MINISTERIAL LEVEL I WOULD LIKE TO THANK MY COLLEAGUES,

THE ISRAELI MINISTERS, THE UNITED STATES AMBASSADORS

IN CAIRO AND TEL AVIV AND THE TRIPARTITE WORKING GROUP

FOR THE INTENSIVE EFFORTS EXERTED TO REACH AN AGREEMENT.

THE FOLLOWING STATEMENT WAS AGREED UPON BY THE THREE SIDES

MESSAGE (CONTINUED):

WITH A SOLID ASSURANCE TO CONTINUE THEIR JOINT SINCERE

EFFORTS TO ENLARGE THE AREA OF UNDERSTANDING IN THE

WAY OF ACHIEVING THE PALESTINIAN FULL AUTONOMY FOR THE

TRANSITIONAL PERIOD AS STIPULATED IN THE CAMP DAVID

ACCORDS.

THE FOLLOWING IS THE JOINT STATEMENT:

BEGIN STATEMENT:

DELEGATIONS AT THE MINISTERIAL LEVEL REPRESENTING EGYPT

AND ISRAEL, AND A DELEGATION REPRESENTING THE UNITED

STATES OF AMERICA, MET IN GIZA NOVEMBER 11-12, 1981, TO

CONTINUE THE NEGOTIATIONS ON AN AUTONOMY AGREEMENT AS

SET FORTH IN THE CAMP DAVID FRAMEWORK FOR PEACE IN THE

MIDDLE EAST. THE THREE DELEGATIONS REAFFIRMED THEIR

RESPECTIVE GOVERNMENT'S DEDICATION TO THE CAMP DAVID

FRAMEWORK AS THE ONLY AGREED AND, THEREFORE, ONLY

VIABLE PATH TO MIDDLE EAST PEACE, TO WHICH THEY ARE

COMMITTED. THE MINISTERS EXPRESSED THEIR DETERMINATION TO BRING THESE NEGOTIATIONS TO AN EARLY AND SUCCESSFUL CONCLUSION.

THE DELEGATIONS WERE ALSO RECEIVED BY PRESIDENT MUBARAK. IN THEIR MEETING THEY AGREED ON THE ABOVE AND DISCUSSED OTHER MATTERS RELATED TO THE PEACE PROCESS.

THE MINISTERS CONTINUED WORK TOWARD THE ELABORATION OF A STATEMENT OF PRINCIPLES AND UNDERSTANDINGS, THE GOAL AGREED AT THE SEPTEMBER 24 PLENARY MEETING IN EGYPT, WHICH WOULD HELP IN REACHING THE FINAL AGREEMENT ON FULL AUTONOMY WHICH MUST ESTABLISH THE PRACTICAL ARRANGEMENTS FOR THE TRANSITIONAL PERIOD.

THE MINISTERS WELCOMED THE REPORT OF THE WORKING TEAM AND COMMENDED IT FOR THE PROGRESS IT HAD MADE IN CONSIDERING POSSIBLE SOLUTIONS TO THE ISSUES OF JURISDICTION, STRUCTURE, AND THE POWERS AND RESPONSIBILITIES OF THE SGA (AC). THE MINISTERS INSTRUCTED THE WORKING TEAM TO CONTINUE ITS WORK, GIVING PRIORITY TO THE ISSUES OF SECURITY AND CONSIDERATION OF LEGISLATION AND REGULATORY POWER, AS WELL AS THE CONTINUING COMMITTEE. THE MINISTERS INSTRUCTED THE WORKING TEAM TO COMPLETE ITS WORK EXPEDITIOUSLY AND, AS SOON AS POSSIBLE THEREAFTER, TO PRESENT A DRAFT AGREEMENT ON CONSIDERATION. END STATEMENT.

Q: MR. MINISTER, WAS THERE NO ELEMENT ON ANY ONE ISSUE OF THE EFFORT TO DRAFT AN AGREEMENT IN PRINCIPLE?
HASSAN ALI: WELL, ACTUALLY THE WORKING TEAMS ARE WORKING VERY HARD. THERE ARE SOME DIFFERENCES IN SOME

POINTS WHICH WE HAVE ALREADY DISCUSSED AND WE HAVE TO WORK AGAIN TO BRIDGE THE GAP WHICH IS EXISTING ALREADY.

Q: CAN YOU TELL US THE TOPICS THAT YOU DEVOTED THE MOST TIME TO TODAY IN THE TALKS?

HASSAN ALI: WELL, WE CONCENTRATED ON THE STRUCTURE AND THE RESPONSIBILITIES AND WE STILL HAVE GAPS.

Q: THERE WAS TALK OF A BREAKTHROUGH BEFORE THIS MEETING AND NOW YOU HAVEN'T SAID ANYTHING ABOUT THAT. WHAT...?

HASSAN ALI: WELL, WE ARE TRYING. AS DOCTOR BURG MENTIONED, THERE IS A TARGET, BUT NOT A TARGET DATE.

Q: MR. BURG, ARE YOU HAPPY WITH THE EGYPTIAN RESPONSE TO THESE IDEAS THAT THE ISRAELI DELEGATION HAS BROUGHT UP IN THE NEGOTIATIONS?

BURG: I CAN IMAGINE MORE HAPPINESS AND I CAN IMAGINE MORE UNHAPPINESS, SO IT IS JUST REALISTIC.

Q: (INAUDIBLE)

HASSAN ALI: WELL, OUR POSITION CONCERNING THE SETTLEMENTS IS NOT A NEW ISSUE AND CERTAINLY IT WILL BE MENTIONED IN SOME STAGE OF THE NEGOTIATION.

Q: GENERAL ALI, WHY IS IT THAT WE CAN NOT HAVE A SORT OF PARTIAL MEMO ON UNDERSTANDINGS AND PRINCIPLES ON ONLY THOSE POINTS WHICH ARE APPARENTLY AGREED UPON OR CAN

BE AGREED UPON?

HASSAN ALI: WELL, I THINK THE DIFFERENCES ARE STILL IN SOME OF THE MAIN ONES THAT WE CAN NOT NOW ISSUE A PAPER OR A MEMO OF UNDERSTANDING.

Q: ...ANY KIND OF PAPER NOW?

HASSAN ALI: IT IS NOT FORESEEN IN THIS SESSION.

Q: DO YOU SEE A POSSIBILITY THAT SOON WE WILL HAVE SOME KIND OF PAPER?

HASSAN ALI: WE ARE TRYING.

Q: DR. BURG, DID YOU MAKE ANY PROGRESS TODAY?

HASSAN ALI: IN CERTAIN AREAS, YES. IN CERTAIN AREAS, NO.

Q: WHAT PROGRESS?

BURG: WHAT PROGRESS? FIRST OF ALL, WE KNOW OUR MAP OF DIFFICULTIES. IT WAS MORE DEFINED. DIFFERENT OPTIONS WERE DESCRIBED AND THE WORKING GROUPS WILL CONTINUE TO WORK ON THIS.
