

## Concerned Women for America's Basic Concerns for Public Policy

Today, more than any other time in American history, American women are seeking to influence public policy decisions. As women who believe in God, traditional family values, and the power of prayer, we affirm these 12 basic concerns as of paramount importance for us today.

We seek a public policy which guarantees the sanctity of human life for the unborn, the handicapped, and the elderly. We support a Human Life Amendment to achieve this goal.

We believe that our nation's heritage of religious freedom must be vigorously maintained as the prime foundation for all of our liberties. The ever growing threat of government intervention in the affairs of churches, their schools, and the religious liberties of families must be forcefully opposed.

We support a public policy of equal protection under the law for men and women. We do not favor, however, total elimination of logical distinctions between the sexes, as would be represented by a policy of drafting women for military service. We oppose the Equal Rights Amendment because its objective is the total elimination of even common sense distinctions between the sexes.

IV We believe that the nation's public schools must once again respect equally the rights of students and teachers who have religious beliefs along with those who do not. The right to voluntarily pray, read the Bible, or meet for religious discussion is necessary to achieve such equal treatment. We support a voluntary prayer amendment to the Constitution to achieve this purpose. We continue to support the principle of equal access for religious student groups and call for vigorous enforcement of the law in this regard.

We oppose any laws designed to grant special legal protection to those who engage in homosexuality. Such laws are an affront to public morality and our dedication to family life.

We call for the strict enforcement of laws against pornography. Crimes against women and children are ever increasing as a result of the anti-social decadence of the peddlers of obscenity.

We call for a public policy which protects the inherent, God-given right of parents to direct the upbringing of their children in matters of education, religion, nurturing, and other areas of traditional parental responsibility.

We deplore the ever widening spread of child abuse. We have reservations, however, about the modern trends which view legitimate parental discipline as abuse. Those who truly abuse children should suffer the most serious of punishments. We hasten to add that abortion and the exploitation of children in pornography are among the worst forms of child abuse.

We support the principle of parental choice in education. We believe that unjustified government regulation of parental choice as well as the economic monopoly of the public school systems both violate this principle. We call for legislation to guarantee legal and economic freedom of parental choice in education.

X We deplore the deteriorating condition of the entertainment industry in our country. The violent and sexually exploitive content of programs is increasing at an alarming rate. We support legislation to curb cable pornography. We urge the Federal Communications Commission to once again enforce rules of decency of the airwaves.

We believe that the defense of our country is a legitimate objective of our national government. We oppose efforts of those who would compromise our safety by advocating a weak defense, a unilateral nuclear freeze, or other similar policies.

We believe in the free enterprise system. We also believe in the principle of equal pay for equal work. We oppose, however, so-called comparable worth legislation because it substitutes government regulation of wages for economic freedom. In the end, all citizens, including women, will lose if we lose our economic freedom.


We have heard much about turning America back to the roots of our Christian forefathers. But I recently read a Christian historian's account of the influence of Godly women in early America. He writes:

## CWA's "535" Program

On Friday morning, September 14, a training program was held for all the Convention participants who were interested in learning more about the legislative process. This was the sixth training seminar CWA has conducted for the "535" volunteers.

This unique program involves 535 women in the Washington, D.C., area who serve as Congressional Liaisons — one to each of the 100 Senators and 435 Representatives. Another 535 women in the home districts of each of these Congressmen and Senators serve as counterparts in the local districts and states. This cooperation can keep the local CWA Prayer/Action Chapters informed concerning legislation on which action is needed.

CWA's Capitol Hill office assumes the responsibility of training and coordinating the efforts of the 535 Congressional Liaisons. Attorney Michael Farris is the overall supervisor of this program; Attorney Diane White watches the bills coming before Congress and keeps the Liaisons informed. They both assist in the training programs. Shannon O'Chester has recently joined the staff to help in coordinating activities of the volunteer liaisons.



Betty Batey needs our help now more than ever. This courageous woman is going through a great deal of emotional trauma in her fight to protect her son from the twin evils of homosexuality and anti-Christian bias.

Most of you will remember this case, but for our new members let me review the basic facts.

Betty is a sincere, committed Christian. Her former husband, Frank, is an admitted homosexual who has totally rejected the Christian faith he once embraced. After Frank divorced Betty, she was awarded custody of their only son, Brian.

Significant legal problems began to develop after Brian observed his father nude in bed with his live-in homosexual partner. Brian balked at going to his father's on visitations thereafter. Under the circumstances Betty did not force him to go. As a result, a Superior Court judge in San Diego used the lack of visitation to order a full investigation into who would be allowed to have custody.

The investigation was carried out by a court appointed psychologist and social worker. Their conclusions were later summarized in a police report as follows: "Ms. P--, (the social worker) stated that counseling for the child had been recommended from the beginning of the court hearings and Mrs. Batey originally chose an unlicensed counselor who was part of her Church, but this counselor was later determined to be unacceptable to the Court and the Court appointed a therapist, Dr. B--. B--. Ms. P-- stated that it was her opinion, as well as Dr. B-'s, that Mrs. Batey's devotion to her church was 'financial' and that it was a detriment and 'unhealthy' for the child.

Based on these reports, the judge awarded custody to the homosexual father.

As we told you before, Betty and Brian hid out of state for nearly a year and a half until Betty turned herself in to the FBI in Denver in April. Almost everyone that I have talked to says they would have done the same thing under the circumstances.

While Betty was in jail in Denver she asked CWA's legal counsel, Michael Farris, to take on her case which really has three parts. First she is charged with a criminal charge of "child stealing" which is a felony in California. Second, she has a child custody suit trying to regain full legal custody of Brian. Third, she has to defend a multimillion dollar lawsuit filed by her ex-husband against herself and the church.

Now that our new members have at least the basic facts, let me update you on what has happened since I last wrote to you.

Concerned Women for America Education & Legal Defense Foundation Post Office Box 5100 • San Diego, CA 92105 (a nonprofit tax-deductible organization) There have been an unbelievable number of court hearings since we first wrote to you. In the criminal case there have been at least four hearings and we expect two more hearings, one of them extremely important, prior to the scheduled trial of September 27. We expect a tough fight but we are praying that a jury will act with true justice when the case is heard. There is a significant possibility that this date will be changed.

In the custody case, there have likewise been a large number of hearings, depositions, and pre-trial maneuvering. This has been exhaustive for Betty and very expensive as well. We have had to have Michael Farris flying out here to San Diego from our Washington office so often that the expenses for air flights alone are mounting substantially.

The most important development in the custody case is a troubling one. The court appointed a new psychologist to make an evaluation of the situation. His report, which has already been broadcast in our local media, was that Brian should be placed in a longer-term foster care situation.

We cannot go into the details of the psychologist's report, but Michael tells me that the underlying reason for not allowing the boy to return to his mother is that the psychologist has a bias against Christians who take a strict view against sin.

There seems to be a consistent pattern among most of the so-called "mental health professionals." There is an anti-Christian bias which pervades their thinking. For example, Betty views modern rock and roll music as being inappropriate for her son--she thinks that such music is sinful.

Many psychologists seem to feel that Christians who reject any portion of modern life and thinking will "warp" their children and deprive them of a "normal" upbringing. With the widespread acceptance of such things as drugs, premarital sex, and punk rock, most Christians could be charged with depriving their children of a normal upbringing. In fact, I hope that we are not conformed to the "norms" of this age.

Betty's custody trial is set for October 4. This date appears to be very firm. This new date was set at the request of Michael Farris. Even though we had some witnesses lined up, he viewed the psychologist's recommendation of long-term foster care as a potentially dangerous development needing additional testimony from our own expert witnesses to combat this report. Thank God that there are some psychologists and psychiatrists who do not share the anti-Christian bias of those who have been involved thus far.

This case is more expensive than we ever imagined. We have spent thousands and thousands of dollars on this case above and beyond the cost of Michael's time and efforts. We have crucial witnesses to be flown in from out of state. We need to hire the best expert witnesses in two or three different areas. We have had to pay large amounts to court reporters for depositions and transcripts. This is an extremely costly set of cases.

Our best estimate is that we will spend an additional \$45,000 to \$55,000 to finish the custody trial and the criminal trial. If appeals are necessary it will be even more.

I want to ask you to pray for Betty with a deeper fervency than ever before. The trauma she is facing would make most people crumble. I know that she is facing this situation with strength by the power of God, and is carried on the wings of thousands of prayers of people like you.

Homosexuals are becoming increasingly bold. At the Democratic convention I am sure that many of you saw the demonstrations of the homosexuals and lesbians. The transvestite mockeries of religion, such as "Sister Boom Boom" (a man dressed as a nun with a short skirt with sequins, make one's stomach turn).

We can get up, disgusted, snap off our television sets and the perversion is removed from our immediate concerns. Betty Batey would love to be able to have that easy of a solution. For her son can be forced by the Superior Court of San Diego County to rejoin his father who is openly a part of that lifestyle. Or she could lose her son to the government's permanent control. She could even end up in prison for doing what most Americans would do--trying to protect her son.

Please don't just "turn off" this letter like you would turn off the TV. Betty's fight needs your active participation. I want to ask thousands of you to commit yourself to pray for Betty during the next few weeks and especially during the period of trial.

Betty's case needs your financial support as well. Although we received a tremendous outpouring of support when I wrote to you the first time on this case, only a small percentage of people helped financially. We greatly appreciate that support, but we need you to consider the follow-up gift to ensure that this case does not fall short from lack of proper finances.

I also want to ask that, if you were not able to help Betty before, you give serious consideration to helping her with a special gift this time. Please consider giving what you can. If you can help with a gift of \$5 or \$10, then please send it. Most of you are able to help with \$25, \$50, or more. We are excited in watching how God uses thousands of people to join together to accomplish a great victory.

Moral freedom and religious freedom are both involved in the case of Betty Batey. It is not only her future and Brian's future at stake; all of us will suffer if Christians are ruled to be parents who are disqualified from raising children because we take a stand against sin.

Please pray and please help.



**The Dangerous Civil Rights Act of 1984** 

G eorge Orwell's frightening (and prophetic) tale of a monolithic police state in his book *1984* may yet come true this year if Congress passes the Civil Rights Act of 1984.

This civil rights act (which has been dubbed by conservatives as "The Big Brother Act" after Orwell's omnipotent and cruel dictator) was introduced as a remedy to the Supreme Court's decision in the *Grove City College* case in February of this year.

In the *Grove City* case, the Supreme Court ruled 6-2 that "any education program or activity receiving federal financial assistance" referred *only* to that specific program receiving the assistance. At issue here is whether federal control can extend to every part of a school or other entity if only one portion receives federal financial assistance.

Liberals in Congress were outraged by the *Grove City* decision and have introduced the Civil Rights Act of 1984 to extend ominous federal control over any institution which receives either direct or indirect federal aid.

This is to be accomplished by redefining who is a recipient of federal aid. Under this new law a recipient of federal financial assistance would be *anyone* who directly or indirectly receives monies from the federal government. If one portion of a state government received federal money, *all* of that government would automatically fall under federal control.

The law is so absurd and far-reaching that a small grocery store could conceivably come under federal control if the owners accepted food stamps from low income families. This would constitute "indirect" federal assistance under the law as it is now written.

The Civil Rights Act of 1984 passed in the house by a vote of 375 to 32. The Senate version (S.2568) is being considered by the Senate Education and Labor Committee chaired by Senator Orrin Hatch (R-UT). Concerned Women for America was among those testifying before this committee against passage of this dangerous bill.

Harvard Law School Professor Charles Fried testified May 30 before Senator Hatch's Judiciary Subcommittee on the Constitution. He warned that S.2568 "represents our legislative process at its worst. It would make major changes in the structure of our anti-discrimination laws, in the balance of responsibility between the federal government and the states, in the balance between the responsibilities and prerogatives of private institutions and bureaucratic authority over those institutions."

"As a response to the *Grove City* case," said Fried, "this bill is like using a nuclear bomb, devastating a complex and carefully patterned institutional landscape, to kill a gnat — and it is not even clear that the gnat exists."

According to Human Events, "Under S.2568, in short, every state legislature, city council, county commission, and local school board in the nation would lose its representative character and become little more than an agent of the federal bureaucracy and the federal courts. Every private entity that benefits, either directly or indirectly, from federal funding would similarly be affected. Freedom as Americans have known it — which is one of the most basic civil rights of all — would be destroyed. And all in the name of 'civil rights.'"

#### The Value of Real Men

Virtually all Americans believe that Abraham Lincoln was our greatest President. But it recently occurred to me that the character qualities that made Lincoln great are generally considered invaluable or even dangerous in today's political scene.

In today's politics the ability to unify diverse factions through political compromise is deemed highly important. Lincoln refused to compromise and the nation divided.

In the course of time it has been proven that Lincoln's divisiveness was the right choice. Lincoln could have chosen a pluralistic solution on slavery. It would have been an immoral choice, but it would have kept America together for a season. But only for a season.

I am convinced that any nation which enslaves or otherwise mistreats its own will not long stand. A house divided may not stand, but neither will a house built on the shifting sand of political compromise.

For a nation to stand, it must stand for what is right in the eyes of a just and holy God. Slavery was not merely out of date or wrong just for that place or time; slavery was wrong in God's eternity.

Lincoln did not wish to divide the nation, but his refusal to compromise on a controversial issue of the day was the only way America could have moved forward toward its national potential of greatness.

Lincoln stood for what was right but in a humble and forgiving way. His singular greatness was not just in what he did but also in the way he did it. The hours he spent in the study of the Scriptures and in prayer throughout his life (including an hour each morning as President) gave him the spiritual strength of conviction to stand firm. But it also gave him the spiritual strength of character to humbly love his enemy.

Where are the Lincolns of today? They are not to be found in the compromising slaves of pluralistic thought. They are not in the camp of those whose every move is guided by the latest poll. They are certainly not to be found among those who openly defy the laws of God by supporting abortion, pornography, and homosexuality.

But neither are they to be found among those who stand for the right principles yet whose manner of political stylistics is brash, offensive, and unforgiving.

Let us have men who strive to be right, yet who are humble enough to admit that neither they nor their party are perfect. Let us have men who will be humble enough not to blame every ill on the last administration, yet claim every victory for themselves.

Let us have men who have the strength of conviction to vote right and the strength of character to live right.

#### "Gay Rights": An Update

"Gay rights" proposals have fared poorly in recent months on both the national and state levels, highlighted by a narrow defeat for homosexuals in California this spring.

Earlier this year, Gov. George Deukmejian of California vetoed a "gay rights" bill passed by the state legislature. "Gay rights" bills have been introduced in many states, and in such areas as employment, housing, credit, and public accommodations (hotels, etc.).

Right now, only Wisconsin has a statewide "gay rights" bill. Other states that have voted on the measures have defeated them frequently on close votes. Although no other state has passed a "gay rights" bill, these proposals have come close to winning.

On the federal level, members of Congress have introduced "gay rights" bills (H.R. 2624, S. 430), but all remain in committee. At this time, these bills have little chance of passage.

Many cities around the nation have "gay rights" ordinances, such as San Francisco, Seattle, Minneapolis, and others. Miami and St. Paul, Minnesota, successfully repealed their "gay rights" ordinances in the late 1970's by public referenda.

It should be remembered that homosexuals do have rights today. No one could deny them the right to free speech, the right to vote, etc., because they are homosexuals. They have all the *rights* anyone else does in the United States.

The "gay rights" laws currently being promoted would grant homoseuxals special *privileges* to practice their perversions without reproach and not affect their status and acceptability in society — such as in

## **Update on News**

#### ABORTION

Milwaukee police were recently dispatched to a scene where four children, ages 4 to 11, were reportedly throwing stones from a bridge. According to one of the officers, they discovered the children were "throwing fetuses around." The youngsters had retrieved 22 aborted infants from a nearby dumpster.

When asked what they were doing, the children replied they were playing with "little people."

The corpses were buried over protests from the A.C.L.U. that the "material" should be returned to the owners.

The U.S. House of Representatives defeated (156 yes to 261 no) an amendment by Congressman Barbara Boxer (D-CA) which would have deleted the Smith/Ashbrook Language from H.R. 5798.

The Smith/Ashbrook Amendment to the Fiscal Year 1985 Treasury/Postal Appropriation Bill (H. R. 5798) will prohibit use of taxpayer funds to pay for federal employee's health insurance abortion coverage.

This is the largest pro-life majority margin (105 votes) in the history of the pro-life movement.

#### HOMOSEXUALITY

Another religious organization faces loss of millions of dollars in contracts with the city of New York because of Mayor Edward Koch's Executive Order #50, which says employment may not be denied because of sexual preference or orientation.

The Roman Catholic Archdiocese of New York has contracts with the city worth about \$60 million a year. They would rather lose millions of dollars in child care contracts with the city than pledge not to discriminate against homosexuals in hiring.

The Salvation Army lost \$4.5 million in contracts with the city in March after it refused to comply with the directive, saying the order violated its religious principles.

#### INFANTICIDE/CHILD ABUSE

An agreement on principles for treating severely handicapped infants has been reached by members of Congress, hospital officials, and pro-life groups.

The new "baby doe" federal policy will be written into a 1974 law, the Child Abuse Prevention and Treatment Act, under which the government provides money to the states to help children who have been neglected or abused. Under the proposal, states that did not require hospitals to meet the new standards might lose this money.

The Senate compromise has been endorsed by 20 national organizations; only the American Medical Association refused to accept the compromise. The AMA said the proposal did not give enough consideration to the "quality of life" of a severely handicapped baby.

#### **RELIGIOUS FREEDOM**

As we go to press, the Equal Access Act (Bonker substitute) is scheduled to be voted on in the House under a procedure known as "Calendar Wednesday" on July 25, 1984. Senator Perkins will substitute the Senate version which passed in the Senate by a wide margin—88-11. By using this procedure, the bill can avoid the House Rules Committee and can be approved by a simple majority instead of a 2/3 vote.

#### **Litigation Update**

#### **Batey Case**

CWA attempted to have the criminal charges dismissed against Betty Batey (Christian mother of 13-year-old Brian Batey) because the crime she is charged with in the San Diego courts — not returning her son to his homosexual father after her visitation period — was not committed in the state of California. (For background information on the case, please refer to our June Newsletter.) However, a judge in the lower court denied this dismissal. CWA expects to appeal this to a superior court.

July 19 was the date set by the courts to begin trial on both the felony and custody cases. CWA hopes to have the criminal case postponed, if possible, so we may pursue the custody case first. More details will be available in the next Newsletter.

#### **Carolyn Grove Case**

The final argument of the Carolyn Grove v. Mead School District case in the Circuit Court of Appeals has been set for September 4 in Seattle. The details of this case appear in our October 1983 and March 1984 Newsletters. It involved the anti-Christian book, *The Learning Tree*, as required reading for high school students.

#### **Gary Jones**

CWA is investigating a case in Greenville, North Carolina, concerning Gary Jones. Gary, a Christian, was fired from his job at a department store because he complained to the city council about lax police enforcement of laws against the homosexual prostitutes in Greenville. In early May, Gary and his wife were driving home through an area of Greenville. Transvestite prostitutes solicited Gary, and he called the police when he got home. The police were unhelpful, so Gary requested to be put on the city council meeting agenda to complain about this problem.

The mayor of Greenville called Gary and asked him not to testify and later contacted his boss and told him about Gary's plans to speak at the city council meeting. The mayor called a meeting at her office with Gary, where his boss, the chief of police, and the city manager, tried to dissuade Gary from speaking at the city council meeting. Gary said he would speak, and his boss promptly fired him. Gary did testify, and this case has been reported in the local media in Greenville. Gary contacted the CWA office in Washington, requesting legal representation.

housing, employment, influence, etc. A "gay rights" law would take away the right of employers to decide whom they will hire, take away the right of parents to determine the moral character of their childrens' teachers, and might even yank the right of churches not to hire professing homosexuals as church leaders.

Some argue that homosexuality should be protected by law, because sexual orientation is unchangable. This cannot be correct. The Bible condemns homosexuality as an abomination (see Romans 1 and I Corinthians 6:9). God does not create and redeem people so that they might practice sin, but that they may practice righteousness. Also, anatomy teaches us that homosexual conduct is abnormal, and that correct sexual coupling is the one-man, one-woman heterosexual norm. As well, many homosexuals have shifted their sexual orientation to heterosexuality through counseling. This would be impossible if sexual orientation is genetically induced or locked in at an early age. If homosexuality is an abnormal sexual choice, it makes little sense to protect it under the law.

If a government passes a "gay rights" law, it is more than accommodating homosexuals, it is conferring society's approval on that way of life (remember, all laws reflect and "dictate" moral values). If the Word of God condemns homosexuality, the laws of men should not contradict that and say otherwise.
