Sacramento--Governor Ronald Reagan today announced the appointment of Harold O. Wilson, 777 Serrano Drive, San Luis Obispo, to the State Board of Agriculture, effective July 10, 1967.

Wilson, Executive Dean of California State Polytechnic College at San Luis Obispo, succeeds Warren T. Smith of San Luis Obispo who resigned. He will represent the state colleges.

Wilson is a native of Kings County, California. He graduated from the University of California at Davis in 1932 with a B.S. in agriculture and did graduate work at U.C. Berkeley and U.C. Los Angeles.

In 1933 he established, and was director of, the vocational agriculture department at Excelsior Union High School in Norwalk. He moved to California State Polytechnic College at San Luis Obispo as an instructor in animal husbandry in 1936.

Wilson was Southern California Supervisor of War Production Training in agriculture 1940-42, and then became a regional supervisor for the state bureau of agricultural education.

He returned to California State Polytechnic College as dean of the Voorhis campus in San Dimas in 1946, where he handled the reopening of the campus after its closure during world war II.

Wilson has held his present position at San Luis Obispo since 1950. His permanent tenure at the college is as a faculty member in the department of animal husbandry.

Wilson is a Republican. He will receive travel expenses.

An executive clemency hearing will be held this morning at 11 a.m. for Edward Louis Arguello, who was convicted in San Diego County of first-degree murder. Conviction took place in a jury trial on April 13, 1966 and the same jury imposed the death penalty on April 15, 1966.

The conviction and penalty were unanimously affirmed by the California Supreme Court on February 8, 1967. Testimony at the trial indicated that Arguello, 58, had murdered Mrs. Marie Chapman, an 82-year old widow, who was found dead in the bathroom of her San Diego home on November 9, 1961. Her death had resulted from multiple skull fractures and lacerations of the brain and throat. She had been beaten with a brick and a hammer and had been cut with a knife. The motive for the killing was robbery.

Two previous murder trials for Arguello had each resulted in the death penalty being imposed by separate juries, but each of those convictions had been reversed by the California Supreme Court.

SACRAMENTO--A United Press International story out of New York saying that Newsweek magazine interviewed Governor Reagan on his views on the war in Vietnam and quoting the Governor as saying what he would do as President is completely false.

Newsweek magazine did not interview the Governor.

At no time has the Governor said what he would do if elected President, because he has made it perfectly clear that he is not a candidate for President.

Newsweek asked if Governor Reagan would submit a statement on Vietnam under the heading "If Elected President I Will...". The request was turned down. However, the Governor's press office did send to William Flynn, the San Francisco Bureau Chief for Newsweek, excerpts from press conferences in which the Governor answered questions on Vietnam. Since these were public record, Mr. Flynn was told that Newsweek could use them. However, he also was asked to make it clear that they were excerpts, that the Governor had not been interviewed and that he is not a candidate for president.

Instead, Newsweek intimates that the excerpts were from an interview. Unfortunately, this means that both Newsweek's readers and UPI's readers have been misled.

Dear Mr. Smith:

This will confirm the conclusions reached in the discussions held today between James S. Dwight, Jr., Deputy Director, Department of Finance, Ralph I. McCarthy, Deputy State Controller, Paul M. Joseph, Deputy Attorney General, and myself, concerning the unpaid temporary loans to the general fund from various special funds existing at the close of this fiscal year.

It is our understanding that as of the close of this fiscal year there will remain outstanding approximately \$200,000,000 of such unpaid loans.

It is further our understanding that these temporary loans were made to provide funds to take care of appropriations which were made on the basis of revenues anticipated on an accrual basis. Since this was done, Chapter 44, Statutes 1967 was passed removing from such revenue estimate approximately \$100,000,000 of revenue which had been anticipated from income taxes.

Article XVI, Section 1 of the Constitution provides, "The Legislature shall not, in any manner create any debt or debts, liability or liabilities, which shall, singly or in the aggregate with any previous debts or liabilities, exceed the sum of three hundred thousand dollars (\$300,000) . . . "except upon express approval by vote of the people.

Temporary transfers from special funds to the general fund may be made when necessary because of the temporary lack of cash in the general fund. Article XXVI, Section 3 of the Constitution expressly authorizes such temporary transfers from restricted gas tax money, and Section 16310, Government Code, authorizes such transfers from any special fund provided that it is not needed in that particular fund and the Controller, the Governor, and the Treasurer so finds. Section 16310, Government Code, then provides, "All money so transferred shall be returned to the fund from which it was transferred as soon as there is sufficient money in the fund to which the transfer was made to return it."

Article IV, Section 12 (a) of the Constitution provides:

"Within the first 30 days of each regular session, the Governor shall submit to the Legislature, with an explanatory message, a budget for the ensuing fiscal year containing itemized statements of recommended state expenditures and estimated state revenues. If recommended expenditures exceed estimated revenues, he shall recommend the sources from which the additional revenues should be provided."

All constitutional and statutory provisions contemplate that the State activities shall be financed on a current basis rather than on a deficit basis.

MORE

As pointed out, the Legislature has no authority or power to incur an indebtedness beyond \$300,000 except upon express vote of the people. Inasmuch as approximately \$100,000,000 of the base upon which the outstanding temporary loans was made has been removed, it becomes incumbent upon the Legislature to provide ways and means to take care of it.

Any continued renewal of temporary loans which, in effect, create a permanent debt contra to the prohibitions of Article XVI, Section 1, of the Constitution would be invalid. Such invalidity might necessitate the registering of warrants, but, in any event, would undoubtedly seriously affect the credit and financial standing of the State.

Governor Ronald Reagan today issued the following statement:

"We're a day late for this press conference but I figured you'd prefer that to being called in on a holiday.

As you know, we have had a state budget since Friday night, but I am still waiting for the revenue bill to finance the budget, in spite of a promise that 24 hours after the budget was signed the Senate Finance Committee would pass out a revenue bill.

"Five days later we still haven't seen one and there is no indication now that we will at any time soon.

"This failure to pass a revenue bill has already cost California 45 million dollars in tax receipts. This means that the budget, even with the 43.5 million dollars worth of cuts, is already out of balance and that means that either the Legislature will have to find additional revenues to pay for it or we will have further cutting to do when it comes to meeting budget commitments.

"One excuse for the delay is the 197 million dollar debt the last administration left the state. This administration intends to pay that debt off this year. But there are those who would pay it off over a three year period or not at all.

"Well, that might solve a problem for those who don't wish to face up to reality, but even for those people there is no legal out.

"I have here a letter from the Attorney General's Office which assures me that we have no choice. This debt must be paid off this year under the State Constitution.

"With that question out of the way, I'm sure the Legislature will get on with the business of providing a revenue bill that will meet scheduled budget outlays."

Sacramento--Governor Ronald Reagan announced today he has signed the following bills:

JUNE 30, 1967

SB 107 - Chapter 430  
Carrell-Collier

Prohibits an automobile dealer from selling, except to another dealer, automobile dismantler, or junk dealer, any used passenger vehicle manufactured on or after January 1, 1962, unless it is equipped with at least two approved safety belts or safety belt-shoulder harness combinations installed for the use of persons in the front seat.

SB 215 - Chapter 431  
Cologne

Enables a county recorder using microfilm system for recording to comply with subpoena by producing a certified copy of the record.

SB 292 - Chapter 432  
Cologne

Permits a school district governing board, in calling for bids for construction work, to specify that it may elect to provide and pay for fire insurance. If the call for bids so provides, bids are required to be in the alternative.

SB 329 - Chapter 433  
Short

Permits county workers under the County Employees' Retirement Law of 1937, who changed employment prior to July 1, 1960, and became members of a retirement system, under the same law of a different county, to elect deferred retirement if prescribed conditions are met.

SB 350 - Chapter 434  
Alquist

Requires school district governing boards prior to the acquisition of any school site to have such site investigated by competent personnel to ensure selection is determined by consideration of all factors affecting the public interest, instead of land cost alone.

SB 383 - Chapter 435  
Carrell

Changes the method of computing base value for vehicle license fee purposes.

SB 440 - Chapter 436  
Miller, Knox & Dent

Extends the date of notice of election for certain county employees to receive credit for service as safety member of the county retirement system from April 1, 1966 to April 1, 1968.

SB 479 - Chapter 437  
Cologne

Declares provision of the Business and Professions Code generally exempting drugs from weights and measures requirements shall not be construed as exempting such products from the accuracy requirements in the statements of new weight, measure, or count, rather than total physical weight, counts, or measures.

SB 559 - Chapter 438  
Burgener

Amends the Improvement Act of 1911 to provide that where the frontage of a block exceeds 1,000 feet, a 1,000-foot frontage constitutes a "block" for purposes of construction of sidewalks and curbs.

SB 612 - Chapter 439  
McCarthy & Bagley

Provides that the Board of Directors of the Marin County Transit District shall levy and collect such taxes as are necessary to meet principal and interest payments on district bonds as they become due in addition to, rather than as part of, the general tax levy which limits district taxes to a maximum of five cents (\$.05) per one hundred dollars (\$100) of assessed value within the district.

SB 630 - Chapter 440 Collier	Authorizes use of exterior pilot indicators of any color on motor vehicles for monitoring exterior lighting devices.
SB 633 - Chapter 441 Collier	Prohibits an owner or operator of tow car from stopping or parking the tow car on a freeway which has full control of access and no crossing at grade unless the tow car has been summoned to render assistance to a disabled vehicle.
SB 634 - Chapter 442 Collier	Makes Vehicle Code provision relating to locking devices on towing equipment applicable to any vehicle, first required to be registered in this state after January 1, 1954.
SB 658 - Chapter 443 Carrell	Provides that motor vehicles may be equipped with inside door-mounted red reflectorizing devices or material, rather than just reflectors.
SB 664 - Chapter 444 Danielson	Requires highway carrier to display a single distinctive identifying symbol, rather than symbols.
SB 667 - Chapter 445 Danielson	Permits any person designated an assistant secretary to certify copies of official documents on file with the Public Utility Commission, rather than only the assistant secretary.
SB 675 - Chapter 446 Danielson	Changes definition of "warehouseman" and "food warehouseman" for public utility purposes to include any operator or owner of a structure in which merchandise is stored for the public or any portion thereof, rather than an owner of a structure in which merchandise is stored regularly for the public generally.
SB 676 - Chapter 447 Short	Extends from January 1, 1968 to January 1, 1970, the cutoff date for persons to obtain a psychiatric technician's certificate without specified educational and training requirements.
SB 680 - Chapter 448 Lagomarsino	Removes the requirement for publishing notice of proposed transfers of property between a county and other governmental entity in those cases in which the board of supervisors is also the governing board of the district.
SB 787 - Chapter 449 McAteer	Clarifies position of director of Compensatory Education in recommending disposition of local program applications and as being under policy direction of State Board of Education and under administrative direction of Director of Education.
SB 854 - Chapter 450 Burns & Veneman	Permits the lieutenant governor to appoint a person in his office in a confidential position as provided in the Constitution to act in his place at meetings of boards, commissions, committees, or governing bodies of a state agency or authority of which he is a member except the Senate, the State Lands Commission, the Regents of the University of California, and the Trustees of the California State Colleges.
SB 868 - Chapter 451 Dolwig	Permits incorporated insurers and reciprocal insurers who are members of a "group" or "fleet" to enter into reinsurance transactions between members of the same "group" or "fleet" unless otherwise specifically prohibited by law.

SB 882 - Chapter 452 Carrell	Includes house trailers, mobile homes, campers, motorcycles, and similar vehicles within the provisions of the Insurance Code relating to the regulation of sale of motor vehicle insurance.
SB 883 - Chapter 453 Carrell	Authorizes payment of commissions or consideration in excess of normally required payments by insurer participating in assigned risk plan to licensed insurance agent who has been designated by applicant for insurance as producer of record for coverages required under such plan.
SB 919 - Chapter 454 Wedworth, Walsh	Eliminates option of a holder of a trading stamp to redeem such stamp for either cash or merchandise when the issuing company only offers to redeem its stamp for cash. The bill provides the holder of such stamp shall only receive a cash redemption.
SB 933 - Chapter 455 Lagomarsino	Permits county mutual fire insurers to merge into a general mutual insurer.
SB 958 - Chapter 456 Cologne	Provides that emergency construction work by Department of Public Works shall be done by day's labor contract upon informal bids, or combination thereof, rather than by day's labor only.
SB 974 - Chapter 457 Lagomarsino	Requires prescribed monthly oil or gas well statement to be filed with the district deputy of appropriate oil and gas district, rather than with state oil and gas supervisor.
SB 1007 Chapter 458 Grunsky	Makes licenses for private mental institutions expire after 12 months rather than at the end of the fiscal year.
SB 1167 - Chapter 459 Teale	Includes Amador County in the group of 36 counties where the board of supervisors, by adopting a resolution objecting to or modifying an order of the Fish and Game Commission authorizing the taking of antlerless deer in such counties, can prevent such taking.
SB 1224 - Chapter 460 Stiern, Ketchum & Stacey	Authorizes counties, if they so desire, to make adjustments in retirement allowance rates and the rates of contribution of safety members of the county retirement system in those instances in which such safety members are subject to federal old age and survivors insurance provisions of the Social Security Act.
SB 1281 - Chapter 461 Short	Amends the electronic repair dealer registration law to provide that if initial registration occurs within two months prior to date on which renewal would ordinarily be required, renewal will not be required until following year. The bill also provides a 30-day grace period during which registration may be renewed without penalty and reduces amount of penalty from 100% of renewal fee to 50% of such fee.
SB 1484 - Chapter 462 Mills	Repeals the Fish and Game Code provision restricting possession of abalones during closed season to abalones in a sliced condition and authorizes possession of abalones not in the shell processed under a processing license. The bill also revises provisions authorizing importation into state of abalone or abalone meat taken outside the state and transportation thereof out of state.

AB 31 - Chapter 463 Chapel, Townsend & Biddle	Makes technical nonsubstantive changes in the Vehicle Code provisions relating to the execution of lefthand turns.
AB 124 - Chapter 464 MacDonald	Exempts physicians, dentists, and optometrists employed by a school district on less than a half time basis from holding a health and development type of credential issued by the State Board of Education.
AB 598 - Chapter 465 Hayes	Specifies that a lien on land for work done and materials furnished is obtained by any person who, at the request of owner of a lot or tract of land or his agent, demolishes or removes any improvements, trees, or other vegetation, or drills test holes.
AB 631 - Chapter 466 Quimby	Amends the Probate Code to make all non-resident executors subject to service through the Secretary of State's office.
AB 746 - Chapter 467 Mobley	Allows the board of supervisors to assess at their discretion, upon value of the real property or the land only, rather than upon the real property, for purposes of financing improvements within maintenance districts.
AB 829 - Chapter 468 Powers and Dent	Authorizes school districts to apply to superintendent of public instruction before June 30, 1967, for exemption from provisions requiring specified percentages of amounts in school district budgets to be expended for the salaries of classroom teachers.
AB 1272 - Chapter 469 McGee	Makes the prohibition against the sale of intoxicating liquor within 1- $\frac{1}{2}$ miles of any federal veterans home inapplicable to the sale of alcoholic beverages by an off-sale general licensee for sale of alcoholic beverages outside of one-half mile of any such federal facility within a county with a population of more than three million.
AB 1518 - Chapter 470 Bee	Extends until 1972 the time within which certain temporary housing projects transferred by the Federal Government to local governments must be demolished.
AB 1374 - Chapter 471 Powers	Amends the labor code to remove organized camps from the definition of "employee housing" under the Employees Housing Act.
AB 298 - Chapter 472 Dunlap & Mobley	Permits a school district governing board to pay teachers twice a month.
AB 644 - Chapter 473 Belotti	Permits the Department of Motor Vehicles to suspend or revoke the license of any person who knowingly fails to disclose the ownership of a vehicle when a certificate of financial responsibility is required.
AB 684 - Chapter 474 Foran	Specifies that the address required to be contained in vehicle registration card may be residence or business address and limits authority of director of Motor Vehicles to modify form of the registration card by providing that general delivery or post office box number shall not be permitted as address unless there is no other address.

AB 685 - Chapter 475  
Foran

Permits the Department of Motor Vehicles to suspend, revoke or refuse to issue a certificate, license or special plates to dismantlers, manufacturers, transporters or dealers when they have violated any of the rules and regulations adopted pursuant to the Vehicle Code rather than just those violations listed in prescribed sections of the Vehicle Code.

AB 738 - Chapter 476  
Foran

Permits the Department of Motor Vehicles to use electronic recording and storage media for its registration and drivers' license records.

AB 760 - Chapter 477  
Wilson & Stull

Provides that the county or city ordinance governing disposition of unclaimed property in possession of sheriff's office or police department shall require that such property, except unclaimed bicycles, generally be held for four months.

AB 792 - Chapter 478  
Hayes

Clarifies the Vehicle Code definition of a "certificate of compliance". The bill also redefines the certificate of compliance for minor drivers as a "nonresident minor's certificate".

AB 813 - Chapter 479  
Crandall

Provides for restoration of all benefits without competitive examination for permanent classified employees of a school district employed in a permanent position and re-employed or reinstated within 39 months after a voluntary resignation.

AB 843 - Chapter 480  
Gonsalves

Requires transporters of vehicles, except those regulated by the PUC to maintain an ability to respond in damages resulting from operation of their business. The bill requires, generally, the suspension of registration of all vehicles registered in name of persons convicted of violation of such requirements.

AB 951 - Chapter 481  
Negri

Includes garages and repair shops which dismantle vehicles within the definition of "automobile dismantler".

AB 956 - Chapter 482  
Schabarum

Requires a dismantler or vehicle salesman to return his license, documents, certificates or other evidence of licensing to the Department of Motor Vehicles when the Department cancels, suspends or revokes the license. Present law covers dealers, manufacturers and transporters. The bill also permits the Department to revoke or suspend the license of a dealer who is found to have loaned or rented or received compensation for the use of his license. This practice permits persons to avoid meeting qualifications for a vehicle dealer's license and to frustrate the intent of the law.

AB 988 - Chapter 483  
Murphy

Permits ballots to be counted by someone other than the precinct election board at any place provided by the punch card voting chapter of the Elections Code. The bill also permits "designated" rather than "employed" persons to handle ballot cards at the central polling place and establishes a more detailed procedure for handling write-in votes, for boxing and delivering ballots, and for replacing defective or mutilated ballots. It further provides for and gives the contents of a certificate of sealing and permits the precinct election board members to be called if the returns are ambiguous or incomplete.

AB 998 - Chapter 48  
Harvey Johnson

Provides that after default by a purchaser of personal property, the executor may petition the court to have the sale vacated and resold; the defaulting purchaser would be liable for any deficiency if the resale is for a lower price, and, as an alternative, the court may vacate the prior sale and at the same time confirm the sale to a new and higher bidder.

AB 1006 - Chapter 485  
Britschgi

Requires a minor's application for a duplicate driver's license, as well as for a driver's license, to be signed and verified by the authorized parents, parent, guardian or person having custody of the minor.

AB 1019 - Chapter 486  
Cullen

Prohibits persons from placing, maintaining or displaying any unofficial marking which purports to be or resembles any official traffic control device or which attempts to direct the movement of traffic.

AB 1151 - Chapter 487  
Pattee

Prohibits sale at retail of condensed skim milk or evaporated skim milk in containers other than hermetically sealed containers, rather than in containers smaller than a "number 10 can".

AB 1276 - Chapter 488  
Briggs

Permits the board of supervisors to delegate to the county road commissioner the power to restrict the use of, or close any, county highway under the conditions set forth in the Street and Highways Code.

AB 1288 - Chapter 489  
Veneman & Moretti

Provides that separate accounts, maintained by insurance companies in connection with pensions, retirement or profit-sharing, are not chargeable with liabilities arising out of any other business the company may conduct except and to the extent provided in the agreement.

AB 1528 - Chapter 490  
Briggs

Provides that the board of retirement of a county retirement system may recommend a rate of interest to be credited to members and to the county or district which is higher or lower than the interest assumption rate established by the actuarial survey.

AB 1529 - Chapter 491  
Briggs

Permits a retirement board of a county retirement system, 90 days after the notice is given to former employee, to authorize the return of contributions deposited with the retirement system by a former member even if no application has been made for its return, if the former employee has less than five years' service credit with the county.

AB 1531 - Chapter 492  
Briggs

Permits a county retirement board to designate upon which day an employee will become a member of a county retirement association, under the County Employees' Retirement Law of 1937, but such day must be no later than 6 weeks after employee's entrance into county service, rather than within 15 days after or 15 days before first day of month following entrance into the county service.

AB 1532 - Chapter 495  
Briggs

Makes the provisions for payment and calculation of retirement allowances for time during which safety members, under the County Employees' Retirement Law of 1937, retiring with credit for such time, were not safety members or members of county peace officer or fire service retirement systems, applicable to other members of the county retirement system.

AB 1533 - Chapter 494  
Briggs

Provides that if a person dies before retirement, under the County Employees' Retirement Law of 1937, and has service credit of 10 or more years, his estate or designated beneficiary shall receive \$400, to be paid by the county or district, but the governing board has to adopt provisions of this act before they are applicable.

AB 1534 - Chapter 495  
Briggs

Provides that county purchasing agent may dispose of any personal property belonging to the county not required for public use, subject to such regulations as may be provided by the board of supervisors.

AB 1536 - Chapter 496  
Briggs

Provides that the board of supervisors shall immediately adjust the rates, rather than rate, of interest in accordance with the recommendations of the board of retirement.

AB 1656 - Chapter 497  
Shoemaker & Knox

Permits a surviving spouse of a deceased public accountant or certified public accountant whose certificate has been cancelled by action of the State Board of Accounting to have in his possession or display the cancelled license.

AB 2061 - Chapter 498  
Ray Johnson

Increases the salary of the Yolo County district attorney from \$15,000 to \$18,000.

AB 2204 - Chapter 499  
Gonsalves

AB 303 - Chapter 500  
Crown & Lanterman

Appropriates \$5.13 billion for the support of the government of the State of California for fiscal year 1967-68.

AB 2218 - Chapter 501  
Belotti

Amends the Agricultural Code provisions which cover labeling requirements for cottage cheese standards for sour cream dressing, and other dairy products.

AB 2459 - Chapter 502  
Zenovich

Increases the compensation received by each member of the board of directors of the Kings River Conservation District for each board meeting attended, not to exceed 5 meetings in any calendar month.

AB 838 - Chapter 503  
Z'berg

Enacts the Uniform Foreign Money-Judgments Recognition Act.

AB 983 - Chapter 504  
Knox

Allows cost of electronic computer or data processing machine in which an insurance company may invest excess funds to be amortized over a period not to exceed 10 years, rather than 5 years.

SB 1428 - Chapter 505

Provides that money in the Surplus Money Investment Fund shall be invested as part of the Pooled Money Investment Account.

JULY 5, 1967

SB 37 - Chapter 506  
Kennick

Provides that the clerk of the juvenile court shall send a copy of the juvenile court petition giving specified information relating to the hearing to the district attorney when the petition alleges that the minor comes within specified provisions relating to violations of any state law, if the district attorney has notified the clerk that he wishes to receive such petition.

SB 38 - Chapter 507  
Kennick

Authorizes the district attorney, with the consent or request of the juvenile court judge, to appear and participate in a juvenile court hearing, to assist in ascertaining and presenting evidence when there is either a contested issue of fact or law, the minor is represented by counsel, and the minor is alleged in the petition to have violated state law. It also authorizes the district attorney to appear, if there is an issue as to whether to institute criminal proceedings against the minor, and to represent neglected minors in the interest of the state in juvenile court proceedings, with the consent or request of the judge, if the person responsible for the neglect has been criminally charged.

SB 49 - Chapter 508  
Dolwig

Authorizes a county board of education to enter into practice teaching agreements with a state college, the University of California, or any other accredited teacher education institution.

SB 150 - Chapter 509  
Collier

Requires that the sample ballots sent to the voters be identical to the official ballots used in the election.

SB 341 - Chapter 510  
Dymally

Authorizes the board of supervisors, in a county with a population of four million or more, to initiate payment of property taxes in four equal installments which would be delinquent October 10, January 10, March 10 and May 10.

SB 355 - Chapter 511  
Marler

Provides that the increase in the maximum tax rate of a junior college district, for any interdistrict attendance agreement and any plant and equipment lease agreement, shall remain in effect until the end of the fourth consecutive fiscal year following the election date at which the first district board issue passed, in junior college districts in which such fourth year expires on July 1, 1968.

SB 362 - Chapter 512  
Sherman

Amends the Code of Civil Procedure by removing "ambiguity" and "unintelligibility" as separate grounds for demurrer. The bill includes the omitted grounds within the ground of uncertainty.

SB 367 - Chapter 513  
Stiern

Allows the Regents of the University of California and the Trustees of the State Colleges to appoint their representatives on the Coordinating Council for Higher Education annually for one-year terms. Present law requires the Regents and the Trustees to appoint such representatives at their first meeting in the calendar year, which is in January.

SB 420 - Chapter 514  
Cusanovich

Gives the governing board of a school district the right, without calling for bids, to authorize by majority vote a change order that does not exceed 10 percent of the original contract price. Presently a 3/4 vote of the membership of the board is required for that purpose. The bill also gives the governing board of a very large school district (400,000 average daily attendance or more), or of two or more districts which together are of that size, the right, without calling for bids, to authorize, by majority vote, change orders affecting contracts for the rehabilitation of existing buildings if the change order does not exceed 25 percent of the original contract price.

SB 474 - Chapter 515  
Collier

Extends the existing authorization for junior college districts to offer courses and classes in out-of-district high schools.

SB 495 - Chapter 516  
Stiern & Duffy

Requires applications for reducing assessments on the local assessment roll to be filed between July 2 and August 26 rather than between the third Monday in July and September 15.

SB 498 - Chapter 517  
McAteer

Increases the salaries of the secretary-jury commissioner and the assistant secretaries of the San Francisco Superior Court.

SB 525 - Chapter 518  
Grunsky & Murphy

Provides for proration of compensation of school district precinct election officers only where polls are kept open for less than 12 hours.

SB 555 - Chapter 519  
McAteer

Increases the salaries of the clerk, jury commissioner, deputy clerks and information clerks, and increases the number of deputy clerks of the municipal court of the City and County of San Francisco.

SB 663 - Chapter 520  
Danielson

Extends misdemeanor liability for a violation of public utility law or regulation to cover public utilities themselves in addition to officers and agents of public utilities.

SB 724 - Chapter 521  
Collier

Amends Section 41102 of the Vehicle Code to require dismissal of parking and registration violations alleged to have been committed by a former owner of a vehicle pursuant to the presumption established in this code section in cases where the motor vehicle was transferred to a new owner prior to the alleged violation. Additionally, the bill would permit the lessor of a motor vehicle to rebut the presumption in cases where proof of written lease or rental agreement for the particular vehicle was presented to the courts.

SB 741 - Chapter 522  
Bradley

Authorizes a court, when it is shown to be in the best interests of the estate, to shorten the time of notice of the sale of personal property of an estate from a minimum of 10 days to no less than five days. The bill requires such notice to be posted, or published one time in the county in which the proceedings are pending, at least five days before the sale, or, in the case of a private sale, at least five days before the day on or after the sale is to be made.

SB 782 - Chapter 523  
Dolwig

Specifies that each county superintendent of schools is authorized upon request to provide consultative or coordinative services for school districts under his jurisdiction which have established educational programs that are designed to meet the requirements of federal law for the support of the programs, and that are supported in whole or in part by federal funds.

SB 811 - Chapter 524  
Short

States that each member of an agency within the Department of Professional and Vocational Standards shall hold office until the appointment and qualification of his successor or until one year shall have elapsed since the expiration of the term for which he was appointed, whichever first occurs.

SB 825 - Chapter 525  
Grunsky

Raises the salary of San Luis Obispo County District Attorney.

SB 832 - Chapter 526  
Kennick

Allows a board of supervisors to provide by ordinance for an admission tax on the actual amount paid for admission to a place of assembly owned, leased, or operated by the county for the benefit of the public.

SB 891 - Chapter 527  
Dolwig

Increases the number of and salaries of clerks of various municipal courts in San Mateo County.

SB 901 - Chapter 528  
Dolwig

Increases the maximum fee which persons licensed to transmit money abroad may charge for selling or cashing checks and money orders to 1/2 of 1 percent of the face amount, or 50 cents, whichever is greater. The current maximum limit is 1/2 of 1 percent of the face amount of 35 cents.

SB 975 - Chapter 529  
Lagomarsino

Revises the date for filing of annual reports by operators and owners of oil and gas wells with Department of Conservation.

SB 1015 - Chapter 530  
Burgener

Requires the board of directors of local hospital districts to let certain contracts to lowest responsible bidder only when expenditures are more than \$3,500, rather than \$2,500.

SB 1042 - Chapter 531  
Stevens

Provides that when a domestic corporation merges or consolidates with a foreign corporation, a certified copy of the agreement of merger or consolidation must be recorded in the appropriate recorder's office.

SB 1137 - Chapter 532  
McCarthy

Provides that any county clerk who maintains his voter files on electronic equipment must provide a copy of this file on magnetic tape to the Secretary of State at selected intervals.

SB 1185 - Chapter 535 Dolwig	Amends Personal Property Brokers Law to exempt loans over \$5,000 from additional regulatory provisions.
SB 1203 - Chapter 534 Wedworth	Prohibits the possession on any boat of any fish, upon which a size or weight limit is prescribed, in such a condition that its size or weight cannot be determined.
SB 1241 - Chapter 535 Short	Provides that secretaries elected from the membership of various boards within the Department of Professional and Vocational Standards shall not receive a salary.
SB 1259 - Chapter 536 Dolwig	Repeals obsolete provisions of the Government Code relating to the Director of General Services being added to, or replacing, the Director of Finance and the Director of Public Works on certain boards, commissions, and committees.
SB 1323 - Chapter 537 Way	Permits the State Fire Marshal to approve component replacement elements for the 140F drycleaning system.
SB 1373 - Chapter 538 Mills	Requires district board of irrigation districts containing more than 500,000 acres to elect a district assessor and collector, and fix their compensation.
SB 1532 - Chapter 539 Short	Authorizes a special tax levy not to exceed \$2.50 per \$100 of assessed value of taxable land and improvements in a district of less than 100 acres and situated within the plan of improvement for flood control and other purposes on the Lower San Joaquin River.
AB 295 - Chapter 540 Dunlap & Mobley	Authorizes a county to loan available funds for acquisition of property and construction purposes to any fire protection district, if the funds of the fire protection district are or, when available, will be in the custody of the county treasurer.
AB 576 - Chapter 541 Quimby	Allows the Department of Alcoholic Beverage Control to issue an alcoholic beverage club license to a nonprofit social and religious club which has operated for not less than 8 years, instead of 10 years.
AB 599 - Chapter 542 Hayes	Makes the statute of limitations for an action to enforce payment to stop notices applicable to financial institutions.
AB 637 - Chapter 543 Foran	Authorizes impounding a vehicle registered in a foreign jurisdiction when such vehicle is found upon a highway and has 5 or more outstanding parking violations issued over a period of 5 or more days to which the owner or person in control of vehicle has failed to respond.
AB 686 - Chapter 544 Foran	Requires motor vehicles manufactured and first registered after January 1, 1970, to be equipped so that all taillamps are capable of remaining lighted for a period of at least one-quarter hour with the engine inoperative.
AB 737 - Chapter 545 Foran	Makes it a crime for any person to display or have in his possession any fraudulently obtained driver's license.
AB 797 - Chapter 546 Stull	Prohibits placing any object or material on the windshield, rear window, and side windows to the left and right of the driver, with limited exceptions.

AB 801 - Chapter 547 Negri	Requires filing of accident report with the Department of Motor Vehicles by the driver of motor vehicle involved in an accident where accident has resulted in damage to property of any one person in excess of \$200, rather than \$100.
AB 912 - Chapter 548 Stull	Requires all motor vehicles registered in this state to be equipped with two rear view mirrors, one of which must be attached to the left-hand side.
AB 919 - Chapter 549 Biddle	Clarifies the language of the Vehicle Code concerning the Department of Motor Vehicles and the court's authority to suspend or revoke drivers' licenses in narcotic cases. The bill makes no substantial changes in the law.
AB 938 - Chapter 550 Gonsalves	Amends the County Employees' Retirement Law of 1937 to permit safety members of the system, with the required minimum years of service, to retire at age 50, rather than age 55.
AB 957 - Chapter 551 Schabarum	Provides that the movement of vehicles pursuant to a court order or upon orders of police officers impounding vehicles would not cause registration fees to become due upon such vehicles.
AB 987 - Chapter 552 Knox	Authorizes the use of sea gill nets in Fish and Game District 10 south of Point Reyes except for taking of salmon.
AB 1087 - Chapter 553 Schabarum	Authorizes any officer designated by the city council, in addition to the city attorney, to give written consent to cancel any erroneously or illegally levied tax, or penalties attached thereto, collectible on behalf of a municipal corporation, unless the city council, by resolution filed with the board of supervisors, has authorized cancellation by county officers.
AB 1234 - Chapter 554 Chappie & Way	Increases the salary of the Mono County district attorney and auditor.
AB 1273 - Chapter 555 Johnson	Grants the conservator of the estate or of the person and the estate of a conservatee powers granted to a guardian relating to inventory, accounting, and investment.
AB 1383 - Chapter 556 Cory	Exempts from use tax the loan by any retailer of any tangible personal property to a school district when such property is used by the school district to conduct an educational program.
AB 1462 - Chapter 557 Karabian	Provides that no person shall act as an automobile dismantler, dealer, manufacturer, or transporter without first having procured a license and certificate or temporary permit issued by the Department of Motor Vehicles, or when such license and certificate or temporary permit has been cancelled, suspended, revoked, or invalidated or has expired.
AB 1482 - Chapter 558 Badham	Prohibits the littering of all waters of the state, rather than just inland waters.
AB 1521 - Chapter 559 Wilson	Requires the county board of supervisors to prescribe the time for equalization of assessments made outside the regular assessment period when there is an assessment appeals board in existence in the county. It also allows county boards of equalization, in certain cases, to waive the appearance of the affected person or his agent at the equalization proceedings.

AB 1605 - Chapter 560  
Briggs & Burke

Permits the notice to a former member of county employees retirement system that there is money to his credit in the retirement system, which he must claim within 10 years or lose, to be sent by registered or certified mail, return receipt requested, rather than just registered mail.

AB 1640 - Chapter 561  
Cullen

Removes the requirement of Department of General Services approval for dissemination of information relating to activities, powers, duties or functions by the Department of Harbors and Watercraft and the Department of Parks and Recreation.

AB 1749 - Chapter 562  
Hayes

Reenacts the assent of the state to designated federal highway acts.

AB 1759 - Chapter 563  
Biddle

Allows the board of supervisors of any county which has created an assessment appeals board to discontinue the appeals board as of the first Monday in June.

AB 1762 - Chapter 564  
Negri

Makes the existing limitations on the number of hours which persons can drive vehicles designed or used for transporting persons for hire or for transporting merchandise, freight or other property inapplicable to certain trucks and buses which are regulated by the California Highway Patrol.

AB 2291 - Chapter 565  
Duffy

Amends the Vehicle Code to permit a person who is in the process of completing an approved first aid course to obtain a schoolbus driver's certificate valid for not more than 90 days if the other requirements of law are met.

SB 187 - Chapter 566  
Moscone

Requires all polling places to remain open until 8 p.m. on election day.

SB 1079 - Chapter 567  
McAteer

Repeals the provision that on-sale general alcoholic beverage licenses can only be issued to United States citizens.

JULY 6, 1967

SB 576 - Chapter 568  
Harmer & Russell

Prescribes alternative standards to govern formation of junior college districts in isolated regions. The bill will permit the creation of a junior college district in Saugus-Newhall.

JULY 7, 1967

AB 223 - Chapter 569  
Britschgi

Revises the labeling requirements for reclaimed oil. The bill brings State law in closer conformity with federal regulation.

AB 297 - Chapter 570  
Dunlap & Mobley

Provides that the revolving fund that a board of supervisors may establish for a county officer shall not exceed \$10,000 in counties having a population less than 6,000,000.

AB 300 - Chapter 571  
Dunlap & Mobley

Revises items that must appear on payroll warrants drawn by county auditor for school district employees under authorized alternative payroll procedure. The bill specifies the items that may be provided for by authorized alternative payroll procedure for school district employees.

AB 361 - Chapter 572  
Warren

Permits the Director of Professional and Vocational Standards to refuse a collection agency certificate to certain persons who were refused a license or registration under the Private Investigator and Adjuster Act or had that license or registration revoked. The bill prohibits a person licensed as a reposessor under the Private Investigator and Adjuster Act, or registered as an employee of a reposessor, from being registered as an employee of a collection agency, unless the reposessor holds a collection agency license.

AB 455 - Chapter 573  
Miliias & Crandall

Permits domestic pets in state parks where overnight camping is provided in accordance with rules and regulations of the Department of Parks and Recreation. The bill's provisions shall only remain in effect until the 61st day following adjournment of 1968 Regular Session.

AB 468 - Chapter 574  
Zenovich & Mobley

Amends the Municipal Improvement Act of 1913 to require the legislative body of a special district to obtain approval from the city or county prior to the time the special district begins proceedings to construct a specific improvement within the boundaries of the city or county.

AB 469 - Chapter 575  
Zenovich & Mobley

Amends the description of the boundaries of the Fresno Metropolitan Flood Control District to reflect annexations made since the formation of the District. The bill provides that land owned by District and annexed to district need not be contiguous. The bill directs Secretary of the District to mail notice of any hearing concerning annexation or exclusion proceedings to all persons owning land within boundaries of area to be annexed or excluded. The State Board of Equalization is authorized to establish an appraisal commission in a county when 50 percent of the sample properties deviates from the county's average ratio for the year by more than 20 percent.
AB 626 - Chapter 578 Monagan	Provides that classified school employees are entitled to paid holidays if they are in a paid status during any portion of the working day immediately preceding or succeeding the holiday rather than, only if the holiday falls during the normal workweek of the employee.
AB 883 - Chapter 579 Knox	Permits nonprofit corporations, cooperatives and other qualified groups which own housing facilities, and whose profits are controlled or eliminated by the terms of an agreement with a federal government or agency, to enter into contracts with local housing authorities. The housing authority would provide services on a nonprofit basis for the planning, management, and operation of the housing facilities.
AB 927 - Chapter 580 Bagley	Provides that certain recreation districts retaining same tax rate established in such districts before they elected to come under Recreation and Park District provisions may also levy up to 10 cents per 100 dollars tax upon property within zones.
AB 1057 - Chapter 581 Foran	Deletes an obsolete provision of the Insurance Code relating to reciprocal or inter-insurance exchanges.
AB 1075 - Chapter 582 Belotti	Provides that local agencies may deposit for safekeeping securities in which they have invested with any Federal Reserve bank, any state or national bank located in any city designated as a reserve city by the Board of Governors of the Federal Reserve System, or a trust company.
AB 1080 - Chapter 583 Dent	Amends the Agricultural Code to require that dogs be licensed or tagged when a dog is four months old, rather than three months old.
AB 1196 - Chapter 584 Bear	Makes it a misdemeanor, punishable by a fine of not more than \$1,000, or by imprisonment for not more than one year, or both, for any person to willfully and knowingly make, circulate, or transmit any statement or rumor, which is untrue, and is directly or by inference derogatory to the financial condition, or affects the solvency or financial standing of any federal savings and loan association, or to knowingly counsel, aid, procure, or induce another to do the same.
AB 1245 - Chapter 585 Knox	Amends the procedure relating to the incorporation of cities. It defines a "qualified signer" for purposes of signing a petition or protest in the event the property owner in a corporation to mean an officer authorized by the board of directors of the corporation to act for and on behalf of the corporation.

<p>AB 1267 - Chapter 586 Dent</p>	<p>Changes definition of bicycles to a device upon which any person may ride, propelled by human power through a belt, chain, or gears and having either two or three wheels in a tandem or tricycle arrangement. The bill defines pedestrian as any person afoot or using a means of conveyance propelled by human power other than a bicycle.</p>
<p>AB 1318 - Chapter 587 Crandall &amp; Dent</p>	<p>Amends sections of the Military and Veterans Code to establish an one-officer special courts-martial with jurisdiction more limited than a three member court now provided by law. The bill creates a court-martial of intermediate jurisdiction between the summary court and the three man special court to take care of minor cases for discipline in the National Guard where the enlisted man refuses trial by summary court in order to obtain representation by counsel, which can be convened with less expense and fewer personnel than a full three member court.</p>

<p>AB 1699 - Chapter 592 Knox</p>	<p>Repeals provisions authorizing a county water district to assess, levy, and collect its own taxes. It permits a county water district which, on the effective date of the bill is assessing, levying, or collecting its own taxes to continue to do so.</p>
<p>AB 1797 - Chapter 593 Ryan</p>	<p>Provides that with respect to traffic offenses where a person has willfully violated his written promise to appear in court for 15 or more days the judge or clerk of the court shall notify the Department of Motor Vehicles of such fact not more than 60 days after issuance of warrant.</p>
<p>AB 1885 - Chapter 594 Sieroty</p>	<p>Provides that motor vehicles manufactured prior to December 31, 1939, which are operated or moved over the highway primarily for the purpose of historical exhibition or other similar purpose shall be required to have sealed beam headlamps.</p>

AB 2055 - chapter 595 Shoemaker & Lagomarsino	Amends the Public Utilities Code provisions relating to the annexation and detachment of territory from the Santa Barbara Metropolitan Transit District. The bill deletes requirement that two of the District's directors shall be residents of unincorporated area if the District contains unincorporated area. It also changes the manner in which territory within the district may be excluded from the district.
AB 2314 - Chapter 596 Veneman	Provides that the title of a grantee of a treasurer's deed for unredeemed property is not free from lien of any special assessment whose lien date is prior in time to the lien date of the assessment for which the deed is issued.
AB 2399 - Chapter 597 Veneman	Provides for issuance of certificates representing unpaid assessments against public property and sets forth the form of such certificates.
AB 1425 - Chapter 598 Lanterman	Grants allowance for member's children under the County Employees' Retirement Act of 1937 to a surviving spouse of a member regardless of remarriage, rather than only to the widow of a member until she remarries.
SB 356 - Chapter 599 Coombs & Cologne	Authorizes a legislative body to order, in its resolution of intention, that private utility damages be included in the assessment for improvements. The bill includes private utility damages within incidental expenses of improvement ordered under Municipal Improvement Act.
SB 561 - Chapter 600 Stiern	Permits the board of supervisors of a county to provide that when annual earnings of the retirement fund in excess of the amounts credited to contributions and reserves exceed 1 percent of the total assets of the system, the excess may be transferred to a special fund which shall be used to increase monthly retirement allowances as economic conditions, as determined by the board of supervisors, warrant.
SB 587 - Chapter 601 Grunsky	Authorizes juvenile court on application of a ward or dependent child and the superior court on application of other minors to grant such minor permission to marry and consent to the issuance of a marriage license where there is no parent capable of consenting. The bill allows licensing clerk to request identification as to name and additional documentary proof as to facts stated on application. It also increases fee for issuing duplicate certificate of license to \$2.50.
SB 651 - Chapter 602 Cologne	Amends the Probate Code to allow summary probate where the value of the decedent's property does not exceed \$3,000 and where there is no interest in any real property rather than the present \$2,000 ceiling.
SB 315 - Chapter 603 Grunsky	Includes deputy constables among persons defined as peace officers.
AB 628 - Chapter 604 Monagan	Specifies that any qualified person, when deputized or appointed by the proper authority as a reserve or auxiliary sheriff or city policeman while performing assigned police functions, is a peace officer under provision of the Penal Code listing peace officers with general authority.

The bill provides for such change only if provided for in terms of agreement for annexation or transfer of territory or is recommended by county committee on school district organization and approved by governing board of the junior college district affected.
- SB 417 - Chapter 606  
Alquist & Vasconcellos  
Continues the authority of school districts to maintain continuation education classes during such hours as classes for adults are maintained.
- SB 478 - Chapter 607  
Collier & Sherman  
Amends the Vehicle Code to differentiate between a speed contest and an exhibition of speed by placing each in a separate subdivision of the Code.
- SB 688 - Chapter 608  
Alquist  
Makes a person eligible to be elected or appointed judge of a municipal court of a judicial district in Santa Clara County or Orange County if he is a resident eligible to vote in the county in which the judicial district is located.
- SB 771 - Chapter 609  
Way  
Permits counties to use electronic data processing equipment in connection with information appearing on extended property tax rolls. If such a procedure is used, the bill provides the data shall be so stored that it can be readily available to the public in an understandable form.

Provides that the Public Utilities Commission shall make payments directly to the railroads involved, from funds allocated to it annually by the California Highway Commission and the Department of Public Works, the local agency share of the expense of maintaining automatic grade crossing protection.

SB 1435 - Chapter 615 Burgener	Establishes a procedure for local legislative bodies to issue bonds for sidewalk maintenance and repair purposes under the Improvement Act of 1911.
SB 1503 - Chapter 616 Teale	Permits the Director of General Services, with consent of the Department of Mental Hygiene, to grant to the County of Stanislaus a right-of-way for public road purposes over the lands of Modesto State Hospital.
AB 296 - Chapter 617 Dunlap	Changes name of forest reserve school fund to forest reserve account in county school service fund. Deletes the Education Code provision authorizing money apportioned there-from to the county superintendent of schools to be deposited by the county auditor to the credit of the county school tuition fund. The bill corrects conflicting provisions of the Government Code and Education Code.
AB 406 - Chapter 618 Ryan	Prohibits school districts, county boards of education, and county superintendents of schools from expending funds or using the regular work time of employees to secure a copy right for any person or firm.
AB 528 - Chapter 619 Crandall	Authorizes governing board of a school district to establish an awards program for employees making exceptional contributions to the operation of the district or to the public welfare through various proposals, acts, services, or accomplishments. The bill authorizes a school board to establish awards committees which may make awards of up to \$200 unless a larger award is expressly approved by board.

SB 266 - Chapter 645  
Burns

Eliminates the State Librarian and Chief of the Division of Industrial Welfare from the provision of the Government Code fixing an annual salary of \$15,500. It provides that appointment of State Librarian by the Governor shall be subject to Senate confirmation. Deletes the Labor Commissioner and Chief of Industrial Safety from the Government Code provision fixing annual salary of \$19,500. The bill also appropriates \$18,008 to State Controller in augmentation of the 1967-68 budget appropriation for personal services.

Note: Chapters 646 and 647 are at the end of this memo.

JULY 11, 1967

SB 171 - Chapter 648  
Song

Provides for the right of transfer of superior court employees in counties with more than 2,000,000 population to other departments of the county government, subject to approval of board of supervisors and subject to county charter and other usual conditions placed upon such a transfer. The bill further provides that rules governing transfers, promotions and demotions between judicial districts shall be substantially the same as those governing county employees in county departments. The bill applies only to employees of the Los Angeles Superior Court.

SB 243 - Chapter 649  
Alquist & Bradley

Provides for the cancellation or refund of any tax or penalty imposed upon property acquired by an organization qualified for the welfare tax exemption if such property presently qualifies for the exemption and was acquired after the lien date but before the commencement of the fiscal year and if the fiscal year began in 1966.

SB 247 - Chapter 650

Amends the Evidence Code by specifying the evidentiary effect of presumptions relating to the violation of a statute, and certain interests in realty. The bill allows counsel identified with a witness or party called as adverse witness or party to use cross-examination rather than redirect-examination in certain circumstances. The bill also provides that certain copies and translations of original Spanish land documents are admissible as evidence without authentication of the original documents.

SB 263 - Chapter 651  
Collier & Carrell

Makes it unlawful to land, taxi, or take off aircraft on a public freeway, highway, road or street, except in certain emergencies.

SB 372 - Chapter 652  
Sherman

Makes technical amendments to the Vehicle Code provisions relating to motor vehicle accidents resulting in injury or property damage. The amendments clarify that a person involved in an accident resulting in damage to property or which causes injury or death must stop and comply with all the requirements of the section.

The bill specifies that annexation or establishment of any zone within a chartered or incorporated city may be upon any conditions imposed by the city and accepted by the District board.</p>
<p>SB 652 - Chapter 655 Coombs &amp; Veysey</p>	<p>Changes description of the boundaries of San Bernardino County to conform to the state boundary changes resulting from the Interstate Compact Defining the Boundary between the States of Arizona and California.</p>
<p>SB 678 - Chapter 656 Short</p>	<p>Deletes requirement of publication of notice of hearing on petition for withdrawal or annexation of territory from or to a storm drain maintenance district where a petition has been signed by 100 percent of the landowners in the subject land, as shown by the last equalized assessment roll.</p>
<p>SB 693 - Chapter 657 Marler &amp; Way &amp; Johnson</p>	<p>Makes permanent the bovine tuberculosis program for exposed nonreacting animals.</p>
<p>SB 773 - Chapter 658 McCarthy</p>	<p>Provides that local public agencies seeking to enter a contract requiring the letting of bids shall specify in the public notice the place such bids are to be received and the time by which they are to be received. The bill requires that bids received after the time specified shall be returned unopened.</p>
<p>SB 813 - Chapter 659 Short</p>	<p>Permits the Director of the Department of Professional and Vocational Standards to inspect the examination papers of the Board of Dental Examiners. This will make uniform the authority of the Director to inspect the completed examination papers of the various boards and commissions within the Department.</p>

SB 1040 - Chapter 666 Stevens	Increases the maximum aggregate amount, from one to two percent of a bank's capital and surplus, which a bank may invest in the stock of small business investment companies authorized to operate under the Small Business Investments Act. The bill will make it possible for state banks to participate equally with national banks in the small business investment company program.
SB 1149 - Chapter 667 Deukmejian	Makes the provision of law prohibiting sale of alcoholic beverages within 1900 feet of any Youth Authority Institution inapplicable as to Fred C. Nelles School for Boys in Whittier.
SB 1186 - Chapter 668 Wedworth	Permits consolidation of the elections of certain school district and regular city elections.
SB 1205 - Chapter 669 Schrade	Includes public corporations and other public entities within the Harbors and Navigation Code provisions allowing the declaration of watercraft left on tidelands without supervision to be abandoned, and allowing the sale thereof by such corporation or entity. The bill requires that if a registration number appears on such watercraft, notice shall be sent to the registered owner at least 5 days prior to introduction of an ordinance to order removal.
SB 1216 - Chapter 670 Bradley	Extends until December 31, 1968 the time within which parties to the conveyances of land as are authorized to be made by the present law may resort to the courts to quiet title and eliminate any clouds that may exist. The basic statute in question was adopted to allow an exchange of slough lands, the title of which is obscure in many instances.

AB 1484 - Chapter 683 Briggs	Requires that court abstract of conviction, and records, or information concerning records, of such abstracts; contain information with respect to the commercial or noncommercial nature or license plate number of the vehicle involved in the offense.

AB 1600 - Chapter 681 Crown	Subjects securities of companies organized for the promotion, development or organization of a world's fair to the Corporate Securities Law.
AB 1677 - Chapter 685 Fenton	Permits judges of the Los Angeles municipal courts, except the Los Angeles Judicial District to select from deputy clerks, persons to serve as court clerks.
AB 1772 - Chapter 686 Badham	Permits a city, city and county or county to use funds allocated from the State Highway Fund or the Highway Users Tax Fund to finance the local agency's share of the cost of constructing protective facilities on all mainline grade crossings.
AB 1805 - Chapter 687 Foran	Provides that a contractor who installs or contracts for the installation of a carpet wherein the carpet is attached to the structure by any conventional method is a specialty contractor.
AB 1806 - Chapter 688 Foran	Provides that the term "property" as used in the Civil Code provisions which relates to the regulation of investments by trustees, includes life insurance, endowment, and annuity contracts issued by legal reserve companies authorized to do business in this state.
AB 1821 - Chapter 689 Moretti	Corrects references in various provisions of the Insurance Code. The bill makes no substantive change.
AB 1850 - Chapter 690 Fenton	Authorizes the Walnut Irrigation District, by agreement with City of Pico Rivera, to transfer all District property to the City. The City is to assume all obligations of the District to provide water service to the District's area.
AB 1907 - Chapter 691 Z'berg	Changes the posting requirements for notices of competitive bidding for contracts executed by the Department of General Services in excess of \$2,500 for work to be performed by use of rented tools or equipment, from posting in the district office of the Division of Highways within which the work is to be done, to posting in the Sacramento and Los Angeles offices of the Office of Architecture and Construction of the Department of General Services.

AB 2115 - Chapter 694 Ketchum	Allows elective officers of a California water district, other than directors, to appoint deputies in such number as the board of directors of the district may authorize.
AB 2116 - Chapter 695 Ketchum	Authorizes California water storage districts to deposit district funds in banks.
AB 2172 - Chapter 696 Priolo	Deletes the Streets and Highways Code provisions authorizing inclusion in the estimated cost of an improvement of an amount, not to exceed \$200 on any one lot, for work under the Improvement Act of 1911 to eliminate disparity in level or size between the improvement and driveways, house-walks, and sewers.

AB 2173 - Chapter 697 Priolo	Adds to the improvements which may be made under the Improvement Act of 1911, the construction of structures, to prevent beach erosion.
AB 2247 - Chapter 698 Z'berg	Permits the State, in exchanges of real property when the State receives the mineral interest in the parcel or parcels being acquired, to transfer the mineral interests in the lands being exchanged.
AB 2330 - Chapter 699 Ryan	Revises provisions of the San Mateo County Flood Control District Act prescribing conduct of proceedings for establishment of zones and subzones by combining such proceedings with provisions authorizing institution of zone projects for benefit of such zones.
AB 2356 - Chapter 700 Miller	Provides that whenever a correction of a clerical error increases a tax assessment, the board of supervisors may apply a rate of tax to such increase at whatever tax rate was in existence in the year in which the clerical error was made.
AB 1403 - Chapter 701 Barnes & Collier	Includes the Teachers' Retirement Board of the State Teachers' Retirement System among those state agencies not required to secure approval of the Department of Finance prior to investment, sale or exchange of securities such agencies are authorized to invest, sell or exchange.

JULY 12, 1967

SB 244 - Chapter 702 Bradley & Song	Extends a vehicle owner's vicarious liability for the acts or omissions of a permissive user to include willful misconduct and intoxication.
SB 249 - Chapter 703 Bradley & Song	Classifies the various presumptions in the Commercial Code in accordance with the statutory scheme set up by the Evidence Code.
SB 297 - Chapter 704 Teale	Permits the use of metal studs in tires between October 1 and May 1 for a two-year period. The bill's provisions are effective until May 1, 1969.
SB 316 - Chapter 705 Grunsky & Petris	Authorizes junior colleges to hire teachers as temporary employees for a semester or quarter of the school year if such additional teachers are needed because of higher enrollment of students during that semester or quarter. The bill limits such employment to a total of two semesters or quarters during any consecutive three-year period.
SB 405 - Chapter 706 Burgener	Grants taxpayer's suits to enjoin public improvement projects special precedence over all civil matters on the court calendar except those matters granted equal precedence by law.
SB 875 - Chapter 707 Short & Monagan	Increases the annual salary of members of the Board of Supervisors of San Joaquin County. The salaries of Board members are raised from \$8,400 to \$12,000.
SB 904 - Chapter 708 Grunsky	Makes it a misdemeanor to sell, offer to sell, or give away any live chicks, rabbits, ducklings, or other fowl which has been dyed or artificially colored.
SB 914 - Chapter 709 Cologne	Permits a person to register with State Board of Accountancy as a public accountant upon payment of prescribed fee if prescribed conditions are met.
SB 953 - Chapter 710 Deukmejian	Declares that an alleged mentally ill person apprehended in an emergency situation shall not be detained in a jail or other correctional facility.
SB 977 - Chapter 711 McCarthy	Deletes the Education Code exemption for children residing more than 2 miles from a school from the requirements of attendance at a school.
SB 1147 - Chapter 712 Deukmejian	Limits use of the diagnostic and treatment centers of Youth Authority to specified minors who are otherwise eligible for commitment to the Youth Authority.
SB 1215 - Chapter 713 Bradley	Provides whenever a notice is required by law to be recorded for any purpose, it shall be signed by the person giving notice or his agent.
SB 1256 - Chapter 714 Dolwig	Increases the monetary amount of transactions which the Director of General Services may exempt from his approval or from the approval of the Department from \$10,000 to \$25,000.

SB 1433 - Chapter 715  
Burgener

Provides that records of domestic relations actions may be destroyed when five years have elapsed since their filing in the office of the county clerk and the action or proceeding in which they were filed is not pending or on appeal in any court.

AB 24 - Chapter 716  
Chapel & Townsend

Makes a technical change in the law relating to the registration of sex offenders.

AB 438 - Chapter 717  
Fenton

Amends the Education Code to clarify provisions relating to counting attendance for apportionment purpose in classes scheduled for more than one period. Total class hours for apportionment attendance are restricted to no more than the scheduled clock hours in the period.

AB 534 - Chapter 718  
Veysey

Expands the definition of "public moneys," for purposes of the Penal Code provisions prohibiting embezzlement and other mishandling of public funds, to include all moneys, bonds, and evidences of indebtedness belonging to any public agency or received or held by any public agency officer, rather than only certain specified public agencies and officers thereof.

AB 854 - Chapter 719  
Powers

Allows letters of administration to be granted to the conservator if the conservatee was otherwise entitled to administer. The bill allows the conservator to receive the property under summary probate in the same manner as the guardian and under the same conditions. It allows the executor or administrator to distribute to a conservator or other fiduciary of the estate of the non resident minor, ward, or conservatee who is the distributee under the probate proceedings.

AB 1306 - Chapter 720  
Negri

Broadens the provisions for substituted service on nonresident motorists by permitting such service in any cause of action arising from the operation of a motor vehicle by the owner of his agent anywhere within this state instead of limiting the cases in which substituted service may be had to actions arising out of the operation of a motor vehicle upon the highways of this state as provided in the present statutes.

AB 1340 - Chapter 721  
Bagley

Authorizes the superior court in Marin County to assign the court commissioner, in addition to other duties assigned by law, the duties prescribed for court commissioners in counties with population of 900,000 or more and the duties of probate commissioner.

AB 1389 - Chapter 722  
Burton

Requires an insurer who determines not to renew an automobile liability insurance policy to give insured a written notice of non-renewal at least 20 days prior to lapse of policy or payment period. The bill provides that written notice mailed to the last known address of the insured, as stated in the policy by regular mail, shall constitute notice to the insured. The bill also makes each willful violation of chapter a misdemeanor punishable by a \$500 fine.

AB 1697 - Chapter 723  
Karabian

Provides that a person who has made a bona fide sale of a vehicle and given appropriate notice to the Department of Motor Vehicles will not be responsible for subsequent traffic violations involving the vehicle. The bill removes restrictions to permit the Department to redesign the vehicle ownership certificate for better flexibility. It exempts the seller of a vehicle from giving information concerning persons involved in the sale of a vehicle other than the purchaser's name and address, the date of sale, and a description of the vehicle involved. The bill also provides that a person need not surrender the registration card when applying for transfer of registration on a certificate of ownership issued for the year of last registration.

AB 1874 - Chapter 724  
Zenovich & Mobley

Permits the superior court in counties having a population of at least 365,000 but not over 400,000 to appoint a supervising counselor and such staff and office assistants as are required to assist the conciliation court.

AB 1988 - Chapter 725  
Moorhead

Permits an executor or administrator of the estate of a deceased person who died having sold but not delivered securities or commodities not owned by such person, to petition the court for an order authorizing purchase of such securities or commodities in order to fulfill the obligation.

AB 2050 - Chapter 726  
Bagley

Provides that trust distributions of ordinary income made by regulated investment companies or real estate investment trusts are income, and that all other distributions, for example capital gains, are principal.

AB 2093 - Chapter 727  
Leroy Greene

Amends the Subdivision Map Act to clarify requirements for parcel maps and standardizes procedures for handling subdivision maps, parcel maps and record-of-survey maps.

AB 2105 - Chapter 728  
MacDonald

Repeals and reenacts provisions prohibiting motor vehicles from being equipped with more than a certain number, color, or type of cowl, fender, or side lamps in the front or rear of vehicles.

AB 2225 - Chapter 729  
Powers

Raises the filing fee in small claims courts from \$1.50 to \$2. The recent increase in the jurisdictional limit of the small claims court makes the fee increase even more necessary.

AB 2313 - Chapter 730  
Zenovich

Increases the salary for court interpreters in Fresno County from \$30 to \$35 per day.

AB 2393 - Chapter 731  
Veneman

Permits cantaloupes of size 18 or larger to be packed in specified containers, if the containers are marked with the exact number of cantaloupes contained therein.

AB 2481 - Chapter 732  
Cory

Provides that any annexation to existing street lighting districts organized pursuant to the Street Lighting Act of 1919 shall be effective for assessment or taxation purposes if the statement and maps or plats required to be filed with the assessor and State Board of Equalization are filed on or before May 1, 1967.

Sacramento--Governor Ronald Reagan announced today he has signed the following bills:

*July*

AB 1371 - Chapter 733  
Stacey & Ketchum

Revises provisions concerning collection of local taxes for support of the education of mentally retarded and physically handicapped minors by the county superintendent of schools, to require levy and collection of taxes at an identical tax rate in smaller school districts not approved to conduct their own schools and classes.

*July*  
~~JUNE~~ 17, 1967

SB 15 - Chapter 734  
Coombs

Requires the Board of Supervisors of San Bernardino County, upon annual request of the Desert View County Water District, to levy a bond tax with respect to land only in the District or improvement district benefited by the purposes of the bonded debt.

SB 27 - Chapter 735  
Stiern

Extends for two years a permissive override tax of 10 cents to pay for the installation of fire and panic safety equipment in school buildings. This override tax was enacted in 1961 to enable school districts to install proper fire and panic safety equipment recommended by the State Fire Marshal.

SB 399 - Chapter 736  
Rodda

Permits the assignment of Sacramento County superior court reporters to the municipal court in civil and criminal cases. The bill also raises the basic per diem for court reporter in Sacramento County.

SB 460 - Chapter 737  
Short

Requires that when a notice of a bulk sale subject to the Commercial Code provides for an escrow, that the full purchase price will be placed with the escrow holder, and that the escrow shall, if the purchase price is insufficient to pay all creditors' claims, delay the closing and give notice to creditors of the deficiency. The bill prohibits payments from the escrow of fees and commissions prior to the close of escrow.

SB 497 - Chapter 738  
McAteer

Increases the salaries of various clerks, commissioners, referees and secretaries of the San Francisco Superior Court and provides for one counselor of conciliation, one counselor in mental health, one additional assistant court commissioner and law clerk, and one additional judicial secretary.

SB 517 - Chapter 739  
Dolwig

Permits firms engaged in rendering civil engineering services to continue to use name of deceased person in firm name if certain conditions are met.

SB 557 - Chapter 740  
Cologne

Prohibits the sale of intoxicating liquor within one airline mile of a specified intersection at the entrance to La Sierra College in City of Riverside, subject to exceptions for the sale of beer, existing licenses, bona fide and public eating places. The bill is so written that the future expansion of the college will not widen the "dry zone".

SB 596 - Chapter 741  
Teale & Lagomarsino

Authorizes cities and counties to enact regulations equal to or greater than those imposed by existing state law regarding motel rate signs. Because of the language of the present law and court decisions, it is not clear whether local government has the authority to enact local ordinances supplementary to existing state law.

SB 646 - Chapter 742  
Short

Provides that a registered apprentice may work 5 years instead of 3 years before having to fulfill the requirements for passage of the journeyman barber examination. The bill is intended to give apprentices sufficient time to prepare for the journeyman barber examination.

SB 764 - Chapter 743  
Burgener, Schrade,  
Barnes

Provides authority for the State Department of Parks and Recreation to enter into a 20-year lease of park land located within the Palomar and Cuyamaca State Parks for elementary school conservation study camps.

SB 768 - Chapter 744  
Way - Mobley

Allows interest on loans to be charged, in the discretion of the board of supervisors, to the general fund of any district or fund for which loans have been made. Local agencies may temporarily borrow moneys which are needed for operating purposes during so-called "dry periods" before property taxes are collected.

SB 841 - Chapter 745  
Bradley

Requires recreation and park districts to let out to bid all construction and materials contracts of more than \$3,000 as prescribed. The bill authorizes a district board to reject bids and to readvertise, or by 4/5 vote purchase the materials or supplies, or undertake the construction by force account.

SB 869 - Chapter 746  
Beilenson

Changes the statute of limitations for refunds on property taxes from three years from the date of payment to three years from the date of payment or one year from the mailing of the notice by the tax collector to the assessee specifying irregularities, whichever occurs later. The bill also provides, with respect to applications for reductions constituting claims for refunds, that the applicant must state in the application that it is intended to constitute a claim for refund, and if it is not so stated, he may file a separate claim for refund within the period of the appropriate statutory limitation.

SB 872 - Chapter 747  
Cologne

Repeals all statutes relating to the licensing of mineral, oil and gas salesmen. There are no mineral, oil and gas salesmen licensed at this time. The mineral, oil and gas broker status is retained and future applicants for salesman status will qualify for broker status since requirements are virtually identical.

SB 895 - Chapter 748  
Dolwig

Raises to \$3,000 the amount for which a county can purchase real estate without publication of a notice of intention. The bill will produce substantial savings to counties each year because of the publication costs and the time and expense involved in preparing and processing the required resolution.

SB 908 - Chapter 749  
Grunsky & Pattee

Authorizes members of the district board of a garbage and refuse disposal district to receive actual necessary travel and meal expenses incurred in performance of official business of district.

SB 1008 - Chapter 750  
Grunsky

Authorizes a county board of education to acquire real property for purpose of housing the offices and services of the county superintendent of schools, providing various duties and functions of county board of supervisors have been transferred to county board of education.

SB 1067 - Chapter 751  
Grunsky

Requires that service of summons and complaint in proceeding to condemn State lands be made on the State Lands Commission instead of the Surveyor General.

SB 1109 - Chapter 752  
Coombs & Lagomarsino

Provides that a corporate merger or consolidation may be approved by the unanimous written consent of shareholders. The bill also requires the corporation president, vice president and the secretary to execute a verified certificate of the fact that written consents have been filed with the corporation.

SB 1227 - Chapter 753  
McCarthy

Requires consideration involved in transfer of an alcoholic beverage license deposited with an escrow holder, if insufficient to pay filed claims of bona fide creditors in full, shall be distributed in prescribed manner, rather than pro rata to all the licensee's creditors. The bill requires escrow holder, if the transferor licensee disputes any claim, to retain the amount or pro rata amount thereof for a period of 25 days, and if not attached to pay the amount to the transferor licensee. The bill also requires escrow holder, if transferor licensee disputes any creditor's claim, to retain amount or pro rata amount and treat as noncash asset.

SB 1265 - Chapter 754  
Dolwig & Britschgi

Provides that the design of the West Bay Rapid Transit Authority's transit facilities need not be compatible with that of the Bay Area Rapid Transit District in regard to modes of transportation other than fixed rail for fixed right-of-way facilities. Extends to June 30, 1969 the deadline by which a master plan must be approved by the voters of the counties in which the authority is authorized to operate. Gives the Authority power to apply for and accept grants from the federal and state governments. Authorizes the Authority to dispose of air space over its properties when it will not interfere with the operation of the transit system.

SB 1455- Chapter 755  
Lagomarsino &  
Shoemaker

Changes the title, classifications, and salaries of various attaches of the Santa Maria Municipal Court.

SB 1476 - Chapter 756  
Lagomarsino

Provides for staffing and compensation of the Ventura County Municipal Court.

AB 46 - Chapter 757  
Leroy Greene

Charges county superintendent of schools with responsibility of coordinating special education programs provided for physically handicapped and mentally retarded minors, of affording all eligible minors an opportunity to participate in such programs, and of marshalling and utilizing all public and private resources for such special education. The bill also requires county superintendent of schools to compile and maintain a tabulation of the number of all physically handicapped and mentally retarded minors enrolled in programs and the schools in which they are enrolled & current list of such minors who

AB 59 - Chapter 756  
Elliott

Provides that whenever any member of the State Teachers' Retirement System or a district teachers retirement system dies while in active membership, or within four months of termination of employment the benefits payable at death shall be paid to the beneficiary or beneficiaries designated by him unless a claim is filed by someone other than designated beneficiary or beneficiaries within 30 days after death.

AB 216 - Chapter 759  
Veneman & Chappie

Establishes in the Department of Justice a central registry of information pertaining to parents who have abandoned or deserted their children. The primary purpose of this registry will be to assist county welfare departments, district attorneys, probation officers, and other appropriate agencies and officials in locating missing parents so that their responsibilities for the support and maintenance of their children may be effectively enforced.

AB 380 - Chapter 760  
Chappie

Authorizes teachers holding a standard teaching credential with a specialization in elementary teaching, to teaching elementary level reading in continuation education classes and continuation high schools. Continuation education classes are for pupils 16 to 18 years of age who have not finished high school but are not enrolled full-time. Some of the pupils are in need of assistance with reading in order to profit from other courses.

AB 456 - Chapter 761  
Cory

Provides that the normal work day for classified school employees shall be 8 hours. Certain classes (security patrol) are exempt from the 8-hour day provisions. It further permits a school board to establish a lesser work day and work week (less than 8 and 40 hours). It also gives part-time classified employees fringe benefits based on the average number of hours actually worked per working day.

AB 567 - Chapter 762  
Wilson & moretti

Includes as eligible securities for the investment of surplus state moneys, bonds, notes, and other obligations issued by the Tennessee Valley Authority.

AB 588 - Chapter 763  
Fong

Authorizes school governing boards to lease land as site for temporary quarters or portable buildings.

AB 609 - Chapter 764  
Veysey

Exempts unified school districts which do not meet regular unification standards and which are not approved as parts of county master plan, if such districts have been formed by specified statutory procedures, or were formed by action of law and in existence since prior to July 1, 1948, and are approved by the county committee on school district organization from required reorganization elections to be held every two years and from inclusion in certain master plans.

AB 627 - Chapter 70  
Monagan

Broadens definition of cement carrier, regulated as common carrier, to include carriers transporting cement either alone or in combination with lime or powdered limestone. It broadens definition of cement contract carrier regulated by Highway Carrier's Act in similar manner. The bill provides that the certificate of public convenience and necessity to operate as cement carrier shall remain in effect until suspended or terminated by the Public Utilities Commission, but shall lapse if not exercised for a period of one year. The bill also makes cement contract carriers rendering service within a city subject to the Highway Carrier's Act.

AB 694 - Chapter 766  
Cory

Authorizes Trustees of California State Colleges to provide for the care or disposition of unclaimed, lost or abandoned property. Requires such property to be held for at least six months' period and to be sold at public auction after publication of notice of sale.

AB 736 - Chapter 767  
Foran

Exempts from prescribed stopping and parking requirements of the Vehicle Code a commercial vehicle when reasonable necessary to load or unload merchandise of passengers.

AB 936 - Chapter 768  
Kochum

Changes the period within which stated maximum amounts of student body organization membership fees and student body center fees may be required from year to academic year.

AB 961 - Chapter 769  
Biddle

Requires the Department of Motor Vehicles to return the driver's license to the licensee, or to grant him a new one after the Department has cancelled his license, if the department determines that grounds for cancellation didn't exist at the time such action was taken.

AB 1012 - Chapter 770  
Cory

Authorizes savings and loan associations in California to invest in securities insured in whole or on part by the Federal Savings and Loan Insurance Corporation.

AB 1022 - Chapter 771  
Shoemaker

Prohibits the appointment of classified employees by a school district to represent employees in employer-employee relations but permits governing board of school district, if no employee organization exists, to appoint such a committee to advise employer on employer-employee relations.

AB 1197 - Chapter 772  
Biddle

Amends the work furlough law to provide specific authority to furlough selected State and county prisoners for educational purposes if the county chooses to adopt the required ordinance. It also permits prisoners to be furloughed from State community correctional centers for educational purposes. The prisoner would be confined when not being educated or working. The bill also eliminates the need for approval by the parole boards of the transfer of a State prisoner to a county jail or community correctional center, requiring instead that the prisoner's term have been already fixed by the parole board.

AB 1205 - Chapter 773  
Negri

Amends the Probate Code to provide that the Civil Discovery Act is applicable in probate proceedings. The bill codifies California Case law.

AB 1367 - Chapter 77  
Townsend

Provides that ordinances creating city civil service systems shall include provision granting service credit to employees on leaves of absence for injuries under workmen's compensation laws, so that their rights to seniority, vacations, sick leaves, and salary adjustments will not be affected by such leaves of absence.

AB 1396 - Chapter 775  
Bear

Requires all automobile liability insurance policies which contain a provision indicating that coverage is extended to accidents, occurring, and losses arising in Mexico, to contain a warning that the insurance policy may not be honored in Mexico and that the insured, before driving into Mexico should obtain insurance from a Mexican insurance company.

AB 1496 - Chapter 776  
Bagley

Provides that the trustee of any trust shall not be required to set aside reserve or allowance from trust income for depreciation or depletion on any property held in such trust unless the instrument in which such trust was created requires such reserve or allowance. The bill also specifies that section applies both to trusts created before, and trusts created after, the effective date of section.

AB 1542 - Chapter 777  
Brown

Deletes the requirement that the State Board of Education submit a copy of petition for formation of junior college to the Coordinating Council for Higher Education. The bill also deletes a requirement that the Coordinating Council submit report on proposal to State Board.

AB 1563 - Chapter 778  
Ray Johnson

Changes from May 1 to March 15 the date by which a contract for the next school year may be presented to a teacher for acceptance or rejection. The bill also increases to 45 days (from 20 days) in which teachers who are not under permanent tenure, after receiving notice of election or employment, must signify acceptance or be deemed to have declined the employment.

AB 1578 - Chapter 779  
Bear

Revises provisions of the Code of Civil Procedure relating to the allocation of peremptory challenges of jurors in civil actions where there are more than two parties.

AB 1595 - Chapter 780  
Shoemaker &  
Lagomarsino

Authorizes a county sanitation district to provide street sweeping and cleaning services upon roads and streets within the boundaries of the district.

AB 1688 - Chapter 781  
Lanterman

Provides authority for advance payment of pro rata fiscal charges upon request of the Department of Finance. It will cause moneys which are now transferred to the General Fund only once a year to be transferred at least four times annually. Agencies will be paying for administrative services as they are received. This will help ease the General Fund's cash flow problems.

AB 1787 - Chapter 782  
Stacey

Corrects reference in a Business and Professions Code Section relating to pharmacy.

AB 1830 - Chapter 783  
Ketchum

Deletes the Agricultural Code provisions relating to foreign cold storage meat.

AB 1914 - Chapter 78  
Zenovich

Deletes language in t. Financial Code which permits the Savings and Loan Commissioner to utilize a sample appraisal as a basis of requiring a specific reserve against the entire portfolio of an institution.

AB 1945 - Chapter 785  
Lanterman

Specifies that certain penalty assessments, as well as various other assessments, shall not be effective for any purpose, until notice has been mailed to the assessee or the assessee has received a tax bill based on such assessment. The intent of the bill is to allow a complete hearing on all the issues relating to an escape or penal assessment at one hearing.

AB 2423 - Chapter 786  
Lanterman

Prohibits designation of particular state hospitals or facilities in court orders committing mentally ill or retarded persons to Department of Mental Hygiene for Placement. The bill requires Department to designate the Hospital or facility for care and treatment and notify clerk of superior court of the facility designated. The bill also prohibits the transfer of a mentally retarded person to a different hospital without consent of parent or guardian.

AB 2424 - Chapter 787  
Lanterman

Continues for two years the authority of the Department of Mental Hygiene to employ physicians from out of state who have not yet obtained their California license to practice medicine for a one-year period to work, if the department is unable to recruit physicians in California.

AB 2495 - Chapter 788  
Brown

Allows a person with specified requirements to take physician's and surgeon's oral examination and to receive a physician's and surgeon's certificate upon successful passage of such examination.

SB 594 - Chapter 789  
Burns & Bagley

Provides that the rights, with respect to any fund from which construction costs are to be paid, of all persons furnishing labor, services, equipment, or materials to a construction project are governed exclusively by the provisions of the Mechanics' Lien Law relating to "stop notices" unless contracted differantly. The bill requires a preliminary notice to be given, by specified persons, to the "construction lender", before a notice to withhold construction funds is valid. Imposes notice requirements on certain persons under direct contract with owner. The bill also provides that the preliminary notice must be given within 20 days after the claimant provides his services, rather than at least 15 days prior to the expiration of the time within which a claim of lien may be filed.

Governor Ronald Reagan today issued the following statement:

"Because there has been great concern on the part of many Californians about racial unrest and rioting in other parts of the nation, I feel it is appropriate now to bring the citizens of this state up to date on what this administration is doing to help solve the problems of our cities.

"As you know, I have scheduled a meeting with a group of responsible leaders of the Negro community from throughout the state to talk about these problems and to seek solutions. I might point out that the meeting is one of a series that I and members of my staff have held since last January with Negro leaders and representatives of Negro groups.

"We are working closely with key leaders at the local level and with local officials to stimulate grassroots actions aimed at eliminating the basic and real causes of racial tensions. We feel that much progress has been made and much more can be made in the days and months ahead as we work together to extinguish hotspots before they flare into major disorders.

"I would like to repeat a statement I made last January 5 at my inauguration: '...Those with a grievance can seek redress in the courts or Legislature, but not in the streets. Lawlessness by the mob, as with the individual, will not be tolerated. We will act firmly and quickly to put down riot or insurrection wherever and whenever the situation requires.'

"There is no change and there will be no change from that position. But it is our hope and aim to eliminate the causes of riots before they can start.

"Now, let me recite just a few of the steps we have taken in this area since January.

"Robert Keyes, my human affairs secretary, has visited and met with community leaders in East Los Angeles, Watts, San Diego, Richmond, Venice, Compton, Hunters' Point, Vallejo, Berkeley, Oakland, Haight-Ashbury, Bakersfield, Fresno and San Bernardino.

"Chad McClellan, as you know, is heading a statewide program in which private industry is training and placing Californians in jobs. I have assigned Lt. Gov. Finch the responsibility of the Job Training and Placement Council which is coordinating these activities.

"Additionally, in May I ordered an expansion of state employment during the summer months, emphasizing jobs for underprivileged youth.

"Members of my staff have been and are continuing visits to the major cities of California, meeting with mayors, human relations officers and city officials to discuss minority problems.

"That briefly gives you an idea of some of the things we have already done in the area of human relations.

"However, I want to emphasize that we will be prepared in case our efforts to prevent riots fail.

"Cabinet Secretary William Clark, Jr. and Clemency and Extradition Secretary Edwin Meese III have established through their offices close liaison with local law enforcement agencies.

"Working with representatives of the California Highway Patrol, the National Guard and the State Disaster Office, state and local officials have set up procedures that can and will be put into effect immediately if any situation requires quick and firm action. But let me emphasize again we are doing all we can to avoid trouble and will continue to do so.

"More meetings will be held in the future and I am confident that all Californians will meet their responsibilities.

"In this regard, I would like to announce that plans are in preparation--and have been since May 31--to call a statewide conference designed to find practical and workable solutions to our problems. Responsible Negro leaders from throughout the state will be invited to meet with department heads, officials in the Health and Welfare Agency, representatives of the Office of Economic Opportunity, and others that can assist us.

"In this way I am sure we can find lasting solutions to the many problems that beset all our poor and our minority groups."

Sacramento--Governor Ronald Reagan announced today he has signed the following bills:

JULY 18, 1967

AB 668 - Chapter 790  
Knox

Makes a number of technical amendments to the Improvement Act of 1911 relating to municipal improvements. The bill also provides that a legislative body in proceeding under the Municipal Improvement Act of 1913 may apply surplus improvement funds as a credit to any governmental bodies or agencies which have contributed toward the costs and expenses of the improvement.

AB 1703 - Chapter 791  
Knox

Provides that in the division of land and bond proceedings under the Improvement Act of 1911, the Improvement Bond Act of 1915, and also the Municipal Improvement Act of 1913, for the issuance of a separate bond issue for each condominium interest.

SB 1009 - Chapter 792  
Grunsky & Bear

Provides for cancellation or refund of property taxes imposed for any fiscal year commencing in 1967 on property as to which the church exemption or the welfare exemption was available but unclaimed. The bill also provides for such cancellation or refund with respect to the cemetery exemption, but such provision has no force or effect after the lien date of 1968.

AB 1360 - Chapter 793  
Knox

Requires any person claiming the cemetery tax exemption to make a return of the property to the assessor annually. The bill provides for cancellation or refund of tax for any fiscal year beginning in 1967 for which the cemetery exemption was available, and makes such provision in cases where such property was acquired during the 1967 calendar year, but prior to the commencement of 1967-68 fiscal year.

SB 307 - Chapter 794  
Wedworth

Authorizes the city attorney of any general law or chartered city to prosecute any misdemeanor committed within the city which arises out of a violation of a state law. Consent of the district attorney of the county would be required before the city could exercise this authority.

SB 393 - Chapter 795  
Cologne, Dills,  
Sherman

Authorizes the State Department of Education to purchase insurance for motor vehicles used in automobile driver training courses at the California Schools for the Deaf.

SB 394 - Chapter 796  
Marler & Lagomarsino  
& Davis

Expands the types of service which may be rendered by retired teachers to include remedial instruction, home teaching and hospital teaching. The bill also deletes the 90 teaching day limitation on this employment during one fiscal year and increases the annual compensation earnable for such service by a retired teacher from \$1800 to \$2500.

SB 481 - Chapter 797  
Dills

Permits municipal court minutes to be destroyed after 10 years instead of being retained indefinitely.

SB 558 - Chapter 798  
Cologne & Schmitz

Authorizes the Department of Fish and Game to review and coordinate fish and wildlife enhancement development at federal projects with state plans, regardless of state participation in the recreation features of the project. The bill postpones determination by Resources Agency of statewide importance of recreation features of federal project and local agency cooperation until after Resources Agency issues letter of intent to participate in such project. The bill also requires that Resources Agency comments on local agency participation be included in report to Governor and Legislature.

SB 580 - Chapter 799  
Grunsky

Adds or amends numerous sections of Commercial Code, conforming language of portions of the code to the Uniform Commercial Code.

SB 1001 - Chapter 800  
Sherman

Allows the board of supervisors of any county in which only one tax appeals board has been established to appoint an alternate member to the appeals board who may replace a member temporarily unable to act as such.

SB 1005 - Chapter 801  
Carrell

Defines unregistered vehicles used or operated by manufacturers and which are later sold to the public as used vehicles. It will put these vehicles in the same category as the demonstrators used by a dealer so that they will not be sold or represented to the buying public as new vehicles. The bill also clarifies the tax status of these vehicles when they are formally registered with the Department of Motor Vehicles.

SB 1006 - Chapter 802  
McCarthy

Requires the election of successors to judges of municipal and justice courts who become such because the municipal and justice courts replaced the courts to which they were elected to be held at the same time and under the same qualifications as set for the election of a successor in original courts.

SB 1062 - Chapter 803  
McCarthy

Makes it possible for the San Quentin cotton textile mill to keep up with technological progress by permitting the mixing of synthetic fibers with cotton in its textile production.

SB 1070 - Chapter 804  
Grunsky

Increases the number of, and salary of, various attaches of the Monterey-Carmel Municipal Court.

SB 1074 - Chapter 805  
Grunsky

Deletes ineffective provisions of the Education Code. The bill makes no substantive changes.

SB 1099 - Chapter 806  
Short

Provides that, for retirement purposes, salaries of superior court official reporters in San Joaquin County shall include the total of all per diem and transcription fees paid to all of the superior court reporters, divided by the number of superior court official reporters provided that such amount shall not exceed \$600 per month.

SB 1196 - Chapter 807  
Lagomarsino

Makes a number of amendments to the Produce Dealers and Processors Law. The changes in the Processors Act clarify bond coverage and cancellation features; revises the hearing of complaint sections; strengthens accounting procedures to producers and in general clarifies the language of the Act. The changes in the Produce Dealers Act are aimed at clarifying licensing procedures; revising the definition of a "Dealer" and establishing a maximum schedule of commissions not to exceed 20 percent of the gross sale price of the farm product.

SB 1225 - Chapter 80  
Stiern & Way & Stacey

Clarifies and enlarges the power of a county committee on school district organization to provide for changing the number of members of a junior college district governing board and to establish, rearrange, or abolish trustee areas in such districts.

SB 1331 - Chapter 809  
Carrell

Extends to premises leased by a county the same privileges with respect to the issuance of a liquor license as are now extended to the premises owned by a county.

SB 1472 - Chapter 810  
Sherman

Permits the Alameda County Board of Supervisors to appoint the clerk of the board in the same manner as other officers.

AB 328 - Chapter 811  
Knox

Includes industrial engineering among branches of engineering for which registration may be obtained from the Board of Registration for Civil and Professional Engineers. The bill also provides that persons licensed under the Civil and Professional Engineers Act may use the titles consulting engineer or registered engineer, as well as the title professional engineer.

AB 432 - Chapter 812  
Bill Greene &  
Brathwaite

Permits a city or county board of education to issue a temporary child care permit, good for 90 school days, to a person who has applied for a regular state permit and who files an affidavit that he knows of no reason why it will not be issued.

AB 585 - Chapter 813  
Bear

Makes the work furlough law applicable to inebriates or habitforming drug addicts who are committed to county jail branch, industrial farm, or industrial road camp.

AB 752 - Chapter 814  
Collier & Stull

Extends the provisions of the Code of Ethics to all appointive State Officers.

AB 811 - Chapter 815  
Fenton

Provides that the amount recoverable by the buyer for property traded in when a conditional sales contract, for motor vehicles is rendered unenforceable because the seller violated specified provisions of the Civil Code, shall be equal to either the agreed cash value as it appears on the conditional sales contract or the fair market value of such property at the time the contract is made, whichever is greater.

AB 824 - Chapter 816  
Knox & Dent

Provides uniform procedures to be followed in any case in which a person arrested for a misdemeanor does not demand to be taken before a magistrate. Present law provides separate procedures for misdemeanor violations of ordinances and misdemeanor violations of state law. The bill authorizes peace officers to use the specified written notice to appear procedures for any misdemeanor offense in which the officer has arrested or taken custody of a person pursuant to specified provisions of the law. The bill also makes provision for use of notice to appear as complaint to which defendant may plead "not guilty" as well as guilty.

AB 1228 - Chapter 817  
Meyers, Milias

Provides for one maximum \$6 state contribution toward the cost of health benefits plan under the Meyers-Geddes State Employees' Medical and Hospital Care Act even though more than one survivor of the same employee or annuitant is authorized to participate.

AF 1348 - Chapter 81  
Knox

Changes the lien date of property tax purposes from noon on the first Monday in March of each year to 12:01 a.m. on the first day of March of each year, effective January 1, 1968. The bill also provides that the fact that a person reports his property as of the first day in March as being his property as of the first Monday in March is not in and of itself evidence of intent to avoid taxation.

AB 1422 - Chapter 819  
Schabarum

Requires the abstract of court record sent to the Department of Motor Vehicles to clearly indicate that charges against an employee were dismissed and the owner of vehicle found guilty, if such be the case.

AB 1468 - Chapter 820  
Beletti

Repeals an obsolete provision of the Government Code. The bill makes no substantive change.

AB 1500 - Chapter 821  
Stacey

Corrects cross-references in the Business and Professions Code provision concerning the sale of drugs.

AB 1540 - Chapter 822  
Zenovich

Requires the board of supervisors of Fresno County, upon request of the Pinedale County Water District, to levy a bond tax with respect to land only in Districts, Improvement District No. 2.

AB 1558 - Chapter 823  
MacDonald &  
Lagomarsino

Makes the Elections Code provisions relating to ballot arguments for county measures applicable to any district bond election, except certain school district or district bond elections.

AB 1568 - Chapter 824  
Duffy

Increases the salary of the Kings County District Attorney. The bill increases the salary from \$13,000 to \$16,000.

AB 1791 - Chapter 825  
Harvey Johnson

Makes the costs of commitment proceedings for nonindigent mentally ill and mentally deficient persons the obligation of the person, the guardian of his estate, or persons legally liable for his maintenance, rather than his estate or persons legally liable for his maintenance.

AB 1882 - Chapter 826  
Dent

Permits a school board to increase salaries of its classified positions at any time during a school year if the position or positions are being increased as a result of a reclassification approved by the board.

AB 1973 - Chapter 827  
McGee

Provides that court must require the probation officer to investigate when a petition for guardianship is filed for a minor two years of age or under and where the petitioner is not a relative of the minor.

AB 1974 - Chapter 828  
McGee

Repeals the provision authorizing the Department of Fish and Game, under regulations of Fish and Game Commission, to pay bounty on crows and black-billed magpies.

AB 2120 - Chapter 829  
Stacey

Authorizes water storage districts to issue authorized bond issues in series and fix different maturity dates for each series. It specifies that bonds of any series shall be of equal security with bonds of other series of same issue. The bill also provides that the report to the California Districts Securities Commission shall include in detail, the amounts to be provided out of bond funds for the establishment of a bond reserve fund and for payment of interest on bonds during the construction project.

AB 2152 - Chapter 830  
Bear

Provides for court-ordered release of habit-forming drug addicts and inebriates from an industrial farm or road camp on recommendation of the county medical director and subject to the supervision of the director of such farm or camp.

AB 2227 - Chapter 831  
Powers

Authorizes public improvement assessments levied on assessable public property to be sold for cash to the highest bidder and prescribes the rights of the purchasers.

AB 2388 - Chapter 832  
Veneman

Clarifies existing law with respect to the leasing provisions of the Sales and Use tax Law, which were enacted in 1965. It provides an exemption from the tax on leases only during the time for which the lessor is obligated to lease property for an amount fixed by the lease prior to August 1, 1965. The bill also provides that the lessor shall be deemed not to be obligated for any period of time for which he has the unconditional right to terminate the lease upon notice, whether the right is exercised or not.

AB 2528 - Chapter 833  
Stacey

Declares that during the pendency of an action to adjudicate substantially all water rights in a ground water basin situated in whole or in part in the Tehachapi-Cummings County Water District in Kern County, the failure by any owner of water rights therein to extract therefrom the full quantity of water which he ultimately is judicially determined to have rights to, shall not result in the loss of such unused portion.

Governor Ronald Reagan today endorsed the plan to bring the Liner Queen Mary to Long Beach and supported a suggestion that the City consider converting a portion of the vessel into a Museum of the Sea.

The historic 81,000-ton British ship has been offered for sale by the Cunard Lines, and Long Beach officials have been working with U. S. firms interested in acquiring the vessel, berthing her in Long Beach Harbor and operating her as a combined hotel-convention center -- tourist attraction.

The idea to also develop a Museum of the Sea aboard the Queen Mary was advanced by Howard Edgerton, President of the California Museum Foundation.

"Bringing the Queen Mary to Long Beach and operating here in this fashion would give California another tremendous tourist attraction," Governor Reagan said.

He said he understood State Legislative Leaders -- Sen. Hugh Burns, President Pro Tem of the Senate, and Assembly Speaker Jesse Unruh also endorse the plan.

The 31-year-old Queen Mary, recognized as the World's most popular passenger liner, will be retired from service by Cunard in October. She is 1020 feet long, 118 feet wide and has 12 decks, three funnels. The forward funnel is 15 feet higher than Niagara Falls.

During World War II, the famous British liner was used as a troopship and carried 765,429 servicemen a total of 569,943 miles. She was reconverted to a luxury passenger ship in 1946.

The Queen Mary has 27 public rooms, including restaurants, spacious lounges, salons, libraries and a theatre. She can accommodate 1,957 passengers and a crew of 1,200.

Governor Ronald Reagan announced today he has signed legislation which will relieve California homeowners of a "double jeopardy" threat which has hung over them for years.

The measure was SB 594, was co-authored by Senator Richard J. Dolwig (R-San Mateo) and Assemblyman William Bagley (R-San Rafael).

It adds certain provisions to California's Mechanics' Lien Law to enable homeowners to protect themselves from having to pay twice for the same services performed or for materials furnished in connection with home building or home improvements, such as swimming pool or room addition.

The new law makes it mandatory for both subcontractors and materialsmen to give the homeowner a notice that work has been done or materials furnished for a job. Such notice must be given within 20 days after first going on the job.

Thus, if the homeowner does not pay any bills presented until the expiration of the 20-day period, he can pay his contractor with assurance that no lien will be filed to force him to pay for the same work twice.

Failure to provide the notice prevents the subcontractor or materialman from filing a claim against the property owner.

Prior to passage of the new law, a homeowner would have actually paid his contractor for a job. However, if the contractor failed to pay the subcontractors or materialmen, both could come back at the homeowner and demand a second payment. The homeowner was in double jeopardy.

If he did not pay, he could lose his home. The new mandatory notice alerts the homeowner to the fact that certain subcontractors or material dealers have been on the job and will be entitled to be paid.

He should then make certain that these bills are paid by the contractor before advancing the contractor money for work already done, or he can pay the subcontractor or material dealer direct and deduct the amount of such payment from that due the contractor.

The legislation was supported by the California Savings and Loan League, the California Bankers and Mortgage Bankers, the Home Builders Council, the California Land Title Assn. and building material dealers and subcontractors associations.

Members of these groups who are involved in construction and its financing will also benefit from this legislation, since a copy of the preliminary notice to property owners also goes to contractors and lenders.

Thus, there should be less controversy in the future about the payment for work done or materials furnished to a job.

To the extent that persons get paid for materials supplied or services performed, and to the extent that liens are not filed which jeopardize the interests of owners and lenders, this legislation will provide a good climate for the construction and financing businesses in California, the Governor said.

Preliminary figures indicate Medi-Cal costs are running substantially above budget estimates, Spencer Williams, Health and Welfare Administrator, cautioned today.

Williams told a regular meeting of the Health Review and Program Council that initial review of expenditures in the fiscal year just ended June 30 shows the deficit could be as much as \$150 million, which must be paid out of the appropriations for this year.

The total budget for the program is about \$904 million of which approximately \$305 million is from the state's general fund. The remainder is paid by the federal government and the counties.

"If this preliminary data is confirmed, I will call you into emergency session for your advice as to the action necessary to keep the program on a stable fiscal basis," Williams told the Council.

The eleven-member council, created by law, consists of five members appointed from the health professions and the remainder from the public at large.

Williams said that the apparent cost increase resulted from both an increase in the costs of medical services and from increased usage of the services. He noted that other states are experiencing similar cost increases.

- SB 137 - Chapter 834  
Mills Permits the use of the same jury panel in both the superior court or municipal courts in Los Angeles or San Diego Counties, when authorized by local superior court rule and pursuant to duly adopted municipal court rule.
- SB 193 - Chapter 835  
Cologne Empowers the public guardian, upon the death of his ward or conservatee, to use certain personal assets of the decedent to pay for the burial expenses and the expenses of the last illness upon court order, if it appears that the total market value of the estate is less than \$1,000.
- SB 233 - Chapter 836  
Schrade Allows the filling of abandoned excavations as an alternative to the presently authorized methods of covering and fencing. Under various sections of the Health and Safety Code and Government Code a Board of Supervisors may securely cover or fence abandoned mining shafts, pits, water wells, cesspools, or other abandoned excavations dangerous to the public.
- SB 290 - Chapter 837  
Cologne Provides that a county recorder is liable in the amount of three times the amount of damages occasioned by specified instances of neglect of or refusal to perform duties of office, if the neglect or refusal to perform was willful and malicious or if he acquired some personal financial benefit.
- SB 662 - Chapter 838  
Danielson Extends liability for violations of public utility law or regulation to individuals who are not public utilities in addition to corporations who are not public utilities. The bill also extends the scope of the offense to include aiding and abetting a violation of public utility law, orders of the Public Utilities Commission, or the California Constitution.
- SB 682 - Chapter 839  
Lagomarsino &  
MacDonald Specifies that members of appointed board of directors of a county waterworks district shall continue to serve at pleasure of county board of supervisors rather than for terms for which they were appointed.
- SB 858 - Chapter 840  
Marler Authorizes the Fish and Game Commission to prescribe regulations which in turn will authorize the Department of Fish and Game to issue pheasant club licenses, including an investigation to the satisfaction of the department, rather than the commission, that the tract of land is suitable for such purposes and that the club will not conflict with the public interest.
- SB 978 - Chapter 841  
Sherman Amends the Code of Civil Procedure to provide that one may answer an interrogatory by merely specifying and making available his business records if the answer requires information which can only be obtained from an audit, compilation or summary of such records, and where such are non-existent or unavailable to the party to whom the interrogatory is addressed.

SB 1017 - Chapter 842 Lagomarsino	Makes technical amendments to the Harbors and Navigation Code. The bill makes no substantive changes.
SB 1063 - Chapter 843 Sherman	Amends the Corporations Code to allow a corporate director to rely upon a financial statement certified by a certified public accountant as well as upon one certified by a public accountant.
SB 1076 - Chapter 844 Grunsky	Authorizes a court (except in cases where the decree or judgment is based upon an integrated property settlement agreement) upon petition by the husband or former husband to modify or revoke a decree or judgment awarding support allowance to a wife who is living with another man and holding herself out as the wife of such man, although she is not married to him.
SB 1142 - Chapter 845 Deukmejian	Requires that a new birth certificate be issued when a child is adopted by an unmarried man or woman to reflect the fact that it is a single-parent adoption if the adopting parent so requests.
SB 1286 - Chapter 846 Marler	Makes it a misdemeanor to operator a powerboat in excess of 5 miles per hour within 200 feet of any way or landing float which is being used, rather than which is used, for the embarkation or discharge of passengers.
SB 1336 - Chapter 847 Cologne	Authorizes the Department of Water Resources, upon compliance with all other requirements of the Davis-Grunsky Act in effect on the date of such grant, to grant to the San Bernardino Valley Municipal Water District an amount not to exceed \$2,354,120 for recreation and fish and wildlife enhancement in connection with the construction of the Yucaipa Project.
SB 1441 - Chapter 848 Danielson	Excludes pesticides, dog repellents, and other substances not intended to be used to produce discomfort or injury to human beings from definition of tear gas for the purposes of the law regulating tear gas weapons.
SB 1445 - Chapter 849 Danielson	Revises the number of, salary schedule of, and various rules pertaining to, attaches of the Municipal Court of Los Angeles County.
SB 1457 - Chapter 850 Lagomarsino & Shoemaker	Authorizes the court with respect to defendants sentenced to be imprisoned in the state prison who have been committed to the custody of the Director of Corrections if it is deemed warranted by the diagnostic study and recommendations approved by the director, to recall the sentence, as well as the commitment, previously ordered and resentence the defendant in the same manner as if he had not previously been sentenced.
AB 351 - Chapter 851 Hinckley	Provides that with certain exceptions no aircraft insurance policy shall exclude coverage because aircraft is operated in violation of federal or civil air regulations, or any state law or local ordinance. The bill does not prohibit specific exclusions in policies relating to certification of the pilot or aircraft, pilot experience, limiting use of aircraft and crop dusting.

Sacramento--Governor Ronald Reagan today asked the State Fish and Game Commission to look into the anchovy fishing problem.

In a letter to the Commission, the governor noted that "There has been considerable concern--and controversy-- over California's anchovy resources. My concern is that this ocean resource, which is vital to both our sport and commercial fisheries, be used wisely and in the best interests of all the people of California."

The governor said he supports "Scientific management of the anchovy by the Fish and Game Commission to assure the best use both for today and for the future."

"I am not opposed to a harvest of anchovies," the governor said, "Provided there are adequate safeguards to assure that the resource is not damaged."

However, the governor also said he believes the commission "must approach the harvest cautiously to fully protect the interests of all our people. . ."

"The question rightly rests with the Commission, which has access to the scientific facts concerning this resource," Governor Reagan said.

Provides that "resignation" as used in the retirement for service provisions of the Judges' Retirement Law does not apply to implied or express resignations for the purpose of accepting an elective or appointive public office, rather than having this exception only apply to such resignations occurring prior to January 1, 1948 and only with reference to certain repayments of contributions withdrawn prior to September 9, 1953.

Increases the membership of the Advisory Commission on Status of Women from 15 to 17, one additional public member to be appointed by the Senate Committee on Rules, and one by the Speaker of the Assembly.
- SB 1000 - Chapter 855  
Sherman  
Prohibits any person engaging in the rental of utility trailers or trailer coaches, for periods of 30 days or less, from renting, leasing, or otherwise allowing the operation of any such trailers unless all necessary equipment required by the Vehicle Code and regulations adopted for the operation of such vehicles in combination have been provided or offered to the lessee for his use.
- SB 1096 - Chapter 856  
Short  
Exempts from definition of "subdivision" for purpose of Subdivision Map Act, any real property upon which apartments are rented, financed, or leased, rather exempting just-leased apartments.
- SB 1512 - Chapter 857  
Short  
Amends the Civil Code provisions relating to the contents of a petition to do business as a sole trader.
- AB 360 - Chapter 858  
Warren  
Amends the provisions of the Collection Agency Act relating to the registration of collection agency employees, receivership actions and the audit report requirements.
- AB 387 - Chapter 859  
Veysey  
Exempts implements of husbandry from requirement to be equipped with turn signal lamp when the body or load extends 24 inches or more to the left of the center of the steering wheel.
- AB 802 - Chapter 860  
Lantermann  
Provides that wine shall have the same credit treatment as distilled spirits and beer.
- AB 868 - Chapter 861  
Ryan  
Extends provisions permitting retired members of the State Employees' Retirement System to be employed on the academic staff of a state college to include employment on the academic staff of the University of California. The bill increases the maximum amount which may be earned in such employment from \$2,000 to \$3,000 per fiscal year.

AB 1010 - Chapter 362 Bear	Increases the minimum amounts of automobile liability insurance or bond required to establish financial responsibility for bodily injury or death of one person in any one accident from \$10,000 to \$15,000 and for bodily injury or death of two or more persons in any one accident from \$20,000 to \$30,000. The bill makes corresponding changes in the minimum amounts of automobile liability insurance required to be provided under the assigned risk plan and in the amounts of coverage required against an uninsured motorist.

AB 1242 - Chapter 866 Knox	Deletes provision requiring counties having a population of less than 5 million to contract directly with the newspaper publishing any list or notice required by the Revenue and Taxation Code. The bill also deletes provision that such contracts are not assignable.
AB 1275 - Chapter 867 Harvey Johnson	Provides that female, when she is the sole shareholder, or when she and her husband are the sole shareholders of an on-sale licensee corporation can dispense or mix wine or distilled spirits on the premises for which corporation holds an on-sale license.
AB 1370 - Chapter 868 Vasconcellos	Increases the number of, and salaries of, various court attaches of certain municipal and superior courts in Santa Clara County.
AB 1405 - Chapter 869 Belotti	Changes number of and increases salary schedule for, municipal court attaches of the Eureka Judicial District.
AB 1424 - Chapter 870 Dent & Knox	Provides that a county surveyor appointed by the board of supervisors shall serve at the pleasure of the board.
AB 1460 - Chapter 871 Chappie	Increases the salaries of members of the Board of Supervisors and Auditors of Nevada County. The Auditor's salary is raised from \$8640 to \$9840. Board members will receive \$6000 instead of \$4800.
AB 1575 - Chapter 872 Bear	Deletes the Chairman of the Industrial Accident Commission from a list of state officers receiving \$500 annually in addition to annual salary.
AB 1701 - Chapter 873 Gonsalves & Porter	Authorizes the district board of a county sanitation district to fix compensation for each meeting attended not to exceed \$50 rather than \$25 and not to exceed \$100 in any one month, rather than \$50.
AB 1754 - Chapter 874 Monagan	Authorizes school district governing boards, at district expense, to conduct achievement tests printed in the Initial Teaching Alphabet for pupils accustomed to learning in that alphabet in lieu of uniform achievement tests.

AB 1794 - Chapter 875 Cullen	Provides for four-year terms for all members of the Southern California Rapid Transit District. It deletes the provision which requires an objecting city or county to pay increased cost of rerouting or redesigning of District facilities. The bill also requires that copies of resolutions appointing members to the city collection committee to be forwarded only to the district secretary rather than to the district secretary and the Secretary of State.
AB 1839 - Chapter 876 Powers	Authorizes a person who manufactures or produces beer outside of this state, but within the United States, in accordance with the requirements of the law of the United States to transport such beer into this state provided there is conformity with enumerated requirements.
AB 1954 - Chapter 877 Dunlap	Prohibits charging of filing fees for any action to declare a minor free from the custody and control of either or both of his parents in cases involving parental abandonment, neglect or cruelty.
AB 1976 - Chapter 878 McGee	Permits deduction of money held by a parent for his minor child as custodial property or money subject to court order in determining the total estate of a minor for purposes of allowing the parent to hold the money belonging to the minor.
AB 1991 - Chapter 879 Fong	Extends to private and parochial schools and all nursery schools essentially the same requirements as now exist in public schools for periodic employee examinations for communicable tuberculosis. It also requires such an examination of volunteers in such schools.
AB 2015 - Chapter 880 Veneman	Requires security held by the Board of Equalization to be used as a payment on account of any liability of the taxpayer to the Board when any such person ceases to be a user or vendor under the use fuel tax provisions or an operator under the motor vehicle transportation license tax provisions.

Barnes Provides that a member of the State Teachers' Retirement system shall not receive credit in the system for more than four years of military service rendered after July 1, 1968.

AB 2160 - Chapter 887  
Belotti Permits local hospital districts to file required documents on or before April 10, 1967, instead of on or before January 1, 1967, for purposes of levying district taxes for the 1967-1968 fiscal year.

AB 2215 - Chapter 888  
Chappie Forbids a board of supervisors from levying the special airport tax in counties in which all or part of an airport district formed pursuant to the California Airport District Act is situated.

AB 2209 - Chapter 889  
Chappie Provides that the Department of Alcoholic Beverage Control may issue one additional on-sale general and one additional off-sale general license in Alpine County. The licenses issued pursuant to this bill shall not be transferred out of the county.

AB 2244 - Chapter 890  
Biddle Increases the annual salary of the District Attorney of Riverside County. The salary is increased from \$19,500 to \$23,000.

AB 2269 - Chapter 891  
Mobley Allows the awarding authority of a public work of improvement to delegate to an officer or employee of their choosing the authority to declare the work completed and file for record a notice setting forth the date of completion.

AB 2326 - Chapter 892  
Monagan Increases retirement allowances and optional death benefits for persons retired under the County Employees' Retirement Law of 1937.

AB 2377 - Chapter 893  
McMillan Prevents an employee of local agency from acquiring any right to preferential treatment upon sale or lease of real property of the local agency which the employee has occupied or used.

AB 2385 - Chapter 894  
Veneman Makes several procedural changes in the procedures for publishing delinquent lists, selling and deeding property to the state. The principal amendment made by the bill changes the date for publishing the delinquent lists from June 8 to September 8.

Veneman Deletes the mandatory requirement that aircraft owners file an annual property statement. The bill provides instead that such statements shall be filed on request of the assessor.

AB 87 - Chapter 911  
Leroy Greene

Establishes restricted credentials for teachers serving as speech and hearing specialists and teachers serving as speech and hearing specialists and teachers of handicapped minors without speech and hearing defects. The bill also makes technical changes in the Education Code provisions relating to special credential to teach severely mentally retarded minors.

AB 774 - Chapter 912  
Bee

Provides that a person who has been a member of the State Teachers' Retirement System for 30 years and who accepts an exempt position in the legislative or executive branch of state government remains a member of the system while he occupies such exempt position unless he elects not to be a member by a writing filed with the Retirement Board within 90 days after employment in such exempt position.

AB 777 - Chapter 913

Governor Ronald Reagan said this afternoon that he and Speaker Jesse Unruh had agreed to workable amendments to the administration's revenue bill.

As amended the bill includes property tax relief through school aid, the form suggested by the administration, inventory tax relief and direct school aid.

The speaker and the governor reached agreement that during this fiscal year an additional 145 million dollars will be appropriated in the revenue bill for direct school tax relief and next year this amount will increase to \$300 million, including \$150 million for property tax relief.

The governor congratulated the speaker on joining with him in increasing the state's contributions to school districts.

"I am sure now that both houses of the legislature will act responsibly to make sure we have a revenue bill prior to August 1. Without it the state will lose another \$45 million in projected revenues, thus adding to our cash flow problems and forcing further cuts in state spending."

The governor and Unruh met for half an hour during the afternoon.

Sacramento--Governor Ronald Reagan said today he signed assembly bill 910, the consolidated milk pooling act, "with reluctance."

However, Reagan, who signed the bill Thursday said indications were that most of the state's milk industry either wanted it or was not opposed to it.

He pointed out that the bill has a referendum feature that will allow milk producers to vote as to whether they want it to go into effect.

"If the dairy people want it we will make every effort to see that it is administered in the spirit of our free enterprise system," Reagan said.

He added that the act represents a compromise of several proposals and demonstrates the willingness of California's dairy-men to work together to solve their problems. This is the first time that this type of legislation has been passed by our Legislature.

"Its effect on the operations of California's important milk industry cannot now be fully estimated. I have discussed this legislation with the Director of Agriculture, and he has assured me that the purpose of the milk pooling plan, which he is required by the legislation to develop, will be to ultimately provide equity in the returns to our California dairymen for the milk they produce, thereby maintaining an adequate supply of milk for consumers at fair and reasonable prices.

"He and I recognize that any legislation that attempts to regulate an industry as varied, involved and complex as California's milk industry will require constant surveillance, and very likely will require modification as experience with it unfolds.

"I have signed AB 910 in the hope that it will prove beneficial to milk producers, distributors and consumers," the governor said.

AB 650 - Chapter 957 Thomas	Provides that one member of the Los Angeles Board of Harbor Commissioners, one member of the Board of Commissioners of the San Diego Unified Port District, one member of the Board of Directors of the Oxnard Harbor District, and one member of the Long Beach Board of Harbor Commissioners shall be members of the Southern California World Trade Center Authority.
AB 1108 - Chapter 958 McMillan	Allows licensed cosmetologists to work time to complete service reasonably expected to be completed within eight hours if such cosmetologist receives compensating time off in the same week and the hours worked for that week do not exceed 48.

I am extremely pleased that the Legislature has passed our revenue bill in time for it to take effect August 1. Had we gone beyond that date the state would have lost another \$45 million in revenues.

The Legislature's action today show its members recognize the fiscal problems facing California and they have put partisanship, and in some cases personal considerations, aside in order to face up to those problems.

I am grateful and all Californians should be grateful that they have done so.

Certainly none of us, least of all those of us charged with asking for one, like the idea of a tax increase. We had no choice this year.

Our state was \$194 million in debt and last year spent nearly \$400 million more than it took in. Previous fiscal management gave us a cash flow problem that only additional revenues would solve.

Passage of our revenue bill today will allow us to meet those problems--if we tighten our belts and keep spending to a minimum. This we intend to do--as we have done all along.

I am proud that our Republican party united in this effort. And I have a special thanks for Senator George Deukmejian and Assemblyman Jack Veneman and for the Republican leaders in both houses for their advice, counsel and all-around help. I also thank those Democrats who put their state above partisanship.

This bill certainly is not perfect but it does meet our immediate needs.

Next year we hope to present a tax reform package that will allow the state to meet its needs for the foreseeable future without further tax increases. July 27, 1967

AB 910 - Chapter 927  
Gonsalves

Provides for the development of equalization milk pooling plan by the Director of Agriculture with the advice and assistance of a formulation committee, representative of all producers and areas to be included in such pooling plan. The bill directs the committee to make recommendations to the director for inclusion in the plan, and requires the director to include in the plan, the base and quotas for new fluid milk producers, the transfer of bases and quotas, and any and all other necessary matters. The bill also makes the operation of proposed plan subject to statewide referendum of producers. Provides for substantive amendment or termination of plan by statewide referendum of producers.

AB 1064 - Chapter 928  
Gonsalves

Changes the filing date of petitions for assessments reduction and proportionate tax reduction or refund in counties of over four million to between third Monday in July and September 15 rather than between fourth Monday in September and fourth Monday in November.

AB 1698 - Chapter 929  
Gonsalves

Authorizes the board of directors of a sanitation district, rather than the board of supervisors, to annex territory in any district which at the time of annexation is not performing similar services in the area proposed to be annexed. The directors must first find and determine that the additional territory will be benefited by annexation.

AB 2382 - Chapter 930  
Shoemaker &  
Lagomarsino

Requires that names for trial jury list in Santa Barbara County be drawn from residents of supervisorial district within which the court sits for trial and adjacent supervisorial districts, except when the court orders a countywide drawing in interests of justice.

AB 2482 - Chapter 931  
Moorhead

Makes it a misdemeanor for a person to willfully and maliciously obstruct the free movement of any person on any street, sidewalk, or other public place or on or in any place open to the public.

SB 769 - Chapter 932  
Way

Provides for the tax collector to use the same collection procedure for unpaid taxes on improvements constituting part of a water distribution system as used with respect to assessments on the unsecured roll if water distribution system assessments are unpaid. The bill also permits counties to have a redemption officer establish a procedure involving making a record of individual redemption and installment payments with respect to redemption of tax-sold property.

SB 770 - Chapter 933  
Way

Authorizes a tax collector to file certificate with county recorder, without fee, for any county, when property taxes on any unsecured property are delinquent. This authorization is in addition to those provisions of law dealing with seizures of property and suits against the taxpayer.

SB 793 - Chapter 9  
Grunsky

Revises the ad valorem taxing procedures of the San Benito County Water Conservation and Flood Control District. The bill also removes property ownership as basis of voting right. It makes provisions of Uniform District Election Law applicable to district and revises provisions for selection, compensation and proceedings of the district governing board.

SB 1037 - Chapter 935  
Collier

Exempts practicing chiropractors from jury duty.

SB 952 - Chapter 936  
Miller

Makes members of the National Guard eligible to serve as jurors in civil cases unless they are on active duty.

SB 1044 - Chapter 937  
Stevens

Amends the Corporate Securities Law to clarify the exemption afforded to public agencies and entities, to provide that a security broker's certificate may be revoked for failure to maintain the required bond, and to impose a specific fee of \$10 for applications for consent to transfer securities pursuant to any condition imposed by the Commissioner of Corporations.

AB 45 - Chapter 938  
Lantermann

Validates organization, boundaries, acts, proceedings, and bonds of counties, cities, and specified districts, agencies and entities. The Third Validating Act of 1967.

AB 1076 - Chapter 939  
Belotti

Permits governing boards of school districts to deposit investment securities in any trust company located within this state or with any Federal Reserve bank or state or national bank located in any city designated as a reserve city by the Board of Governors of the Federal Reserve System.

AB 1379 - Chapter 940  
Davis

Provides that certain increases in retirement allowances, under the State Employees' Retirement System, shall apply to persons who later were reinstated from retirement and, subsequently, retired again. The bill applies to those with less than one year of employment during reinstatement.

AB 1561 - Chapter 941  
Brown

Revises the Penal Code provisions regarding compensation of counsel assigned to represent an indigent defendant to require, in any case in which any person, including a minor, desires but is unable to employ counsel and in which counsel is assigned in the superior, municipal, or justice court to represent such person in a criminal trial, proceeding, or appeal, that such counsel receive a reasonable sum for compensation and necessary expenses determined by the court to be paid out of the county general fund.

AB 1602 - Chapter 942  
McGee

Corrects erroneous cross-reference in the State Contract Act.

AB 1679 - Chapter 943  
Elliott

Provides for the preservation of the tenure rights of nonteaching certificated employees who are advanced to supervisory, administrative or other higher level positions.

AB 1776 - Chapter 944  
Badham

Enables the Public Utilities Commission to prescribe certain types of stop signs at farm or private grade crossings where no automatic grade crossing protective device is in place. The bill also provides safety regulations which drivers of vehicles must observe, and makes failure to observe these safety regulations a misdemeanor.

AB 1816 - Chapter 945  
Murphy

Increases salaries of various attaches of the municipal courts located in Santa Cruz County.

AB 1822 - Chapter 946 Moretti	Reduces the number of publications and the time for which claims may be made against accounts in banks and savings and loans associations held by nonresident decedents.
AB 1867 - Chapter 947 Cory & Vasconcellos	Requires instruction to be given on all elementary and secondary schools on the effect on the human body of dangerous drugs and other dangerous substances as well as alcohol and narcotics.
AB 1964 - Chapter 948 Dunlap	Permits a person who is a member of the State Employees' Retirement System when he becomes an elective officer to resign and withdraw all of his accumulated contributions. The bill also provides for an election to rejoin the System.
AB 2045 - Chapter 949 Bagley	Provides that a telegraphic copy of a warrant or abstract of a warrant may be sent by any other electronic devices as well as by telegraph or teletype. The bill also requires the abstract of the warrant if for a misdemeanor to state whether the warrant has been certified for night service.
AB 2046 - Chapter 950 Bagley	Allows the Governor to delegate authority to sign warrants of arrest issued pursuant to a demand for extradition.
AB 2053 - Chapter 951 Bagley	Gives local legislative body discretion to transfer unclaimed property to the local government purchasing and stores agency or other similar agency for sale to the public, as alternative to selling it at public auction.
AB 2060 - Chapter 952 Leroy Greene	Changes requirement that State Architect have an inspector at state buildings during their entire construction to a requirement that an inspector be assigned to them during their construction.
AB 2257 - Chapter 953 Fong	Makes technical and clarifying changes in the Bank and Corporation and Tax Law. The bill makes no substantive changes.
AB 2358 - Chapter 954 Z'berg	Changes from 30 days to 45 days the time for boundary descriptions and maps required to be filed with the State Lands Commission when any tidelands or submerged lands are included within the boundaries of territory proposed to be annexed to a city.
AB 2435 - Chapter 955 Bagley & McCarthy	Raises salaries of personnel of Marin County municipal courts.
AB 2444 - Chapter 956 Brathwaite	Authorizes governing board of a school, in its discretion, to provide information as to pupils in a research project or study conducted, sponsored, or approved by a college or educational research organization, provided no pupil will be identified in a resulting report.

Governor Ronald Reagan today asked that all sportsmen of this State be extremely careful and protect against forest fires during the coming deer seasons. He said that the California Division of Forestry, United States Forest Service, and California Disaster Office are particularly concerned because of the high fire hazards caused this year by an abundant grass growth from well-spaced rains which continued late into the spring.

The coastal deer season which starts August 5 is expected to draw thousands of sportsmen into the wildland areas increasing forest fire hazards. He has asked that a stepped-up forest fire patrol be established by the forest fire agencies to guard against careless acts leading to the start of disastrous fires. Reagan said that the year 1967 has already seen numerous forest fires start causing a loss of thousands of acres of watershed lands in the State of California. Reagan also said that California became the wonderful state it is because of its resources and warned that continuing forest fire damage detracts from its resource wealth. He asked that all citizens of this State join forces with all forest fire protection agencies to eliminate disastrous forest fires.
