Appointment of Benjamin Hargrave, 51, of Oakland, as deputy director for the new State Department of Human Resources Development was announced today by Governor Ronald Reagan.

Hargrave, a Democrat, is education and training officer for the Economic Opportunity Council of San Francisco. Prior to joining the EOC earlier this year, he spent 22 years with the Oakland Unified School District.

Hargrave will direct the Northern California region of HRD's Job Training and Development Division when the department is activated later this year. His headquarters will be in San Francisco.

The department of HRD, headed by Gilbert L. Sheffield, is a component of the Human Relations Agency. It was created by the Human Resources Development Act of 1968 to consolidate and streamline the services of the State's Department of Employment, Service Center Program, Office of Economic Opportunity and Commission on Aging.

The department is designed to place new emphasis on providing expanded manpower and training services to the hardcore unemployed.

Hargrave, who will join the department immediately, has been active in manpower projects for several years.

He is president of the West Oakland Area Council and a member of the Oakland Manpower Commission. He is an advisory board member for the Educational Opportunities Clearinghouse (PACT) and a member of the advisory committee to the East Bay Skills Center.

In 1966, he was president of the Men of Tomorrow in Oakland.

"His broad range of experience, plus his intimate involvement in community manpower development, gives HRD a vital dimension in its top management," Governor Reagan said.

management," Governor Reagan said. Hargrave's other activities include membership on the Board of Directors of the NAACP's Oakland branch, the Alameda County Mental Health Association, the Alameda County Negro Leadership Conference, the Oakland Principal's Association and the Northern California Industry-Education Council.

He is a member of the National Advisory Council for Upward Bound. A veteran of World War II, Hargrave received his Bachelor of Science degree from Springfield College, Springfield, Mass., in 1941, and his Master of Arts degree from San Francisco State College in 1951. He did graduate work at the University of California at Berkeley and at Stanford University.

A native of Wakefield, Virginia, he attended public schools in Westfield, New Jersey.

He taught elementary and junior high school in Oakland between 1946-51. He was named principal of Harbor Homes School there in 1951 and subsequently served as principal of Longfellow School, Golden Gate Elementary and Junior High School and McClymonds and Castlemont High Schools.

He lives at 3468 Calandria Avenue, Oakland, with his wife, Carolease.

AB 1146 - Burke (Chapter 654) Appropriates \$50,000 to the Division of State Lands to continue work of removing beach and underwater obstructions from state-owned tidelands and submerged lands near Summerland, Santa Barbara County.

Applies the "Basic Property Insurance Inspection and Placement Plan" (assigned risk program for property difficult to insure) to property in geographic or urban areas designated by the Insurance Commissioner, rather than to residential property only to tangible personal property generally, rather than at a fixed location, and to persons who cannot obtain basic property insurance from licensed surplus line brokers as well as admitted insurers. The bill also creates the California Riot and Civil Disorders Insurance Association, to be established by specific licensed insurers with approval of the Insurance Commissioner. It appropriates \$1,500,000 from the General Fund to the Insurance Commissioner for purposes of the act. The bill implements the federal Urban Property Protection and Reinsurance Act of 1968.

Extends the date for conclusion of the statewide exhaust control device testing program being conducted by the State Air Resources Board, and extends to December 15, 1970, the final date for the report of such testing results.

Provides that no classified school employee, when he is absent because of any accident or illness, shall be paid less than the amount of the difference between his normal salary and the amount paid to his substitute.

Provides that pupils shall not be required to participate in a special class or program unless the parent is first informed of the reasons for placements of the pupil in such program.

Provides that teachers employed less than full time shall be paid on or before the tenth day of the month for services performed during the preceding month.

Deletes escrow requirements from Business and Professional Code provision providing for transfer of an alcoholic beverage license for a fee when 50 percent or more of the shares of stock of the corporation which owns such a license is transferred to new parties.

Revises qualifications for members of the Historical Landmarks Advisory Committee. AB 1213 - Chappie (Chapter 628) The bill provides for 4-year terms of office instead of serving at pleasure of governor, and authorizes committee to maintain a comprehensive record of all archaeological sites in California and to obtain data for such record from appropriate sources. The bill also authorizes the California Bicentennial Celebration Commission to sell commemorative medallions, booklets, and artifacts and appropriates the proceeds for the purposes of the commission without regard to fiscal year. Includes all districts in the Government AB 1383 - Badham Code section that provides that moneys (Chapter 655) left unclaimed in treasuries of local agencies more than 10 years may become property of such agencies after specified publication of notice. AB 1554 - Bagley Provides that the Sonoma County Flood (Chapter 656) Control and Water Conservation District shall be known as Sonoma County Water Agency. The bill also increases maximum permissible interest rate on district bonds from 5 to 6 percent. Appropriates \$300,000 from the Capital AB 1797 - Ketchum Outlay Fund for Public Higher Education to the Trustees of the California State (Chapter 657) Colleges for purchase of property for the use of California State Polytechnic College. The bill also provides for the deposit of proceeds from sale of certain land in San Luis Obispo in Capital Outlay Fund for Public Higher Education. AB 2061 - Knox Provides that tangible personal property (Chapter 658) of a profession, trade or business determined by the State Board of Equalization to be of a specified full cash value may be deemed an audit for the purposes of prescribed provisions of the Revenue and Taxation Code. AB 2067 - Knox Permits the blending of olive oil with (Chapter 659) other edible oils, if such blend is not labeled as olive oil or imitation olive oil, is clearly labeled as a blended vegetable oil, and if the contents and proportions of such blend are prominently displayed on the label. AB 2352 - Lanterman Provides that on or after June 30, 1969, no state officer or employee shall be (Chapter 627) deemed to have a break in service or to have terminated his employment, for any purpose, solely because of the failure to enact a budget bill for the 1969-70

Provides that subject to the terms of the policy or any agreement between the insured employee or member, the group policyholder and the insurer, such insured member of employer under a group life insurance policy can assign his rights under the policy to anyone other than the master policyholder including any incidents of ownership conferred on him by law or the policy including the right to exercise the conversion privilege or to name a beneficiary.

Provides that any superintendent, assistant superintendent, supervisor, or employee having custody of wards, of each institutio of the Department of Youth Authority, and any transportation officer of such departme is a peace officer.

Specifies that a reproduction from an electronic recording of video images on magnetic surfaces which was authenticated under designated conditions is as admissabl as original writing itself in court proceeding.

Provides that where community property is transferred by husband and wife to specified inter vivos trust, unless the trust otherwise expressly provides the respective interest of each spouse, such trust shall be community property.

Creative solutions to California's environmental problems will be sought at a conference of more than 1,000 scientists, industrialists, educators and conservationists called by Governor Ronald Reagan November 17 and 18 in Los Angeles.

The "Conference on California's Changing Environment" was called by Governor Reagan today following an organizational meeting of the Citizen's Advisory Commission today in his office.

"We must seek new ways to protect what God has given us and at the same time make certain that every citizen has an opportunity to enjoy and use our natural heritage," the Governor told the organizational meeting.

He also announced the appointments of conference co-chairmen, Robert H. Gerdes of San Francisco, chairman of the executive committee, Pacific Gas and Electric Company, and Lt. General Victor Krulak of San Diego, president of the Copley News Service.

"As California's population continutes to grow, the demands of that growth often raise conflicts between preserving what we have and carrying on with the progress that must be made.

What we must achieve is an accomodation so that every segment of our in California society/can live and work in the best possible environment" the governor said.

William Penn Mott Jr., state director of parks and recreation, has been named state co-ordinator for the environment conference, and Norvell Gillespie of San Francisco, executive vice president of the California Anti-Litter League, will be executive director.

In a joint statement, co-chairmen Gerdes and Lt. General Krulak called on Californians to "be prudent and ever watchful to protect our natural heritage. We must also be realistically alert to the need to expand facilities in both the public and private sectors to serve Californians of this generation and those to follow.

"One of today's greatest challenges," the statement continued, "is to conserve and, where necessary, enhance our precious environment while serving the needs of modern man. We must expand outdoor recreational opportunity, clear our air and clean our waters.

opportunity, clear our air and clean our waters. "We must also provide housing, schools, waterways, transportation, and industry to meet the needs of our growing state and to build a healthy economy.

"The task Governor Reagan has assigned this conference is to consider ways and means to reach both objectives. I am confident that we Californians have the intellectual, spiritual and economic capacity to provide for growth and at the same time wisely use and conserve the state's natural and human resources for the future." The food, beverage, container and petroleum industries were commended today by Governor Ronald Reagan for increasing their antilitter activities in California.

In marking the observance of August as National Litter Month, the governor announced he has received pledges from a number of companies doing business in the state to step-up their efforts to help solve the litter problem.

The governor recently pointed out to some 40 companies that litter costs the state more than \$50 million a year.

He asked firms to search for new approaches to help stop the spread of litter, and to incorporate anti-litter messages in product advertising.

Response to the appeal has been gratifying, the governor said.

The brewing industry, for example, has used a variety of techniques to fight litter. They range from placement of anti-litter slogans on delivery trucks and packages and financial assistance to such organizations as the California Anti-Litter League and Los Angeles Beautiful to development of plastic instead of carboard packaging.

Several oil companies reported to the governor they had prepared special material for advertisements, produced motion pictures on the problem and worked with conservation organizations to develop new projects.

Another new anti-litter project is being conducted to reclaim allaluminum beverage cans.

"These activities indicate a commitment by industry to do its part to help keep California clean," the governor said.

"And these companies have assured me they will continue to be extremely active in the fight against litter in the years ahead."

"I am delighted the legislature has responded to my continued requests for a strong BCDC bill.

"San Francisco Bay is one of the most important resources that California possesses. But we were in very real danger of destroying this priceless natural asset.

"This bill will save the bay. It is, I believe, a milestone in our continuing efforts to preserve 'the quality of life'---not only for this generation but also for those who will follow us.

"And it is an example of creative partnership through which we <u>can</u> preserve the irreplaceable. We can be proud of the fact that while we have taken action to preserve something that belongs to all of us, we have also protected the rights of private property owners.

"We have accomplished this without imposing the stifling controls of a regional government on the cities and counties that surround the bay.

"I am particularly pleased that the co-authors have included the extension of the California Land Conservation Act of 1965 to bay lands. This will insure vitally needed open space.

"I have only one regret--and that is that the legislature chose to exempt two cities from BCDC control, although I am confident they will cooperate fully with the commission to protect the bay.

"We have a strong bill. It demonstrates that the private sector and the government can work in harmony to preserve what nature has given without taking away the rights of the individual.

"I want to extend my thanks to the co-authors, to BCDC Chairman Mel Lane and to the many key officials in the administration for their efforts in putting this together."

SB 684 - (Chapter	Lagomarsino 674)	Renames the California Riding and Hiking Trails Law as the California Recreational Trails Act. The bill redefines "trails" to include those for motorized vehicles when so designated and for bicycles as well as for horse riding and hiking. SB 757 - (Chapter		Extends the 65-foot maximum length to include combinations of vehicles with forklift trucks. logging dollies, semitrailers designed to transport a forklift truck and motortrucks and truck tractors while being operated in a driveaway-towaway operation.
SB 772 - (Chapter		Permits the State Forester to adopt regulations regarding the removing of flammable vegetation around structures constructed of non-flammable materials.
SB 858 - (Chapter		Expands the definition of "fish" as used in Fish and Game Code to include invertebrates and amphibians. It authorizes the Fish and Game Commission to regulate the taking for commercial purpose of any fish for educational and scientific purposes, and suspends the prohibition against the transportation of abalone meat out of state for an additional two years.
5B 872 - (Chapter		Provides that an order for a civil arrest must contain on its face a statement that the defendant is entitled to an attorney, including appointed counsel if he is indigent; a statement that the defendant must be immediately taken before the court for the setting of bail; and a statement that the defendant is entitled to an immediate hearing on the validity of his arrest.
SB 926 - (Chapter		Revises requirements relating to payment to Dry Cleaners Board of Fees for certificates of completion issued by the State Fire Marshal for new clothes cleaning establishments.

SB 936 - Bradley (Chapter 692)	Authorizes a governing board of a school district to establish and maintain a school safety patrol in schools of the district to assist school pupils, rather than pupils of such school, in safely crossing streets and highways adjacent to or near the school. The bill also provides that the members of such school safety patrol shall be required to give traffic signals and directions to assist school pupils, rather than pupils of the public schools, in safely crossing streets and highways.
SB 974 - Dills (Chapter 693)	Establishes the Point Fermin Marine Life Refuge and authorizes the taking, in specified refuges under the authority of a sport fishing license, of certain designated fish, mollusks and crustaceans.
SB 999 - Sherman (Chapter 660)	Provides that funds for homemaker services be allocated to counties and be subject to Budget Act limitations. All non-federal costs of providing homemaker services are to be covered by state funds except where attendant c care costs are provided through the grant wherein the regular state-county sharing formula applies. In addition, grants to recipients of public assistance requiring new medical protective living arrangements will be regulated by rate schedules established by the Secretary of Human Relations Agency, and will be subject to Budget Act limitations.

SB 1331 - Petris (Chapter 699)	Revises authorization of a property tax assessee to pay taxes under protest when not notified by the assessor.

SB 1428 - Danielson (Chapter 700) Establishes the James V. Fitzgerald Marine Reserve in a designated area of San Mateo County.

Provides that affidavits required for classification of vessels as documented vessels eligible for assessment at one percent of full cash value for purposes of property taxation shall be filed with the assessor between the lien date and 5 p.m. on April 1.

REASON FOR VETO: Governor Reagan said, "This bill would chapter out provisions of AB 1840 (Chapter 369, Statutes of 1969) requiring affidavits for the homeowner's property tax exemption be filed by April 15 instead of March 15."

Accordingly, I am returning the bill unsigned.

force to Detroit on October 21, to inspect the automobile industry's smog testing and research laboratories.

Purpose of the visit, he said, will be to learn about the progress being made against air pollution caused by the internal combustion engine.

The task force will be comprised of legislators, representatives of the State Air Resources Board and others directly concerned with air pollution, including representatives of the California State Chamber of Commerce.

"The people of California-and the nation-are greatly concerned about their environment and what can be done to insure present and future generations a clean, healthful atmosphere in which to live," Governor Reagan said.

"This administration shares that concern. It is my intention to do everything we can to eliminate smog and air pollution."

Governor Reagan expressed his appreciation to the automobile industry for opening their test and research facilities to the task force and commended them for the progress they and others in the automotive and petroleum industries have made up to this time.

"Despite the achievements and the millions of dollars invested to reduce automotive emissions and comply with the stringent air pollution requirements called for in the Clean Air Act of 1968," the governor said, "much more remains to be done.

"While the emission standards required by next year are stringent-in fact, the toughest in the nation--the requirements that must be met by 1974 are even more demanding.

"This means the auto industry will have to spend even more time and money to comply with those strict but absolutely necessary requirements. Time is running out. The people of California feel this and the industry knows it.

"I look forward to my meeting with the industry and I pledge them our cooperation and continued assistance in helping them meet our California requirements.

"We have a mandate by the people for clean air in California. With common purpose and common dedication we will meet that demand as we move ahead on all fronts to clean, protect and preserve our environment," the governor added.

Governor Ronald Reagan today appointed a fact-finding commission to look into a dispute involving the Southern California Rapid Transit District and the Amalgamated Transit Union, Division 1277.

Creation of the fact-finding commission came after district officials and union negotiators reached a stalemate in attempts to work out a new contract for members of the Amalgamated Transit Union.

Creation of the commission assures the continuation of service with a strike for at least 60 days.

The district operates busses over a 2300-mile network and carries nearly 700,000 daily passengers.

Commission members are Morris Myers of San Francisco; Melvin Lennard of San Francisco and Adolph Koven of San Francisco, all experienced attorneys and arbitrators.

The commission is set up under a section of the Rapid Transit District Law (Public Utilities Code, Section 30756) that calls on the governor to appoint a fact-finding commission when district and union negotiators fail to agree.

The parties have been negotiating for several weeks.

The dispute revolves around wages, pensions, health and welfare benefits and other issues.

Two months ago, the governor appointed a fact-finding commission which successfully settled a dispute between the transit drivers and the Southern California Rapid Transit District.

Governor Ronald Reagan said today the 1969 legislature produced some of the most significant and far-reaching legislation in the state's history---measures "that will have a beneficial impact upon the lives of Californians who will not even be born until the 21st Century."

In a statement evaluating the 1969 session, the governor praised the efforts of the Republican leadership in the Senate and Assembly for steering key parts of his administration's program into law despite the lack of a firm working majority.

"However, I would be less than candid if I expressed total satisfaction with the 1969 legislative accomplishments.

"I am disappointed that we failed to reach agreement on several major issues, including a comprehensive tax reform program that would have provided a long-range solution to the critical problem of school financing and made our tax structure more equitable.

"And I believe the people of California were disappointed and dismayed by the partisan obstructionism that left the state without a budget for the first three days of this fiscal year.

"But the positive and constructive progress we made in other areas will mark this session of the legislature as one of the most significant in the state's history.

"I am particularly pleased with the progress we achieved in conservation, consumer protection and in strengthening our criminal laws.

"Some of the anti-pollution and conservation measures which I requested and which the legislature passed are tremendous milestones in solving some of the most urgent problems facing our state---the triple menace of air and water pollution and the uncoordinated and uncontrolled developments that have threatened to mar the priceless scenic, natural environment of California.

"Several of these measures implement programs of environmental protection that will have a beneficial impact upon the lives of Californians who will not even be born until the 21st Century," the governor said.

Three major environmental programs deserve special note: The California Water Quality Improvement Act of 1969 (coauthored by Assemblyman Carley V. Porter, D-Compton and Senator Gordon Cologne,

-1-

R-Indio) was an administration bill drafted by a task force of experts and represents the first complete revision of California's water pollution laws in 20 years. It includes tough provisions for violations and greatly improves the administration of water quality control laws.

The legislature also approved another pioneering air pollution control program as part of the continuing follow-up to the massive Air Quality Act of last year. This measure (AB 988 by Assemblyman Robert Beverly, R-Manhattan Beach) places strict limitations on air pollution from jet aircraft beginning Jan. 1, 1971. It is the first program in the nation controlling jet emissions.

In addition, "California took a tremendous stride toward protecting and preserving its priceless esthetic environment when the legislature passed the bill (AB 2057 - Knox) extending permanently the life of the San Francisco Bay Conservation and Development Commission," the governor said.

"I asked for a strong BCDC bill and we have one. It will preserve San Francisco Bay without imposing the stifling bureaucratic controls of a full-scale regional government.

"I also am pleased that we finally broke the legislative bottleneck which for a number of years prevented the passage of stronger laws against obscenity and drunk driving.

"The passage of SB 62 and SB 63 (by Sen. Robert J. Lagomarsino, R-Ventura County) culminates a long battle by this administration and by Republican legislators to keep pornographic materials out of the hands of our children," Governor Reagan said.

(The Lagomarsino measures were the first anti-pornography bills to secure passage in eight years and were approved a few weeks after the Republicans gained a narrow, one-vote margin in both houses of the legislature.)

"Equally important to the safety and well-being of cur citizens is the 'presumptive limits' bill of Assembly Majority Leader Craig Biddle (R-Riverside).

"This legislation--which establishes a point at which a motorist may be presumed to be under the influence of alcohol--will be a tremendous tool for law enforcement officers attempting to deal with the drinking driver who insists on endangering not only his own life, but the lives of innocent persons," Governor Reagan said.

"Legislation dealing with campus disturbances also was passed, giving administrators and law enforcement officials added tools to deal with disruptions.

"For the second straight year, the administration sought and received legislative permission to reorganize the Executive Branch of government, eliminating unnecessary boards and commissions and streamlining outdated concepts of government.

"I also would like to congratulate Republican lawmakers for their leadership in enacting important new legislation to protect the interest of the consumer."

As examples, Governor Reagan cited AB 77 by Assembly Speaker Robert Monagan which permits a recipient of unsolicited merchandise in the mail to keep such merchandise as a gift and AB 1763-64 which strengthens the consumer laws to protect citizens egainst being billed for merchandise charged to unsolicited or stolen credit cards.

"The list of other important legislation passed this year covers many other subjects of vital concern---ranging from health care to rapid transit," Governor Reagan said.

"The legislature responded favorably to my request for bills strengthening laws against drug abuse, to protect the Medi-Cal program against fiscal abuses, to provide more flexibility in the planning and financing of rapid transit systems, to create an Office of Transportation Planning, and to improve health and alcoholism rehabilitation programs.

"One of the most significant measures approved was my request to give the state's taxpayers a 10 percent rebate on their income tax next year.

"Instead of spending this one-time fiscal windfall to establish programs that would cost even more in years to come, we are returning the unexpected surplus to those who paid it---a move I hope we can repeat as we continue efforts to reduce the cost of government.

"Yet even while practicing an economy drive, this administration in 1969 provided more money for education and more new funds for the public schools than ever before---without increasing taxes."

Governor Reagan pledged that his administration would continue to seek a comprehensive tax reform program. "This administration has taken the lead for two years in seeking to overhaul our outmoded tax structure and will continue those efforts."

He noted that the impact of the pending federal tax reform bill in Washington would have to be considered in putting the tax reform program together for California.

AB 986 - Lanterman Revises the Lanterman-Petris-Short Act, Short-(Chapter 722) Doyle Act, and related provisions for care and treatment of mentally disordered persons, persons impaired by chronic alcoholism, and persons subject to judicial commitment, and for the administration and financing thereof. AB 1708 - Thomas Authorizes the County of Los Angeles to limit (Chapter 723) the size of vehicles as a condition of approving narrower street sizes in undeveloped areas on Santa Catalina Island. "After a thorough evaluation of all legal and factual matters in this case, it is my conclusion that there is no basis on which to refuse to honor the requisition of the Governor of Arizona.

"Under the U. S. Constitution and the laws of California, it is my duty to grant requests by Governors of sister states for the extradition of fugitives. These constitutional and statutory requirements are based on the right of a sister state to bring a person to trial who has committed a crime within its borders and to see that whatever sentence rendered after conviction is fulfilled.

"There are certain legal defenses to extradition, none of which have been raised in this case. Evidence of Mrs. Judd's rehabilitation was presented at an extradition hearing before my Legal Affairs Secretary Herbert E. Ellingwood. However, the proper forum in which to consider matters such as Mrs. Judd's rehabilitation, her mental condition, and questions of parole is Arizona, the state in which the crime was committed and where Mrs. Judd was convicted and sentenced."

Governor Ronald Reagan today made the following statement: "Today I have, with some reluctance, signed into law Assembly Bill 606 authored by Assemblyman Victor Veysey. The bill is necessary to implement the supplementary financing for schools that I recommended last January. My reluctance to sign this bill is based upon the fact that the measure commits one-time surpluses to continuing programs. In this context, I must warn the school districts of Californi that at least a portion of the increased level of state support contained in this bill will not, in all probability, be available in 1970-71. School district budgets should be planned accordingly.

"This year, I broke past precedent and requested \$105 million in additional school aid in my budget as presented to the legislature in February. To that amount, which we included because we knew we could continue to finance it in coming years, we were able to add \$15 million due to the federal cancellation of the freeze on aid to families with dependent children, bringing the total additional sum available on a continuing basis to \$120 million.

"Additionally, I agreed to make available any surplus as of June 30, 1969 not anticipated in our May 26th estimates. These additiona/ funds, which will result from a combination of additional revenue and savings from our intensive economy program, will not be available for the schools again in 1970-71.

"Since these funds are non-recurring, I urged the legislature to commit these one-time funds for one-time purposes such as construction or restoration of reserves. However, they saw fit to use some of these funds to increase the regular support formulas.

"Therefore, today I must make the same plea to the school districts of California--to commit, to the extent possible, these onetime funds to one-time purposes. If these funds are expended for continuing programs requiring additional personnel, salary increases, or the like, districts will face the need of curtailing the regular expenditures in the 1970-71 fiscal year. Unfortunately, such curtailment will just create more pressure on the already overburdened property taxpayer and I believe that we must be completely candid in warning districts of the fiscal realities they will face in 1970-71.

"I realize the lateness of the hour for school districts struggling against deadlines for preparation of their budgets. This has long been a problem, and I have asked my recently-established Educational Reform Commission to recommend better procedures to allow school districts more time and earlier information as to available state funds for the preparation of their annual budgets.

"Finally, as I sign this measure, I am compelled to point out that my tax reform and school finance proposal would vastly improve the whole complex subject of paying for our schools. My proposal would abolish basic aid and equalization aid and provide 80% of the total cost of our schools in state funds distributed strictly on the basis of enrollment.

"Passage of the tax reform proposals would give to our schools not only the bulk of their necessary funds, with provision for increases based on inflation, but it would give the schools the regular, early knowledge they need to prepare their budgets without the annual wait to see if the legislature is or is not going to give additional school funds. Finally, tax reform would give our hard pressed residential real estate taxpayers their first real guaranteed tax releif in a generation of steadily rising taxes on homes."

Removes the requirement that 156 acres of land adjacent to Kellogg-Voorhis (Pomona) Campus of California State Polytechnic College be sold as surplus state property. The land is needed for planned expansion of the Pomona campus.

Provides, with specified exception, that agencies contracting with the Public Employees' Retirement System do so on the basis of entire compensation of local members rather than be limited to specified amount of compensation. The bill provides that prior service benefits for local safety and local miscellaneous members shall be based on final compensation. Clarifies application of 1968 cost-of-living amendments to the Public Employees' Retirement Law to allowances of persons retired under a terminated public agency contract or under a local system terminated by a public agency's contract to participate in the system by providing for cost-of-living adjustment of all such allowances except those under a contract terminated before enactment of the legislation.

Provides for reduction of retirement allowances and contribution rates of local safety members covered under Social Security whose allowance is determined on the basis of 2 percent of final compensation upon retirement at age 50. The bill applies the maximum for such allowances and similar allowances for patrol members to the total allowance payable to the member for all service to all employers rather than to service of a single employer and prescribes the manner of computing allowance for service to each employer where the maximum applies.

Includes libraries and parks adjacent to school sites within the definition of "recreation center" in the statutes authorizing school districts to jointly participate with other public authorities in projects for purposes of community recreation.

Eliminates minimum license fees that may be charged employment agencies.

AB 606 - Veysey Provides additional allocations of state (Chapter 784) funds for school support purposes. AB 854 - Conrad Deletes a Health and Safety Code provision (Chapter 756) relative to the sale of blank cartridges. AB 1020 - Hayes Provides that in cases where preparation of plans and specifications for construction, (Chapter 757) alteration, improvement, or repair of buildings or structures is subject to architectural licensing law, each city or county which require: a building permit for such work shall also require, as a condition precedent to issuance of a permit, a signed statement that the person who prepared the plans or specifications is registered or certified under architectural licensing law, or otherwise licensed so to do. Requires city or county treasurer, if he receives for payment an interest coupon from a bond issued pursuant to the Improvement Bond Act of 1915 for which notice of advanced maturity has been given without the bond being surrendered, to mail a copy of the notice of advanced maturity to the address given for payment of the coupon. The bill provides for the amortization of assessment bonds issued pursuant to the Improvement Bond Act of 1915 where the procedure used is the Improvement Act of 1911. AB 550 - Bagley

Redefines "cigarette" in the California Cigarette Tax Law. The bill also prohibits the State Board of Equalization from issuing a wholesaler's license to a wholesaler, rather than to a distributor, whose license has been revoked or suspended unless specified conditions are met.

REASON FOR VETO : Governor Reagan said, "This measure redefines 'cigarette' in the California Cigarette Tax Law to exempt cigarettes that are rolled in tobacco (little cigars) from the cigarette tax.

"It should be noted that while these small cigars are not included in the federal cigarette tax definition of 'cigarette,' they are taxed by federal law under another provisio Conforming the California definition of 'cigarette' to the federal definition achieves, therefore, a very different tax result. While these items would be totally exempt from any kind of California tobacco tax, they would still be subject to a federal tobacco tax."

It is estimated that the adoption of this bill will result in an annual General Fund loss of \$28,000 and a loss of \$12,000 to local government.

"Accordingly, I am returning the bill unsigned."

AB 1725 - Quimby

Adds transportation of wheelchair or litter patients, or both, in nonemergency vehicles, and the transportation of persons in emergency vehicles, to exceptions to the authority granted by the Public Utilities Code to charter party carriers.

<u>REASON FOR VETO</u>: Governor Reagan said: "The position of those who provide nonemergency transportation services was not heard when this bill was before the legislature, nor was the potential fiscal impact of the measure fully examined. I believe that the matter of regulation of nonemergency transportation services deserves more intensive study by the legislature.

"Accordingly, I am returning the bill unsigned."

A bill that makes it tougher for unethical land promoters to bilk the public was signed into law today by Governor Ronald Reagan.

In signing the measure, <u>AB-1214</u>, Governor Reagan called it "an excellent example of how private enterprise can cooperate with government to protect our citizens from dubious land speculators and at the same time not hamper the promotional activities of legitimate subdividers."

The new law allows the Real Estate Commissioner to prevent the sale of subdivisions in remote areas when promised improvements appear to be financially infeasible. It also requires subdividers of large projects away from population centers to report the names of all defaulting purchasers to the Real Estate Commissioner.

And, it allows buyers of lots to withdraw from signed sales contracts within two days after they receive the Commissioner's public report on the subdivision.

The legislation grew out of a series of meetings conducted by a special advisory committee organized by Burton E. Smith, State Real Estate Commissioner.

The committee included representatives of the office of the Attorney General, the State Department of Real Estate, the California Real Estate Association, the California Home Builders Council and major subdividers of remote lands.

"The growth and healty development of this state is influenced to a great extent by the success or failure of real estate promotions," Governor Reagan said. "This law should make it possible to achieve this growth and at the same time provide safeguards for the buyer."

The bill was authored by Assemblymen Eugene Chappie (R-Cool) and

California has moved up from 11th to 2nd place among the states in the total number of persons rehabilitated into gainful employment during the course of the Reagan administration.

A telegram from the U.S. Department of Health, Education and Welfare to Governor Reagan showed that 14,450 handicapped persons were restored to productive lives during the past fiscal year through the efforts of the State Department of Rehabilitation.

This is nearly 10,000 more than the number rehabilitated during the last full fiscal year of the previous state administration (1965-66)

During the past year alone, rehabilitations increased 39 percent in California, or by some 4,000 over the previous fiscal year. During the same one-year period, California moved up from third to second among the states and now trails only Pennsylvania.

Over the past three years, however, California has increased rehabilitations of its handicapped by 219 percent, while Pennsylvania's rate of increase for the same period has climbed only 34 percent.

The top five states in rehabilitations last year were: Pennsylvania, 16,544; California 14,450; Illinois, 13,410; Texas, 11,861; New York, 10,250.

Governor Reagan noted that during his 1966 gubernatorial campaign he pledged to see to it that in the future the state's rehabilitation program must produce much greater results, commensurate with the taxpayer dollars spent for its support. "At that time, California was among the first in the dollars spent for rehabilitation programs, but far down the list of major states in terms of results." the governor said.

The wire to the governor from HEW Social and Rehabilitation Service Administrator Mary E. Switzer said:

"I am pleased to inform you that California now ranks second in the nation in the number of disabled people rehabilitated to more productive lives.

"Final figures for fiscal year 1969 show that 14,450 disabled people were rehabilitated in your state, out of a total of 241,390.

"Heartiest congratulations to you, and to your director, Robert E. Howard, Department of Rehabilitation and his dedicated staff.

"Your continued strong support, and the support of your state legislature, will enable us to expand our cooperative program to increase services to the disabled people of California and to pursue our national goal of helping every handicapped citizen achieve his fullest potential."

Governor Reagan also commended Howard and his staff on the "achievement" which, he said, "has attracted nationwide attention and will now, more than ever, serve as an example to other states of how to make rehabilitation programs work, how to get the most from every dollar spent'

From an economic standpoint, the governor pointed out, the 14,450 disabled persons who were able to go to work last year as the result of vocational rehabilitation services will earn more than \$66 million annually. "In slightly over three years these rehabilitants will have returned the cost of their rehabilitation through the income taxes they pay and the savings in public assistance funds and institutional costs," he said.

Governor Ronald Reagan today announced the appointment of Winfred (Win) W. Adams, his former cabinet secretary and for the past seven months interim executive assistant to Lt. Governor Ed Reinecke, as assistant to the governor, to take charge of establishing an administration management evaluation system.

The appointment is effective September 1. Adams' salary will be \$22,050 per year.

Adams, 51, returns to the governor's staff after leaving the cabinet post last January to serve temporarily as Reinecke's top aide during the newly appointed lieutenant governor's transition to state government.

"Now that the transition period has successfully been completed," Governor Reagan said, "I have asked Win to return to head up a comprehensive management evaluation project relating to administration programs and policy, as recommended by the cabinet after several months of intensive study. The project is intended to provide the cabinet with an even better grasp of how effective our management procedures are in relation to administrative costs, and where further improvements may be made.

"With his keen understanding of the workings of the executive branch, and of the people who make it work, I am sure that Win's important new responsibilities will further strengthen our efforts to assure that every taxpayer dollar over which we have control is used both wisely and sparingly," the governor said.

Adams, who served as cabinet secretary to the governor for 16 months, joined the administration in 1966 and was a member of the interim government prior to his appointment in January, 1967, as assistant secretary of the State Resources Agency. He was promoted to cabinet secretary in September, 1967.

Governor Reagan noted that during his assignment in Reinecke's office Adams "has continued to be a key administration advisor on major governmental and political matters while, at the same time, furnishing the lieutenant governor with a valuable insight into state government."

Adams also played a key role in both the formulation and establishment of a new administration office of intergovernmental management, headed by the lieutenant governor.

Prior to joining state service, Adams worked for four years as campaign director for the Republican State Central Committee. He also was director of the "Cal-Plan" to elect Republican legislators.

State Finance Director Caspar W. Weinberger said today he is "appalled by the lack of knowledge" displayed by Thomas T. Jordan, General Manager of the California State Employees' Assn., regarding preparation of next year's budget.

"If Mr. Jordan had taken the time to determine the facts instead of displaying his ignorance by trying to frighten people, he would have known that his charge that 25,000 students would be turned away from state colleges next year was false and ridiculous," Weinberger said.

"Since the state colleges determine their priorities in the preparation of their budget, it would be inconceivable that they would recommend eliminating 25,000 students," Weinberger said.

The finance director said that every agency of state government was allocated funds based on the current year's budget and told to assign their highest priorities within that amount. They also were told to submit supplemental lists of high priority programs. In this manner, the preparation of next year's budget can be based on overall statewide priorities.

"I would hope that Mr. Jordan is not suggesting that economy in government is not necessary and I further hope that he is not advocating new taxes and a return to the old theory of spend, spend, spend.

"If he is, he is in obvious opposition to Governor Reagan's insistence that the cost of government be reduced and that taxes be lowered. already

"Mr. Jordan should know, if he/doesn't, that the governor has given higher education the highest priority of any item in the budget and that higher education has received the highest percentage of increase in the state's history during the Reagan administration.

"Furthermore, Mr. Jordan's unsupported claim that the quality of services provided by state government has been croded is not borne out by the fact that just today the U. S. Department of Health, Education and Welfare announced California ranks among the top two states in the number of persons rehabilitated into gainful employment--a significant step upwards from the 11th place ranking California had before this administration took office.

"It is very regrettable that Mr. Jordan has, by his outlandish claims, chastised the state employees he is supposed to represent because the vast majority of state workers are serving the public with greater devotion and efficiency than at any time in the past," Weinberger said.

AB 726 - Beverly Provides that judgments in favor of public agencies (Chapter 822) shall include process fees which would have been charged if a public agency had not been involved.

AB 757 - Arklin (Chapter 823) Adds a provision to the Public Utilities Code permitting the commission to accept for deposit insurance policies issued by nonadmitted insurers covering the operations of highway carriers, household goods carriers and for-hire vessels if such policies meet the commission's regulations. The bill would allow household goods carriers to self-insure if authorized by the commission.

AB 759 - Arklin Permits the Department of Harbors and Watercraft (Chapter 824) to register vessels at its Long Beach office rather than only at its Sacramento office.

AB 774 - Dunlap (Chapter 825) Includes in the definition of "remote interest" the interest of certain public officers and employees in any contract or agreement entered into pursuant to the provisions of the California Land Conservation Act of 1965.

AB 784 - Murphy (Chapter 826) Generally revises provision relating to posting of rates by innkeepers. The bill further requires that with respect to a hotel, inn, boardinghouse or lodging house, a person who collects or receives sum greater than the statement of rate or range of rates by the day for lodging posted, shall forfeit greater of \$100 or three times the amount of the sum charged in excess of what he is entitled to under designated circumstances, rather than just three times the amount. AB 820 - Beverly (Chapter 828)

tion of "employer" relating to operators of hospitals for purposes of unemployment insurance. The bill excludes death, pension and retirement payments paid by an employer in another state from definition of "remuneration" for the purpose of determining the basis of contribution.

AB 821 - Beverly (Chapter 829) Provides that the State Treasurer, rather than the Department of Finance, will invest the Disability Fund under the supervision of the Director of Employment. It also permits investment of the Disability Fund in enumerated eligible securities, rather than only in United States or California interest-bearing obligations only.

AB 822 - Crandall Revises procedures for transferring territory from (Chapter 830) one elementary, unified, or junior college district to another such district.

AB 831 - Wilson (Chapter 831) Repeals the requirement that perjury be proved by the testimony of two witnesses, or of one witness and corroborating circumstances and instead provides that no person shall be convicted of perjury where proof of falsity rests solely upon contradiction by testimony of a single person other than the defendant. The bill specifies that proof of falsity may be established by direct or indirect evidence.

AB 841 - Duffy (Chapter 832) Grants blind persons, visually handicapped persons, and other physically disabled persons full and equal access to all housing accommodations offered for rent, lease or compensation in this state.

AB 849 - Biddle Permits authorized employees of the Department of (Chapter 833) Motor Vehicles to expend appropriated support funds for the purchase or procurement of evidence or to investigate violations of laws administered by the department.

AB 852 - MacDonald Deletes the specific criteria for the erection of (Chapter 834) yield right-of-way signs and would require that such signs shall be erected only in accordance with regulations to be established by the Department of Public Works.

AB 868 - Dunlap (Chapter 835) Requires proponents of initiative, referendum and recall petitions for local and statewide elections to file with the Secretary of State, not later than 35 days after measure has qualified for ballot, a statement of expenses and receipts.

AB 895 - Sieroty (Chapter 836) Provides that holder of a certificate of registration authorizing service as a school audiometrist issued by the State Board of Public Health may test the hearing of pupils of a school district through the use of an audiometer for the purpose of detecting pupils with impaired hearing.

AB 915 - Murphy (Chapter 837)

AB 932 - Milias (Chapter 838) Authorizes a junior college district to contract with another school district in the same county, or a county superintendent of schools that maintains facilities for the education of physically handicapped children, if the district does not maintain its own facilities for such children.

Provides that the director of Parks and Recreation may examine any tangible personal property delivered to the state controller under the Unclaimed Property Law to determine whether such property may be useful for the interpretive program of the State Park System.

Governor Ronald Reagan today signed two bills which will provide property tax relief to homeowners and veterans who have been excluded from refunds.

The measures, AB-1726 by Assemblyman John Quimby (D-Rialto), and AB-2349 by Assemblyman R. E. Johnson (R-Chico), extend the deadline for filing for a \$750 reduction in home assessments until September 1.

The Quimby bill also allows persons who qualify for the 1968-69 tax rebate but did not file for the \$750 property tax exemption to now do so.

Qualified veterans who had filed for the exemption but were told by local assessors that they were ineligible now automatically become eligible for the \$750 under the Johnson bill.

(Chapter 842) Increases from six months to one year the time AB 1011 - Johnson, H. within which a bank must open a branch which (Chapter 843) has been approved by the Superintendent of Banks. The bill increases from six months to one year the periods for which the superintendent may extend the times for opening a branch. The bill further authorizes foreign branch of bank to transact such business as may be usual in connection with the transaction of the business of banking in the places where such foreign branch is located. Increases the permissible amount of revolving AB 1016 - Miller cash fund of school district. (Chapter 844) Redefines "employees" for purposes of the workmen's compensation laws to exclude officers AB 1036 - Priolo (Chapter 845) and directors of private corporations where they are sole shareholders of the corporations except when their employer has elected to come under certain compensation provisions by specified procedures. Authorizes the governing body of school district AB 1051 - Mulford to reimburse, under specified conditions, any (Chapter 846) person or persons for loss, destruction, or damage by arson, burglary, or vandalism of personal property used in schools of the district. The bill permits a school district to bring action in small claims court or other court of competent jurisdiction for payments made for damage to or loss of certain personal property of employees. AB 1067 - Gonsalves Requires that structures on property acquired for future highway use conform to local building and safety code requirements. (Chapter 849) AB 1079 - Briggs Clarifies that the death of an injured employee (Chapter 850) terminates the liability of the employer for both temporary and permanent disability as of the date of death. AB 1084 - Dent Requires the Department of Public Works to condemn property for the replacement of the (Chapter 851) riding and hiking trail in the vicinity of Alhambra Avenue in Martinez. Provides an exemption in the Weighmaster Law AB 1091 - Johnson, R. (Chapter 852) with respect to persons who may possess blank weighmasters certificate forms. The bill provides that employees of marketing order boards or grading inspection services under conditions prescribed by regulation of the Director of Agriculture are exempt from this provision. AB 1092 - Priolo Requires that delegates to a Constitutional (Chapter 853) Convention be voters elected from districts as nearly equal in population as may be practicable. The bill makes other changes related to revision of the State Constitution by ACA 28.

Codifies various provisions now found in the California Constitution which are to be omitted from proposed revised portions of Constitution. The bill provides for procedures to allow the Public Utilities Commission to fix compensation to be paid when property is condemned for certain grade crossings and railroad rights-of-way and where property of a public utility is condemned, with the consent of the condemnor and condemnee under certain circumstances. The bill becomes operative upon adoption of Assembly Constitutional Amendment No. 31 of 1969 regular session.

Directs the manner of distribution of specified community and other property of a decedent which would otherwise escheat to the state.

Prescribes the manner in which a county purchasing agent may sell various kinds of unclaimed property, when the property has been transferred to him. Permits specified agencies or officers to retain the property that they received for sale if it is determined that the property is needed for public use. Reduces period of time which University of California must hold unclaimed property before selling it at public auction from six months to three months.

Redefines motor club service, insurance, travel and miscellaneous services for the purpose of updating the motor club laws. Prohibits motor clubs from furnishing any service on reimbursement basis which constitutes transaction of insurance. Expands services of motor clubs to include vacation trailers and boats and their trailers.

Exempts certain types of insurance from the effective time of 12:01 a.m. on the date of coverage and extends coverage for 12 hours preceding or following such hour.

Revises the definition of ocean marine insurance for tax purposes and states that the revised definition is a restatement and continuation of existing law.

Declares that the Professional Engineers Act does not prohibit a licensed contractor, while engaged in the business of contracting for the installation of electrical or mechanical systems or facilities from designing such facilities in accordance with applicable construction codes and standards for work to be performed and supervised by such contractor within the classification for which his license is issued.

Provides that open-space lands shall be valued for tax purposes by the capitalization of income method which is defined in the bill.

Provides that the person, his estate and relatives are liable for care provided to person on leave of absence from state hospital where care is paid for either by Department of Social Welfare or by Department of Mental Hygiene.

Authorizes the Director of the Youth Authority to purchase annuity contracts for permanent employees under specified conditions. AB 1229 - Quimby (Chapter 865)

Provides procedures for the custody, evaluation, and treatment under the Lanterman-Petris-Short Act of users of narcotics and restricted dangerous drugs.

Permits voters, whose registrations are subject to cancellation because they moved to another precinct within the county, in lieu of executing a new affidavit of registration, to notify the county clerk of address change.

Exempts from secured transactions regulation any security interest created by assignment of benefits of any public construction contract under the Improvement Act of 1911.

Provides for treatment and evaluation or intensive treatment, pursuant to specified provisions of law, of a prisoner who is a danger to others as a result of a mental disorder.

Provides that provisions of Industrial Loan Law, relating to certain transactions between an industrial loan company and specified persons and transactions under a name other than that set forth in articles of incorporation of such company shall not be applicable to a premium finance agency.

Provides that a county may, with the permission of an incorporated city, conduct assessment proceedings wholly within the boundary of such city.

Allows taxpayers, filing property statements in duplicate, to have the duplicate returned with the full cash value of each category of property, as determined by the assessor, marked on the statement.

Grants the Superintendent of Banks clear authority to regulate the issue of securities by state banks. AB 1437 - Russell (Chapter 877)

Authorizes department, when contracting for services through health benefit plans, to limit benefit coverage to a fixed number of days or amount or duration of services. Also provides that the carrier may be authorized to continue to administer the benefits provided beyond the limitation with the state paying for such extended coverage on the basis of reasonable costs or charges. Declares the intent of the legislature to authorize a limitation on the liability of a carrier in catastrophic or extended care situations.

Authorizes the board of directors of a county sanitation district in Ventura County to include in resolution proposing as general objects and purposes of the incurring of the bonded indebtedness the acquisition, construction or reconstruction of new local street sewers or laterals.

Authorizes the governing board of a school district maintaining a community college to participate in various enumerated federal programs, and further authorizes such board to spend funds as matching funds for federal grants.

Authorizes state participation in a joint federal-state feasibility investigation of the Salton Sea problems, and makes an appropriation of \$47,500 of which \$8,000 shall come from the Harbors and Watercraft Revolving Fund and \$39,500 from the General Fund.

Amends the Milk Stabilization Law to revise the definition of "distributor" and to clarify the applicability of subdistributor prices under the Act. AB 1519 - Schabarum

Extends resident status to spouses of militar personnel on active duty.

Eliminates the Coordinating Council on Programs for Handicapped Children.

Permits the Fresno Metropolitan Flood Control District to develop district property for recreation uses and purposes in connection with the use of property for the control and conservation of flood waters. Authorizes the district the right to dispose of, or lease, real and personal property with the requirement that any compensation from such transactions be deposited in the general fund of the district. Also amends the District Act to declare that a resolution of intent to take property by eminent domain shall be prima facie evidence of the truth of the recitals in the resolution.

Revises definition of affiliated group and authorization to file consolidated tax return as such with regard to taxation of railroad corporations. Provides that revised definition of "affiliated group" shall not preclude the application of income allocation provisions of the Revenue and Taxation Codes.

Authorizes the Superintendent of Banks to reduce the reserve requirements for state banks below the amount fixed by statute, but not lower than the amount set at the time by the Federal Reserve System.

Adds the Office of Tourism and Visitor Services to those state agencies which the Advisory Committee on a Master Plan for Scenic Highways may consult with for technical and other assistance.

Increases the limit on the amount that a state bank may invest in the stock of small business investment companies from 2 percent to 10 percent of the bank's capital and surplus.

Provides that veterans who have suffered loss, or loss of use, of two or more limbs or of one eye and one limb, need not pay annual registration fees on any one noncommercial vehicle that they own. Under present law, this exemption is granted veterans who have lost, or lost the use of, both legs or who have suffered permanent blindness.

Authorizes cities to enact ordinances requiring sellers of residences to obtain a report showing the authorized use, occupancy and zoning classification of the building and property prior to sale. Charter cities now have such authority.

AB 1703 - Beverly (Chapter 895)	Authorizes a bank, with the prior written approval of the Superintendent of Banks to acquire and hold not less than 80 percent of the voting stock of one or more corporation that perform functions a bank may perform other than receipt of deposits.
AB 1726 - Quimby (Chapter 899)	Permits persons qualified for both the 1968-69 rebate and the 1969-70 exemption for homeowners who filed an application for only one, to file for the other before September 1, 1969. Changes title of state hospital resident AB 1776 - Duffy position of medical program director to (Chapter 907) program director. Allows position to be filled by professional persons who do not meet qualifications of medical director but meet standards prescribed by Director of Mental Hygiene. Provides that if the duties of the program director include the medical care of patients, the qualifications of program director shall be the same as those of medical director. Broadens definition of the term "project" AB 1782 - Johnson, R. as used with respect to water development project maintenance areas to include certain small projects for which funds are available pursuant to specified (Chapter 908) federal flood control act. AB 1796 - Ketchum Authorizes the sale of prison-made goods at the state prisons, in public buildings, at fairs or on property operated by nonprofit associations, rather than only (Chapter 909) at the state prison. AB 1801 - Dent Provides that standard teaching credentials (Chapter 910) with specialization in elementary or secondary teaching shall authorize the holder to teach any subject in juvenile detention facilities classes. The bill provides that holder of secondary credential may teach any subject in the home of a hospital teaching grades 7 to 12. Allows the Franchise Tax Board to make AB 1811 - Dunlap (Chapter 911) credits or refunds of amounts in excess of \$1,000, resulting from overpayment of estimated tax for personal income tax and bank and corporations tax, without approval of the Board of Control. AB 1816 - Belotti Revises provision allowing the State Personnel Board to grant a three-year (Chapter 912) extension of rights and benefits of state civil service employees on military leave. AB 1823 - Milias Authorizes the Secretary of State to make available ballot paper to any jurisdiction (Chapter 913) holding an election, instead of only to counties and cities, and adds the requirement that punch cards be available. AB 1824 - Milias Requires county clerks to transmit semiofficial election returns to the Secretary (Chapter 914) of State in a manner and under a schedule prescribed by him prior to the election, but in no event, at intervals greater than 2 hours. SB 1838 - Song Authorizes and establishes procedures for (Chapter 915) filing of statewide personal property liens by the state to secure payments of sales and use taxes, personal income tax, bank and corporation taxes, and unemployment compensation insurance taxes. Creates the Madera County Flood Control and AB 1854 - Mobley Water Conservation Agency, consisting of (Chapter 916) all the territory of Madera County.

AB 1869 - Lanterman (Chapter 917) Requires that the initial program for replacement housing for construction of State Highway Route 105 in Los Angeles to be conducted in a manner conducive to maximum community participation. Exempts contracts for such replacement housing from conventional contracting procedure in favor of procedure established by the Director of Public Works.

AB 1870 - Lanterman (Chapter 918) Provides that the requirements of the Labor Code section relating to decisions of the Workmen's Compensation Appeals Board shall not be construed so as to broaden the scope of judicial review of appeals board decisions.

#485 AB 1873 - Mobley Authorizes local entities to assess fees against (Chapter 919) the owner for inspection of places of deliberation, worship, drinking or dining and awaiting transportation. Such authorization is effective until 91st day after adjournment of 1973 regular session of legislature. AB 1874 - Mobley Provides for exceptions from the professional (Chapter 920) qualifications imposed for members of hearing boards for certain county air pollution control districts where persons with such qualifications are not available to serve thereon. AB 1881 - Barnes Amends the County Employees' Retirement Law of 1937 to provide that the allowance for non-service-(Chapter 922) connected disability for safety members under the age of 55 shall be the sum to which he would be entitled to as service retirement or a specified annuity or disability retirement pension rather than such specified annuity or pension. AB 1885 - Murphy Provides that murder perpetrated by bomb, as (Chapter 923) defined, is murder of first degree. AB 1888 - Murphy Provides that if a person convicted of a public offense is committed to the Youth Authority and the Youth Authority returns him to the committing court (Chapter 924) as an improper person or incorrigible, and the court in turn, commits the person to the state prison, the maximum term shall be the maximum term for the public offense committed, less the time served under the Youth Authority. AB 1890 - Murphy Provides that expert witnesses are not required to (Chapter 925) determine harmful or obscene character of matter in cases involving obscenity or harmful matter, and permits any evidence tending to establish various elements of obscenity or harmful matter. AB 2119 - Russell (Chapter 936)	Amends the Education Code to provide that the last day to file school district nomination papers is the close of business on the 54th day prior to the election. Present law permits such filing until 12 noon on the 54th day prior to the election.
AB 2209 - Fong (Chapter 937)	Authorizes school district governing boards to provide, without charge or at a reduced price, other nutrition periods during which foods or beverages, or both, are served to pupils.
AB 2217 - Lewis (Chapter 938)	Authorizes county superintendents of schools to obtain air travel insurance for their own office and to carry a master policy for air travel insurance on behalf of the school district of the county.
AB 2319 - Stull (Chapter 945)	Prescribes procedure for governing board of any school district to establish a revolving cash fund for the purpose of paying bills for purchase of \$100 or less. Requires monthly list of such payments to be approved by the governing board. Provides that person issuing check drawn on such fund will be personally liable for amount of check if the expenditure is in violation of rules and regulations adopted by governing board with respect to such revolving cash fund.

AB 2285 - Stull Authorizes county clerk of organizing county of (Chapter 943) local hospital district to accept and distribute arguments for and against a measure relating to the election of directors of such district.

Authorizes court, with concurrence of the board AB 2292 - Bagley of supervisors, to employ an investigative staff for purpose of recommending whether a defendant should be released on own recognizance.

AB 2346 - Lewis Provides that capital notes and debentures of (Chapter 946) banks from time to time outstanding shall be deemed "Capital," "paid-up capital," and "paid-in capital," as such terms are used in provisions relating to loan limits for commercial, nondepartmental, and savings banks.

AB 2349 - Johnson Permits veterans whose claims for the veterans' (Chapter 900) exemption for the 1969-70 fiscal year are disallowe to file claims for the homeowners' exemption for su year until September 1, 1969, if otherwise qualifie for the homeowners' exemption.

AB 1056 - Schabarum Authorizes State Air Resources Board to establish (Chapter 847) exhaust emission standards for used motor vehicles.

AB 1058 - Schabarum (Chapter 848) Authorizes the State Air Resources Board to determine and publish criteria for the accredition of motor vehicle pollution control devices for used motor vehicles and authorizes revocation, suspension and restriction of previously granted certificates when the device no longer meets such criteria.

AB 1249 - Biddle (Chapter 866)

Allows criminal defendant committed to a state hospital as "not guilty by reason of insanity"to be placed on parole if he has recovered to extent he is no longer a danger to others and will benefit from parole within 90 days, rather than three years, of commitment. Retains three-year limitation for death penalty cases. Retains requirement of court approval in all cases. Allows new recommendation for parole within see months rather than a year, in non-death penalty, when court disapproves earlier recommendation for parole.

AB 2000 - Knox (Chapter 928) Enacts the Real Estate Syndicate Act. The bill provides for regulation of issues of real estate syndicate securities by the Real Estate Commissioner.

Governor Ronald Reagan announced today he has signed the following bills: Extends the effect of provisions authorizing an increase of not to exceed 10 cents in the maximum rate of school district taxes to permit districts to take corrective measures for fire AB 3 - Belotti (Chapter 997) and panic safety in school buildings from July 1, 1969, to July 1, 1971. AB 79 - Monagan Increases the maximum age from 16 to 18 years at which junior driver permits may be issued. It also requires the Department of Motor (Chapter 947) Vehicles to cancel any permit six months from issuance unless the holder has completed prescribed courses in driver education and training. AB 708 - Hayes Prohibits persons who are registered as (Chapter 948) affiliated with a qualified political party or who were so registered during the year prior to the preceding primary election at which a candidate was nominated for the office referred to in his nomination papers from being candidates under the independent nomination procedure. AB 1477 - MacDonald Provides that in computing aid grants under (Chapter 998) federally supported aid programs, the amounts used shall be based on the nearest dollar. Provides for similar changes in computing cost-of-living adjustments for such grants. SB 40 - Carrell Requires vehicles or combinations of vehicles (Chapter 949) designed to be and operated at a speed of 25 miles per hour or less to display a slowmoving vehicle emblem and prohibits such display if operated in excess of 25 miles per hour. The bill further specifies that the provisions of the bill are applicable to implements of husbandry. Specifies that, for a five-year period, the Director of General Services may dispose of certain property in Los Angeles County, former SB 41 - Carrell (Chapter 950) site of San Fernando State Hospital, only to a public body or local governmental agency who will dedicate such property exclusively for public park recreational or public educational purposes, or both. SB 52 - Alquist Declares that money appropriated by Item 345 (Chapter 951) of Budget Act of 1969 shall also be used for Aid to Families with Dependent Children. Makes permissive, rather than mandatory, various SB 115 - Dymally (Chapter 952) specified components of a More Effective Schools Program. The bill permits up to \$1,000,000 of federal funds, rather than \$500,000 to be used for facilities, construction, and personnel rather than only for facilities. It limits to \$1,000,000 the amount of federal funds which may be annually allocated by the Educational Innovation Commission to the More Effective Schools Program. SB 122 - Teale Requires State Board of Education approval for (Chapter 953) establishment of Regional Occupational Centers and Programs.

SB 137 - Wedworth (Chapter 954)	Requires additional punishment of imprisonment for period of not less than 5 years for any person who uses firearm in commission or attempted commission of robbery, assult with deadly weapon, murder, rape, burglary, or kidnapping, and requires that such additional punishment run consecutively with punishment for the crime for which such person is convected.
SB 146 - Moscone (Chapter 955)	Revises the Community Redevelopment Law to insure that residents of redevelopment projects are not displaced from the project area without sufficient opportunity being made available to them to be rehoused. The bill also establishes a procedure for improvis the communication between redevelopment agency officials and residents of redevelop- ment projects.
SB 176 - Sherman (Chapter 956)	Authorizes peace officers to arrest without a warrant a person involved in a traffic accident when the officer has reasonable cause to believe that the person was under the influence of alcohol or combined influence of alcohol and drugs.
SB 193 - Dills (Chapter 957)	Provides that the court in which proceeding is pending may make the final determination as to whether a defendant is financially able to employ counsel and qualifies for the services of a public defender.
SB 221 - Moscone (Chapter 958)	Revises the authority of a court to dismiss an action for failure to prosecute for two years after the action is filed. The Judicial Council is authorized to adopt the rules governing such dismissals.
SB 213 - Moscone (Chapter 959)	Authorizes filing of specified tort claims against decedents' estates within one year after accrual of cause of action where such claims are not otherwise filed within time allowed. Specifies procedure and liability with respect to such claims.
SB 215 - Cologne (Chapter 960)	Limits the effect of the provisions of Chapter 93 of Statutes of 1969 relating to the adjustment of average daily attendance in kindergarten classes maintained for 180 minutes or more with a part-time teacher by providing that such law shall not be applicable to a school district with respect to a part-time kindergarten teacher teaching 180 minutes or more in a single session class with whom an employment contract was entered into prior to September 1, 1968.
SB 221 - Alquist (Chapter 961)	Provides criteria for issuance of teacher credentials for employees of community colleges and prescribes procedure for issuance of credentials by the board of governors of the Community Colleges.
SB 247 - Grunsky (Chapter 962)	Establishes minimum retirement allowance for person who retired from service under the State Teachers' Retirement System, was reinstated, and subsequently retired.
SB 249 - Carrell (Chapter 963)	Appropriates \$50,000 for support of the State Environmental Quality Study Council.
SB 256 - Moscone (Chapter 964)	Increases allowance of judges who retired for disability prior to January 1, 1948.

SB 633 - Dymally (Chapter 999)	Limits the mode of expression by a person directing, prior to his death, the preparation for, type and place of interment of his remains, to written instructions.
SB 642 - Marler (Chapter 1000)	Authorizes California Disaster Office to dispose of equipment which was purchased and released to local governments. The bill affects commu- nications, attack warning systems and rescue equipment purchased by the state for use by local governments in fulfilling their civil defense obligations. Title to the federal share has already passed to local governments.
SB 645 - Kennick (Chapter 1001)	Provides that prescribed annual inspections conducted by the judge of the juvenile court and the Department of the Youth Authority be made with respect to jails, juvenile halls or lockups which were used for specified confine- ment of persons known to be under 18 years of age rather than with respect to such facilities which were used for such confinement without regard to whether use occurred knowingly.
SB 650 - Beilenson (Chapter 1002)	Specifically includes frame or receiver of a pistol, revolver, and firearm capable of being concealed upon the person within the definition of pistol, revolver and such firearm for specified regulatory purposes.
SB 651 - Beilenson (Chapter 1003)	Provides, with respect to state regulation of possession and transfer of machineguns, that the definition of "machinegun" also includes any combination of parts designed and intended for use in converting a weapon into a machine- gun.

SB 758 - Marler Makes it a misdemeanor for any person to assist in the escape of any judicially committed, or remanded, patient of a state hospital, instead (Chapter 1021) of judicially admitted patient only. The bill clarifies the section making it a misdemeanor for any person to furnish, knowingly, a firearm to a mental patient in a hospital or institution so that it is clear that the hospital or institution is either a public or private institution. SB 759 - Dymally Makes nonsubstantive amendments to the Educa-(Chapter 1022) tion Code. SB 769 - Deukmejian Authorizes the Director of the Youth Authority to provide useful work projects to persons committed to the Youth Authority and to pay (Chapter 1023) wages for such work from funds made available. SB 777 - Lagomarsino Authorizes the Department of General Services, (Chapter 1024) with the approval of the State Public Works Board, to dispose of specified parcels of property upon giving of public notice and to transfer certain property to the Department of Public Works. SB 798 - Collier Provides that a board of supervisors shall (Chapter 1025) decide on formation of a county road division after a hearing. The bill authorizes the board to change boundaries only if it decides to form the division. SB 807 - Stiern Specifies the powers and duties of the Board (Chapter 1026) of Governors of the California Community Colleges and governing boards of junior college districts and districts maintaining junior colleges. SB 815 - Cologne Permits the San Gorgonio Pass Water Agency to (Chapter 1027) condemn property situated outside the agency upon consent of the board of supervisors of the county in which such property is located. SB 817 - Cologne Provides for the licensing of nonresident (Chapter 1028) distributors of hypodermic needles and syringes doing business in this state. SB 829 - Dymally Expands the definition of dependent children to include dependent children under 25 who are (Chapter 1029) full-time students and dependent children who URGENCY are physically or mentally incapacitated, for whom local public agencies, including school districts, may pay group accident and health insurance premiums. Validates establishment of a pension trust established by a specific

housing authority.

SB 834 - Dolwig (Chapter 1030)	Permits any state department, board, or commission to lease real property for up to one year subject to approval of the Department of General Services and provided such leases do not exceed a total rental of \$1,000.
SB 841 - Cologne (Chapter 1031)	States the expiration date of the New Car Dealers Policy and Appeals Board is the 91st day after final adjournment of the 1971 regu- lar session of the legislature and that neither the New Car Board or the Cannery Inspection Board will be affected by the Governor's Reorganization Plan No. 1 of 1969.
SB 846 - Grunsky (Chapter 1032)	Requires the advisory board appointed by Joint Legislative Investigating Committee for Revision of Penal Code to review all proposed tentative drafts prepared by committee staff and make whatever recommendations it considers appropriate. The bill also requires appoint- ment of a peace officer and a public defender to the advisory board.
SB 853 - Short (Chapter 1033)	Deletes certain provisions in the Vehicle Code which set up standard specifications for some official traffic control devices and would direct the Department of Public Works, after consultation with local agencies, to adopt standard specifications for all official traf- fic control devices.
SB 867 - Moscone (Chapter 1034)	Provides that a notice in lieu of a subpoena duces tecum may be used to compel production of books, documents or other things in a civil action or proceeding by a party to the action or by a person immediately benefited thereby or by the agents of such party or person.
SB 878 - Collier (Chapter 1035)	Authorizes Department of Public Works, for projects under construction which will not be completed within the current fiscal year, to obligate and make available funds, on and after January 1 preceding the forthcoming fiscal year, for expenditures on such projects during the current fiscal year.
SB 884 - Collier (Chapter 1036)	Amends the State Contract Act so as to permit more simplified procedures for administering contracts estimated to cost less than \$10,000.
SB 890 - Collier (Chapter 1037)	Increases the amount which may be spent annually for maintenance of landscaping and functional planting along state highways from \$10,000,000 to \$12,500,000.
SB 893 - Collier (Chapter 1038)	Authorizes the Sonoma Creek Flood Control Project in Sonoma County for state payment of lands and rights-of-way costs required by Corps of Engineers construction. Recommendations as to amounts to be appropriated by the legisla- ture will be made by the Department of Water Resources.
SB 917 - Song (Chapter 1039)	Limits exemption of hotels and resident clubs from regulation as drycleaners to those hotels or resident clubs whose services in the nature of drycleaning involve only spotting, sponging or pressing for their guests or employees only.
SB 919 - Burgener (Chapter 1040)	Authorizes statewide association composed exclusively of school district governing boards or county boards of education, or both, and Department of Education to conduct annual work- shops in the state to include but not limit study and instruction on the subjects of school finance, the Education Code and related laws, and the ethics, duties, and responsibilities of school district governing boards and county boards of education

SB 924 - Burgener Requires the Director of Social Welfare to (Chapter 1041) adopt regulations establishing criteria for evaluation of allowances provided to applicants or recipients who reside in a facility operated by organizations providing any or all basic needs or reside in a living arrangement paid for and controlled by an organization. Such facilities or arrangements are often called "life-care" situations. SB 941 - Moscone Enlarges functions of State Environmental Study (Chapter 1042) Council to conduct study into noise emission control problems. Directs council to appoint a scientific advisory group to report on the state of the art of noise control. Requires council to acquire available federal technical information. SB 947 - Lagomarsino Increases the fine and imprisonment applicable (Chapter 1043) to anyone who deposits in, permits to pass into, or places where it can pass into, the waters of the state any of certain substances or materials as specified. SB 950 - Short Authorizes State Lands Commission to negotiate (Chapter 1044) with, and with the approval of the governor, to enter into agreements with the United States concerning the effect of any fill, dredging, or construction operations, or other activities on or adjacent to tide and submerged lands within the County of Ventura upon the boundary between state-owned submerged lands and outer continental shelf lands. Provides that such agreements may, without limiting scope of agreements, waive on behalf of state any increases in submerged lands resulting from such activities which would otherwise inure to the state. Requires finding of public interest prior to entering into such agreements. SB 951 - Sherman Prohibits the Department of Motor Vehicles' (Chapter 1045) order of suspension or revocation of the driving privilege or order imposing terms or conditions of probation relative to safe operation of a vehicle in specified situations from becoming effective until 30 days, rather than 10 days, after the giving of written notice to the person affected. SB 958 - Mills Provides that land leased by an irrigation (Chapter 1046) district to the Department of Parks and Recreation at a reduced rental will have the taxes on that land reduced in proportion to the reduction in rental. SB 983 - Petris Adds continuation education to provisions (Chapter 1047) presently authorizing maximum school districts tax rate increase of \$0.05 per \$100 of assessed valuation in elementary or high school districts and \$0.10 per \$100 of assessed valuation in unified school districts for support of opportunity schools. SB 984 - Dolwig Increases the maximum amount of money which (Chapter 1048) may be raised by an annual tax to support the police department in a police protection district. SB 988 - Richardson Makes eligible for Cal-Vet loan benefits all (Chapter 1049) those California veterans who served 90 or more days on or after August 5, 1964. The bill deletes the requirement that a campaign medal must have been awarded. It places Vietnam

SB 1001 - Sherman (Chapter 1050)

SB 1010 - Short (Chapter 1051)

SB 1013 - Lagomarsino (Chapter 1052) Revises various Business and Professions Code provisions relating to inactivating of and reinstating or renewing licenses of real estate brokers or salesmen.

Authorizes the Department of Public Works to participate in fringe parking facility demonstration projects provided for by Federal-Aid Highway Act of 1968.

Establishes the Resources Protection Account in the General Fund to be used for resources affected by state highways and for facilities along state highways for overnight recreational use. It requires the Department of Public Works to determine the value of certain property it acquires and to deposit such amount in the Resources Protection Account. The bill appropriates \$100,000 from this account for 1969-70 to be allocated by the Director of Finance upon recommendation by the Resources Secretary.

SB 1105 - Bradley (Chapter 1053) Provides that school district governing boards shall act by majority vote of all of the members of the board.
