MEMO TO THE PRESS

Sacramento--Governor Ronald Reagan announced today he has signed the following bills:

JUNE 12, 1967

AB 1371 - Chapter 733 Stacey & Ketchum Revises provisions concerning collection of local taxes for support of the education of mentally retarded and physically handicapped minors by the county superintendent of schools, to require levy and collection of taxes at an identical tax rate in smaller school districts not approved to conduct their own schools and classes.

July 17, 1967

SB 15 - Chapter 734 Coombs

Requires the Board of Supervisors of San Bernardino County, upon annual request of the Desert View County Water District, to levy a bond tax with respect to land only in the District or improvement district benefited by the purposes of the bonded debt.

SB 27 - Chapter 735 Stiern Extends for two years a permissive override tax of 10 cents to pay for the installation of fire and panic safety equipment in school buildings. This override tax was enacted in 1961 to enable school districts to install proper fire and panic safety equipment recommended by the State Fire Marshal.

SB 399 - Chapter 736 Rodda Permits the assignment of Sacramento County superior court reporters to the municipal court in civil and criminal cases. The bill also raises the basic per diem for court reporter in Sacramento County.

SB 460 - Chapter 737 Short Requires that when a notice of a bulk sale subject to the Commercial Code provides for an escrow, that the full purchase price will be placed with the escrow holder, and that the escrow shall, if the purchase price is insufficient to pay all creditors' claims, delay the closing and give notice to creditors of the deficiency. The bill prohibts payments from the escrow of fees and commissions prior to the close of escrow.

SB 497 - Chapter 738 McAteer

Increases the salaries of various clerks, commissioners, referees and secretaries of the San Francisco Superior Court and provides for one counselor of conciliation, one counselor in mental health, one additional assistant court commissioner and law clerk, and one additional judicial secretary.

SB 517 - Chapter 739 Dolwig

Permits firms engaged in rendering civil engineering services to continue to use name of deceased person in firm name if certain conditions are met.

SB 557 - Chapter 740 Cologne

Prohibits the sale of intoxicating liquor within one airline mile of a specified intersection at the entrance to La Sierra College in City of Riverside, subject to exceptions for the sale of beer, existing licenses, bona fide and public eating places. The bill is so written that the future expansion of the college will not widen the "dry zone".

SB 596 - Chapter 741 Teale & Lagomarsino Authorizes cities and counties to enact regulations equal to or greater than those imposed by existing state law regarding motel rate signs. Because of the language of the present law and court decisions, it is not clear whether local government has the authority to enact local ordinances supplementary to existing state law.

SB 646 - Chapter 742 Short Provides that a registered apprentice may work 5 years instead of 3 years before having to fulfill the requirements for passage of the journeyman barber examination. The bill is intended to give apprentices sufficient time to prepare for the journeyman barber examination.

SB 764 - Chapter 743 Burgener, Schrade, Barnes

Provides authority for the State Department of Parks and Recreation to enter into a 20-year lease of park land located within the Palomar and Cuyamaca State Parks for elementary school conservation study camps.

SB 768 - Chapter 744 Way - Mobley Allows interest on loans to be charged, in the discretion of the board of supervisors, to the general fund of any district or fund for which loans have been made. Local agencies may temporarily borrow moneys which are needed for operating purposes during so-called "dry periods" before property taxes are collected.

SB 841 - Chapter 745 Bradley Requires recreation and park districts to let out to bid all construction and materials contracts of more than \$3,000 as prescribed. The bill authorizes a district board to reject bids and to readvertise, or by 4/5 vote purchase the materials or supplies, or undertake the construction by force account.

SB 869 - Chapter 746 Beilenson Changes the statute of limitations for refunds on property taxes from three years from the date of payment to three years from the date of payment or one year from the mailing of the notice by the tax collector to the assessee specifying irregularities, whichever occurs later. The bill also provides, with respect to applications for reductions constituting claims for refunds, that the applicant must state in the application that it is intended to constitute a claim for refund, and if it is not so stated, he may file a separate claim for refund within the period of the appropriate statutory limitation.

SB 872 - Chapter 747 Cologne

Repeals all statutes relating to the licensing of mineral, oil and gas salesmen. There are no mineral, oil and gas salesmen licensed at this time. The mineral, oil and gas broker status is retained and future applicants for salesman status will qualify for broker status since requirements are virtually identical.

SB 895 - Chapter 748 Dolwig

Raises to \$3,000 the amount for which a county can purchase real estate without publication of a notice of intention. The bill will produce substantial savings to counties each year because of the publication costs and the time and expense involved in preparing and processing the required resolution.

Authorizes members of the district board of a garbage and refuse disposal district to receive actual necessary travel and meal expenses incurred in performance of official business of district.

SB 1008 - Chapter 750 Grunsky

Authorizes a county board of education to acquire real property for purpose of housing the offices and services of the county superintendent of schools, providing various duties and functions of county board of supervisors have been transferred to county board of education.

SB 1067 - Chapter 751 Grunsky

Requires that service of summons and complaint in proceeding to condemn State lands be made on the State Lands Commission instead of the Surveyor General.

SB 1109 - Chapter 752 Coombs & Lagomarsino

Provides that a corporate merger or consolidation may be approved by the unanimous written consent of shareholders. The bill also requires the corporation president, vice president and the secretary to execute a verified certificate of the fact that written consents have been filed with the corporation.

SB 1227 - Chapter 753 McCarthy

Requires consideration involved in transfer of an alcoholic beverage license deposited with an escrow holder, if insufficient to pay filed claims of bona fide creditors in full, shall be distributed in prescribed manner, rather than pro rata to all the licensee's creditors. The bill requires escrow holder, if the transferor licensee disputes any claim, to retain the amount or pro rata amount thereof for a period of 25 days, and if not attached to pay the amount to the transferor licensee. The bill also requires escrow holder, if transferor licensee disputes any creditor's claim, to retain amount or pro rata amount and treat as noncash asset.

SB 1265 - Chapter 754 Dolwig & Britschgi Provides that the design of the West Bay Rapid Transit Authority's transit facilities need not be compatible with that of the Bay Area Rapid Transit District in regard to modes of transportation other than fixed rail for fixed right-of-way facilities. Extends to June 30, 1969 the deadline by which a master plan must be approved by the voters of the counties in which the authority is authorized to operate. Gives the Authority power to apply for and accept grants from the federal and state governments. Authorizes the Authority to dispose of air space over its properties when it will not interfere with the operation of the transit system.

SB 1455- Cahpter 755 Lagomarsino & Shoemaker Changes the title, classifications, and salaries of various attaches of the Santa Maria Municipal Court.

SB 1476 - Chapter 756 Lagomarsino

Provides for staffing and compensation of the Ventura County Municipal Court.

AB 46 - Chapter 757 Leroy Greene Charges county superintendent of schools with responsibility of coordinating special education programs provided for physically handicapped and mentally retarded minors, of affording all eligible minors an opportunity to participate in such programs, and of marshalling and utilizing all public and private resources for such special education. The bill also requires county superintendent of schools to compile and maintain a tabulation of the number of all physically handicapped and mentally retarded minors enrolled in programs and the schools in which they are enrolled & current list of such minors who have applied for but have been denied access.

AB 59 - Chapter 758 Elliott

Provides that whenever any member of the State Teachers' Retirement System or a district teachers retirement system dies while in active membership, or within four months of termination of employment the benefits payable at death shall be paid to the beneficiary or beneficiaries designated by him unless a claim is filed by someone other than designated beneficiary or beneficiaries within 30 days after death.

AB 216 - Chapter 759 Veneman & Chappie Establishes in the Department of Justice a central registry of information pertaining to parents who have abandoned or deserted their children. The primary purpose of this registry will be to assist county welfare departments, district attorneys, probation officers, and other appropriate agencies and officials in locating missing parents so that their responsibilities for the support and maintenance of their children may be effectively enforced.

AB 380 - Chapter 760 Chappie

Authorizes teachers holding a standard teaching credential with a specialization in elementary teaching, to teaching elementary level reading in continuation education calsses and continuation high schools. Continuation education classes are for pupils 16 to 18 years of age who have not finished high school but are not enrolled full-time. Some of the pupils are in need of assistance with reading in order to profit from other courses.

AB 456 - Chapter 761 Cory

Provides that the normal work day for classified school employees shall be 8 hours. Certain classes (security patrol) are exempt from the 8-hour day provisions. it further permits a school board to establish a lesser work day and work week (less than 8 and 40 hours). It also gives part-time classified employees fringe benefits based on the average number of hours actually worked per working day.

AB 567 - Chapter 762 Wilson & moretti

Includes as eligible securities for the investment of surplus state moneys, bonds, notes, and other obligations issued by the Tennessee Valley Authority.

AB 588 - Chapter 763 Fong

Authorizes school governing boards to lease land as site for temporary quarters or portable buildings.

AB 609 - Chapter 764 Veysey Exempts unified school districts which do not meet regular unification standards and which are not approved as parts of county master plan, if such districts have been formed by specified statutory procedures, or were formed by action of law and in existence since prior to July 1, 1948, and are approved by the county committee on school district organization from required reorganization elections to be held every two years and from inclusion in certain master plans.

AB 627 - Chapter 765 Monagan

Broadens definition of cement carrier, regulated as common carrier, to include carriers transporting cement either alone or in combination with lime or powdered limestone. It broadens definition of cement contract carrier regulated by Highway Carrier's Act in similar manner. The bill profides that the certificate of public convenience and necessity to operate as cement carrier shall remain in effect until suspended or terminated by the Public Utilities Commission, but shall lapse if not exercised for a period of one year. The bill also makes cement contract carriers rendering service within a city subject to the Highway Carrier's Act.

AB 694 - Chapter 766 Cory

Authorizes Trustees of California State Colleges to provide for the care or disposition of unclaimed, lost or abandoned property. Requires such property to be held for at least six months' period and to be sold at public auction after publication of notice of sale.

AB 736 - Chapter 767 Foran

Exempts from prescribed stopping and parking requirements of the Vehicle Code a commercial vehicle when reasonable necessary to load or unload merchandise of passengers.

AB 936 - Chapter 768 K. chum

Changes the period within which stated maximum amounts of student body organization membership fees and student body center fees may be required from year to academic year.

AB 961 - Chapter 769 Biddle

Requires the Department of Motor Vehicles to return the driver's license to the licensee, or to grant him a new one after the Department has cancelled his license, if the department determines that grounds for cancellation didn't exist at the time such action was taken.

AB 1012 - Chapter 770 Cory

Authorizes savings and loan associations in California to invest in securities insured in whole or on part by the Federal Savings and Loan Insurance Corporation.

AB 1022 - Chapter 771 Shoemaker Prohibits the appointment of classified employees by a school district to represent employees in employer-employee relations but permits governing board of school district, if no employee organization exists, to appoint such a committee to advise employer on employer-employee relations.

AB 11976- Chapter 772 Biddle

Amends the work furlough law to provide specific authority to furlough delected State and county prisoners for educational purposes if the county chooses to adopt the required ordinance. It also permits prisoners to be furloughed from State community correctional centers for educational purposes. The prisoner would be confined when not being educated or working. The bill also eliminates the need for approval by the parole boards of the transfer of a State prisoner to a county jail or community correctional center, requiring instead that the prisoner's term have been already fixed by the parole board.

AB 1205 - Chapter 773 Negri Amends the Probate Code to provide that the Civil Discovery Act is applicable in probate proceedings. The bill codifies California Case law.

AB 1367 - Chapter 774 Townsend Provides that ordinances creating city civil service systems shall include provision granting service credit to employees on leaves of absence for injuries under workmen's compensation laws, so that their rights to seniority, vacations, sick leaves, and salary adjustments will not be affected by such leaves of absence.

AB 1396 - Chapter 775 Bear Requires all automobile liability insurance policies which contain a provision indicating that coverage is extended to accidents, occurring, and losses arising in Mexico, to contain a warning that the insurance policy may not be honored in Mexico and that the insured, before driving into Mexico should obtain insurance from a Mexican insurance company.

AB 1496 - Chapter 776 Bagley

Provides that the trustee of any trust shall not be required to set aside reserve or allowance from trust income for depreciation or depletion on any property held in such trust unless the instrument in which such trust was created requires such reserve or allowance. The bill also specifies that section applies both to trusts created before, and trusts created after, the effective date of section.

AB 1542 - Chapter 777 Brown

Deletes the requirement that the State Board of Education submit a copy of petition for formation of junior college to the Coordinating Council for Higher Education. The bill also deletes a requirement that the Coordinating Council submit report on proposal to State Board.

AB 1563 - Chapter 778 Ray Johnson

Changes from May 1 to March 15 the date by which a contract for the next school year may be presented to a teacher for acceptance or rejection. The bill also increases to 45 days (from 20 days) in which teachers who are not uner permanent tenure, after receiving notice of election or employment, must signify acceptance or be deemed to have declined the employment.

AB 1578 - Chapter 779 Bear

Revises provisions of the Code of Civil Procedure relating to the allocation of peremptory challenges of jurors in civil actions where there are more than two parties.

AB 1595 - Chapter 780 Shoemaker & Lagomarsino Authorizes a county sanitation district to provide street sweeping and cleaning services upon roads and streets within the boundaries of the district.

AB 1688 - Chapter 781 Lanterman Provides authority for advance payment of pro rata fiscal charges upon request of the Department of Finance. It will cause moneys which are now transferred to the General Fund only once a year to be transferred at least four times annually. Agencies will be paying for administrative services as they are received. This will help ease the General Fund's cash flow problems.

AB 1787 - Chapter 782 Stacey Corrects reference in a Business and Professions Code Section relating to pharmacy.

AB 1830 - Chapter 783 Ketchum Deletes the Agricultural Code provisions relating to foreign cold storage meat.

AB 1914 - Chapter 784 Zenovich

Deletes language in the Financial Code which permits the Savings and Loan Commissioner to utilize a sample appraisal as a basis of requiring a specific reserve against the entire portfolio of an institution.

AB 1945 - Chapter 785 Lanterman Specifies that certain penalty assessments, as well as various other assessments, shall not be effective for any purpose, until notice has been mailed to the assessee or the assessee has received a tax bill based on such assessment. The intent of the bill is to allow a complete hearing on all the issues relating to an escape or penal assessment at one hearing.

AB 2423 - Chapter 786 Lanterman Prohibits designation of particular state hospitals or facilities in court orders committing mentally ill or retarded persons to Department of Mental Hygiene for Placement. The bill requires Department to designate the Hospital or facility for care and treatment and notify clerk of superior court of the facility designated. The bill also prohibits the transfer of a mentally retarded person to a different hospital without consent of parent or guardian.

AB 2424 - Chapter 787 Lanterman Continues for two years the authority of the Department of Mental Hygiene to employ physicians from out of state who have not yet obtained their California license to practice medicine for a one-year period to work, if the department is unable to recruit physicians in California.

AB 2495 - Chapter 788 Brown Allows a person with specified requirements to take physician's and surgeon's oral examination and to receive a physician's and surgeon's certificate upon successful passage of such examination.

SB 594 - Chapter 789 Burns & Bagley Provides that the rights, with respect to any fund from which construction costs are to be paid, of all persons furnishing labor, services, equipment, ormaterials to a construction project are governed exclusively by the provisions of the Mechanics' Lien Law relating to "stop notices" unless contracted differently. The bill requires a preliminary notice to be given, by specified persons, to the "construction lender", before a notice to withhold construction funds is valid. Imposes notice requirements on certain persons under direct contract with owner. The bill also provides that the preliminary notice must be given within 20 days after the claimant provides his services, rather than at least 15 days prior to the expiration of the time within which a claim of lien may be filed.

Sacramento--Governor Ronald Reagan announced today he has signed the following bills:

JULY 18, 1967

AB 668 - Chapter 790 Knox

Makes a number of technical amendments to the Improvement Act of 1911 relating to municipal improvements. The bill also provides that a legislative body in proceeding under the Municipal Improvement Act of 1913 may apply surplus improvement funds as a credit to any governmental bodies or agencies which have contributed toward the costs and expenses of the improvement.

AB 1703 - Chapter 791 Knox

Provides that in the division of land and bond proceedings under the Improvement Act of 1911, the Improvement Bond Act of 1915, and also the Municipal Improvement Act of 1913, for the issuance of a separate bond issue for each condominium interest.

SB 1009 - Chapter 792 Grunsky & Bear

Provides for cancellation or refund of property taxes imposed for any fiscal year commencing in 1967 on property as to which the church exemption or the welfare exemption was available but unclaimed. The bill also provides for such cancellation or refund with respect to the cemetery exemption, but such provision has no force or effect after the lien date of 1968.

AB 1360 - Chapter 793 Knox Requires any person claiming the cemetery tax exemption to make a return of the property to the assessor annually. The bill provides for cancellation or refund of tax for any fiscal year beginning in 1967 for which the cemetery exemption was available, and makes such provision in cases where such property was acquired during the 1967 calendar year, but prior to the commencement of 1967-68 fiscal year.

SB 307 - Chapter 794 Wedworth

Authorizes the city attorney of any general law or chartered city to prosecute any mis-demeanor committed within the city which arises out of a violation of a state law. Consent of the district attorney of the county would be required before the city could exercise this authority.

SB 393 - Chapter 795 Cologne, Dills, Sherman Authorizes the State Department of Education to purchase insurance for motor vehicles used in automobile driver training courses at the California Schools for the Deaf.

SB 394 - Chapter 796 Marler & Lagomarsino & Davis Expands the types of service which may be rendered by retired teachers to include remedial instruction, home teaching and hospital teaching. The bill also deletes the 90 teaching day limitation on this employment during one fiscal year and increases the annual compensation earnable for such service by a retired teacher from \$1800 to \$2500.

SB 481 - Chapter 797 Dills

Permits municipal court minutes to be destroyed after 10 years instead of being retained indefinitely.

SB 558 - Chapter 798 Cologne & Schmitz

Authorizes the Department of Fish and Game to review and coordinate fish and wildlife enhancement development at federal projects with state plans, regardless of state participation in the recreation features of the project. The bill postpones determination by Resources Agency of statewide importance of recreation features of federal project and local agency cooperation until after Resources Agency issues letter of intent to participate in such project. The bill also requires that Resources Agency comments on local agency participation be included in report to Governor and Legislature.

SB 580 - Chapter 799 Grunsky

Adds or amends numerous sections of Commercial Code, conforming language of portions of the code to the Uniform Commercial Code.

SB 1001 - Chapter 800 Sherman Allows the board of supervisors of any county in which only one tax appeals board has been established to appoint an alternate member to the appeals board who may replace a member temporarily unable to act as such.

SB 1005 - Chapter 801 Carrell

Defines unregistered vehicles used or operated by manufacturers and which are later sold to the public as used vehicles. It will put these vehicles in the same category as the demonstrators used by a dealer so that they will not be sold or represented to the buying public as new vehicles. The bill also clarifies the tax status of these vehicles when they are formally registered with the Department of Motor Vehicles.

SB 1006 - Chapter 802 McCarthy

Requires the election of successors to judges of municipal and justice courts who become such because the municipal and justice courts replaced the courts to which they were elected to be held at the same time and under the same qualifications as set for the election of a successor in original courts.

SB 1062 - Chapter 803 McCarthy

Makes it possible for the San Quentin cotton textile mill to keep up with technological progress by permitting the mixing of synthetic fibers with cotton in its textile production.

SB 1070 - Chapter 804 Grunsky

Increases the number of, and salary of, various attaches of the Monterey-Carmel Municipal Court.

SB 1074 - Chapter 805 Grunsky

Deletes ineffective provisions of the Education Code. The bill makes no substantive changes.

SB 1099 - Chapter 806 Short Provides that, for retirement purposes, salaries of superior court official reporters in San Joaquin County shall include the total of all per diem and transcription fees paid to all of the superior court reporters, divided by the number of superior court official reporters provided that such amount shall not exceed \$600 per month.

SB 1196 - Chapter 807 Lagomarsino Makes a number of amendments to the Produce Dealers and Processors Law. The changes in the Processors Act clarify bond coverage and cancellation features; revises the hearing of complaint sections; strengthens accounting procedures to producers and in general clarifies the language of the Act. The changes in the Produce Dealers Act are aimed at clarifying licensing procedures; revising the definition of a "Dealer" and establishing a maximum schedule of commissions not to exceed 20 percent of the gross sale price of the farm product.

SB 1225 - Chapter 808 Stiern & Way & Stacey

Clarifies and enlarges the power of a county committee on school district organization to provide for changing the number of members of a junior college district governing board and to establish, rearrange, or abolish trustee areas in such districts.

SB 1331 - Chapter 809 Carrell

Extends to premises leased by a county the same privileges with respect to the issuance of a liquor license as are now extended to the premises owned by a county.

SB 1472 - Chapter 810 Sherman

Permits the Alameda County Board of Supervisors to appoint the clerk of the board in the same manner as other officers.

AB 328 - Chapter 811 Knox

Includes industrial engineering among branches of engineering for which registration may be obtained from the Board of Registration for Civil and Professional Engineers. The bill also provides that persons licensed under the Civil and Professional Engineers Act may use the titles consulting engineer or registered engineer, as well as the title professional engineer.

AB 432 - Chapter 812 Bill Greene & Brathwaite Permits a city or county board of education to issue a temporary child care permit, good for 90 school days, to a person who has applied for a regular state permit and who files an affidavit that he knows of no reason why it will not be issued.

AB 585 - Chapter 813 Bear Makes the work furlough law applicable to inebriates or habitforming drug addicts who are committed to county jail branch, industrial farm, or industrial road camp.

AB 752 - Chapter 814 Collier & Stull

Extends the provisions of the Code of Ethics to all appointive State Officers.

AB 811 - Chapter 815 Fenton Provides that the amount recoverable by the buyer for property traded in when a conditional sales contract, for motor vehicles is rendered unenforceable because the seller violated specified provisions of the Civil Code, shall be equal to either the agreed cash value as it appears on the conditional sales contract or the fair market value of such property at the time the contract is made, whichever is greater.

AB 824 - Chapter 816 Knox & Dent Provides uniform procedures to be followed in any case in which a person arrested for a misdemeanor does not demand to be taken before a magistrate. Present law provides separate procedures for misdemeanor violations of ordinances and misdemeanor violations of state law. The bill authorizes peace officers to use the specified written notice to appear procedures for any misdemeanor offense in which the officer has arrested or taken custody of a person pursuant to specified provisions of the law. The bill also makes provision for use of notice to appear as complaint to which defendant may plead "not guilty" as well as guilty.

AB 1228 - Chapter 817 Meyers, Milias Provides for one maximum \$6 state contribution toward the cost of health benefits plan under the Meyers-Geddes State Employees! Medical and Hospital Care Act even though more than one survivor of the same employee or annuitant is authorized to participate.

AB 1358 - Chapter 818 Knox Changes the lien date for property tax purposes from noon on the first Monday in March of each year to 12:01 a.m. on the first day of March of each year, effective January 1, 1968. The bill also provides that the fact that a person reports his property as of the first day in March as being his property as of the first Monday in March is not in and of itself evidence of intent to avoid taxation.

AB 1422 - Chapter 819 Schabarum Requires the abstract of court record sent to the Department of Motor Vehicles to clearly indicate that charges against an employee were dismissed and the owner of vehicle found guilty, if such be the case.

AB 1468 - Chapter 820 Beletti Repeals an obsolete provision of the Government Code. The bill makes no substantive change.

AB 1500 - Chapter 821 Stacey Corrects cross-references in the Business and Professions Code provision concerning the sale of drugs.

AB 1540 - Chapter 822 Zenovich Requires the board of supervisors of Fresno County, upon request of the Pinedale County Water District, to levy a bond tax with respect to land only in Districts, Improvement District No. 2.

AB 1558 - Chapter 823 MacDonald & Lagomarsino

Makes the Elections Code provisions relating to ballot arguments for county measures applicable to any district bond election, except certain school district or district bond elections.

AB 1568 - Chapter 824 Duffy

Increases the salary of the Kings County District Attorney. The bill increases the salary from \$13,000 to \$16,000.

AB 1791 - Chapter 825 Harvey Johnson Makes the costs of commitment proceedings for nonindigent mentally ill and mentally deficient persons the obligation of the person, the guardian of his estate, or persons legally liable for his maintenance, rather than his estate or persons legally liable for his maintenance.

AB 1882 - Chapter 826 Dent

Permits a school board to increase salaries of its classified positions at any time during a school year if the position or positions are being increased as a result of a reclassification approved by the board.

AB 1973 - Chapter 827 McGee

Provides that court must require the probation officer to investigate when a petition for guardianship is filed for a minor two years of age or under and where the petitioner is not a relative of the minor.

AB 1974 - Chapter 828 McGee

Repeals the provision authorizing the Department of Fish and Game, under regulations of Fish and Game Commission, to pay bounty on crows and black-billed magpies.

AB 2120 - Chapter 829 Stacey Authorizes water storage districts to issue authorized bond issues in series and fix different maturity dates for each series. It specifies that bonds of any series shall be of equal security with bonds of other series of same issue. The bill also provides that the report to the California Districts Securities Commission shall include in detail, the amounts to be provided out of bond funds for the establishment of a bond reserve fund and for payment of interest on bonds during the construction project.

AB 2152 - Chapter 830 Bear

Provides for court-ordered release of habitforming drug addicts and inebriates from an industrial farm or road camp on recommendation of the county medical director and subject to the supervision of the director of such farm or camp.

AB 2227 - Chapter 831 Powers

Authorizes public improvement assessments levied on assessable public property to be sold for cash to the highest bidder and prescribes the rights of the purchasers.

AB 2388 - Chapter 832 Veneman

Clarifies existing law with respect to the leasing provisions of the Sales and Use tax Law, which were enacted in 1965. It provides an exemption from the tax on leases only during the time for which the lessor is obligated to lease property for an amount fixed by the lease prior to August 1, 1965. The bill also provides that the lessor shall be deemed not to be obligated for any period of time for which he has the unconditional right to terminate the lease upon notice, whether the right is exercised or not.

AB 2528 - Chapter 833 Stacey Declares that during the pendency of an action to adjudicate substantially all water rights in a ground water basin situated in whole or in part in the Tehachapi-Cummings County Water District in Kern County, the failure by any owner of water rights therein to extract therefrom the full quantity of water which he ultimately is judicially determined to have rights to, shall not result in the loss of such unused portion.

Governor Ronald Reagan announced today he has signed legislation which will relieve California homeowners of a "double jeopardy" threat which has hung over them for years.

The measure was SB 594, was co-authored by Senator Richard J. Dolwig (R-San Mateo) and Assemblyman William Bagley (R-San Rafrael).

It adds certain provisions to California's Mechanics' Lien Law to enable homeowners to protect themselves from having to pay twice for the same services performed or for materials furnished in connection with home building or home improvements, such as swimming pool or room addition.

The new law makes it mandatory for both subcontractors and materialsmen to give the homeowner a notice that work has been done or materials furnished for a job. Such notice must be given within 20 days after first going on the job.

Thus, if the homeowner does not pay any bills presented until the expiration of the 20-day period, he can pay his contractor with assurance that no lien will be filed to force him to pay for the same work twice.

Failure to provide the notice prevents the subcontractor or materialman from filing a claim against the property owner.

Prior to passage of the new law, a homeowner would have actually paid his contractor for a job. However, if the contractor failed to pay the subcontractors or materialmen, both could come back at the homeowner and demand a second payment. The homeowner was in double jeopardy.

If he did not pay, he could lose his home. The new mandatory notice alerts the homeowner to the fact that certain subcontractors or or material dealers have been on the job and will be entitled to be paid.

He should then make certain that these bills are paid by the contractor before advancing the contractor money for work already done, or he can pay the subcontractor or material dealer direct and deduct the amount of such payment from that due the contractor.

The legislation was supported by the California Savings and Loan League, the California Bankers and Mortgage Bankers, the Home Builders Council, the California Land Title Assn. and building material dealers and subcontractos associations.

Members of these groups who are involved in construction and its financing will also benefit from this legislation, since a copy of the preliminary notice to property owners also goes to contractors and lenders.

Thus, there should be less controversy in the future about the payment for work done or materials furnished to a job.

To the extent that persons get paid for materials supplied or services performed, and to the extent that liens are not filed which jeopardize the interests of owners and lenders, this legislation will provide a good climate for the construction and financing businesses in California, the Governor said.

July 19, 1967

SB 137 - Chapter 834 Mills

Permits the use of the same jury panel in both the superior court or municipal courts in Los Angeles or San Diego Counties, when authorized by local superior court rule and pursuant to duly adopted municipal court rule.

SB 193 - Chapter 835 Cologne

Empowers the public guardian, upon the death of his ward or conservatee, to use certain personal assets of the decedent to pay for the burial expenses and the expenses of the last illness upon court order, if it appears that the total market value of the estate is less than \$1,000.

SB 233 - Chapter 836 Schrade Allows the filling of abandoned excavations as an alternative to the presently authorized methods of covering and fencing. Under various sections of the Health and Safety Code and Government Code a Board of Supervisors may securely cover or fence abandoned mining shafts, pits, water wells, cesspools, or other abandoned excavations dangerous to the public.

SB 290 - Chapter 837 Cologne

Provides that a county recorder is liable in the amount of three times the amount of damages occasioned by specified instances of neglect of or refusal to perform duties of office, if the neglect or refusal to perform was willful and malicious or if he acquired some personal financial benefit.

SB 662 - Chapter 838 Danielson

Extends liability for violations of public utility law or regulation to individuals who are not public utilities in addition to corporations who are not public utilities. The bill also extends the scope of the offense to include aiding and abetting a violation of public utility law, orders of the Public Utilities Commission, or the California Constitution.

SB 682 - Chapter 839 Lagomarsino & MacDonald

Specifies that members of appointed board of directors of a county waterworks district shall continue to serve at pleasure of county board of supervisors rather than for terms for which they were appointed.

SB 858 - Chapter 840 Marler

Authorizes the Fish and Game Commission to prescribe regulations which in turn will authorize the Department of Fish and Game to issue pheasant club licenses, including an investigation to the satisfaction of the department, rather than the commission, that the tract of land is suitable for such purposes and that the club will not conflict with the public interest.

SB 978 - Chapter 841 Sherman Amends the Code of Civil Procedure to provide that one may answer an interrogatory by merely specifying and making available his business records if the answer requires information which can only be obtained from an audit, compilation or summary of such records, and where such are non-existent or unavailable to the party to whom the interrogatory is addressed.

SB 1017 - Chapter 842 Lagomarsino

Makes technical amendments to the Harbors and Navigation Code. The bill makes no substantive changes.

SB 1063 - Chapter 843 Sherman

Amends the Corporations Code to allow a corporate director to rely upon a financial statement certified by a certified public accountant as well as upon one certified by a public accountant.

SB 1076 - Chapter 844 Grunsky Authorizes a court (except in cases where the decree or judgment is based upon an integrated property settlement agreement) upon petition by the husband or former husband to modify or revoke a decree or judgment awarding support allowance to a wife who is living with another man and holding herself out as the wife of such man, although she is not married to him.

SB 1142 - Chapter 845 Deukmejian Requires that a new birth certificate be issued when a child is adopted by an unmarried man or woman to reflect the fact that it is a single-parent adoption if the adopting parent so requests.

SB 1286 - Chapter 846 Marler Makes it a misdemeanor to operator a powerboat in excess of 5 miles per hour within 200 feet of any way or landing float which is being used, rather than which is used, for the embarkation or discharge of passengers.

SB 1336 - Chapter 847 Cologne

Authorizes the Department of Water Resources, upon compliance with all other requirements of the Davis-Grunsky Act in effect on the date of such grant, to grant to the San Bernardino Valley Municipal Water District an amount not to exceed \$2,354,120 for recreation and fish and wildlife enhancement in connection with the construction of the Yucaipa Project.

SB 1441 - Chapter 848 Danielson

Excludes pesticides, dog repellents, and other substances not intended to be used to produce discomfort or injury to human beings from definition of tear gas for the purposes of the law regulating tear gas weapons.

SB 1445 - Chapter 849 Danielson

Revises the number of, salary schedule of, and various rules pertaining to, attaches of the Municipal Court of Los Angeles County.

SB 1457 - Chapter 850 Lagomarsino & Shoemaker

Authorizes the court with respect to defendants sentenced to be imprisoned in the state prison who have been committed to the custody of the Director of Corrections if it is deemed warranted by the diagnostic study and recommendations approved by the director, to recall the sentence, as well as the commitment, previously ordered and resentence the defendant in the same manner as if he had not previously been sentenced.

AB 351 - Chapter 851 Hinckley

Provides that with certain exceptions no air-craft insurance policy shall exclude coverage because aircraft is operated in violation of federal or civil air regulations, or any state law or local ordinance. The bill does not prohibit specific exclusions in policies relating to certification of the pilot or air-craft, pilot experience, limiting use of air-craft and crop dusting.

SB 256 - Chapter 852 Collier & Carrell

Creates an Airport Land Use Commission in each of the 25 counties currently served by a commercial air carrier. If the board of supervisors and the selection committee (made up of all the mayors of all the cities in the county) make a determination that adequate land use review provisions exist, the Commission would not be created.

SB 488 - Chapter 853 Short Provides that "resignation" as used in the retirement for service provisions of the Judges' Retirement Law does not apply to implied or express resignations for the purpose of accepting an elective or appointive public office, rather than having this exception only apply to such resignations occurring prior to January 1, 1948 and only with reference to certain repayments of contributions withdrawn prior to September 9, 1953.

SB 564 - Chapter 854 Schrade, McAteer, Burton, Britschgi Increases the membership of the Advisory Commission on Status of Women from 15 to 17, one additional public member to be appointed by the Senate Committee on Rules, and one by the Speaker of the Assembly.

SB 1000 - Chapter 855 Sherman Prohibits any person engaging in the rental of utility trailers or trailer coaches, for periods of 30 days or less, from renting, leasing, or otherwise allowing the operation of any such trailers unless all necessary equipment required by the Vehicle Code and regulations adopted for the operation of such vehicles in combination have been provided or offered to the lessee for his use.

SB 1096 - Chapter 856 Short Exempts from definition of "subdivision" for purpose of Subdivision Map Act, any real property upon which apartments are rented, financed, or leased, rather exempting just-leased apartments.

SB 1512 - Chapter 857 Short Amends the Civil Code provisions relating to the contents of a petition to do business as a sole trader.

AB 360 - Chapter 858 Warren

Amends the provisions of the Collection Agency Act relating to the registration of collection agency employees, receivership actions and the audit report requirements.

AB 387 - Chapter 859 Veysey Exempts implements of husbandry from requirement to be equipped with turn signal lamp when the body or load extends 24 inches or more to the left of the center of the steering wheel.

AB 802 - Chapter 860 Lanterman Provides that wine shall have the same credit treatment as distilled spirits and beer.

AB 868 - Chapter 861 Ryan Extends provisions permitting retired members of the State Employees' Retirement System to be employed on the academic staff of a state college to include employment on the academic staff of the University of California. The bill increases the maximum amount which may be earned in such employment from \$2,000 to \$3,000 per fiscal year.

AB 1010 - Chapter 802 Bear

Increases the minimum amounts of automobile liability insurance or bond required to establish financial responsibility for bodily injury or death of one person in any one accident from \$10,000 to \$15,000 and for bodily injury or death of two or more persons in any one accident from \$20,000 to \$30,000. The bill makes corresponding changes in the minimum amounts of automobile liability insurance required to be provided under the assigned risk plan and in the amounts of coverage required against an uninsured motorist.

AB 1066 - Chapter 863 Gonsalves

Provides that under specified conditions, that personal property on consignment shall be assessed either to the consignee or to the consignor, or to both.

AB 1159 - Chapter 864 Crown

Adds salary ranges to the salary schedule for attaches of municipal courts in Alameda County. The bill also increases salaries of clerks and deputy clerks and revises the number of deputy clerks.

AB 1214 - Chapter 865 Brathwaite, Chappie

Permits the commitment of minor made ward of court to juvenile hall, if there is no county juvenile home, ranch, camp or forestry camp within the county.

AB 1242 - Chapter 866 Knox

Deletes provision requiring counties having a population of less than 5 million to contract directly with the newspaper publishing any list or notice required by the Revenue and Taxation Code. The bill also deletes provision that such contracts are not assignable.

AB 1275 - Chapter 867 Harvey Johnson

Provides that female, when she is the sole shareholder, or when she and her husband are the sole shareholders of an on-sale licensee corporation can dispense or mix wine or distilled spirits on the premises for which corporation holds an on-sale license.

AB 1370 - Chapter 868 Vasconcellos

Increases the number of, and salaries of, various court attaches of certain municipal and superior courts in Santa Clara County.

AB 1405 - Chapter 869 Belotti Changes number of and increases salary schedule for, municipal court attaches of the Eureka Judicial District.

AB 1424 - Chapter 870 Dent & Knox Provides that a county surveyor appointed by the board of supervisors shall serve at the pleasure of the board.

AB 1460 - Chapter 871 Chappie Increases the salaries of members of the Board of Supervisors and Auditors of Nevada County. The Auditor's salary is raised from \$8640 to \$9840. Board members will receive \$6000 instead of \$4500.

AB 1575 - Chapter 872 Bear Deletes the Chairman of the Industrial Accident Commission from a list of state officers receiving \$500 annually in addition to annual salary.

AB 1701 - Chapter 873 Gonsalves & Porter Authorizes the district board of a county sanitation district to fix compensation for each meeting attended not to exceed \$50 rather than \$25 and not to exceed \$100 in any one month, rather than \$50.

AB 1754 - Chapter 874 Monagan

Authorizes school district governing boards, at district expense, to conduct achievement tests printed in the Initial Teaching Alphabet for pupits accustomed to learning in that alphabet in lieu of uniform achievement tests.

AB 1794 - Chapter 875 Provides for four-year terms for all members Cullen of the Southern California Rapid Transit District. It deletes the provision which requires an objecting city or county to pay increased cost of rerouting or redesigning of District facilities. The bill also requires that copies of resolutions appointing members to the city collection committee to be forwarded only to the district secretary rather than to the district secretary and the Secretary of State.

AB 1839 - Chapter 876 Powers

Authorizes a person who manufactures or produces beer outside of this state, but with-in the United States, in accordance with the requirements of the law of the United States to transport such beer into this state provided there is conformity with enumerated requirements.

AB 1954 - Chapter 877 Dunlap

Prohibits charging of filing fees for any action to declare a minor free from the custody and control of either or both of his parents in cases involving parental abandonment, neglect or cruelty.

AB 1976 - Chapter 878 McGse

Permits deduction of money held by a parent for his minor child as custodial property or money subject to court order in determining the total estate of a minor for purposes of allowing the parent to hold the money belonging to the minor.

AB 1991 - Chapter 879 Extends to private and parochial schools and all nursery schools essentially the same requirements as now exist in public schools for periodic employee examinations for communicable tuberculosis. It also requires such an examination of volunteers in such schools.

AB 2015 - Chapter 880 Veneman

Requires security held by the Board of Equalization to be used as a payment on account of any liability of the taxpayer to the Board when any such person ceases to be a user or vendor under the use fuel tax provisions or an operator under the motor vehicle transportation license tax provisions.

AB 2018 - Chapter 881 Veneman

Provides with respect to the Sales and Use Tax, the Motor Vehicle Fuel License Tax Law, the Use Fuel Tax, the Motor Vehicle Transportation License Tax Law, the Cigarette Tax Law, and the Alcoholic Beverage Tax Law, that every petition for redetermination of amount of such taxes shall be in writing and shall state the grounds for such redetermination, and such petition may be amended to state additional grounds before any decision is made on the matter.

AB 2020 - Chapter 882 Veneman

Requires an application made by a city or county for review of an assessment made outside the regular period for such assessments to be filed with the Board of Equalization within two weeks from the date the tax bill is mailed to the assessee.

AB 2026 - Chapter 883 Veneman

Validates certain acts of taxing agencies and revenue districts or their officers relative to determing or fixing the budget or tax rates, equalization of property, or tax sales.

AB 2033 - Chapter 884 Wilson	Allows a counselor of conciliation upon order of the conciliation court judge to destroy any record, paper or document filed or kept in his office which is more than two years old and authorizes judge to order the microfilming of any such material. The bill also prohibits destruction of such records, papers, or documents until 30 days after notice thereof has been sent to the attorneys of record, or the parties themselves if they have no attorney of record.
AB 2087 - Chapter 885 Meyers	Permits an application for a disability retire- ment to be made while the member is on an approved leave of absence.
AB 2149 - Chapter 886 Barnes	Provides that a member of the State Teachers' Retirement system shall not receive credit in the system for more than four years of military service rendered after July 1, 1968.
AB 2160 - Chapter 887 Belotti	Permits local hospital districts to file required documents on or before April 10, 1967, instead of on or before January 1, 1967, for purposes of levying district taxes for the 1967-1968 fiscal year.
AB 2215 - Chapter 888 Chappie	Forbids a board of supervisors from levying the special airport tax in counties in which all or part of an airport district formed pursuant to the California Airport District Act is situated.
AB 2209 - Chapter 889 Chappie	Provides that the Department of Alcoholic Beverage Control may issue one additional onsale general and one additional off-sale general license in Alpine County. The licenses issued pursuant to this bill shall not be transferred out of the county.
AB 2244 - Chapter 890 Biddle	Increases the annual salary of the District Attorney of Riverside County. The salary is increased from \$19,500 to \$23,000.
AB 2269 - Chapter 891 Mobley	Allows the awarding authority of a public work of improvement to delegate to an officer or employee of their choosing the authority to declare the work completed and file for record a notice setting forth the date of completion.
AB 2326 - Chapter 892 Monagan	Increases retirement allowances and optional death benefits for persons retired under the County Employees' Retirement Law of 1937.
AB 2377 - Chapter 893 McMillan	Prevents an employee of local agency from acquiring any right to preferential treatment upon sale or lease of real property of the local agency which the employee has occupied or used.
AB 2385 - Chapter 894 Veneman	Makes several procedural changes in the procedures for publishing delinquent lists, selling and deeding property to the state. The principal amendment made by the bill changes the date for publishing the delinquent lists from June 8 to September 8.

Deletes the mandatory requirement that aircraft owners file an annual property statement. The bill provides instead that such statements AB 2386 - Chapter 895 Veneman shall be filed on request of the assessor.

AB 2590 - Chapter 896 Amends the Uniform Limited Partnership Act to allow the admission of new or substituted Russell limited partners by the execution of an amendment to the certificate by the general partner and the new or substituted limited partner, if the partnership has 25 or more limited partners and its certificate so provide

SB 426 - Chapter 897 Coombs & Way

Amends the Agricultural Code to make it clear that the Department of Agriculture has authority to control insects or other carriers of disease that may be associated with rodents.

SB 575 - Chapter 898 Miller

Amends the Check Seller and Cashers Law to clarify definition of "prorater", and to modify fees charged by proraters by eliminating default and termination charges upon obligations secured by real estate and specified recurring obligations.

SB 605 - Chapter 899 Stevens & Marler

Includes solicitation of insurance adjusting business within definition of activities for which insurance adjuster's license is required under Private Investigator and Adjuster Act.

SB 778 - Chapter 900 Beilenson

Amends the Rees-Levering Act to make unenforceable any agreement between a buyer and seller in connection with the sale of a motor vehicle which provides for the inclusion of title to or a lien upon any personal or real property, other than the motor vehicle which is the subject matter of the sale, or accessories therefor or special and auziliary equipment used in connection therewith, as security for payment of the contract balance.

SB 1128 - Chapter 901 Corrects an obsolete reference in the Education Code to the Department of Finance. Rodda

SB 1207 - Chapter 902 Validates certain final apportionments of state school building aid based on conditional apportionments made prior to the 91st day after final adjournment of the 1967, rather than the 1965 Regular Session of the Legislature.

SB 1208 - Chapter 903 Permits an affidavit of the parent, guardian, or custodian to verify a child's age for the purposes of admission to kindergarten or first grade only when neither a certified copy of a birth record, a statement by the local registrar or county recorder, a baptism certificate, nor a passport is available.

AB 44 - Chapter 904 Lanterman

Validates organization, boundaries, acts, proceedings, and bonds of counties, cities, and specified districts, agencies and entities.

AB 267 - Chapter 905 Chappie

Clarifies the emergency powers of health officers in the event of the disaster.

AB 1005 - Chapter 906 Permits the governing body of a city or county, Chappie within the reasonable exercise of the police power, to enact ordinances imposing regulations equal or greater than those imposed by state law regulating motel and motor court signs.

AB 1156 - Chapter 907 Increases the salaries of the clerk, deputy clerks, Veneman marshal, and deputy marshals of the Modesto Municipal Court.

AB 1238 - Chapter 908 Deletes an obsolete provision which requires that survey reports by the State Board of Equalization of counties as to the procedures and practices of the county assessors in their valuation of property include a showing of the nature and extent of the counties taxable resources.

AB 1233 - Chapter 903 The bill provides for proportionate tax rate increase above the statutory maximum tax rate for a city which availed itself of county tax assessment and collection, where the total assessed valuation of property within the city is reduced by county officials from the total assessed valuation of property within the city used in the immediately preceding fiscal year. The bill also provides that certain statements and maps, which are required to be filed with the State Board of Equalization, will be filed with the Board's office in Sacramento.

AB 2299 - Chapter 909 Authorizes the board of directors of a municipal Mulford utility district to fix the rates of contribution by officers and employees of the district who are members of the district's retirement system. The rates would be based on tables and assumptions adopted by the board.

SB 80 - Chapter 910 Rodda

Creates the Brannan-Andrus Levee Maintenance District, incorporating all land within Reclamation Districts Nos. 317, 407 and 2067.

AB 87 - Chapter 911 Leroy Greene Establishes restricted credentials for teachers serving as speech and hearing specialists and teachers serving as speech and hearing specialists and teachers of handicapped minors without speech and hearing defects. The bill also makes technical changes in the Education Code provisions relating to special credential to teach severely mentally retarded minors.

AB 774 - Chapter 912 Bee Provides that a person who has been a member of the State Teachers' Retirement System for 30 years and who accepts an exempt position in the legislative or executive branch of state government remains a member of the system while he occupies such exempt position unless he elects not to be a member by a writing filed with the Retirement Board within 90 days after employment in such exempt position.

AB 777 - Chapter 913 Miller & Wilson Authorizes school districts to pay travel expenses of applicants coming to the district by request for an employment interview and examination.

AB 778 - Chapter 914 Miller & Crandall Authorizes school districts to use unpaid volunteers to assist teachers. The volunteers may be included in the district's insurance and workmans compensation coverage. The bill prohibits school districts from abolishing any classified positions and utilizing volunteer aides in lieu of laid off classified employees.

AB 1053 - Chapter 915 Foran

Permits the opening of construction bids at the direction of the Board of State Harbor Commissioners for San Francisco Harbor rather than requiring the board to open the bids.

AB 1375 - Chapter 916 Dunlap & Mobley Makes clarifying amendments relating to the use of county enterprise funds. It clarifies the use of equipment replacement reserve in a county budget with respect to the amounts which may be accumulated. The bill also specifies the requirements for inclusion of working capital and enterprise in the county budget document.

AB 1427 - Chapter 917 Bear & Wilson Provides for the establishment of judicial secretary positions in the San Diego Municipal Court.

AB 1431 - Chapter 918 Bagley

AB 1546 - Chapter 919 Lanterman Establishes colors for State Seal when it appears in color.

AB 1620 - Chapter 920 Knox & MacDonald Revises provisions of barious codes dealing with local agency formation commissions, district reorganizations, county service areas, and incorporation of and annexations to cities, including definition of terms, jurisdiction of local agency formation commissions, and procedures relating to change of district organization.

AB 1825 - Chapter 921 Bee Provides for sabbatical leaves of absence for one-quarter periods.

AB 1924 - Chapter 922 Z'berg & Ray Johnson, Marler

Sets compensation for superior court reporters in Yolo county at \$50 per day.

AB 1989 - Chapter 923 Moorhead Enables guardians to lease real property belonging to their wards without court order when the rental does not exceed \$250 per month and the term does not exceed one year, or, regardless of the amount of the rental, when the lease is from month to month.

AB 1993 - Chapter 924 Fong

Makes several technical, nonsubstantive changes in the Personal Income Tax Law.

AB 2013 - Chapter 925 Veneman Relieves a taxpayer from penalties for failure to prepay sales tax on time the failure was due to reasonable cause.

AB 2191 - Chapter 926 Z'berg

Permits a municipal utility district to invest surplus funds in obligations issued by certain specific bodies, certain banker's acceptances, and in securities in which savings banks may legally invest their funds in addition to the presently permitted investments.

Sacramento--Governor Ronald Reagan said today he signed assembly bill 910, the gonsalves milk pooling act, "with reluctance."

However, Reagan, who signed the bill Thursday said indications were that rmost of the state's milk industry either wanted it or was not opposed to it.

He pointed out that the bill has a referendum feature that will allow milk producers to vote as to whether they want it to go into effect.

"If the dairy people want it we will make every effort to see that it is administered in the spirit of our free enterprise system," Reagan said.

He added that the act represents a compromise of several proposals and demonstrates the willingness of California's dairymen to work together to solve their problems. This is the first time that this type of legislation has been passed by our Legislature.

"Its effect on the operations of California's important milk industry cannot now be fully estimated. I have discussed this legislation with the Director of Agriculture, and he has assured me that the purpose of the milk pooling plan, which he is required by the legislation to develop, will be to ultimately provide equity in the returns to our California dairymen for the milk they produce, thereby maintaining an adequate supply of milk for consumers at fair and reasonable pri ces.

"He and I recognize that any legislation that attempts to regulate an industry as varied, involved and complex as California's milk industry will require constant surveillance, and very likely twill require modification as experience with it unfolds.

"I have signed AB 910 in the hope that it will prove beneficial to milk producers, distributors and consumers," the governor said.

AB 650 - Chapter 957 Thomas

Provides that one member of the Los Angeles Board of Harbor Commissioners, one member of the Board of Commissioners of the San Diego Unified Port District, one member of the Board of Directors of the Oxnard Harbor District, and one member of the Long Beach Board of Harbor Commissioners shall be members of the Southern California World Trade Center Authority.

AB 1108 - Chapter 958 McMillan

Allows licensed cosmetologists to work time to complete service reasonably expected to be completed within eight hours if such cosmetol-ogist receives compensating time off in the same week and the hours worked for that week do not exceed 48.

AB 1376 - Chapter 959 Miller & Fong

Provides with respect to counties under the County Employees' Retirement Law of 1937 which come under certain retirement allowance provisions of such law, that certain county employees having current and prior service pensions as of the month after the effective date of the bill shall receive an increase in such pensions to an amount which they would have received if the present retirement allowance provisions had been in effect at the time they retired.

AB 1591 - Chapter 960 Mulford

Prohibits the carrying of a loaded firearm on one's person or in a vehicle while in any public place or on any public street in a prohibited area of unincorporated territory, except for specified law enforcement officers, military personnel, bank guards and messengers, sportsmen, private investigators and patrol operators, and persons authorized to carry concealable weapons.

AB 1779 - Chapter 961 Chappie

Permits a city and a county to agree to adjust the percentages of fines and forfeitures which are to be transferred to the county upon con-viction or forfeiture of bail in any municipal or justice court in cases arising from arrests made by employees of the city.

AB 910 - Chapter 927 Gonsalves

Provides for the development of equalization milk pooling plan by the Director of Agriculture with the advice and assistance of a formulation committee, representative of all producers and areas to be included in such pooling plan. The bill directs the committee to make recommendations to the director for inclusion in the plan, and requires the director to include in the plan, the base and quotas for new fluid milk producers, the transfer of bases and quotas, and any and all other necessary matters. The bill also makes the operation of proposed plan subject to statewide referendum of producers. Provides for substantive amendment or termination of plan by statewide referendum of producers.

AB 1064 - Chapter 928 Gonsalves

Changes the filing date of petitions for assessments reduction and proportionate tax reduction or refund in counties of over four million to between third Monday in July and September 15 rather than between fourth Monday in September and fourth Monday in November.

AB 1698 - Chapter 929 Gonsalves

Authorizes the board of directors of a sanitation district, rather than the board of supervisors, to annex territory in any district which at the time of annexation is not performing similar services in the area proposed to be annexed. The directors must first find and determine that the additional territory will be benefited by annexation.

AB 2382 - Chapter 930 Shoemaker & Lagomarsino

Requires that names for trial jury list in Santa Barbara County be drawn from residents of supervisorial district within which the court sits for trial and adjacent supervisorial districts, except when the court orders a countywide drawing in interests of justice.

AB 2482 - Chapter 931 Moorhead

Makes it a misdemeanor for a person to will-fully and maliciously obstruct the free movement of any person on any street, sidewalk, or other public place or on or in any place open to the public.

SB 769 - Chapter 932 Way

Provides for the tax collector to use the same collection procedure for unpaid taxes on improvements constituting part of a water distribution system as used with respect to assessments on the unsecured roll if water distribution system assessments are unpaid. The bill also permits counties to have a redemption officer establish a procedure involving making a record of individual redemption and installment payments with respect to redemption of tax-sold property.

SB 770 - Chapter 933 Way

Authorizes a tax collector to file certificate with county recorder, without fee, for any county, when property taxes on any unsecured property are delinquent. This authorization is in addition to those provisions of law dealing with seizures of property and suits against the taxpayer.

AB 2045 - Chapter 949 Bagley Provides that a telegraphic copy of a warrant or abstract of a warrant may be sent by any other electronic devises as well as by telegraph or teletype. The bill also requires the abstract of the warrant if for a misdemeanor to state whether the warrant has been certified for night service.

AB 2046 - Chapter 950 Bagley

Allows the Governor to delegate authority to sign warrants of arrest issued pursuant to a demand for extradition.

AB 2053 - Chapter 951 Bagley

Gives local legislative body discretion to transfer unclaimed property to the local government purchasing and stores agency or other similar agency for sale to the public, as alternative to selling it at public auction.

AB 2060 - Chapter 952 Leroy Greene Changes requirement that State Architect have an inspector at state buildings during their entire construction to a requirement that an inspector be assigned to them during their construction.

AB 2257 - Chapter 953 Fong

Makes technical and clarifying changes in the Bank and Corporation and Tax Law. The bill makes no substantive changes.

AB 2358 - Chapter 954 Z'berg

Changes from 30 days to 45 days the time for boundary descriptions and maps required to be filed with the State Lands Commission when any tidelands or submerged lands are included within the boundaries of territory proposed to be annexed to a city.

AB 2435 - Chapter 955 Bagley & McCarthy Raises salaries of personnel of Marin County municipal courts.

AB 2444 - Chapter 956 Brathwaite

Authorizes governing board of a school, in its discretion, to provide information as to pupils in a research project or study conducted, sponsored, or approved by a college or educational research organization, provided no pupil will be identified in a resulting report.

SB 556 - Chapter 963 Duckmejian Revenue bill.

SB 1488 - Chapter 964 Coombs

Requires a certificate from the Franchise Tax Board in cases where assets having a value of \$5,000 are distributable from an estate to one or more nonresident beneficiaries, instead of requiring such a certificate if the value of the assets of an estate exceeds \$50,000 and any beneficiary is a nonresident. The bill also reduces by 25 percent the sales tax on material and fixtures obligated pursuant to an engineering construction project contract or a building construction contract entered into for a fixed price prior to August 1, 1967.

AB 1269 - Charter 966 Leroy Greene Extends for one year provisions of licensing under Certificated Personnel Law of 1961 dealing with issuance of credentials pursuant to laws in effect before 1964 to persons who were in preparation to qualify for the credentials in 1963 or were then teaching in a foreign country.

Governor Ronald Reagan announced today he has signed the following bills:

AUGUST 3, 1967

SB 389 - Chapter 967 McAteer

Provides specific provisions which may be included in insurance coverage for members of educational institution teams. It authorizes the Trustees of the California State Colleges and the Regents of the University of California to require student body organizations to be responsible for such medical and hospital expenses up to \$250 with a deductible clause in that amount. The bill requires governing board of a school district to provide such insurance to members of athletic teams who are financially unable to pay costs thereof. The bill also requires the Insurance Commissioner to study operation and affect of the school insurance program. \$6,000 is appropriated to conduct such a study.

SB 896 - Chapter 968 Sherman Permits school district governing boards to use school district funds for cash deposits, when required to guarantee payment for health plans purchased on credit for school district employees.

SB 910 - Chapter 969 Cusanovich Provides that a school district governing board having an average daily attendance of 400,000 or more may, in lieu of the declaration of intention to lease real property, publish notice three times in a newspaper of general circulation and provides for the contents of such notice.

SB 1004 - Chapter 970 Beilenson

Permits out-of-state attorneys to qualify for admission to practice law in California if the applicant demonstrates to the satisfaction of the examining committee that his experience and qualifications qualify him to take the bar examination.

SB 1011 - Chapter 971 Grunsky

Specifies that the notice of sale requirements in the Code of Civil Procedure, with respect to sale of property under power contained in a mortgage or deed of trust, is limited in application to sales of real property.

SB 1022 - Chapter 972 Whetmore

Restricts to ungranted tide and submerged lands and such other tide and submerged lands granted by the state, the lands from which the State Controller must apportion revenue derived from such lands to a city or county within whose boundaries such lands are located.

SB 1031 - Chapter 973 Cologne

Increases the size of Fish and Game Refuge 4D in the Santa Rosa Mountains of Riverside County from its present size of 110 square miles to approximately 170 square miles. This refuge is designed to protect bighorn sheep which are classed as fully protected mammals.

SB 1054 - Chapter 974 Way

Authorizes the issuance of temporary bar pilot's license for San Francisco, San Pablo, and Suisun Bays, until March 1, 1969. The bill raises the number of licenses that can be issued from 25 to 30.

SB 1107 - Chapter 975 Dymally Authorizes junior college districts to grant leaves of absence to academic employees after six years of service, but limits such leaves of absence to one for each six-year period.

SB 1183 - Chapter 976 Dolwig

Provides that the amount that a state bank may invest in the stock of foreign banks, in the stock of international banking corporations, and in foreign branches would be limited to 25 percent of the bank's capital and surplus. The bill sets substantially the same limits for state banks as presently exists for national banks.

SB 1310 - Chapter 977 Rodda

Restates the Insurance Code provisions relating to the filing of notices of appointment and termination of agents by insurance companies. The bill also clarifies the responsibilities of organizations sponsoring new agents.

SB 1377 - Chapter 978 Grunsky

Establishes the Santa Cruz Metropolitan Transit District and prescribes the purpose, organization, powers and duties of the district. The District may include incorporated and unincorporated territory within the County of Santa Cruz.

SB 1444 - Chapter 979 Danielson

Amends the Improvement Act of 1911 to permit local legislative bodies to make progress payments on combined capital improvement and assessment act projects to contractors.

AB 168 - Chapter 980 Leroy Greene Requires school districts to make specified annual reports to county superintendent of schools of handicapped children participating in special classes, schools and programs for handicapped children, as well as those for whom application for enrollment was made. The bill also requires county superintendent of schools to make similar annual report of such handicapped children to Superintendent of Public Instruction.

AB 336 - Chapter 981 Barnes Increases the mileage fee charged by the sheriff for the service or execution of process from 35 cents to 70 cents per mile, one way only.

AB 372 - Chapter 982 Belotti, L. Greene Provides that a person who would otherwise qualify for free hunting and fishing licenses as a disabled veteran may receive such licenses even though still a member of the armed forces.

AB 521 - Chapter 983 Roberti & Elliott Extends to teachers, vice principals, and principals immunity from criminal prosecution or penalties for the exercise during the performance of their duties, of that degree of physical control over a pupil reasonably necessary to maintain order, protect property, or protect the health and safety of pupils.

AB 554 - Chapter 984 Deddeh Prohibits a school district from decreasing the salary of certificated employees for failure to meet any district requirement that such employees complete additional educational units, course of study, or work in any college or university. School districts can still refuse to grant salary increases for failure to complete prescribed college courses.

AB 563 - Chapter 985 Moretti Establishes a \$1,000 limitation on a loan by a credit union to any person under 18 years of age, unless payment is guaranteed by a governmental agency, or the loan is secured by such person's investment in the credit union. The bill also provides that total loans by credit union to any one member, rather than amount of any single loan, may not exceed \$3,000 or 10 percent of paid-in and unimpaired capital, not to exceed \$10,000 plus the then unpledged shares.

AB 569 - Chapter 986 Veysey Permits school board members to attend the Department of Education in-service training workshops once every four years.

AB 589 - Chapter 987 Fong

Expands duties of school security patrols to include protection of school district personnel and pupils in or about school district premises.

AB 652 - Chapter 988 Milias

Provides that a State employee who is unable to continue his State employment because of permanent disability resulting from industrial injury will be paid in full for any remaining credits for sick leave, vacation, or overtime prior to being separated for retirement, leave of absence, or medical termination. The bill contains provisions to facilitate the return of the employee if he is physically able to come back to work at a later date.

AB 662 - Chapter 989 Milias Permits the sick leave account of a person formerly employed in a State position exempt from civil service to receive credit for accumulated but unused sick leave if he enters a civil service position within six months after separation from the noncivil service position.

AB 885 - Chapter 990 Bagley

Exempts New York dressed poultry from the Poultry Meat Inspection Law without any time limit. This exemption in the law has been continued for a two-year period at each legislative session since the enactment of the law in 1955. The bill permits the inspection and evisceration of any lot of New York dressed fowl, and the evisceration and inspection of the entire lot, if disease is indicated. The bill also authorizes the poultry meat class of "caponette" only when the bird is treated with a hormone approved by the Federal Food and Drug Administration.

AB 947 - Chapter 991 Deddeh Permits the Department of Motor Vehicles to exempt vehicles owned by a duly recognized foreign government or by an official representative thereof from specified vehicle fees.

AB 1147 - Chapter 992 Fenton

Authorizes a court to order the payment of reasonable fee, not exceeding 5 percent of the child support payments collected, when the order for child support is enforced by the district attorney. The fee may not be imposed by the court unless the board of supervisors authorizes such action. The bill authorizes the board of supervisors to designate any county officer to perform the services of the court trustee. Because the processing of these payments is strictly a financial and accounting procedure, it is better to transfer these functions to the auditor or other county fiscal officer so that the probation officer may devote more effort to his customary duties. The bill also authorizes the board of super-visors to impose a 2 percent fee to defray the cost of the court trustee in processing child support, alimony and restitution payments. The fee will relieve the general taxpayer of approximately 2/3rds of the cost of this service.

AB 1448 - Chapter 993 Ryan

Reduces from 90 to 60 days the period of time an abandoned vehicle, having an appraised value in excess of \$100, must be held in storage.

AB 1450 - Chapter 994 Ryan Permits assignments of savings accounts in insured savings and loan associations to satisfy the motor vehicle dealer bonding requirements.

AB 1476 - Chapter 995 Duffy, Stiern & Way Revises maturity standards for Thompson Seedless and Perlette grapes and maturity test procedures for group A grapes.

AB 1507 - Chapter 996 Thomas Authorizes the Fish and Game Commission to prohibit taking or possessing Pacific halibut in the same manner as taking or possessing Pacific halibut is prohibited by federal law or by regulations adopted by the International Pacific Halibut Commission.

AB 1614 - Chapter 997 Fong

Requires establishment of a property tax reduction fund, and requires county boards of supervisors to place into the fund new revenues from sources other than property taxation which are hereinafter specifically earmarked for this fund by the Legislature. The bill also provides that a county may use funds in the property tax reduction fund to reduce property tax rate in year in which moneys are deposited in the fund.

AB 1646 - Chapter 998 Chappie

Provides that counties and other agencies such as public districts and private utilities may apportion between them the costs of removing, repairing or relocating any facilities owned or to be owned by either party on the roads or other property of the other.

AB 1671 - Chapter 999 Z'berg

Permits the California Highway Commission to delegate, upon conditions deemed appropriate, to the Department of Public Works any ministerial or administrative power, duty, responsibility, or function of the Commission, including the authority over the select highway systems.

AB 1810 - Chapter 1000 Foran

Substitutes the Dapartment of Public Works for the Division of Highways for purposes of the Vehicle Code provision permitting maintenance employees to transport or arrange transportation of persons injured on highways to a doctor or hospital, if the person does not object, without liability therefor if ordinary care is exercised.

AB 1851 - Chapter 1001 Duffy Allows specified persons to receive copies of lists of contents of safe deposit boxes prepared by any county treasurer, bank, savings and loan association, or company conducting a safe deposit business, in addition to lists prepared by the controller.

AB 1879 - Chapter 1002 Mulford

Requires that all insurance contracts issued or delivered on or after July 1, 1972, in this state to state an inception hour of 12:01 am of the date the contract is dated, with the prescribed hour to be the standard time at the residence or principal place of business of the insured within the state unless a specific provision of the Insurance Code otherwise prescribes or permits.

AB 1908 - Chapter 1003 Miller Provides that deficiency judgments shall not be ordered where the prohibition against deficiency judgments in the Code of Civil Procedure, relating to purchase money mort-gages and trust deeds, or to property sold under power of sale contained in mortgages or deeds of trust, is applicable.

AB 1958 - Chapter 1004 Dunlap Amends the Land Conservation Act to broaden the definition of "prime agricultural land". It authorizes the Storie Index Rating as an alternative classification system for land which has not been mapped or classified under the Soil Conservation Service classification system now designated in the Act.

AB 1972 - Chapter 1005 McGee Provides that whenever a state agency is abolished or ceases to function, control and possession of assets, shall vest in Department of General Services, unless otherwise provided by law. The bill also provides that if state agency was entirely or substantially supported from a special fund, any money arising from the use or disposition of such assets shall be deposited in special fund or its successor.

AB 1996 - Chapter 1006 Fong

Allows a county superintendent of schools, with the approval of the county board of education, to make certain management and financial studies, to maintain educational exhibits at county fairs, and to make known to the citizens of the county the educational programs and activities of the school districts within his jurisdiction.

AB 2019 - Chapter 1007 Veneman Conforms the Insurance Tax Law to recent constitutional amendments, relating to the retaliatory tax and the home office deduction.

AB 2094 - Chapter 1008 Knox, Dent

Authorizes a regional park district to levy an additional tax of 5 cents per \$100 for fiscal years 1969-70 through 1974-75. The bill relates only to the east Bay regional Park District which administers 12 regional parks in Alameda and Contra Costa County.

AB 2114 - Chapter 1009 Ketchum Adds publicly owned vehicles operated by the University of California and California State College police departments as authorized emergency vehicles.

AB 2139 - Chapter 1010 Badham

Amends provisions of the Business and Professions Code relating to tank vehicle measuring devices for petroleum products. It provides for larger size pipes on metered discharged equipment used for measuring the quantities of products of different grades, brands, or trade names withdrawn from any compartment in the vehicle. The bill also repeals the requirement that gasoline advertising signs must use the same color or tint for all words, letters or figures.

AB 2155 - Chapter 1011 Belotti Authorizes county boards of supervisors to provide one official bond for a county officer performing duties of offices which are consolidated pursuant to law.

AB 2312 - Chapter 1012 Zenovich & Pattee

Exempts from the Special Assessment Investigation, Limitation and Majority Protest Act of 1931, proceedings for the construction of improvements undertaken for the safety of school pupils, farmworkers, or other workmen.

AB 2328 - Chapter 1013 Bagley

Allows a judge who is an ex officio or elected member of board of law library trustees to designate a member of the bar of the county to act for him as trustee.

AB 2408 - Chapter 1014 Vasconcellos

Permits the Department of Motor Vehicles after three, rather than five, years to terminate any action taken under the Financial Responsibility Law. The bill also permits after three, rather than five, years, a person unable to respond in damages to be relieved of the penalties thereof, if he can show proof of ability to respond in damages for the future.

AB 2539 - Chapter 1015 Shoemaker Provides that residence of husband is the residence of the wife with the exception that a woman resident of this state who marries a man employed temporarily in this state in the service of U. S. government, may elect to retain residency to qualify as a voter only until she becomes an elector in any other state or territory.

Sacramento -- Statement by Governor Ronald Reagan

"I have today vetoed SB No. 539, the so-called ARCOSS bill, which would have provided retirement benefits for out of state service for teachers who finish their teaching careers in California.

"I am sorry to have had to veto this bill because I recognize that many of these teachers get no retirement credit for their out of state teaching time and, as a result, are forced to live on retirement income that is less than the income received by teachers who spend their entire careers in California.

"During the campaign I expressed sympathy for their plight and I promised to see what could be done. And I am still hopeful that we can find a way to eventually remedy this situation.

"But SB No. 539 is not the way. Our best experts tell us that this will cost the state in the foreseeable future around \$800 million dollars. That kind of money is not available.

"Those legislators in both houses who voted for the ARCOSS bill approved a bill calling for increased spending, but they did not provide the money or even tell us where we could get it.

"I would urge those who introduced the bill and who voted for it to get together and work out a responsible bill and find a reasonable way to finance it.

"When they do that I will be glad to reconsider today's action.

"Until they do that, the people of California cannot be asked to take on the additional financial burden the ARCOSS bill would demand. This is especially true in light of the facts that they are already being asked to shoulder the heaviest tax load in the Nation and are also being faced with a 10% increase in their Federal income taxes."

THE OVERHAUL OF THE 106-YEAR-OLD ABORTION LAW WAS THE MOST

EMOTIONAL ISSUE FACED BY LEGISLATORS.

THE NEW LAW LEGALIZES ABORTIONS WHEN THE PREGNANCY THREATENS THE PHYSICAL OR MENTAL HEALTH OF THE MOTHER; IN CASES OF STATUTORY RAPE INVOLVING A GIRL UNDER 15; AND WHEN PREGNANCY RESULTED FROM FORCIBLE RAPE OR INCEST. IT GOES INTO EFFECT EARLY IN NOVEMBER.

THE PRESENT CALIFORNIA LAW--WHICH DATES BACK TO 1861--ALLOWS

ABORTION ONLY TO SAVE A MOTHER'S LIFE.

SEN. ANTHONY C. BEILENSON, D-BEVERLY HILLS, AUTHOR OF THE LIBERALIZATION BILL, DROPPED A PROVISION WHICH WOULD HAVE ALLOWED ABORTIONS WHEN THERE IS A PROBABILITY THE CHILD WOULD BE BORN MENTALLY OR PHYSICALLY DEFORMED. THE AMENDMENT WAS NEEDED TO MEET THE OBJECTIONS OF GOV. RONALD REAGAN.



CHAPTER____

An act to amend Section 291 of the Penal Code, relating to schoolteachers arrested for sex offenses.

The people of the State of California do enact as follows:

Section 1. Section 291 of the Penal Code is amended to read:

291. Every sheriff or chief of police, upon the arrest for any of the offenses enumerated in Section 290 of any person who is employed as a teacher in any of the public schools of this state, shall immediately give written notice of the arrest to the State Department of Education and to the superintendent of schools in the county wherein such person is employed. Upon receipt of such notice, the county superintendent of schools shall immediately notify the governing board of the school district employing such person. The sheriff or chief of police shall notify immediately the superintendent of schools in the school district employing such person by telephone.

Senate Bill No. -436 requires the sheriff or police chief to notify immediately by telephone the appropriate superintendent of schools as to the arrest of a schoolteacher for a sex offense.

The Education Code requires that a teacher arrested for a sex offense be removed from the classroom immediately. But the present procedure for notification of arrest, provided in the Penal Code, has created a problem of delays in the transmittal of written notices of arrest.

The Attorney General and Legislative Counsel have no constitutional or legal objections to approval.

The Board of Education of the Santa Ana Unified and Junior College Districts urges approval.

The Department of Education recommends approval.

Senator Schmitz, the author, requests approval.

Governor Ronald Reagan announced today he has signed the following bills:

SB 1393 Chapter 1016 Wedworth

Authorizes school districts to raise their maximum tax rates by an amount sufficient to recoup the loss in revenues incurred because of an erroneous reduction of their tax rates.

SB 179 Chapter 1017 Miller

Provides that when an expenditure for sanitary district project exceeds \$3,500 rather than \$2,500, it shall be contracted for and let to lowest responsible bidder after notice.

SB 180 - Chapter 1018 Miller Increases the maximum daily compensation of sanitary district board member for attendance at meetings from \$25 to \$40. The bill also increases maximum per month for such services from \$75 to \$120.

SB 181 - Chapter 1019 Miller Requires that the notice inviting bids for a sanitary district project be published in a newspaper of general circulation, circulated within the sanitary district, rather than to be published in a newspaper of general circulation printed and published in the district.

SB 235 - Chapter 1020 Grunsky Amends the Education Code to substitute hourly maximums for the present monetary maximums in employing readers for blind college students.

SB 288 - Chapter 1021 Cologne

Requires pupils of private elementary and secondary schools and of school districts to be immunized against measles (rubeola) in accordance with regulations of the Department of Public Health, prior to their first admission to school.

SB 502 - Chapter 1022 Grunsky Authorizes the merit system personnel commission of any school district or county superintendent of schools employing 100 or less classified employees, with the consent of a majority of such employees, to contract with local agencies for the services of a personnel director.

SB 538 - Chapter 1023 Whetmore

Makes it a felony for any officer, director or employee of a financial institution to receive anything of value for procuring a loan or extension of credit from such financial institution for any person.

SB 547 - Chapter 1024 Dills

Provides that municipal court attaches in chartered counties with a civil service system shall, subject to approval by the board of supervisors and subject to the county charter, be transferred, promoted, or voluntarily demoted into other positions of county employment in accordance with civil service regulations.

SB 548 - Chapter 1025 Whetmore

Revises the government code provisions dealing with the organization of municipal courts in Orange County. The bill adjusts the number of positions and the salaries of the clerks and attaches of the municipal courts, and also changes the names of the various judicial districts.

SB 578 - Chapter 1026 Schmitz Permits funds of local agencies to be invested in bonds or interest bearing notes of the United States, bonds of California, or of various other political subdivisions of the state, or in the various obligations issued under specified federal financial programs.

SB 606 - Chapter 1027 Grunsky

Permits an educational institution accredited by an agency recognized by the U.S. Office of Education to grant diplomas for its accredited courses of study.

SB 683 - Chapter 1028 Cusanovich

Adds to the requirements which must be met before a portable fire extinguisher can be sold in the state, the requirement that it does not use as an extinguishing agent any carbon tetrachloride, chlorbromomethane, or methyl bromide.

SB 820 - Chapter 1029 Grunsky Provides that married minors between the ages of 18 and 21 have reached the age of majority for all purposes of the Civil Code, Probate Code, and Code of Civil Procedure. The bill does not permit a married minor to purchase alcoholic beverages.

SB 885 - Chapter 1030 McCarthy

Grants certain salt marsh, tide and submerged lands to the City of Benicia upon certain trusts and conditions.

SB 886 - Chapter 1031 Burns Increases real estate license fees. It increases the broker license fee from \$65 to \$75 and the salesman license fee from \$40 to \$50. The new fees would become effective January 2, 1968.

SB 887 - Chapter 1032 Way

Extends indefinitely the authorization of the Department of Finance to participate in assisting public and nonprofit private agencies in providing housing and services for migratory farm workers.

SB 889 - Chapter 1033 Stevens Clarifies a school district's authority to purchase certain school buses from bond funds.

SB 397 - Chapter 1034 Short

Authorizes the Department of Alcoholic Beverage Control to refuse to transfer any licenses when the applicant is delinquent in the payment of any taxes on unsecured property which tax liability arises out of the exercise of an alcoholic beverage license.

SB 918 - Chapter 1035 Sherman

Restates academic standards for clinical laboratory bioanalysts' licenses. It reduces practical experience from five to four years. The bill raises the clinical laboratory permit application fee from \$10 to \$15 to match the current annual renewal fee for such a permit. The provisions for returning application fees when applicants are not admitted to examination is repealed.

SB 960 - Chapter 1036 Collier

Prohibits title insurers, controlled escrow companies and underwritten title companies from giving rebates. The bill increases the advance which may be put into escrow to facilitate the closing thereof from 1 to 2 percent of the sales price of the real property involved. The bill also requires any title insurer, controlled escrow company or underwritten title company to charge for a title report, and describes under what circumstances such charge may be waived.

SB 964 - Chapter 1037 Collier

Permits an authorized emergency vehicle, operating under prescribed conditions, to display a flashing white light from a gaseous discharge lamp designed and used for purpose of controlling official traffic control signals.

SB 1048 - Chapter 1038 Carrell

Makes it unlawful and cause for disciplinary action for a motor vehicle salesman to engage in false advertising, make false charges for fees, to pay fees to unlicensed individuals or to act as a dealer. The bill also broadens the definition of vehicle salesman to include managers, sales managers whether compensated by salary or commission. It makes conviction of a crime of moral turpitude prima facie evidence of moral character. The bill also adds to the possible causes for suspension or revocation of license the failure of the licensee to pay over to a dealer funds or property acquired in the course of employment when the dealer is entitled to them.

SB 1049 - Chapter 1039 Cologne Provides for staffing of the Redlands Judicial District with provisions for salaries and related matters with respect to the court's employees and attaches.

SB 1106 - Chapter 1040 Dymally

Specifies that a probationary teacher may not be dismissed except as provided in prescribed sections of the Education Code.

SB 1115 - Chapter 1041 Grunsky

Allows officers of school districts, school principals, physicians or hospitals to treat children injured or taken ill during regular school hours without liability for reasonable treatment without parents' or guardian's consent when parent or guardian cannot be reached unless the parent or guardian has previously filed with school district a written objection to any medical treatment other than first aid.

SB 1217 - Chapter 1042 Permits Alameda County to prohibit the use of any highway located in an unincorporated residential or subdivision area of the county by any commercial vehicle exceeding a gross weight of 5,000 pounds. Counties may prohibit commercial vehicles exceeding a gross weight of 14,000 pounds from using certain highways within the county.

SB 1223 - Chapter 1043 Stiern

Changes the salaries of clerks of municipal court in Kern County.

SB 1233 - Chapter 1044 Schmitz

Requires a board of supervisors to provide that an office vacant on the first Monday after January 1 following a general election because the person elected has resigned or died shall be filled at the next regularly scheduled election.

SB 1282 - Chapter 1045 Short

Authorizes the director of General Services to sell, exchange, lease, or otherwise dispose of certain enumerated parcels of land.

SB 1285 - Chapter 1046 Marler

Provides that in administration of Emergency Flood Relief Law, the Department of General Services shall have jurisdiction over building construction, alteration, repair and improvement rather than over state building construction, alteration, repair and improvement.

SB 1298 - Chapter 1047 Marler

Authorizes the payment of mileage fees to grand jurors for attendance at meetings of grand jury committees.

SB 1299 - Chapter 1048 Marler & Johnson

Permits cities, by ordinance, to establish and regulate bicycle lanes which are separate from vehicular traffic upon certain city streets.

SB 1321 - Chapter 1049 Way

Requires that a physician's or psychiatrist's statement stating that the judge is mentally or physically disabled be presented in order for a retirement on the grounds of such disability to be approved, and requires Commission on Judicial Qualifications, as well as Chief Justice to approve such retirement.

SB 1343 - Chapter 1050 McCarthy

Provides that contractors bidding on all state projects where federal funds are used for public works, rather than merely road, street, and bridge work, need not be licensed in California. The bill further provides that if a contract is awarded to unlicensed contractor, he must become licensed before payment is to be made.

SB 1366 - Chapter 1051 Collier

Makes permanent the previously temporary changes in crab seasons in all fish and game districts. The bill also changes opening day of crab season in Districts 6, 7, 8 and 9 from December 8 to December 1.

SB 1447 - Chapter 1052 Danielson

Authorizes an action to be brought for the purpose of having any person under the age of 21 years declared free from the custody and control of either or both of his parents when his parents are and will remain incapable of supporting or controlling the child in a proper manner because of mental deficiency or mental illnesses, if there is testimony to this effect from two certified medical examiners. The bill requires the parent or parents to be cited to be present at the hearing, and provides for the appointment of counsel, if parent or parents are financially unable to employ counsel.

SB 1505 - Chapter 1053 Teale

Requires payment on account of the attendance of pupils of a local school district in the School for the Deaf or the School for the Blind to be made to State Department of Education by the September 30 following the end of the fiscal year of attendance. The bill also provides that the State Controller shall withhold from the second principal apportionment of the fiscal year following the year of attendance the amount left unpaid by a local school district due on account of the attendance of pupils of the district in the School for the Deaf or School for the Blind. The bill declares that its provisions are declaratory of existing law.

SB 1529 - Chapter 1054 Lagomarsino Requires Department of General Services, rather than 3 appraisers appointed by the Governor, to determine the fair market value of lands to be leased by Department of Parks and Recreation.

AB 66 - Chapter 1055 Chappie, et al Authorizes cities and counties to adopt ordinances setting procedures for the abatement and removal of an abandoned wrecked, dismantled, or inoperative motor vehicle as a public nuisance, and to assess the costs of administration or removal of such vehicle against property upon which vehicle is located.

AB 250 - Chapter 1056 Chappie Repeals exisiting provisions of the Health and Safety Code relating to mobile homes and mobile home parks and re-enacts, with various clarifying changes, the provisions relating to mobile homes as a separate part and the provisions relating to mobile home parks as a separate part.

AB 310 - Chapter 1057 Cory Restores tenure and retirement rights to teachers who serve in programs organized pursuant to prescribed state and federal acts and who were previously employed in the regular educational programs of the school district.

AB 340 - Chapter 1058 Crown Authorizes the Director of General Services to sell described tidelands to the Alameda Unified School District for educational purposes. The bill restrains alienation of such lands for any purpose whatsoever. It provides for reversion to the state if the land is not used for educational purposes. The bill specifies that the sale is subject to the written authorization of the Secretary of the Interior.

AB 415 - Chapter 1059 Conrad Allows Los Angeles County and special districts within the county to establish tort liability funds for the purpose of paying tort liability claims and judgments under the Governmental Liability Act of 1963.

AB 564 - Chapter 1060 Moretti Amends various provisions of Credit Union Law including requirements for surety bonds, security on loans, quarterly dividends and call of membership meetings. It increases surety; bond requirements, eliminates cosigners as "security" for loans over \$3,000 permits quarterly dividends to members with the Corporation Commissioner's consent, and increases the number of members required to call special meetings in large credit unions.

AB 643 - Chapter 1061 Fenton

Provides that coroner's jurors shall reveive a fee identical to the fees as provided for jurors in criminal cases.

AB 658 - Chapter 1062 Milias Authorizes lump-sum payment for accrued vacation credits when a State employee is appointed to one of the non-civil service positions in which vacation credits arenot accrued or used. This bill also authorizes such payment when State College employees move from a nonacademic year position to an academic year position.

AB 661 - Chapter 1063 Milias, et al

Provides that state civil service employee who obtains a career executive appointment can, when such appointment is terminated, return to his former position, rather than a position in his former class in which he had permanent civil service status.

AB 793 - Chapter 1064 Hayes

Changes the required amount of fees to be paid by vehicle dealers, dismantlers, manufacturers, and transporters for a certificate, license and special plates. The bill also provides that whenever any person becomes a vehicle dealer, manufacturer, or tansporter as well as whenever a person becomes an automobile dismantler, without first having paid the license or certificate and special plate fees required, the fees are delinquent.

AB 846 - Chapter 1065 McMillan

Modifies the exemption in the Barber License Law which pertains to haircutting in cosmetology shops by providing that the exemption applies only when the shop does not represent itself to the public as being primarily engaged in the business of haircutting and is not primarily so engaged. The bill also provides that only a licensed barber or apprentice barber may perform the acts which constitute barbering, including haircutting, in a barber shop.

AB 850 - Chapter 1066 Fenton

Provides for newpaper publication within areas of former judicial districts which have been consolidated.

AB 851 - Chapter 1067 Quimby, etcal acc Coauthors - Coombs, et al Allows winegrowers to serve wine for consumption in a bona fide restaurant operated by the winegrower at his licensed production premises or adjacent thereto. The Department of Alcoholic Beverage Control is authorized to deny the on-sale privilege if the restaurant is within 200 feet of a school or church, or if exercise of the privilege would be contrary to public welfare and morals.

AB 867 - Chapter 1068 Z'berg

Adopts the Uniform Federal Tax Lien Registra= tion Act to permit the federal government to file tax liens with the Secretary of State, as well as with county recorders, to conform with procedures established by the Uniform Commercial Code for the filing of various other liens.

AB 953 - Chapter 1069 Townsend Requires cemetery equipment to display an identification plate and prescribes the manner of application and fee therefor. Cemetery equipment is excempt from registration. However, no provision is made in present law to identify such vehicles. As a result these vehicles are often cited for failure to comply with the registration requirements of the Vehicle Code.

AB 1096 - Chapter 1070 Biddle, et al Beilenson & Deukmejian Permits the Youth Authority and the counties to establish work furlough programs for juvenile offenders.

AB 1158 - Chapter 1071 Sieroty Requires the Department of Public Works and all rapid transit districts to cooperate with each other with respect to the planning of rapid transit facilities in relation to freeway and highway planning.

AB 1308 - Chapter 1072 Benton

Includes within the definition of "uninsured motor vehicle" a vehicle upon which there is in force insurance or a bond at the time of accident, but the company writing the same refuses to admit coverage thereunder except conditionally or with reservation.

AB 1502 - Chapter 1073 Stacey and Ketchum Increases rate of interest payable on bonds of member units or improvement districts of the Kern County Water Agency from 5% to 6½%.

AB 1617 - Chapter 1074 Knox

(or who is a director)
(or officer of such)
(insurer,)

Provides, with certain prescribed exceptions, that any profit realized by owners of 10 percent of the stock of a domestic insurer, from any purchase and sale or any sale and purchase, instead of sale or purchase, of any stock of such insurer, within 6 months, inure to insurer and may be recovered by or on behalf of insurer. The bill exempts transactions which the Insurance Commissioner may by rule and regulation exempt as not within the scope of provision requiring such owners, directors and officers to file statements as to their ownership of stock with the Commissioner by October 31, 1965, and monthly thereafter if there has been change in ownership of stock.

AB 1661 - Chapter 1075 Belotti Extends to 61st day after adjournment of the 1969 Regular Session, the statutory provisions fixing seasons for commercial taking of crabs. The bill also changes opening date for crab season in Districts 6, 7, 8 and 9 from December 8th to December 1st.

AB 1678 - Chapter 1076 Fenton

Provides that where property is acquired by eminent domain proceedings and is encumbered by a mortgage or deed of trust the amount payable from the award to the mortgagee or beneficiary under the deed of trust shall not include any penalty for prepayment.

AB 1739 - Chapter 1077 MacDonald

Authorizes the Board of Optometry to adopt regulations providing that when a certificate holder practices in more than oneplace and it is not feasible for him to keep his certificate posted in more than one place of practice, he may post such other evidence of his license status in his additional places of practice as the Board may prescribe.

AB 1786 - Chapter 1078 Stacey Requires each applicant for the examinations given by the State Board of Pharmacy to be a citizen of the United States or a lawful permanent resident. Provides as an alternative to the requirement that each applicant for registration as a registered pharmacist f be a citizen of the United States, the requirement that he be a lawful permanent resident, rather than eligible for citizenship.

AB 1795 - Chapter 1079 Cullen

Amends the law regarding the issuance of general obligation bonds by cities to provide that, if approved by the voters, interest costs estimated to accrue during the construction period of revenue-producing public works may be included in the bond issue. The bill would also apply to general obligation bonds issued by a city for the purpose of paying its portion of costs of a redevelopment project. A maximum time limit for deferring payment of principal and for funding of interest is 10 years. This is identical with the law now as to general obligation bonds issued to pay for revenue-producing facilities.

AB 1838 - Chapter 1080 Powers Exempts the transfer of beer between wholesalers who sell the same brand in package form requirement of filing and compliance with the schedule of selling prices with the Department of Alcoholic Beverage Control.

AB 1843 - Chapter 1081 Porter Provides that any building area excluded from the area of adequate school construction by adjustments made under provisions of the Education Code shall not be subsequently included in the computation of such adequate school construction when such building area has been converted by federal or district funds to usable instructional area for vocational educational programs. The bill has no fiscal implication insofar as the State budget is concerned.

AB 1852 - Chapter 1082 Duffy Prescribes the persons who, upon payment of a fee not exceeding \$1, are entitled to receive a copy of the inventory of a safe deposit box filed with the county treasurer.

AB 1915 - Chapter 1083 Zenovich Provides that no licensed workmen's compensation insurance rating organization, its officers or employees shall be liable for injury, death, or other damage proximately caused by a failure to inspect, or the manner or extent of inspection of, an employer's locations, plants, or operations for classification or rating purposes, or by such persons comment or failure to comment on the subject matter or object of such inspection.

AB 1938 - Chapter 1084 Shoemaker

Permits a veterans' association, which owns at least 20 lots or plots within any cemetery of a cemetery district on July 1, 1967, to acquire 70 additional burial lots or plots within any cemetery of the district.

AB 1982 - Chapter 1085 Quimby Permits, with respect to the Vehicle Code provision authorizing a lienholder to sell a motor vehicle subject to the lien at public sale such sale upon lienholders certification under penalty of perjury, that the vehicle does not exceed \$100 in value, rather than an appraisal by an officer or employee of the Department of Motor Vehicles to that effect. The bill also requires all notices under law relating to liens on vehicles to specify the make, engine or identification number, and license number, if available, or the vehicle, whereas present law requires such notices to specify make, engine, and vehicle identification or license number.

AB 2023 - Chapter 1086 Veneman Estends exemption from sales tax to mobile transportation equipment for use in for-hire transportation of property in interstate of foreign commerce, such as railroad locomotives, trucks, truck tractors, truck trailers, dollies, bogies, chassis, and cargo shipping containers. The bill does not affect the application of tax to the sale or use of such equipment if such sale or use does not take the form of a lease.

AB 2075 - Chapter 1087 Bagley

Requires members of governing bodies and boards and commissions of local agencies to disclose any direct personal financial interest in any matter coming before such a body.

AB 2112 - Chapter 1088 Hayes

Provides that it is a misdemeanor for any person or agency to offer to pay, or to pay, money to a parent for the placement of their child for adoption. The bill further declares it to be a misdemeanor for any parent to obtain money with the intent to receive the same without completing the adoption. The bill exempts donations made to a mother preceding and during confinement so long as those payments are not contingent upon placement of the child for adoption.

AB 2129 - Chapter 1089 Deddeh

Establishes a procedure whereby a person may by deed make an irrevocable offer of dedication of land for public purposes in the same manner that an offer of dedication may be presently made on a final subdivision map. The bill authorizes city council or board of supervisors to accept offer until time of termination or abandonment done in the same manner as abandoning or vacating streets and highways.

AB 2130 - Chapter 1090 Provides that monthly salary payment for certificated employees shall be made not Deddeh

earlier than last working day of month, or last working day of the payroll period, but such salary payments may be made on the last working day of the month or payroll period. The bill also provides that monthly wage payments for &lassified employees may be made on the last working day of the month and shall be made not earlier than the last working day of the month in which the labor was performed. The bill also provides that a school district is not prohibited from making a payment of earned salary prior to the last working day of the month or payroll period.

AB 2144 - Chapter 1091 Barnes

Authorizes and prescribes procedure for the nomination and revocation of beneficiaries by a member of the State Teachers' Retirement System. The bill provides that a designation of beneficiary is nullified upon a member's marriage, divorce, or annulment. also provides that if after children are nominated as beneficiaries, there are additional children born, such additional children will participate in any benefits which are payable to the survivors unless specifically excluded.

AB 2148 - Chapter 1092 Barnes

Changes the payroll date the county superintendent of schools certifies the number of members in the retirement system to the Retirement Board from the last payroll in the shcool year to the March and October payrolls.

AB 2151 - Chapter 1093 Barnes

Makes numerous technical and clarifying changes and revisions and repeals obsolete provisions relating to the State Teachers' Retirement System.

AB 2277 - Chapter 1094 Moorhead

Makes it a crime for any person to willfully and unlawfully prevent or dissuade, by use of force or threats of unlawful injury to person or property, any actual or potential witness from attending any proceeding authorized by The bill provides a more stringent penalty when force or threats of unlawful injury are involved.

AB 2310 - Chapter 1095 Shoemaker

Provides that no city or county may prohibit a person licensed by one of the agencies in the Department of Professional and Vocational Standards from engaging in the business, occupation, or profession, or any part thereof, authorized by his license.

AB 2352 - Chapter 1096 Lanterman

Provides that the arresting agency shall provide for the return of an indigent to the place of arrest, if more than 25 miles, when the person is released without trial or is acquitted

AB 2363 - Chapter 1097 Veysey

AB 2594 - Chapter 1100 MacDonald-Lagomarsino

Governor Ronald Reagan announced today he has signed the following

bills:

SB 99 - Chapter 1101 Deukmejian & Fenton Provides that State Highway Route 605 shall be known as the "San Gabriel River Freeway".

SB 191 - Chapter 1102 Sherman Authorizes the State Department of Education to employ, subject to specified limitations, persons retired for service under either the State Employees' Retirement System or the State Teachers' Retirement System, as substitute teachers at the California School for the Deaf or at the California School for the Blind.

SB 225 - Chapter 1103 Carrell

Makes it a misdemeanor for any person to practice any system of healing the sick, or to diagnose or treat for a mental or physical condition of any person, without having a certificate under the Medical Practice Act or without being able to perform such act pursuant to a certificate obtained in accordance with some other provision of law. The bill also increases the penalty from simple misdemeanor to possible felony for unlicensed performance of prescribed acts in cases of aggravated circumstances described.

SB 253 - Chapter 1104 Bradley Specifies procedures for the exchange of valuation information in eminent domain proceedings.

SB 374 - Chapter 1105 Burgener, Stevens, Wilson & Stull Creates the California Job Training and Placement Council to develop a coordinated system for job training and placement programs.

SB 439 - Chapter 1106 Kennick Establishes uniform state-wide rules and regulations regarding flammable liquids.

SB 471 - Chapter 1107 Grunsky & Murphy Adds Route 9 from Route 236 near Boulder Creek to Route 236 near Waterman Gap and Route 152 from Route 1 to the Santa Clara county line at Hecker Pass to the state scenic highway system.

S3 505 - Chapter 1108 Bradley, Alquist, & Milias Includes Route 9 from Blaney Plaza in Saratoga to Route 35 in the state scenic highway system.

SB 528 - Chapter 1109 Carrell

Makes it a misdemeanor to advertise for sale, sell, install or use any device which causes the odometer of any motor vehicle to record any incorrect mileage.

SB 635 - Chapter 1110 Collier

Strengthens the vehicle anti-theft laws by extending to all police officers and deputy sheriffs the authority to take possession of registration documents or license plates. The bill makes it unlawful to possess any vehicle or component part of a vehicle from which the identification number has been removed and by requiring the Department of Motor Vehicles upon recommendation of a court, to suspend or revoke the driving privilege of those found quilty of taking a vehicle without the owner's consent.

SB 638 - Chapter 1111 Stevens

Requires underwritten title companies to be stock corporations. The bill prescribes licensing requirements for underwritten title companies. The bill permits underwritten title companies to carry as an asset the actual cost of its title plant provided the value ascribed to it does not exceed the lesser of its actual cost or 50 percent of its stated capital. The bill also provides for insolvency and delinquency proceedings and states such companies are subject to the stop order power of the Insurance Commissioner

SB 672 - Chapter 1112 Cologne

Amends the Riverside County Flood Control and Water Conservation District Act to revise the boundary descriptions of zones within the District. The bill also authorizes the District to acquire entire parcels of land by eminent domain when a taking of less than the entire parcel will cause substantial damage or interfere with reasonable access to the remainder. The bill also authorizes the board of supervisors (the District's governing body) to create improvement districts within the District.

SB 694 - Chapter 1113 Stevens Authorizes banks to make a loan to an officer if such loan, together with any previous loans to such officer, does not exceed \$5,000. The bill also authorizes banks to make a loan to a director if such loan together with any previous loans, other than loans which may have been made under prescribed provisions, does not exceed \$5,000.

SB 732 - Chapter 1114 Beilenson Specifies that a marriage may be solemnized by any clergyman as defined, rather than by a priest or minister of the gospel of any demomination, of the age 21 years or upwards, The bill states the amendments are declaratory of existing law.

SB 828 - Chapter 1115 Mills

Provides that an admitted insurer, without first obtaining the written consent of the Insurance Commissioner, shall not enter into any agreement with a nonadmitted insurer which results in the admitted insurer ceasing to service any insurance contract made in this state insuring California residents or property without having first obtained written consent from the Commissioner, unless it has by valid contract arranged for an admitted insurer to perform such servicing.

SB 844 - Chapter 1116 Stevens Parmits local fire authorities to request and to conduct fire prevention inspections in state-owned buildings upon authorization from the State Fire Marshal. Only those local authorities which maintain full time paid fire prevention personnel could be granted such authorization.

SB 853 - Chapter 1117 McCarthy

Establishes the Fairfield-Suisun Municipal Court District.

SB 857 - Chapter 1113 Lagomarsino

Requires the Fair Employment Practices Commission to notify persons, employers, labor organizations, or employment agencies that they are being investigated for unlawful employment practices.

SB 867 - Chapter 1119 Coombs, Quimby & Briggs Revises the statutory provisions relating to the number, classifications and compensation of the officers and attaches of the municipal courts in the San Bernardino and Ontario Judicial Districts in the County of San Bernardino. SB 923 - Chapter 1120 Sherman Amends the Corporate Securities Law to permit the Commissioner of Corporations to destroy escrowed share certificates of suspended companies. The bill also provides for the issuance of permits to cure defects in securities issues.

SB 937 - Chapter 1121 Lagomarsino

Requires that a copy of the directional survey, if made, be filed with the Division of Oil and Gas. This information is necessary for correlating subsurface formations penetrated by a directionally drilled well.

SB 957 - Chapter 1122 Stevens & Cusanovich Includes the portion of State Highway Route 27 from Route 1 to Route 268, in the state scenic highway system. The bill makes the portion of Route 21 lying between the Coast Highway and Mulholland Drive a part of a Scenic Highway System.

SB 987 - Chapter 1123 Short Increases the salaries of, and changes the number of, various attaches of the Stockton Municipal Court.

SB 1003 - Chapter 1124 Danielson Is a comprehensive reorganization and recodification of the statutory procedures to be followed in the commitment of narcotics addicts to the California Rehabilitation Center.

SB 1165 - Chapter 1127 Requires the State Fire Marshal to pre-Danielson and Alquist pare and adopt regulations, in accordance with prescribed procedure, to promote the safe use of portable internal combustion engine-driven pumps used to transfer flammable liquids. SB 1181 - Chapter 1128 Provides for a lien with respect to taxes Dolwig on possessory interests and real property improvements on such interests or improve-ments rather than a lien on the other real property of taxpayer. Provides for recording in any county, without fee, of such liens or delinquencies with respect to possessory interests, goods in transit, improvements, and unsecured property. SB 1193 - Chapter 1129 Changes the salary of, and revises salary schedule for, various court attaches of Coombs the Victorville Municipal Court. SB 1237 - Chapter 1130 Provides that proof of motor vehicle Moscone being leased or rented on date and during time when parking violation occurred rebuts prima facie evidence that registered owner was person who parked or placed such vehicle at point where violation occurred. SB 1287 - Chapter 1131 Reserves blue lights for use by law Marler enforcement vessels and authorizes such use day and night when a vessel is engaged in direct law enforcement activities. Such light, when used, will be in addition to any other lights and day signals required by law. The bill prohibits use of such lights on vessels for other purposes, and prescribes penalties for violations. Amends the Public Resources Code relating to mining claims by providing the locator with the option of using drill holes for SB 1320 - Chapter 1132 Teale discovery work requirements in place of digging a 10-foot shaft or excavating 7 cubic yards of material. Authorizes the Department of Harbors and Watercraft to inspect for-hire vessels on SB 1325 - Chapter 1133 Lagomarsino waters of this state other than those waters which have been declared to be navigable by agencies of the federal govern-Requires the Department of Public Works, SB 1365 - Chapter 1134 Collier after consultation with the Department of Harbors and Watercraft, to prepare a report estimating the amount of money in the Motor Vehicle Fuel Fund attributable to taxes on fuel used by vessels. SB 1381 - Chapter 1135 Provides for an increase in the compensation of the members of the San Diego Schrade and Bear County Board of Supervisors from \$12,500 per year to \$16,000 per year. The bill also includes the provision that the proposed increase will become effective only after local action is taken to provide for a conflict of interest ordinance, or charter amendment, similar in substance to the language contained in the Government Code sections pertaining to the mem-

SB 1029 - Chapter 1125

SB 1160 - Chapter 1126

AB 375 - Chapter 1136 Russell and Knox

Requires that a prospective purchaser of a subdivision lot be informed of the actual and estimated indebtedness against the lot for construction of local improvements in the subdivision, including streets, sewers, drains, water lines, street lights, and recreational facilities.

AB 597 - Chapter 1137 Veneman Permits person divorced in this state to remarry within one year after the service of copy of summons and complaint upon, or appearance by, the defendant spouse rather than one year after the entry of an interlocutory decree, thereby reflecting the change in the interlocutory period made by the Legislature in 1965.

AB 604 - Chapter 1138 Knex, et al

Requires public entities provided for by a joint powers agreement or certain redevelopment agencies to file report of financial transactions if required by the State Controller. Deletes provisions dealing with accounting duties of city clerks.

AB 794 - Chapter 1139 MacDonald

Gives the power to appoint notaries public and commissioners of deeds to the Secretary of State. The Governor presently makes such appointments. The bill provides that if notary public commission is denied, suspended or revoked, the person has a right to a hearing to be conducted in accordance with provisions of law dealing with state administrative adjudications. The bill also adds new standards of good moral character including a questionnaire concerning fitness for the functions of the office. It imposes a \$6 fee to be paid by one requesting a notary public commission.

AB 994 - Chapter 1140 Townsend

Exempts commercial schools giving off-highway instruction in the operation of special construction equipment from provisions regulating driving schools and instructors. The bill permits a person who has satisfactorily completed courses in the teaching of driver education and driver training acceptable to the Department of Motor Vehicles to be exempted from parts of the driving instructor's examination. This bill also requires, in addition to other prescribed qualifications for operating a driving school, the applicant to pass within three attempts the Department's examination on traffic laws, safe driving practices, operation of motor vehicles, teaching methods and techniques, driving school statutes and regulations, office procedures and record keeping.

AB 1083 - Chapter 1141 Wilson, et al

Requires the Department of Motor Vehicles to mail notice of application for registration of any vehicle previously registered outside this state to governmental authority outside this state only when written request is filed with the Department, instead of whenever such application is filed.

AB 1141 - Chapter 1142 Duffy Authorizes the Governor to take whatever action necessary for the state to secure financial assistance from the federal government pursuant to the Comprehensive Health Planning and Public Health Services Amendments of 1966.

AB 1157 - Chapter 1143 Veneman Increases the annual salary of the Stanislaus County Board of Supervisors and District Attorney. The District Attorney's salary is raised from \$18,000 to \$21,300 and Board members are raised from \$7,800 to \$8,400.

AB 1410 - Chapter 1144 Ralph

Amends the Civil Code provision relating to the repossession of motor vehicles to provide that ten days written notice (twenty days if the notice is mailed to or from a place outside this state) must be given to persons liable on the contract, and that the notice must be personally served or sent by certified mail.

AB 1446 - Chapter 1145 Ryan Permits licensed escrow agents to substitute the assignment of savings accounts in an insured savings and loan association in lieu of a surety bond or cash as now required by the Financial Code.

AB 1549 - Chapter 1146 Veneman-Monagan-Veysey Allows school districts that are affected by fluctuations in attendance to estimate the total yearly attendance for apportionment purposes subject to adjustment in following year if the estimated attendance is different than the actual.

AB 1550 - Chapter 1147 Veneman Provides that city, county, or district, using voting machines to vote tabulating devices may use reasonable facsimiles of the sample ballots. The bill provides that the clerk may count such ballots by using a voting machine or vote tabulating device. The bill also permits abbreviation of ballot measure statements, and requires Attorney General to compose abbreviated statements.

AB 1583 - Chapter 1148 Fenton

Clarifies, and makes consistent, provisions of the Elections Code dealing with circulation and verification of petitions for municipal initiative referendum and recall elections. AB 1608 - Chapter 1149 Zenovich

Increases from five to eight the number of secretaries for whom the governor could set salaries of not more than \$20,000 per year. No more than two of the secretaries could be legislative secretaries.

AB 1707 - Chapter 1150 Priolo

Makes several technical amendments to the Financial Code relating to savings and loan associations.

AB 1766 - Chapter 1151 Johnson, Ray

Deletes the requirement that certain Zone A licensed pheasant clubs be at least one-half mile apart.

AB 1800 - Chapter 1152 Ryan

Amends the Municipal Improvement Act of 1913 to permit local legislative bodies to make initial loans from any available funds rather than only the general fund of the municipality in order to expedite the conduct of proceedings and to make acquisitions or improvements.

AB 1826 - Chapter 1153 Brathwaite Allows the State Board of Public Health to authorize a local health department to enforce the provisions of the California Food Act as it pertains to retail food establishments if the Board determines that a local health department has sufficient personnel with adequate training to do so.

AB 1898 - Chapter 1154 Z'berg

Authorizes the Department of Harbors and Watercraft to suspend, cancel or revoke the registration of a vessel, certificate of number, sticker, certificate of ownership or temporary certificate of number in cases of fraud, error or failure to pay required fees.

AB 2052 - Chapter 1155 Bagley

Provides for increased retirement allowance formula for employees in Los Angeles County, and counties who wish to adopt such provisions under the County Employee's Retirement Law of 1937. The bill requires employees under such formula provisions to retire at age 65 from January 1, 1973 on, or from within 2 years of a county adopting such provisions, whichever date is later.

AB 2104 - Chapter 1156 MacDonald & Lagomarsino Authorizes the Board of Directors of the Ventura County Waterworks District No. 6 to create a special zone by 4/5 vote and after notice of hearing. The zone would encompass land which has been inadvertently allowed to escape the obligation of paying a share of the cost of improvements serving a portion of the district, which improvements benefit such land.

AB 2145 - Chapter 1157 Barnes Requires local law enforcement agencies to report to the Bureau of Criminal Statistics such information as the Attorney General requires relative to misdemeanor violations of obscenity laws.

AB 2246 - Chapter 1158 Biddle

Increases the number of, and salaries of, various attaches of the municipal courts in Riverside County.

AB 2263 - Chapter 1159 Mobley

Authorizes initiation of proceedings for installation of additional lights in a high-way lighting district, by the governing body on its own initiative or by the written request by two members thereof, in addition to a petition by 20 or more taxpayers of the district.

AB 2437 - Chapter 1160 Bagley

Amends the Business and Professions Code provision which permits cities and counties to require subdividers of 400 or more units to set aside land for school site purposes. The bill allows the subdivider to repurchase the land thus set aside if not used for school purposes within ten years. It requires the school district to record a certificate with the county recorder relating to the dedicated property.

AB 2532 - Chapter 1161 Campbell

Makes it a misdemeanor for any person to enter upon any school premises or adjacent public way, without lawful business thereon, and whose presence or acts disrupt the school and who remains after having been asked by a school administrator to leave. The bill is applicable only to elementary, junior high and senior high schools.

NOTE: SB 1505 which had been assigned Chapter #1053 contained a printing error and was withdrawn. It will be assigned a new chapter number when the corrected bill is signed.

SB 1525 authored by Senator Lagomarsino now carries Chapter No. 1053. The bill authorizes the Department of Parks and Recreation to remove and dispose of logs, timber, lumber and debris deposited on public beaches or waterways within the State Park System when the deposits create a hazard to public safety and the use of the public facilities.

MEMO TO THE PRESS

Sacramento--Governor Ronald Reagan announced today he has signed the following bills:

August 15, 1967

AB 116 - Chapter 1185 Lanterman & Burton Prohibits persons from operating specified motor vehicles which emit noise exceeding specified noise limits at any time or under designated conditions.

AB 622 - Chapter 1186 Pattee Abolishes the Agricultural Prorate Commission.

AB 1041 - Chapter 1187 Veysey Transfers from the Penal Code to the Fish and Game Code provisions making it unlawful to enter another's land for purposes related to hunting. The bill adds provisions making it unlawful to enter such land for the purpose of discharging any firearm, to maliciously tear down, mutilate, or destroy any sign, signboard, or other notice forbidding trespass or hunting on land. The bill also makes all hunting and shooting by all persons, except the taking of nonprotected mammals or birds by the owner or his agent, unlawful on lands where prescribed signs declaring land to be a private refuge are displayed at designated locations.

AB 1182 - Chapter 1188 Milias & Dent Exempts persons engaged in performance of military duty in pursuance of an order of the President, as well as person belonging to active state militia or engaged in performance of duty on call of Governor, from Civil process while going to, remaining at, or returning from military duty.

AB 1274 - Chapter 1189 H. Johnson

Permits bowling alleys of 32 lanes or more to sublease restaurant operations to food management specialists.

AB 1399 - Chapter 1190 Biddle

Authorizes the Regents of the University of California to collect, and act as an information exchange for, information on research and service projects relating to drug abuse and to provide advice with respect to the areas in which research is needed. The bill provides that a state agency shall not conduct research project on subject of drug abuse until it has provided the regents with a description of its proposed project. The bill further requires the Regents to submit a report of its activities under this provision annually to the Governor and the Legislature.

AB 1430 - Chapter 1191 Bagley Limits the amount of the security bond that can be required in a corporate derivative action to a maximum of \$25,000. The bill provides that upon posting of a \$25,000 bond by plaintiff, either before or after a motion is made by a defendant for security in a derivative action, to secure reasonable expenses, the plaintiff shall be deemed to have complied with the security requirements otherwise imposed by statute. The bill further provides that any motion for such a hearing or order for security pending shall be deemed disposed of upon posting such bond and no additional bond or other security shall be required.

Knox

Ab 1626 - Chapter 1192 Establishes procedure for intercounty districts which fix their own tax rates, as well as for such districts wherein the tax rate is fixed by county boards of supervisors, to follow the alternate method of computing tax and assessment levies on the basis of tentative full values of property within the district. The bill also specifies that if the alternate method is followed, maximum tax rates otherwise established by law or pursuant to law in one or more counties may be exceeded so long as the total revenue received by the district does not exceed the maximum amount which it would have received if the alternate method had not been followed.

AB 1630 - Chapter 1193 Knox

Provides that, when examining books, records, accounts and documents of the county assessor, a grand jury may, with the consent of the board of supervisors, employ expert auditors or appraisers who shall have same access as grand jury to records and documents and who shall be subject to same limitations as grand jury on public disclosure while so employed.

AB 1681 - Chapter 1194 Z'berg

Authorizes insurance companies to enter into a contract with a group policy-holder or contract-ing entity under any group, selected group, or franchise policy to determine the amount the insurer may retain from premiums paid or to provide for the establishments of reserves or deposits to meet future contingencies of any nature under such insurance policy.

AB 1744 - Chapter 1195 Harvey Johnson

Requires the rules and regulations of Director of Social Welfare to be printed in the California Administrative Code or California Administrative Register if they relate to institutions for child care and home finding agencies, institutions and boarding homes for aged persons, and life care contracts.

AB 1961 - Chapter 1196 Dunlap & McCarthy

Authorizes the Director of General Services, with consent of the Department of Mental Hygiene, to lease property not exceeding 5 acres at Napa State Hospital, for a period not to exceed 20 years, to a nonprofit corporation, for the purpose of conducting an educational and work program for mentally retarded persons.

Bagley

AB 2047 - Chapter 1197 Requires the State Fire Marshal, in adopting regulations affecting aged and children's homes of six or less capacity, to pattern such regulations on the concept of family-type care.

AB 2185 - Chapter 1198 Bill Green

Permits reimbursement of the costs, including tuition fees, to permanent classified employees of school districts who satisfactorily complete approved training to aid in their work.

AB 2280 - Chapter 1199 Wilson

Makes it a misdemeanor for any person to willfully ingest, inhale, or breathe the fumes of toluene and similar substances with intent to become intoxicated. The bill is intended to deter the dangerous practice of "glue sniffing".

AB 2281 - Chapter 1200 Wilson

Permits a school superintendent, when authorized by his governing board, to suspend or expel a pupil for use, possession, or sale of dangerous drugs or substances. The bill expends the classification of dangerous and hallucogenic drugs. The time for which a pupil may be suspended prior to transferral to a continuation education class is extended from 10 to 20 days.

AB 2285 - Chapter 1201 Karabian-Lagomarsino

Makes it a felony to offer to unlawfully sell or furnish any restricted dangerous drug and then to sell or furnish any other liquid substance of material in lieu of that restricted dangerous drug. Present law applies only to narcotics.

AB 2416 - Chapter 1202 Elliott

Provides that in a school district having the merit system, appointments are required to be made from the top three, rather than from the top two, applicants on the eligibility list if one of the top two applicants is closely related to an employee or pupil at the school where the vacancy exists.

AB 2422 - Chapter 1203 Lanterman

Authorizes the Department of Mental Hygiene to contract with local health agencies to obtain psychiatric, medical, and other necessary after care services for patients on leave from state hospitals.

AB 2426 - Chapter 1204 Z'berg

Expresses consent of the Legislature to retrosession of jurisdiction over lands within state by the United States.

AB 2514 - Chapter 1205 Russell

Authorizes court in action for annulment, divorce or separate maintenance, upon a determination that payment of an obligation of a party would benefit either party or a minor child, to order one of the parties to pay all or any portion of an obligation of a party directly to the creditor. The bill provides that the creditor shall have no right to enforce the order nor shall his rights be affected by such determination.

AB 2537 - Chapter 1206 Briggs

Specifies under what circumstances the Insurance Commissioner may suspend the privilege of an insurer, agent or broker from appointing a candidate for a certificate of convenience. The bill specifies how the Commissioner can prevent evasion of such suspension.

AB 2573 - Chapter 1207 Meyers

Requires that at least one automatic elevator in each multistoried building that has a vertical travel above ground floor of more than 100 feet shall be equipped to bypass all car and corridor calls and return to the main The bill does not apply to commercial floor. office buildings existing on the date of enactment of the bill.

AB 2576 - Chapter 1208 Authorizes oil and gas leases by local agencies on land used for public park, highway, street, walk, or playground if the governing body determines it will not substantially interfere with such use. The bill will give to counties the same authority as now possessed by cities in connection with the leasing of parks, highway, street, walk or playground property for the extraction of oil and gas.

SB 135 - Chapter 1162 Mills

Changes the authority of the court to release exhibits in criminal cases any time after the final determination of the action or proceeding by providing that any exhibits in an action or proceeding which results in an order of probation may be released any time after the final determination of an appeal of such order or after the time for such appeal has elapsed. The bill further provides that such exhibits cannot be destroyed until 60 days after specified notice to the party entitled to such exhibits unless such party consents to its destruction.

SB 240 - Chapter 1163 Beilenson

Specifies that the substitution of trustee authorized by Section 2934a of the Civil Code shall be effective notwithstanding any contrary provisions in any deed of trust executed on or after January 1, 1968.

SB 353 - Chapter 1164 Short

Amends the Education Code so that financial need shall be considered in the furnishing or denial of rehabilitation services in accordance with the Federal Vccational Rehabilitation Act.

SB 414 - Chapter 1165 Wedworth

Simplifies the procedures for having the county road department do road work inside of a city.

SB 704 - Chapter 1166 Teale

Increases from 2 million dollars to 4 million dollars the appropriation to the State Water Quality Control Board from the Water Pollution Control Fund, for leans to construct sewage and storm drainage facilities to prevent and control water pollution in the north Lake Tahoe area. Of the 4 million dollars, 2 million is authorized from 1967-68 revenues to the Fund and 2 million from 1968-69 revenues. The legislation also provides that loans may be made to the Truckee Sanitary District, as well as the North Tahoe and Tahoe City Public Utility Districts. The bill requires that each district execute an agreement with the State Pollution Control Board to repay the loan within 25 years with interest on the principle following a 10 year moratorium.

SB 765 - Chapter 1167 Stiern

Provides that the State Board of Equalization shall not be reimbursed for expenditures for training of assessors and their staffs. The bill changes the rate of the private car tax to be computed on the average rate of general property taxation rather than on the average rate of taxation. Requires that this be computed without the inclusion of special taxes on intangibles, aircraft, baled cotton, or any other property subject to a uniform statewide tax.

SB 827 - Chapter 1168 Moscone

Provides that Pilotage Rate Committee in preparing recommendations to the Legis-lature may require an independent audit of bar pilotage operations. Present law requires such an audit.

SB 929 - Chapter 1169 Moscone Increases bar pilotage rates through the Golden Gate and into or out of the Bays of San Francisco, San Pablo and Suisun, from \$7 to \$7.50 per draft foot.

SB 972 - Chapter 1170 Lagomarsino

Makes commission wages paid to any person employed by a licensed vehicle dealer due and payable once during each calendar month on a regular designated payday, rather than twice a month, unless there exists a collective bargaining agreement which provides for the date on which wages shall be paid.

SB 988 - Chapter 1171 Short Increases collection agency license fees. The increased fees are necessary for the Collection Agency Licensing Bureau to maintain itself on a self-supporting basis.

SB 989 - Chapter 1172 Short Provides that two persons cut of seven who are required to be appointed to the advisory board to each community mental health service be representative of the public interest in mental health and mental retardation services, rather than only be representative of public interest in mental health. The bill also eliminates the prohibition against employment of aliens as physicians in local mental health service.

SB 996 - Chapter 1173 Miller

Establishes procedure for applicants for assessment reductions, in certain cases, to waive the examination under oath by local boards of equalization.

SB 1032 - Chapter 1174 Harmer Requires junk and secondhand dealers to require adequate evidence of authority to sell from any person who attempts to sell any finished product, new item of finished or merchandisable quality, inventory items of new materials or finished quality, or other goods or materials which appear to be neither abandoned nor scrapped. The bill makes it a misdemeanor to fail to obtain such evidence. The bill also makes it a misdemeanor or felony, depending on the value of the item, to resell any of the items listed above without proof of authority.

SB 1034 - Chapter 1175

Specifies that the Parking and Business Improvement Area Law of 1965 is available to cities which have not imposed a general business license tax, as well as to those which have. The bill authorizes city council to establish and modify one or more benefit zones based on degree of benefit derived from any purpose for which parking improvement area taxes may be imposed, and to impose different tax rate within each zone. The bill further requires that the tax imposed on businesses for purpose of acquisition, construction, or maintenance of parking facilities for the benefit of the area be imposed on the basis of benefit determined by the council.

SB 1061 - Chapter 1176 Cologne

Provides that any unmarried minor who is a bona fide resident of the State of California and whose parent or guardian is in the military services, but is stationed outside the continental limits of the United States, shall be considered a resident student in regard to the state colleges. The bill also provides that any unmarried minor whose parent is in the military service shall not lose status as resident student for purposes of attending the University of California by reason of such parent's removal, pursuant to military order, to a place outside the United States.

EB 1138 - Chapter 1177 Sherman

Prohibits providers of medical assistance under the California Medical Assistance Program (Medi-Cal) from advertising that they are authorized to provide services to beneficiaries.

SB 1240 - Chapter 1178 Short Increases the salaries of certain attaches of the Lodi Minicipal Court.

SB 1301 - Chapter 1179 Lagomarsino and Z'berg

Provides for the recrganization of the Department of Parks and Recreation. The bill abclishes the State Park Commission and the State Recreation Commission. A State Park and Recreation Commission consisting of nine members appointed by the Governor is created in place of the abclished commissions.

SB 1380 - Chapter 1180 Schrade Increases the salaries of, and increases the number of, certain attaches of municipal courts in San Diego County. The bill also provides for the position of judicial secretary.

SB 1456 - Chapter 1181 Lagomarsino and Shcemaker

Specifies that resolutions of the Santa Barbara County Flood Control and Water Conservation District and Santa Barbara County Water Agency adopted by 2/3 vote of all its members, to exercise eminent domain power shall be conclusive, rather than prima facie, evidence that the condemnation of the property in question is necessary to serve the purposes of the district. The bill also authorizes such districts to reduce increased severance damages resulting from condemnation of part of a parcel which interferes with access to the remainder by either acquiring the remainder.

SB 1475 - Chapter 1182 Lagomarsinc & MacDonald Allows any county sanitation district to construct and maintain domestic and other water supply facilities. The bill precludes such districts from furnishing a domestic water supply outside of the district except by means of facilities designed primarily to serve inside the district unless agreement is reached with a neighboring or overlying water agency where water is to be served.


SB 1523 - Chapter 1183 Lagcmarsino Requires the State Lands Division to maintain records of all publicly owned lands in California and publish a summary report every two years.

SB 1528 - Chapter 1184 Lagomarsino

Provides that any local agency aggrieved by application of zoning ordinance of county or city or by decision or an officer, department, board or bureau of the county or city made in connection therewith may appeal to the Planning Advisory Committee rather than the Local Planning Advisory Committee.

The people of the State of California do enact as follows:

Section 1. Section 19074 is added to the Business and Professions Code, to read:

19074. This chapter shall not apply to the sale of any bedding, except mattresses, by a nonprofit religious organization for which no salary or commission is paid to the sales personnel and the sales price is used for charitable purposes.

SEC. 2. Section 19032 is added to Article 1 (commencing with Section 19000), Chapter 3, Division 8 of the Business and Professions Code, as proposed by Senate Bill No. 423, to read:

19032. This chapter shall not apply to the sale of any bedding, except mattresses, by a nonprofit religious organization for which no salary or commission is paid to the sales personnel and the sales price is used for charitable purposes.

SEC. 3. Section 2 of this act shall become operative only if Senate Bill No. 423 is enacted by the Legislature at its 1967 Regular Session and in such case at the same time as Senate Bill No. 423 takes effect at which time Section 1 of this act is repealed.

Sacramento--Governor Ronald Reagan announced today he has signed the following bills:

August 15, 1967

AB 272 - Chapter 1209 Unruh Provides increased state support for the public school system.

August 17, 1967

SB 134 - Chapter 1210 Beilenson Makes it a misdemeanor for any person with intent to defraud to operate a motor vehicle knowing that the odometer of such vehicle is disconnected or nonfunctional. The bill also makes it a misdemeanor for any person to disconnect, turn back, or reset the odometer of any motor vehicle.

SB 237 - Chapter 1211 Grunsky

Requires the State Board of Education to issue a credential for service restricted to service as a speech and hearing specialist, or teaching handicapped children other than certain mentally retarded minors in areas other than those involving speech and hearing handicaps.

SB 320 - Chapter 1212 Dymally, Bill Greene, & Sieroty Permits a school district to charge needy pupils reduced prices for breakfast and lunch or, as at present, to furnish those meals free. It would authorize the school district to help pupils who are unable to pay part, but not all, of the cost of these meals.

SB 348 - Chapter 1213 Kennick Authorizes the governing board of a school district to increase the maximum tax rate for purposes of undertaking corrective measures to repair or replace school buildings found to be unsafe because of earthquake hazards.

SB 493 - Chapter 1214 McCarthy

Removes from the jurisdiction of the Public Utilities Commission the regulation of a corporation or person under contract with a federal agency, who operates any vessel for the transportation of persons between termini within the state of which one terminus is within the boundaries of a U.S. military reservation.

SB 598 - Chapter 1215 Carrell

Revises provisions relating to borrowing by the Southern California Rapid Transit District. The bill permits the District to issue limited tax bonds, as well as other bonds, to provide financing for District purposes.

SB 610 - Chapter 1216 McCarthy & Bagley Permits the Commissioner of the California Highway Patrol to issue emergency vehicle permits for any vehicle operated by the chief or assistant chief of a fire department organized as provided in the Government Code or pursuant to special act of the Legislature.

SB 614 - Chapter 1217 McCarthy & Bagley

Permits boat transporters to haul loads consisting solely of boats exceeding 13'6" in height but not exceeding 14'. Since 1965, similar height provisions have applied to vehicles hauling motor vehicles without any significant problems.

SB 624 - Chapter 1218 Lagomarsino, Shoemaker

Provides that theft of a dog having a value of over \$200.00 is a felony, theft of a dog of less than \$200.00 in value is a misdemeanor, and theft of a dog for sale, medical research, or other commercial use is a felony.

SB 650 - Chapter 1219 Cologne

Enables a testamentary trustee to petition court for authority to exercise designated powers where, after hearing, it appears necessary or desirable to carry out trust purposes that trustee be given powers not expressed in will or conferred by law.

SB 687 - Chapter 1220 Alquist & Crandall

Provides that the area of any building, the construction of which was financed by the proceeds from a tax levied for maintaining children centers, shall not be included in any computation of the area of adequate school construction so as to prohibit an apportionment of funds for new construction under the State School Building Aid Law of 1952.

SB 728 - Chapter 1221 Alquist & Bradley, Vasconcellos Allows the Santa Clara County Board of Supervisors to adopt a local vehicle license fee not to exceed \$10 to continue the construction of the county expressway system. The Department of Motor Vehicles is to collect the fees.

SB 767 - Chapter 1222 Dolwig, Bee & Pattee Provides for intercounty transfer of offsale general licenses subject to limitations
in number and as to eligible counties. This
is the type of license for package liquor
stores, grocery stores and drug stores.
Present law makes no provision for transfer
of any license from one county to another
county, although transfer of licenses within
the counties in which they have been issued
is permitted.

SB 835 - Chapter 1223 Lagomarsino Designates the portion of Route 126 from Route 101 near Ventura to Route 5 as the Santa Paula Freeway.

SB 850 - Chapter 1224 Rodda

Provides that an employee in a position requiring certification qualifications for not less than the minimum schoolday may specifically contract with the governing board to be a part-time employee.

SB 852 - Chapter 1225 McCarthy

Increases the number of, and salaries of, various attaches of the Vallejo Municipal Court.

SB 905 - Chapter 1226 Grunsky

Requires board of supervisors to hold public hearings before consolidating judicial districts. The bill is not applicable to counties with population of over 4,000,000.

SB 913 - Chapter 1227 Grunsky

Deletes the Education Code provision reducing the weekly student contact hour factor in district entitlement computation for junior college district that became effective for all purposes on or after July 1, 1960, which has expended, committed, or dedicated less than 1 percent of its assessed valuation for junior college facilities, or has acquired as a successor district facilities having a value of less than 1 percent of its assessed valuation.

SB 962 - Chapter 1228 Collier

Authorizes the California Highway Commission to invest presently unneeded money in the Stat Highway Fund, in time bank deposits in banks eligible for deposits of state money and in securities of the federal government eligible for investment of state money.

SB 982 - Chapter 1229 Dolwig & Coombs Permits joint power agreement agencies to issue revenue bonds for buildings, property, and parking facilities for the facilities it is presently authorized to construct and maintain.

SB 1057 - Chapter 1230 Cologne

Authorizes a court in its discretion to permit recovery of interest on any judgment for damages based upon a cause of action in contract where the claim is unliquidated from a date prior to entry of judgment, but not earlier than date action was filed.

SB 1090 - Chapter 1231 Short Deletes the Code of Civil Procedures provision allowing an unmarried female to prosecute a civil action for her own seduction occurring at a time when she was below age of legal consent. The bill also deletes the provision allowing a parent entitled to services and earnings of an unmarried female below the age of legal consent to maintain a civil action for seduction of such female.

SB 1113 - Chapter 1232 Coombs

Makes several changes in egg grades and standards in the Agriculture Code. These changes relate to the yolk position in the egg, provide a uniform minimum size lettering for marking on containers, add an armedforces grade, and add a provision for the movement of below-grade eggs to reconditioning or processing.

SB 1200 - Chapter 1233 Dymally & Ralph Requires the county committee on school district organization to report to the board of supervisors, county board of education, and the district governing boards whether a proposed transfer of territory from one school district to another will or will not result in racial integration in the schools of the districts affected by the transfer.

SB 1234 - Chapter 1234 Schmitz

Defines "veteran" for purpose of ascertaining eligibility for veteran's preference points in state civil service to include persons serving in the armed forces of the United States full time for at least 30 days during the period September 16, 1940, to January 31, 1955, or 181 consecutive days since January 31, 1955, in addition to the periods of service presently specified.

SB 1244 - Chapter 1235 Short Authorizes the Director of Professional and Vocational Standards to negotiate and execute for the department and its agencies leases or agreements for short-term hiring of space for examination purposes.

SB 1248 - Chapter 1236 Danielson

Requires that actions brought for refunds of property taxes must be commenced, within one year after a claim for such refund shall have been denied.

SB 1260 - Chapter 1237 Dolwig

Creates in the Insurance Commissioner authority to grant exemption for certain transactions relating to interest of an insurer's officer and others in purchases, sales and loans by insurers, otherwise prohibited, upon an insurer filing application for the exemption, accompanied by a \$250 filing fee, provided the transaction to be exempted is fair, just and equitable to all concerned and in accordance with all conditions imposed by the Commissioner.

SB 1264 - Chapter 1238 Dolwig

Permits a State Bank to invest in the stock of one or more international banking corporations organized under the laws of any State of the United States, provided that such stock would constitute a permissible investment for a national bank.

SB 1350 - Chapter 1239 McCarthy

Provides that the Department of General Services, with the consent of the Department of Corrections, may lease a ten-acre portion of the grounds of the Calfornia Medical Facility at Vacaville to a non-profit corporation (Upper Solano Association for Retarded Children) for the construction of a retarded children's school. This measure extends the limit on the lease from twenty years to fifty years and the acreage from five acres to ten acres, in order to qualify for federal funds. The bill also provides that the Department of General Services, with the consent of the Director of Mental Hygiene, may let to a non-profit corporation for twenty-five years a building within the grounds of the Napa State Hospital for a canteen.

SB 1361 - Chapter 1240 Grunsky

Provides that when a highway patrolman, sheriff deputy sheriff or city policeman appears as witness, the California Highway Patrol or the public entity employing law officer has standing to sue for recovery of statutory witness fee.

SB 1443 - Chapter 1241 Danielson

Provides that the value of a motor vehicle or house trailer exempt from execution or attachment shall be based on the value over and above all liens and encumbrances thereon, provided that the value of such motor vehicle shall not exceed \$1,000. The bill further provides that the existing exemption for a house trailer applies only if neither debtor nor his spouse has an existing homestead.

SB 1477 - Chapter 1242 Kennick Authorizes a redevelopment agency to construct foundations or platforms upon which structures can be built by private developers who acquire the air rights above such structures for development.

SB 1494 - Chapter 1243 Harmer Authorizes two or more banks, with the prior written consent of the Superintendent of Banks, to invest in the stock of a corporation engaged exclusively in the business of performing for one or more banks various types of services. The bill limits the amount of investment by any bank to a maximum of 10 percent of the capital and surplus. The bill further requires the corporation to furnish assurance to the superintendent that the performances of services will be subject to regulation and examination to the same extent as a bank.

SB 1495 - Chapter 1244 Way

Provides for a one-year extension of time for submitting plans and recommendations to * counties having special problems resulting from topography and isolation on appeal to State Board of Education, for submission of such plans to include territory of all high school districts and unified districts in districts maintaining a junior college.

SB 1506 - Chapter 1245 Rodda Provides that plans of a county committee on school district organization for formation of a preliminary junior college district may require authorization of bonds in an amount sufficient to pay an equitable share of the cost of the property to be held by the largest junior college district in which it is to be included. The bill also provides that such preliminary junior college district shall, after inclusion in the larger, district continue to exist for the purpose of issuing and selling the bonds.

SB 1541 - Chapter 1246 Marler, Ray Johnson & Chappie Validates a particular unification of school district territory located in Placer, Sutter and Yuba Counties. This particular unification is the subject of litigation questioning the validity of election procedures undertaken in connection therewith. The bill requires a second election to be held on the unification proposal in November 1967.

AB 257 - Chapter 1247 Veysey Permits a school district governing board to select either March 30, 1964 or October 30, 1964 as the date to be used by the Superintendent of Public Instruction in computing a portion of the second principal apportionment for the current fiscal year.

AB 373 - Chapter 1248 Russell

Amends the existing law that authorizes local agencies to contract with private developers for reimbursement of the added construction costs of water, sewage and drainage facilities which are adequate to serve land that does not belong to the developers. The bill also amends a provision that requires payment of fees by subdividers to build these local improvements.

AB 395 - Chapter 1249 Cory

Broadens definition of "degree", for purposes of California teaching credential, to include any degree granted by a foreign institution of higher learning which is equivalent to an American degree meeting the requirements for a California teaching credential, as determined by the State Board of Education.

AB 464 - Chapter 1250 Moretti

Requires school districts having merit systems for classified personnel to provide, rather than only an open competitive examination, an open competitive examination and a promotional examination for positions of business manager and certain positions in connection with budget preparation and interpretation or evaluation of equipment, material, and housing, and of school information.

AB 557 - Chapter 1251 Chappie

Authorizes the Director of Parks and Recreation, with the consent of the Director of General Services, and subject to the final approval of the Legislature, to divest the state of all its rights, title, interest, and obligations in or to Squaw Valley State Recreation Area.

AB 582 - Chapter 1252 Z'berg

Requires a certificate of zoning compliance, or a date stamped application, before a permit for an advertising display will be issued by the Department of Public Works, if the local governing board so resolves. The bill is intended to insure that applicants for State outdoor advertising permits comply with local zoning ordinances.

AB 659 - Chapter 1253 Milias Defines the breaks in state employment as "permanent separation" or "temporary separation". The bill makes medical termination a temporary separation for purposes of continuity of service.

AB 664 - Chapter 1254 Monagan Provides that procedure for determining fraction of time spent by various certificated and classified employees on special education programs are to be in accordance with California School Accounting Manual and repeals present procedure.

AB 730 - Chapter 1255 Bagley & Deukmejian Permits a city or county to create, by ordinance, a commission on human relations.

AB 764 - Chapter 1256 Zenovich & Dolwig Creates an Automobile Accident Study Commission. The bill directs the commission to study automobile accidents, common law tort liability systems, as modified by statute, including related insurance, motor vehicle and procedural laws bearing both on the prevention and consequences of automobile accidents and to make suggestions for improvement thereon. The bill also appropriates \$5,000 from the Motor Vehicle Fund for the expenses of the commission. It permits the commission to accept contributions from public or private groups for certain purposes established by the commission.

AB 889 - Chapter 1257 Barnes & Schrade Establishes procedures for the taxation of certain documented vessels with a port of documentation in California at 1 percent of full cash value.

AB 893 - Chapter 1258 Burke Permits counties with tabulating equipment to maintain an alphabetical index of voter registration in addition to an index of voters by street address.

AB 1004 - Chapter 1259 Bagley

Declares that no provisions of the Code of Civil procedure, Probate Code, or Civil Code is intended to prohibit a minor from exercising an intelligent and knowing waiver of his constitutional rights under the Juvenile Court Law.

AB 1015 - Chapter 1260 Foran

Authorizes the California Highway Patrol to refuse to issue a license to an applicant for a motor vehicle pollution control device station or installer if the applicant does not meet minimum standards established by the Department.

AB 1023 - Chapter 1261 Moretti, Zenovich Limits the amount to be paid under a premium guarantee to be paid by members of an association of employers to their workmen's compensation insurer, to the amount of dividends due the association from the insurer.

AB 1052 - Chapter 1262 Foran

Permits fraternal fire insurers to institute a plan whereby they may reinsure all of their policies upon compliance with specified requirements.

AB 1079 - Chapter 1263 Knox Permits a school district to employ, under described circumstances, the spouse or child of a member of the governing board. These circumstances are that the position is one not requiring a credential and that the person is competent, is selected on a competitive basis, meets written qualification and is hired only as a limited term employee or a short term employee.

AB 1160 - Chapter 1264 Chappie

Creates the Folsom Lake Bridge Authority, including power to study feasibility of, and to construct, operate, and maintain, a toll bridge crossing of the upper arm of Folsom Lake. The Authority has power to issue revenue bonds secured by tolls and revenues of authority and to exercise power of eminent domain. The bill also authorizes any city, county, district of political subdivision of state to advance or contribute money to authority and to issue general obligation bonds to secure funds for such purposes.

AB 1170 - Chapter 1265 Deddeh & Bear Requires the entire highway which is superseded by relocation, rather than just the surface thereof, to be placed in a state of good repair prior to its relinquishment by the California Highway Commission to any city or county.

AB 1172 - Chapter 1266 Barnes & Collier Prevents adjustment of the state disability retirement allowance after the effective date of retirement, owing to a change in the Social Security disability allowance. This provision would facilitate stability in the state disability retirement benefit, and enable retired disabled members to experience higher disability benefits when there is an upward revision in the Federal Social Security benefit.

AB 1213 - Chapter 1267 Brathwaite

Authorizes the juvenile court to detain a minor believed to be mentally ill, or whose mental health is in doubt prior to, as well as during, a hearing on juvenile court petition and broadens the classes of hospitals in which such minor may be held.


AB 1300 - Chapter 1268 Foran

Defines term "safety glazing material" and requires that vehicles be equipped with safety glazing material, rather than "safety glass".

CHAPTER____

An act to add Section 25 to the Business and Professions Code, relating to disciplinary action against licentiates.

The people of the State of California do enact as follows:

Section 1. Section 25 is added to the Business and Professions Code, to read:

25. Whenever any licentiate, his agent, or employee is prosecuted for a public offense defined in this code and is found not guilty thereof, no proceeding to inflict any disciplinary action upon the licentiate, including, but not limited to, the suspension or revocation of his license, or other such authority, based on the same charge or charges alleged in the criminal action against said licentiate, his agent, or employee, shall be commenced or maintained by the board or other agency issuing the license or other authority.

This section does not apply to any person licensed as a dentist pursuant to Chapter 4 (commencing with Section 1600) of Division 2, as a physician and surgeon pursuant to Chapter 5 (commencing with Section 2000) of Division 2, as a veterinarian pursuant to Chapter 11 (commencing with Section 4800) of Division 2, or as an attorney pursuant to Chapter 4

(commencing with Section 6000) of Division 3.

Lenate Bill No. 95 provides that whenever any licensee, his agent, or his employee is prosecuted for a public offense defined in the Business and Professions Code and is found not guilty, no proceeding to inflict any disciplinary action upon the licensee, based on the same charge alleged in the criminal complaint, shall be commenced or maintained by the board or agency issuing the license or other such authority. The bill excludes from its provisions dentists licensed pursuant to the Dental Practice Act, physicians and surgeons licensed pursuant to the State Medical Practice Act and veterinarians licensed pursuant to the State Bar Act from provision.

The Attorney General and Legislative Counsel have no constitutional or legal objections to approval.

The California Retail Liquor Dealers Institute urges that the bill be approved. The Retail Liquor Dealers assert that the present law permits licensees to be treated in a harsh and unreasonable manner.

Several letters and telegrams have been received which urge that the bill be signed.

The Transportation AGency and the Department of Alcoholic Beverage Control and the Division of Corporations urge veto.

Ed Meese urges that the bill be vetoed.

The League of California Cities urges veto.

The Attorney General recommends that the bill be vetoed. The bill proposes a radical departure from the longstanding law of this State which has recognized a difference between criminal proceedings and administrative disciplinary actions against licensees of the State. This departure may weaken the protection to the public afforded by the State licensing statutes.

Criminal proceedings have as their goal direct punishment of the individual for his wrongdoing against the people of the State. Conviction may affect the liberty of the accused and the criminal record can follow him into every facet of his life. Thus it is required that evidence of guilt be proven "beyond a reasonable doubt" and to "a moral certainty."

Administrative disciplinary action is not directed, as such, against an individual, but rather is against his license. A license, in the first instance, is a privilege granted conditionally by a governmental agency to engage in a specific activity.

In connection with licenses issued by the Department of Alcoholic Beverage Control, this bill would limit the authority of the Department to suspend or revoke a license in some cases. Since the California Constitution places authority in the Department to discipline licensees, a serious question arises as to whether this bill conflicts with such constitutional provisions (art. XX, §22, Const.).

Finally, certain licentiates, such as dentists, doctors, lawyers, veterinarians, are specifically excluded from the provisions of this bill. In other words, a chiropractor, architect, engineer, nurse, contractor, etc., may not be disciplined after a not guilty criminal trial, but a dentist, doctor, lawyer, or veterinarian may be so disciplined. It is likely that doctors, lawyers, dentists and veterinarians excepted from the provisions of this bill will raise additional constitutional questions by arguing that they have been unfairly discriminated against and that the law violates the equal protection guarantees of both the Federal and California Constitutions.

An act to add Section 6768 to the Business and Professions Code, relating to engineering.

The people of the State of California do enact as follows:

Section 1. Section 6768 is added to the Business and Pro-

fessions Code, to read:

6768. The board shall register without examination in that branch of engineering designated as metallurgical engineering any applicant who applies prior to June 30, 1966, and who meets all of the following qualifications:

(a) Is over the age of 21 years and has been a resident of

this state for at least five years.

(b) Has received an engineering degree from an accredited college or university located in the United States.

(c) Has one of the following:

(1) Holds a valid registration in California in another branch of engineering; for at least five years has taught engineering courses at college or university level, including courses concerned with the atomic and molecular structures of metals, alloys, semiconductors, insulators, and other materials; is presently a professor of engineering in a California state college and a senior instructor in nuclear power engineering at a U.S. naval officers' school; has done research in aspects of metallurgical engineering such as the strength of metals and materials, structures, weights, thermal properties, reactions,

forming processes, and fabricating.

(2) Has had at least 10 years' experience in a position requiring a knowledge of the various furnaces used in metallurgical processes, including such factors as emissions from the metallurgical industry operations that may be generated from metal melting, refining and pouring, molding, core baking, grinding, polishing, fabricating, plating and heat treating. Has directed programs that include technical studies calling for the collection of data and extensive knowledge of a wide field of metallurgical and filtering equipment varying from high velocity multijet scrubbers to an evaporative cooler, to complex furnaces; every type and design of metallurgical equipment in use today is thoroughly studied, necessitating a knowledge of metallurgy in its most basic form; these include such furnaces and operations as aluminum chlorination, aluminum melting crucible furnaces, aluminum reverberatory furnaces, aluminum

sweating furnaces, brass melting crucible furnaces, brass pouring, brass melting electric furnaces, brass melting reverberatory furnaces, brass melting rotary furnaces, iron melting cupola furnaces, iron melting electric induction furnaces, iron melting reverberatory furnaces, lead melting cupola furnaces, lead melting pot furnaces, lead melting reverberatory and smelting furnaces, magnesium melting furnaces, electric arc steel and iron melting furnaces, electric induction steel melting furnaces, open hearth steel melting furnaces, zinc galvanizing kettles, zinc calcine processing kilns, zinc pouring furnaces, zinc sweating furnaces, heat treating furnaces, foundry sand handling systems, core ovens, shell core machines, wax burnout ovens, tungsten carbide melting furnaces, zirconium melting furnaces, titanium melting furnaces, gold and silver reclaiming furnaces, tin reclaiming equipment, abrasive blasting, virgin zinc reclaiming furnaces and brass melting cupola furnaces.

Greetings:

I am returning without my mignature Senate Mill Mo. 1344, Am act to add Saction 6760 to the Susiness and Professions Code, relating to engineering."

This measure requires the State Board of Registration for Civil and Professional Engineers to register without examination in metallurgical engineering any applicant who applies prior to June 30, 1966, and who meets specified qualifications.

Legislation acacted in 1965 added metalluration amelicaning to the Catacoriae of ancimenting subject to registration by the Board of Registration for Civil and Parferminal Engineers. It provided that persons who applied priof to June 30, 1966, and who but qualifications prescribed by the Board could obtain registration without examination. I understand that two individuals filed timely applications but were decided registration without examination on the ground that they did not possess the required experience in metallurations are the required experience in metallurations.

It is not in the intent of orderly and equitable administration of the engineer registration program to selectively lower standards as was done in this case. If an applicant feels that the Scard of Registration has made a mistake in evaluation his engineering background, he can request a hearing under the Administrative Procedures Act. If there is an adverse ruling, an appeal can be made to the courts.

Accordingly, I am returning this bill unsigned.

Senate Bill No. 1344 requires the State Board of Registration for Civil and Professional Engineers to register without examination in metal-lurgical engineering any applicant who applies prior to June 30, 1966, and who meets specified qualifications.

The Legislative Counsel has no constitutional or legal objections to approval.

The Attorney General points out that the bill is to enable two specific individuals to become registered without examination as metallurgical engineers. It is our understanding that the Board of Registration for Civil and Professional Engineers previously refused to grant registration to these two individuals having determined that they did not meet the requirements of the Civil and Professional Engineer Act.

Article IV, section 16 of the California Constitution provides that a local or specific statute is invalid in any case if a general statute can be made applicable. Although phrased in general terms, this statute is subject to the claim thattit is special legislation.

The California Council of Civil Engineers and Land Surveyors urge veto.

The Department of P & V Standards recommends signature with some reservation. The Board of Registration for Civil and Professional Engineers requests veto.

Senators Song and Burns, the author, requests approval. They point out that the measure is intended to accommodate two persons only - one a close friend of Senator Song, the other a close friend of Senator Burns.
