Dear Mr. Kuhnmuensch:

Thank you for your recent letter inquiring about the Administration's position on the House and Senate omnibus trade bills, particularly the Gephardt amendment. I understand that Ambassador Clayton Yeutter, the U.S. Trade Representative, already has provided you a detailed description of the Administration's major concerns with these bills. Therefore, I will simply summarize our position at this point.

We have a number of problems with provisions in H.R. 3, the bill passed by the House of Representatives. These include: sweeping transfers of authority from the President to the U.S. Trade Representative under various trade remedies; reduced Presidential discretion and mandatory retaliation under some trade remedies; amendments to the antidumping and countervailing duty laws that violate our international obligations; some sectoral schemes (such as for telecommunications); disclosure requirements for foreign investment in the U.S.; a requirement for currency negotiations and intervention in currency markets; denial of primary dealer status to foreign securities dealers; one billion dollars in increased subsidies for agricultural exports; a requirement to establish guidelines for debt relief; and the establishment of a new international debt facility.

We also have concerns about the bill approved recently by the Senate Finance Committee. For example, S. 490 fails to provide traditional tariff proclamation authority for the Uruguay Round of multilateral trade negotiations; drastically reduces the President's discretion under the "escape clause"; mandates retaliation more broadly in more types of unfair trade cases under Section 301 of the Trade Act of 1974 than does H.R. 3; requires the imposition of an import fee to fund Trade Adjustment Assistance; and establishes a quota/voluntary restraint agreement scheme for lamb imports.

The House has already passed H.R. 3, and S. 490 is unlikely to be improved significantly on the Senate floor. However, the President continues to hope that trade legislation can be made constructive and responsible in the House-Senate conference following Senate passage of an omnibus trade bill.

Dear Brent:

Thank you for your letter, written on behalf of NCPAC's 450,000 members, concerning the participation of the United States as amicus curiae in urging the Supreme Court to grant certiorari in Beck v. Communications Workers of America. Although your letter did not arrive until after the Solicitor General filed his amicus brief on April 30, 1987, the information that you provided, and the strength of your views, will be helpful in deciding whether -- and if so, how -- the Administration should participate when the case is briefed on the merits. As you know, the Supreme Court granted certiorari in this case on June 1, 1987, the date of your letter.

While the use of compulsory dues and fees for partisan political purposes is central to Beck, the issues raised in this case are many -- involving the Administration's commitment to strict construction of the Constitution, limitation of the concept of "state action" for purposes of constitutional redress, and careful adherence to Federal statutes and the intent of Congress in passing them. As a result, the decision made by the Justice Department at the certiorari stage was a difficult one. Notwithstanding the surface appearance of the Administration's amicus filing in Beck, however, you may rest assured that the President remains firmly committed to the Republican Party's platform planks, in both 1980 and 1984, opposing the use of compulsory dues and fees for political purposes.

I welcome your further thoughts on this subject prior to the Administration's decision whether to participate as amicus in this case when it is briefed during the Supreme Court's next term.

Dear Mr. Ambassador:

Thank you for your letter of May 18 expressing your concerns about the recently introduced Textile and Apparel Trade Act of 1987.

The President is vigorously opposed to this legislation and the Administration is working hard to prevent its passage. As you can see from the enclosed letter, the United States Trade Representative and the Secretary of Commerce have already contacted undecided Members of Congress urging them not to support it.

We are deeply concerned that passage of this legislation would mandate actions that would breach United States obligations under the General Agreement on Tariffs and Trade (GATT), the Multifiber Arrangement (MFA), as well as our bilateral agreements. We also share your concern with the potential damage to the Uruguay Round.

We are well aware of the effect this legislation could have on Turkey. Please be assured that we will continue our vigorous efforts to oppose this bill and will convey your concerns to the rest of the Administration and Congress alike.
