The word is out that because of your new position you will not be running for President. This is disheartening. This is a mistake. I believe we can "have our cake and eat it too".


Your new job is going to take at least 200% of your time - I think you can take that handicap and turn it into the most dynamic "position" in which to run for President of the United States





President Reagan names Vern McCarthy
to Highway Safety Advisory Committee

OAK BROOK, IL (8 Jan. 1986)--President Ronald W. Reagan has announced the appointment of Vern I. McCarthy, Jr., Oak Brook, Illinois, to the National Highway Safety Advisory Committee, U.S. Department of Transportation, Washington, D.C. for a three-year term.

The National Highway Safety Advisory Committee, numbering thirty-five, was created to communicate public concern with national highway safety to the National Highway Traffic Safety Administration, Department of Transportation. Committee members represent Federal officers, State and local legislators, associations and organizations affected by highway safety, safety research groups and the general public.

Appointment to a federal advisory committee is an authority that rests with the President under an Act of Congress. Federal advisory committees, referred to as the 'fourth arm of government,' provide advice, counsel and recommendations on matters directly related to the activities of various federal agencies. Secretary

of Transportation Elizabeth Hanford Dole will swear in the newly appointed committee members in early 1986.

McCarthy, former owner of Vulcan Containers, a manufacturer of chemical shipping containers, has previously served as an officer and director of numerous chemical, container, hazardous materials and packaging associations. He is a member of the National Defense Executive Reserve, Federal Emergency Management Agency, Washington, and at one time was a consultant in the U.S. Department of Commerce, Washington. In 1984 he founded the Mid America Institute for Public Policy Research as the first free market "think tank" in the Chicago area. The Institute engages academics and scholars to critique proposed or enacted legislation and regulations.

McCarthy has been an officer and director of the Bank of Bellwood and Westlake Community Hospital, Melrose Park, Illinois. Now President of Vern McCarthy, Ltd., he has resided with his wife and family in Oak Brook since 1968.


