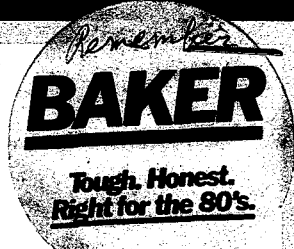

New chief of staff takes on job at personal cost, national gain

WHY would Howard Baker give up a \$1 million-a-year law practice and a chance to run for president to replace the discredited Donald Regan as chief of staff in the scandal-shaken White House?

The answer has to be a combination of old-fashioned patriotism and loyalty to the Republican Party, because the former senator from Tennessee is taking on a job for which the word "unenviable" is an understatement.

Baker will have to deal with a forgetful, lame-duck president; a first lady powerful enough to have got Regan's scalp; investigations of the Iran-Contra affair that threaten to go on indefinitely and produce more damage; a White House staff that needs rebuilding; and foreign and domestic crises that inevitably will erupt.

However, Baker has valuable attributes that Regan, an arrogant and vain Wall Street millionaire, sorely lacked. He knows his way through the political minefields, which is essential in the aftermath of the president's misguided Iran initiative. He is trusted by Congress, which was skeptical of Regan.

As a senator from 1967 to 1985 and as minority and majority leader, Baker earned a reputation for common sense

and good judgment, qualities much needed by an administration that thought it was clever to trade arms for hostages, while proclaiming "no deals with terrorists" and "no guns for the ayatollahs."

Baker had been considering a run for the 1988 GOP nomination, which he cannot do while cleaning up the White House mess and serving in effect as acting president. His departure from the field most helps Sen. Bob Dole, since they both are centrist, competent and experienced, and thus appeal to the same constituencies.

President Reagan should be grateful that Baker has signed on, but shouldn't be complacent. The sensible Tennessean can assist Reagan with sound advice, if it is accepted, but only the chief executive himself can save the rest of his term from irrelevancy. He must be more alert and less passive to succeed in putting Irangate behind him.

Though well known in Tennessee and the Congress, Baker only became a national figure during the televised Watergate hearings with his famous line: "What did the president know, and when did he know it?" Ironically, that may be the last question he would want asked of Reagan today.

Thank you for your recent encouragement and expression of support.


After careful consideration, I have decided not to seek election to a fourth term as a United States Senator from Tennessee. It has been the greatest honor of my life to serve the people of Tennessee in the Senate. My debt to my fellow Tennesseans is immeasurable and one I could not hope to repay no matter how long or well I might try to serve them.

It has long been my personal conviction that, for me, service in the Senate would not and should not be a lifetime career. I have often spoken of my desire to see the Congress function as a citizen legislature in which men and women from many walks of life serve for a time without severing all ties to the places and callings they are elected to represent. Acting on this belief, I have resolved to leave the Senate at the conclusion of my term in December, 1984. Until that time, I will continue to do the best I possibly can to represent my state and her people.

It is my belief and my hope that President Reagan will seek reelection in 1984. I have urged him to do so and intend to support him. However, I also intend to stay active in Republican and public affairs.

In that regard, I am hopeful our paths will cross again and I once more thank you for your thoughtfulness.
