BACKGROUND: In an effort to come up with a quick solution to filling this vacancy, the Office of Presidential Personnel, in addition to reviewing its EPA candidate files, consulted with CEQ Members (Hill, Minor, Maloley), OPD staff (Boggs and Smith), OMB staff (Khedouri and DeMuth), the Vice President's Office (Boyden Gray), and EPA Administrator Ann Gorsuch. Several good suggestions have been forthcoming and other sources have offered suggestions, as well.

CAVEATS: Some "near-consensus" names developed from the review described above. These would seem to be "safe" names to go with, although we would caution against a quick announcement based solely on an FBI name check. If our candidate gets derailed in the comprehensive clearance process we may end up exacerbating an already messy situation. In addition, there are a couple of other pretty good names that have been brought to our attention that require a more thorough screening. Remember Murphy's Law!

We corresponded in the Spring of 1982 regarding an appointment in the Reagan administration. I would like to more fully respond to your last inquiry and to express particular interest in the position recently vacated by Rita Lavelle, or in any other suitable position.

The EPA program for hazardous waste has been essentially a good one, but neither the agency nor the administration has received its fair share of credit, in large part because of the general distrust which your key personnel faced from various members of Congress and the national environmental organizations. I spoke briefly with Marty Smith this morning about a person I know very well and would recommend highly as a candidate to fill this important position, Don Elliott. At Marty's suggestion, I am sending you some essential information about Don. I subsequently called Don, determined that he is very interested and probably could be available fairly soon.

Don Elliott is currently Associate Professor of Law at the Yale Law School. He teaches courses in environmental law, toxic chemicals, and complex civil litigation.
