SUBJECT: Summary of Decisions -- Meeting of the President's Federal Judicial Selections Committee -- December 20, 1984

Summarized below are the decisions reached in the December 20, 1984 meeting of the President's Federal Judicial Selections Committee. Our next meeting will be at 5:00 p.m. Thursday, January 3, 1985 in the Roosevelt Room.

I. DISTRICT COURTS

A. District of New Jersey: The nomination of Joseph Rodriguez will be resubmitted to the Senate on January 3, 1985.

B. <u>District of Montana</u>: B. Oglesby is to ascertain Congressman Marlenee's views on a selection of Judge Jack Shanstrom as the candidate for nomination to this position. Upon receipt of Oglesby's report, Fred Fielding will circulate a decision memorandum on this appointment.

C. Eastern District of North Carolina: The Justice Department is to advise Senator Helms that U.S. Attorney Samuel Currin will not be selected as the candidate for nomination to fill this vacancy, and will seek new recommendations from Senators Helms and East.

D. <u>Claims Court</u>: The background investigations will be initiated on Loren Smith as a candidate to fill one of the vacancies on this court. Candidates for the remaining vacancy will be discussed January 3.

E. <u>Eastern District of Virginia</u>: The background investigations will be initiated on Claude M. Hilton as the candidate for nomination to this position. B. Oglesby will advise Senator Trible that Christine Perdue will be interviewed by Justice for consideration for a future vacancy.

II. COURTS OF APPEAL

A. <u>Third Circuit</u>: Judge Carol Los Mansmann will be nominated to fill one of the two vacancies on this court. Justice will present its evaluation of Judge Walter K. Stapleton as a candidate for appointment to the other vacancy on this court at our next meeting.

B. <u>D.C. Circuit</u>: Discussion of candidates for nomination to the remaining vacancy on this court will continue at our next meeting.

C. <u>Seventh Circuit</u>: The background investigations will be initiated on Kenneth Ripple and Dean William Harvey as candidates for nomination to the two vacancies on this court.

D. <u>Tenth Circuit</u>: The background investigations will be initiated on Stephen Williams as the candidate for nomination to fill one of the vacancies on this court.

E. <u>Ninth Circuit</u>: The background investigations will be initiated on Judge Alex Kozinski as a candidate for nomination to one of the three remaining vacancies on this court.

- SUBJECT: Recommendation for U.S. District Court for the Western District of Washington

The Justice Department has recommended the immediate initiation of the necessary background investigations on Washington State Justice Carolyn R. Dimmick as the candidate for nomination to the U.S. District Court for the Western District of Washington. The immediacy of this recommendation is based on the fact that Senator Gorton has arranged with Justice Dimmick that she will resign her seat on the Washington Supreme Court in time for outgoing Governor Spellman to appoint her successor if the Administration can assure her that she will be appointed to the Federal district court.

As noted in the agenda materials for the upcoming judicial selection committee meeting (attached), Justice Dimmick's extensive experience as a trial lawyer and as both a trial judge and an appellate judge make her clearly qualified for a position on the district court. Moreover, Justice has reported that "all questions raised last year (when she was under consideration for the Ninth Circuit) regarding her philosophy on issues of criminal justice have been resolved to [its] satisfaction." Indeed, Justice states that prosecutors and conservatives describe Justice Dimmick as the "most pro-lawenforcement justice on a generally liberal court", and that a review of her recent opinions confirms that description. Of her 24 criminal law opinions (including 15 dissents), 21 supported upholding convictions. Justice also notes that her three majority opinions overturning convictions were "consistent with this Administration's philosophy."

RECOMMENDATION: That we initiate the background investigations on Justice Carolyn Dimmick as the candidate for appointment to the U.S. District Court for the Western District of Washington as soon as possible.

Please advise my office immediately if you have any objections to this recommendation.

U.S. DISTRICT COURT FOR THE WESTERN DISTRICT OF WASHINGTON

Senator Gorton has recommended three candidates -- Carolyn R. Dimmick, Robert J. Bryan, and Alan A. McDonald -- for the three district court vacancies in Washington state. While Justice has not completed its review of Bryan and McDonald, it is familiar with Justice Dimmick, who was considered for the Ninth Circuit last year. Also, Senator Gorton is concerned that we move quickly on Justice Dimmick, who has agreed to resign from the Washington Supreme Court before her Federal appointment so that outgoing Governor Spellman can appoint her replacement.

As an experienced trial attorney, prosecutor, trial judge, and state Supreme Court justice, there is no question about Justice Dimmick's qualifications for the district court. She is strongly praised by the state Attorney General, the U.S. Attorneys, and Judge Beezer, our recent appointee to the Ninth Circuit, for her judicial opinions. She was described as a rational voice on a liberal court. In particular, she is regarded as a "bulwark of conservatism" on criminal justice issues and a strong voice against the liberal trends of the Washington Supreme Court. A review of some of her recent opinions clearly demonstrates her conservative approach to criminal law and procedure.

Therefore, Justice recommends that we proceed immediately with the background investigations on Justice Dimmick.

SUBJECT: Exemption from Prohibition Against the Use of Alcoholic Beverages on Federal Property

Part 101-20.307 of the Federal Property Management Regulations (41 C.F.R. § 101-20.307) provides that "[t]he use of alcoholic beverages on [Federal] property is prohibited except, upon occasions and on property upon which the head of the responsible agency or his or her designee has for appropriate official uses granted an exemption in writing." The appropriate building manager is to be notified of all exemptions.

The Counsel's Office has scheduled its fourth annual Christmas Party for Tuesday, December 18, 1984, from 5:00 to 7:00 p.m., in the Indian Treaty Room of the Old Executive Office Building. Accordingly, we request that, consistent with your decisions on this issue in 1981, 1982 and 1983, you sign the attached memorandum granting, for this occasion, an exemption from the alcoholic beverage prohibition. OEOB Building Manager Charles B. Respass is copied on the memorandum.

State Legislative Races

Of the 99 chambers in the country, 26 are held by Republicans and 73 by Democrats. Most are up for election this year and profiled below are some of the states where control of a chamber may change as a result of the November election.

Best Case: Gain of 8 Chambers Worst Case: Loss of 4 Chambers Probable: Gain of 3 Chambers

Possible Republican Takeovers

Connecticut

Republican control of both chambers is possible if the President runs very well in Connecticut. The House (87D-64R) is a better shot for control than the Senate (23D-13R) due to the urban dominance in key Senate races.

Delaware

Republican control of the House (24D-17R) is very possible depending on how well the President, Castle and DuPont run. The Senate (13D-8R) could change but is considered less likely.

Iowa

It is likely that the <u>Senate</u> (24D-22R) will be taken over by the Republicans but that, despite gains, the House will remain Democratic.

Illinois

Republicans are four seats short of control in the <u>Senate</u> (33D-26R) and there is a chance that with strong showings around Cook County, the Republicans could take control. The House is out of reach.

Michigan

The House (55D-45R) is within reach and an anti-tax referendum on the ballot should help. The Senate (26R-24D) is not up this year.

Nevada

The Assembly (23D-19R) stands a good chance of going Republican.

New Mexico

Senate (23D-19R) control is possible given the strong showing of the President and Senator Domenici, but not likely.

North Dakota

The House (55D-51R) is likely to return to Republican control but the Senate (31R-20D) could slip back to the Democrats.

Ohio

The Senate (17D-16R) is considered a toss-up, but given the President's visit to Cleveland, coat-tailing could do it.

Pennsylvania

The House (104D-99R) is a likely target for Republican takeover with the Senate (27R-23D) being retained.

Washington

The House (53D-45R) looks good for returning to Republican control but the Senate (26D-23R) is less likely.

Wisconsin

The Senate (19D-14R) is certainly within reach, the House (59D-40R) is not.

Possible Democratic Takeovers

Alaska

The <u>Senate</u> (11R-9D) could be vulnerable but the House (21R-19D) should be secure.

Montana

The Senate (26R-24D) is vulnerable in view of the number of Republican incumbents not seeking re-election, but retention is probable.

New York

Despite a tough race, Republicans are looking good to back the Senate (35R-26D).

Vermont

The Senate (17R-13D) is vulnerable but the House is probably not (83R-65D).

A Labor Day of Change

According to economic theory, the three factors of production are resources, capital and labor. The resources are the raw material from which things are manufactured, the capital is the investment in plant and equipment, and labor is the human element which brings it all to life.

Labor is the millions of men and women who hold down jobs, and on this Labor Day there are about S million more Americans in that category than ever before in our nation's history.

Even as the total of Americans at work reaches new heights, the power of organized labor — both in the workplace and on the national political scene — is on the wane. Less than 20 percent of the work force now belongs to unions, and the percentage continues to drop? Further, those workers who do belong are showing ever-increasing political independence. In the 1950s, a union endorsement was usually worth about 70 percent of the union vote. In 1968, Hubert Humphrey got only 36 percent of

the union vote despite being heavily supported by the leadership.

President Reagan was strongly opposed by organized labor, yet almost half of the rank and file voted for him anyway.

Labor's leadership isn't as monolithic as it once was. The scandal-tainted Teamsters Union broke with the other unions in 1980 to endorse Reagan. It repeated this year, allegedly as the result of a "deal" with the White House of the endorsement in exchange for an end to the incumbency of Donald L. Dotson as chairman of the National Labor Relations Board.

Also hovering in the background is a scieral investigation of Teamsters Chief Jackie Presser in connection with ghost payroll allegations. Presser has been linked in sworn testimony to the Clevel and family of La Cosa Nostra. His endorsement is eagerly embraced by the Reagan-Bush team nonetheless.

The image of organized labor in the 1970s and early '80s has been one of too much power and — in the case of the Teamsters and Culinary Workers Union — too many reports of corruption.

Even the clean unions were largely perceived to be

When President Reagan wiped out the Professional Air Traffic Controllers Organization in response to an illegal strike, PATCO sought public sympathy near and far. Public opinion went the other way however, and that union died for its sins.

Union workers from airlines to bus lines were obliged to take pay cuts to protect jobs and union contracts in negotiations undertaken in the recession-size of and deregulated marketplace of the early Reagan years.

It hasn't changed with better economic times. For Motor Co. and General Motors have had the audacity to make an opening proposal of no hike in base pay a they began contract negotiations in the aftermath o the most profitable year in Detroit history.

Spokesmen for the postal unions are more mea sured in tone.

Even so, he who counts out the organized labor movement on the basis of today's position of the pendulum does so at the danger of getting bowled over on the next swing.

Organized labor is suffering from the excesses of the past — and from the fruits of its own success Wages are higher, workplaces are safer and worker have more rights in today's mixing of the factors of production.

Today's new worker can logically ask why h should undertake the expense of union membershi when all the battles have already been won.

Today's population at large, basking in an econom ic recovery so far amazingly free of inflation, wi look askance at any union wage demands deemed t be potentially inflationary.

Today's visionaries in organized labor are lookin beyond the narrow wage and fringe benefit battles o old to a lower-key and more complex round o labor-management relations.

Questions of job security, worker retraining an product quality are competing with the short-tern economic concerns of old.

Like all vital human institutions, organized labo will change and evolve to meet the needs of the changing economy.

The growing strength of big business riding the coattails of the Republican administration Washington will help in reforming both organized labor and public opinion.

Through it all, the workers themselves — by far the largest voting bloc in America — will form the mainstream political and social opinion of the natio

Union leaders, businessmen and political leade all recognize that, and their actions are large governed by it.

SUBJECT: Use of the Presidential Seal and the President's Name in NRCC Fundraising Letters

This will respond to your request for a summary of the positions we have taken in regard to the permissible uses of the Presidential Seal and the President's name in political fundraising letters.

Federal law prohibits the knowing manufacture, reproduction and sale of any facsimile of the Seal of the President of the United States except in those specific instances authorized by Federal statute or by the Counsel to the President. 18 U.S.C. § 713 and Executive Order No. 11649 (1972). Neither 18 U.S.C. § 713 or Executive Order No. 11649 authorize the use of the Presidential Seal (or the Great Seal of the United States) in political fundraising letters.

Despite the above statutory restrictions, the question of the use of the Presidential Seal in political fundraising letters has been raised on numerous occasions by the various Republican Party committees. Because of these inquiries, there have been discussions between my office and the Department of Justice on what is considered a "facsimile" of the Presidential Seal under 18 U.S.C. § 713. Justice advises that use of any part of the Presidential Seal, including the eagle pictured in the Great Seal (which is virtually identical to the eagle in the Presidential Seal), in a political fundraising letter raises serious questions under the current law, 18 U.S.C. § 713, and that such uses were ill-advised.

Given the Justice Department position on this matter, it has been our consistent policy to refuse to grant permission for use of the Presidential Seal, or any likeness thereof, including the use of the eagle pictured in the Great Seal, in any political fundraising letters involving Presidential participation.

As you are aware, it is a matter of longstanding policy, in this and previous Administrations, to refuse to permit the use of the President's name in support of various charitable or other organizations, regardless of their merits, unless his 14

participation is a matter of historical precedent or the entity is one in which he is personally involved. Consistent with this policy, we have maintained a practice of requiring prior approval by appropriate White House officials of any political fundraising letters invoking the President's name, signature or likeness in support of any political activity.

Dear Guy:

Following our meeting on Friday, September 14, I requested Fred Fielding to provide me with a memorandum setting forth our policy regarding uses of the Presidential Seal and the President's name in political fundraising letters. A copy of that memorandum is enclosed for your information. Please note that, pursuant to statutory prohibitions, we have consistently denied permission to use the Presidential Seal, or any facsimile thereof (including the eagle in the Great Seal, which, according to the Department of Justice constitutes a "facsimile" of the Presidential Seal), in any political fundraising letters involving Presidential participation.

In view of the above, and consistent with this Administration policy, I must request that the National Republican Congressional Committee refrain from using the Presidential Seal, or any likeness thereof, including the eagle depicted in the Great Seal, in any future fundraising letters involving Presidential participation. To do otherwise, is to place the President in the untenable position of participating in what has been determined by the Department of Justice to be a "misuse" of the Presidential Seal. Additionally, I would appreciate it if you would obtain prior White House approval of all NRCC fundraising efforts using the President's name, signature or likeness in support of a particular NRCC fundraising activity.

Thank you for your cooperation in this matter.
