It's time for me to return to the fold.

For the past six years I've been in the economic and political trenches: helping the private sector deal with government; finding support for candidates; and, most relevant, developing expertise in the field of international trade.

After service as Director of Congressional Affairs for GSA in the Ford Administration, I became Manager of Government Relations for Potlatch Corporation, handling their dealings with governments at all levels. In 1980, I founded The Washington Pacific Group, which is a public affairs firm with a strong specialty in Pacific Basin international trade development. My work has ranged from responsibility for countervailing duty cases to obtaining Export-Import Bank lending commitments; from trade development negotiations in Papua New Guinea and Yemen to helping U.S. companies with difficulties in Mexico, Syria, Japan and Korea.

Dear Mr. President:

I am writing to you to request your nomination of Mr. Robert J. Ludwiczak to fill the vacancy that will occur on the International Trade Commission in June.

I believe in Bob you have a unique candidate to fill this position who for ten years has served in trade legislative and administrative positions on both the House and Senate sides. More importantly, while growing up and working in the private sector in Pennsylvania, he gained the perspective of industry which he brought with him in joining the staff of a Member of Congress from Pennsylvania. ## PROFESSIONAL BACKGROUND

#### INTERNATIONAL TRADE LEGISLATIVE ASSISTANT...United States Senate Washington, D.C.

Served as the Senator's Legislative Assistant on the Finance Committee's Sub-Committee on International Trade. This position required the preparation of statements and questions for Senator during formal hearings in the committee. I drafted trade legislation in the committee as well as for introduction on the Senate floor for the Senator. This responsibility required my working with officials of the Executive Branch and private sector individuals to discuss pending legislation, work out compromises or introduce legislation in their behalf. The Federal Farm Credit Board was established by Public Law 92-181 of December 10, 1971.

The purpose of the Board is to assist in carrying out the provisions of the Farm Credit Act of 1971.

The Board is made up of not more than thirteen (13) Members:

- 1 Designated by the Secretary of Agriculture.
- 12 Not more than twelve (12) appointed by the President, one from each Farm Credit District, with the advice and consent of the Senate.

The Chairman and Vice Chairman are elected annually by the Board.

Current membership at TAB A.

The Board meets six (6) times a year. Members are paid \$100 each day and shall be reimbursed for necessary travel, subsistence, and other expenses.

On March 31, 1982, two (2) vacancies will occur due to the expiration of terms representing the Fourth and Tenth Districts (see map at TAB B.)

By statute, three organizations must make recommendations to the President for appointments to the Board: The Federal Land Bank Associations, the Product Credit Associations, and the Borrowing Cooperative Associations. The results of polls conducted in 1981 are attached at TAB C.

The Secretary of Agriculture and our office support the nominations of:

TOM H. CAROTHERS of Palestine, Texas (10th District) of the Federal Land Bank Association. He is active in agri-business and ranching. He has the strong support of Senator Tower.

LEONARD R. FOUTS of West Point, Indiana (4th District) from the Production Credit Association. He is also an active farmer in the area. He has the strong support of Senator Lugar.

While this office and the Secretary of Agriculture supports Leonard Fouts of Indiana to represent the 4th District, it should be noted that the Ohio Delegation strongly supports the appointment of Roger M. 



### A WOMEN'S PLACE IS IN THE ADMINISTRATION

by John S. Herrington Assistant to the President for Presidential Personnel

With the nomination of Geraldine Ferraro for Vice-President, the Democratic Party has moved to solidify female voters. The shock effect, however, won't last long and the American people will soon examine the records of both parties and will conclude that the actions of the Republican Party and President Ronald Reagan speak louder than the words of the Democrats.

Sometimes we forget that the Republican Party in 1896 was the first major political party to build an equal rights for women plank in their platform, and in 1916 the Republican Party again took an unprecedented step and went on record supporting voting rights for women. We also forget that it was a Republican controlled Congress which finally voted suffrage for women, and Margaret Chase Smith, Republican Senator from Maine, in 1964 was the first woman whose name was ever placed in nomination for President. The history of women and the Republican Party is one of partnership and progress.

In my position as director of all presidential appointment making, I can speak authoritatively on one matter of immense importance to the advancement of women, and that is the tremendous record President Reagan has made appointing women to high-level government posts. We are all aware of the President's superb appointment of Sandra Day O'Connor to the Supreme Court. The President often refers to that day as "one of his proudest," but it didn't start there.

The President demonstrated his commitment to excellence quickly following his election by selecting Jeane Kirkpatrick to serve as a member of his Cabinet. She is the first woman to serve as Ambassador to the United Nations and is a pioneer for women in the leadership of U.S. foreign policy. She has almost

single-handedly brought sanity and balance back to the UN assemblage. The Eastern Bloc and Third World countries have been put on notice that the U.S. will no longer be quiescent in the face of their advancement of totalitarian measures. In the aftermath of the shooting down of the Korean Airliner last year at the United Nations Special Session, Ambassador Kirkpatrick, in a moment not to be forgotten, played for the world to sit in judgement the actual tapes of the Russian fighter pilot zeroing in on his target of 269 innocent civilians. This was quite a turnabout from the usual UN double speak. The presentation of this evidence of the Soviet's barbaric act would have been quite improbable during the Carter Administration. Pundits might say that's because Carter had a mere man in charge at the UN.

The President's appointment of Elizabeth Dole as Secretary of Transportation broke more ground as she became the first woman to serve in this post. As Secretary of Transportation, Secretary Dole also became the first woman to head the Coast Guard, (a military service contingent). Hailing from North Carolina, she has represented women of the South with a fierce spirit of independence and resilience.

Margaret Heckler became President Reagan's third female Cabinet member after serving for eighteen years as a Member of Congress from Massachusetts. The budget of the Department of Health and Human Services is the third largest in the world - behind the entire U.S. budget and that of the USSR. Social Security, child care, the public health system and medical research are among the major programs under her responsibility.

In addition to these outstanding women, there are others equally qualified who serve as the heads of ten (10) major government agencies in the Reagan Administration: Nancy Steorts, Chairman of the Consumer Product Safety Commission; Janet Steiger, Chairman of the Postal Rate Commission; Lee Ann Elliott, Chairman of the Federal Election Commission; Rosemary Collyer, Chairman of the Federal Mine Safety and Health Review Commission; Susan M. Phillips, Chairman of the Commodity Futures Trading Commission; Susan E. Phillips, Director of the Institute of Museum Services; Barbara Mahone, Chairman of the Federal Labor Relations Authority; Loret Ruppe, Director of the Peace Corps; Helen Witt, Chairman, National Mediation Board; and Winifred Pizzano, Federal Co-Chairman Appalachian Regional Commission.

In addition to the above, the most striking part of President Reagan's record is the list of full-time important government positions he has filled where women never have served before in the history of our country:

Examples of other top-ranking women are legion and include: Martha Seger, Member of the Federal Reserve Board; Katherine Ortega, Treasurer of the United States; Aulana Peters, Member of the Securities and Exchange Commission; Mary Ann Dawson, Commissioner of the Federal Communications Commission; Patricia Diaz Dennis, Member, National Labor Relations Board, Paula Tennant, Commissioner, U.S. Parole Commission; and many ambassadors, and judges. On the President's own immediate senior staff at the White House, there are a dozen or so women in top policy-making positions.

Still other women who are successful and choose to remain in the private sector have been asked by President Reagan to serve on Advisory Boards and Commissions. Among these are: Anne Armstrong, Chairman of the President's Foreign Intelligence Advisory Board; Clare Boothe Luce, a member of PFIAB; Anna Chennault, Vice Chairman of the President's Export Council; Gloria Toote, Vice Chairman of the Advisory Council on Private Sector Initiatives; Ann Landers, the President's Commission on Drunk Driving; and Rita Ricardo-Campbell, National Council on the Humanities. The President has asked for and is receiving the expert guidance of these women and hundreds of others on advisory commissions.

All told, President Reagan has selected women for more than 1,600 important positions to date. The 1600 women include 169 uppermost level appointees who require Senate confirmation, over 200 in the Senior Executive Service (a non-career super grade with a base salary of \$59,223), more than 800 high-level Schedule C's (GS-13, \$36,327 per year, and above) and upwards of 400 members of part-time presidential advisory boards. In fact, among all Schedule C appointments fully 58 percent are women. In an earlier detailed study of Reagan's female appointments in comparison to those of the previous administration, it was found that in his first two years in office Reagan selected more women for top full-time, policy-making positions than Carter or any other President in history. Women are making it big in the Reagan Administration, and they are making it on merit. Their positions run the gamet, encompassing traditional and non-traditional areas, from international affairs and defense, to health care and education, to business and finance, to justice and They were selected not because of their sex, energy. but because they were the best person for the job. As the President recently stated in a speech to the American Bar Association:

"We aim for a cross-section of appointments that fully reflects the rich diversity and

talent of our people. But we do not, and will never, select individuals just because they are men or women, whites or blacks, Jews, Catholics, or whatever. I don't look at people as members of groups; I look at them as individuals and as Americans. I believe you rob people of their dignity and confidence when you impose quotas. The implicit, but false, message of quotas is that some people can't make it under the same rules that apply to everyone else."

I can vouch that the women who comprise the Reagan Administration appointees have made it under the same rules which apply to everyone else. They are extraordinarily capable in their own right and did not need a helping hand from a quota to be chosen.

Finally, I'd like to mention the women who have been chosen to serve in an unsung, seldom recognized yet greatly demanding role. These are the women of the Reagan Administration who are contributing their husbands to the service of their country, and who are led by Mrs. Ronald Reagan, surely one of the finest and most caring First Ladies to serve her country. The President's strong commitment to family values is reflected in his appreciation and gratitude to these women. They are among those giving the greatest contribution in support of the principles they accept and believe.

Ronald Reagan believes that the women of America are a great resource for this land. He has selected more to serve in critical positions than any previous President and he and the country benefit from their ability and commitment.
