PRESIDENTIAL TALKING POINTS: RESPONSE TO REAGAN-BUSH '84
ACTUALITY
October 31, 1984

Question: "President Reagan, the polls show you with a large lead. Would you please tell us why the election is not over yet and why people should work even harder now to turn out the vote?"

Suggested response:

-- I have always said that the election is not over until the polls close on November 6.

-- My opponent and I don't agree on much, but we do agree that polls don't vote, people do. And "President Dewey" cautioned me never to assume victory, so I keep campaigning as if I'm one point behind.

-- Remember that elections have been lost by one-half of one percent per precinct in this country. That's why our volunteers must continue their "turn out the vote" phone calls and letters this week.

-- We need to make a special effort to put our opportunity team in Congress.

-- Vice President Bush and I will not -- and should not -- rest until victory is achieved.

-- Please be sure to vote on November 6, and encourage your friends and neighbors to do the same. Together we can continue this course which has returned America to its greatness once again.

CAMPAIGN WORKERS
WEDNESDAY, OCTOBER 31, 1984

-- You are the "A Team." I am very proud of our campaign leadership, our staff and especially our tireless volunteers. You are dedicated people sacrificing your time for a cause.

-- I look around this room and I see young people. You in your 20s and 30s give me great confidence in the future of our Party as you play a new and major role in American public life.

I. PURPOSE

To show support and appreciation for the Democrat, Black, Hispanic, Jewish and Ethnic Groups for Reagan-Bush.

II. BACKGROUND

°Democrats for Reagan-Bush is organized in all 50 states. Its 17-member National Steering Committee is headed by former Washington Governor Dixy Lee Ray, and includes several former Democratic public officials. This group has communicated the Reagan-Bush message so effectively that they have garnered support from more than 25% of all Democrats.

°Organized in 36 states, Black Voters for Reagan-Bush has a very active speakers program and has distributed more than 100,000 pieces of literature through direct mail to key black spokesmen and potential supporters. Under the leadership of Mrs. LeGree Daniels, its National Steering Committee is a cross-section of leaders from the National Black Republican Council; the Council of 100; and persons who are party leaders within their state.

°Hispanics for Reagan-Bush, under the leadership of Tirso del Junco, is organized in 31 states, with county-level organizations active in such key states as California, Illinois, New York and Texas. Their goal is to win 45%-50% of the Hispanic vote nationwide. Spanish-speaking volunteers are manning phone banks in targeted states to get out the vote for the R-B ticket.

°Jewish Voters for Reagan-Bush, under the leadership of Dick Fox, has targeted the Jewish vote in key states. They also have set up extensive phone banks to identify the Jewish vote.

°Ethnics for Reagan-Bush has 55 organized outreach groups actively supporting the ticket, from Albanians to Vietnamese, with Byelorussians, Latvians, Filipinos, Ukrainians and several dozen other nationalities represented. Under the leadership of Michael Sotirhos, each ethnic group has a national and an honorary chairman.

I. PURPOSE

To discuss this Committee's request that the President consider an early endorsement of the Constitutional amendment that would provide the President with a single, six-year term. NOTE: I would suggest that you refrain from giving a definitive response to this Committee, though I am sure that you could state your thoughts generally, without making any commitment for or against.

II. BACKGROUND

The Committee for the Single Six-Year Presidential Term is now over two years old and has enlisted over 200 leaders in communities across the nation. This group plans to set the stage for a broad-based grass roots campaign if the President agrees to endorse their proposal and to put it before the public. Over 35 members of this committee had hoped to attend, but many were unable to travel to Washington due to the last minute scheduling of this meeting. Copies of Charley Bartlett's letters are attached, for your information.

JAB:

Never in the four years that I have worked for you have I spoken to so many "general citizens" on one subject. The debates have sparked a genuine concern in those who support the President so strongly and, as I mentioned in a previous note, your callers are from all over the country and from varying backgrounds and age groups.

Those outside of Washington are warning that "we in Washington are so close to the forest that we can't see through the trees."

The general theme of these callers is that they want the President to stick to themes and concepts, but to balance this with an informative approach that does not dwell on facts and statistics, but rather gives the clear impression of a President who is "on top of things."

These callers stress that the country does not know what a "verifiable treaty" is....and that they do not care how many nuclear war heads there are in a particular region....the general public wants to be assured that our nation will remain at peace....and if that means peace through strength, then fine....but, if it means that he has to call Mondale a liar, the President must convey this message to the people.

Some callers are warning the President not to try to "out Mondale" Walter Mondale. Remain Presidential and avoid his jabs. But, don't hesitate to point out Mondale's flaws, i.e. it took Walter Mondale 16 days to voice an opinion on Grenada -- just long enough to wait for the public opinion polls (as one caller suggests).

Re: arms control, one caller suggested the following response from the President: "An arms control agreement that cannot be verified is not a contribution to peace, it is a surrender to blackmail (or panic). This caller was from L.A. and said that Walter Mondale was campaigning there today and that he got a lot of mileage out of this arms control issue.

To summarize, the callers want the President to show that he is for peace...peace through strength; that he is a leader who is respected by our allies; that he is dedicated to achieving a world of peace, etc. etc.; and that he will not stoop to the level of Walter Mondale in this upcoming debate.

Mrs. Baker asked that you think about family, friends, etc., whom you think should be on your Inaugural ticket allocation list. The deadline for turning in names is the day after tomorrow (Wednesday, November 28) at 10:00 a.m. Margaret Tutwiler said that this is a STRICT AND INFLEXIBLE deadline.

Each "invitation" entitles the recipient to purchase 2 tickets. Your allocation includes:

- 3 invitations to the "Salute to the Vice President" on Friday, January 18. These tickets run \$75 - \$100 per person.
- 3 invitations to the "Presidential Inaugural Gala" on Saturday, January 19. These tickets run \$150, \$175, or \$200 per person (depends on seating area you prefer).
- 15 invitations to the Inaugural Ball on Monday, January 21. Tickets are \$125. per person.

Dear Mr. Pratt:

I am responding to the October 1984 cover letter to your Gun Owners of America September issue in which you state that President Reagan has "betrayed gun owners by nominating an anti-gun activist, Andrew Frey, to a judgeship in Washington, D.C."

I would like to point out that Andrew Frey's nomination to be an Associate Judge of the D.C. Court of Appeals resulted from a thorough search of potential candidates for this position by the Department of Justice and the White House. The recommendations and endorsements of a number of Members of Congress, leading members of the business community and individuals of high standing in the legal profession were taken into account.

The White House Judicial Meetings, to which you refer on page 3 of your September magazine, are attended by Ed Meese, Mike Deaver, myself, and a number of senior officials from the White House and the Department of Justice staffs. The attendees of this meeting jointly determine a recommendation for all judicial appointments that are sent forward to the President for his decision.

We feel that Andrew Frey is eminently well-qualified for this judicial appointment. For the last decade, Mr. Frey has been the federal government's chief advocate before the Supreme Court on criminal law matters. He has consistently and effectively taken conservative legal positions during his 12-year tenure, spanning several administrations, in the Office of the Solicitor General.

I know that you are aware of the President's position on gun control, as summarized in the attached copy of the 1980 Platform. Please be assured that President Reagan's nomination of Andrew Frey as Associate Judge of the D.C. Court of Appeals does not reflect a change in his position. Nor does it reflect any effort on my part, or on the part of any other member of this Administration, to undermine the President's stand on gun control.
