Dear Senator Kerry:

We have had an opportunity to review our records relating to your request as stated in your letters of January 25 to Colin Powell and February 5 and 17 to me for the declassification review of certain excerpts you identified from the notebooks apparently maintained by Lt. Col. Oliver L. North while he was a member of the National Security Council staff. As you may know, these documents were not available to us and therefore not included among the materials produced by the White House or NSC to the House and Senate Select Committees investigating the Iran/Contra matter. Rather, the documents were produced to the Select Committees directly by Lt. Col. North. The transmittal letter from the Select Committees accompanying one of the first deliveries to us of North's notebooks for declassification stated: "These notebook excerpts were provided to the Committee pursuant to a subpoena and in connection with a grant of immunity to Mr. North. As such, their contents should not be disclosed to any person other than those who are participating in the [declassification] review that is requested by this letter." (Letter from W. Neil Eggleston, Deputy Chief Counsel to the House Select Committee, to Alan Charles Raul, Associate Counsel to the President, dated July 2, 1987)

Thus, the White House received only those portions of the North notebooks that the House and Senate Select Committees chose to provide to us in connection with their declassification requests. The Select Committees did not purport to provide us with the complete set of North notebooks. Moreover, the identification numbers you used to identify the excerpts you asked to have declassified appear to be Bates stamp numbers applied to the notebook pages by the Senate Select Committee -- unfortunately, these identification numbers are not keyed into our document retrieval system. This, combined with the fact that we do not have all of the North notebooks, makes it extremely difficult for us to determine whether we even have copies of the excerpts you identified.

I can assure you, however, that all portions of the North notebooks submitted to us for declassification review by the House and Senate Select Committees were reviewed thoroughly by the inter-agency declassification review committee that was established under the auspices of the White House Counsel's Office and NSC. Accordingly, those portions of the North notebooks submitted to us for declassification have already been reviewed and declassified to the extent consistent with the national security standards set forth in Executive Order 12356, and returned in unclassified form to the House and Senate Select Committees.

Since the House and Senate Select Committees submitted only limited portions of the North notebooks to us for declassification, and we have reviewed them, there is simply nothing further we can add at this time. In fact, it is entirely possible that we never received and, consequently, do not have, the excerpts identified in the attachment to your January 25 letter. We must therefore respectfully refer you to the Senate Select Committee for any further information. That Committee may be in a position to advise you whether the materials have previously been declassified or, alternatively, whether they were never provided to the White House for declassification review. It may also be appropriate to consider with the Senate Select Committee whether it is consistent with that Committee's governing Resolution, and the subpoena issued to and agreements reached with counsel for Lt. Col. North, as well as other applicable rules, for members of the staff of your Subcommittee or any other committee to have access to the documents in question.

Finally, we only this week concluded an expedited and very substantial declassification review for an ongoing independent counsel investigation, and we also were completing some other declassification tasks pursuant to longstanding commitments. Accordingly, it simply was not possible to undertake a declassification review of any additional material during February. A declassification review requires the dedication of significant legal and intelligence officer resources on an inter-agency basis by the intelligence community, and we have taxed those scarce human and budgetary resources to the very limit.

While I understand that this response may be somewhat disappointing, I can assure you that we will consider requests for declassification should documents be properly submitted to us by the Committee on Foreign Relations for declassification review.

Ms. Smith had been the subject of an appropriate background investigation and held the current codeword clearance. Pursuant to my instructions, Patti Aronsson made the necessary arrangements to have Brian Merchant read Ms. Smith into the program.

White House News Summary -- Friday, April 8, 1988 -- Page 1 of 2

ABC COVERAGE ON CONTRAS/DRUGS (Thursday evening, April 7)

Jennings: We have the news tonight of a major ABC News investigation. We have been reporting for many months now on the ins and outs of the Iran-contra affair -- selling arms to Iran and using the profits to buy guns for the Nicaraguan contras. We can now report that long before that operation began, there was another operation to provide guns for the contras, which was also against the law. In this operation, Americans and Israelis provided arms to the contras and then the same network smuggled drugs into the U.S.

ABC's Richard Threlkeld: For three years, from 1983 to 1986, the contras fought the Marxist government of Nicaragua with weapons made in the communist bloc, bought by Israeli agents with American financial support and delivered by a U.S.-Israeli airlift, which wound up, incredibly enough, delivering illegal drugs to the U.S. That's the astonishing story told to ABC News by American, Israeli, and Panamanian sources -- some of whom insist on remaining anonymous, including this American we'll call "Harry," who helped purchase the arms and deliver them.

("Harry": "I guess you'd have to say at that time I felt my primary employer was Israel. Secondarily my employer was the United States of America.")

The operation was launched in the spring of 1983 at Washington's request with at least \$20 million of Israeli government money, later reimbursed we're told, from U.S. covert operations funds. The Israelis purchased the weapons from Poland and Czechoslovakia and began shipping them secretly from Yugoslavia to Bolivia and then to Panama. The Israeli liaison man there, this man Michael Herari (phonetic), until recently a close aide to Manuel Noriega. Israel was already selling arms to Central America, what better middleman for Washington to use to arm the contras.

(Policy expert: "I don't think that Israel will get involved in these kinds of things without the very clear understanding with the Reagan Administration.")

Although the Israeli government today denied that it has ever supplied arms to the contras, nonetheless our investigation shows a supply network did exist — a makeshift air cargo network, also experienced in running illegal drugs. From Panama our sources say the weapons were shipped in cargo planes — old DC6's and C123's flying from an extensive network of Panamanian airfields to supply points for the contras in Costa Rica and El Salvador. And what was the American connection in all this? Our sources tell us it included the late William Casey's CIA, and Felix Rodriguez, a former CIA agent and counterinsurgency expert active in aiding the contras. Although Rodriguez denies it, Jose Blandon, Noriega's former intelligence aide, confirms there was such a network and says Rodriguez was, in fact, a key figure:

(Blandon: "There was a man who worked in El Salvador -- (inaudible) who was in charge of all the relations and who supplied the arms to the contras.")

But ABC News has learned arming the contras was only the half of it. After dropping off their weapons, the planes and contract pilots of this makeshift Israeli-American airlift went back to business as usual -smuggling illegal Colombian cocaine across the U.S. border. If U.S. officials who had sponsored this airlift knew it was drug dealing, they did nothing to stop those cargo planes.

("Harry": "You'd bring the ship into Colombia, you'd load the drugs aboard it and you would bring those drugs back to Panama with you.") From Panama and Colombia, the planes flew north to the U.S. -- loaded with illegal drugs. "Harry" flew one of the drug deliveries himself to one of these secluded dirt airstrips near Amarillo, Texas -- a mission he'd just as soon forget.
