The Embassy of Switzerland presents its compliments to the Department of State and has the honor to refer to the letter of the Secretary of State of December 4, 1986, requesting the assistance of the Swiss government in freezing certain funds in an account at a Geneva branch of Credit Suisse.

The Embassy is in a position to inform the Department that the bank in question has agreed on an informal basis and provisionally to immediately freeze the funds in the account mentioned. A compulsory freeze could be envisaged as a provisional measure on the basis of article 18 of the Federal Act on International Mutual Assistance in Criminal Matters (IMAC) if criminal proceedings were instituted in the United States. In this case the Embassy suggests that the Office of International Affairs in the Department of Justice contact the Federal Office for Police Matters in order to establish the conditions for a request for assistance.

The Swiss authorities would like to draw the Department's attention to the fact that it is in the first instance in the competence of the United States authorities to determine the ownership of and/or right of access to, the account in question.

The Embassy of Switzerland avails itself of this opportunity to renew to the Department of State the assurances of its highest consideration.
