This afternoon Jerry Bremer asked INB to put together the "facts" regarding Iranian support for terrorism over the last 18 mos. He has apparently said that he intends to "shoot holes" in the President's statement that they have desisted from such activities since the dialogue began. Charlie Allen has prepared an assessment which he will LDX to us. I will have it sent to you when it comes in. You shd also be aware that Bremer has pulled all his people off all public appearances because "we cannot support a policy when we dcn't have a policy." This screwed Walt Raymond, who had Bremer scheduled for an appearance w/ one of his Pub Dipr grps in Germany next week. UNODIR, I will have Bob or Craig take the space as Walt needs help. It wd seem to me that at least a margin of loyalty is required in this event - even from the State Dept - rather than working directly against the President.
