MEMORANDUM FOR SENIOR REVIEW GROUP

SRG Meeting, Task Force on Combatting Terrorism, April 20, 1987, 10:00 AM

In his address to the nation on March 4, 1987, the President announced that he was directing the Vice President to reconvene the Task Force on Combatting Terrorism to conduct a program review to evaluate the effectiveness with which the recommendations forwarded by the Task Force Report of December 20, 1985 have been implemented.

The Task Force was in effect reconvened by my return as Executive Director on March 30, 1987 in response to the request of the President's National Security Advisor.

In the initial phase of the review process, meetings have been held with you and other senior representatives of the Task Force principals, and the staff working group has subsequently prepared individual evaluations based upon these consultations and the written reports submitted by the responsible agencies.

The Vice President will conduct a review of these draft positions with the Senior Review Group at 10:00 AM in the Cordell Hull Conference Room 208 of the Old Executive Office Building on Monday, April 20, 1987. You, as a member of the Senior Review Group, are invited to attend. The Agenda is attached.

Enclosed is a compendium of the original recommendations contained in the report with draft evaluations which have been prepared by the working group based upon inputs made by those agencies with primary and collateral responsibility. Since the purpose of the Vice President's review is to attain a consensus at the SRG level on the effectiveness with which the original recommendations have been accomplished, the discussion will be limited to substantive issues.

In order to allow the Vice President to focus on these first order issues, I would appreciate your early input well prior to the April 20 meeting as to any of the specific evaluations with which you may have serious differences. These comments should be transmitted to Mr. Ted McNamara, Deputy Director of the Review Group, by telephone (395-5066) or memorandum. Comments received before COB, April 15 can probably be incorporated as fixes before the Vice President's review.

Please indicate whether you will attend, or provide the name of your representative to Mr. McNamara's office by April 15, 1987.
