Alabama Officers Freed Of Torture Charges

#### BODY:

An all-white Federal jury, which first tried to return a verdict of 11 to 1 for acquittal, changed its vote to 12 to 0 and found five officers on the Bessemer police force not guilty of torturing black prisoners.

After the earlier verdict was returned Wednesday, the courtroom was emptying and the defendants were congratulating each other as Federal District Judge Sam Pointer polled the panel. But everything came to a halt when one juror said she wanted to vote guilty.

''We can only receive a verdict that is unanimous,'' Judge Pointer said. He ordered the jury to resume deliberations. Two hours later, after a total of 10 hours of deliberations, the dissenting member of the jury, Deborah Cupp, a legal secretary, concurred and the not-quilty verdict was accepted.

#### BODY:

A spokesman for business urged Congress Wednesday to "quickly, quietly and mercifully inter" legislation that would allow the U.S. attorney general to sue on behalf of large groups of consumers.

Washington antitrust lawyer Philip A. Lacovara, testifying on behalf of the National Association of Manufacturers and the Business Roundtable, denied Justice Department claims that the bill would deter price fixing.

Earlier, Attorney General Griffin Bell called the bill "constructive beginning" toward President Carter's proclaimed goal of expanded opportunity for "responsible" consume lawsuits.

Bell stopped short of endorsing the bill, although it was drafted by the Justice Department's Office for Improvements in the Administration of Justice.

Daniel Meador, Bell's assistant in charge of that office, said Congress should pass legislation to replace rules adopted by federal courts 12 years ago to govern consumer class actions.

Under the existing rules, Meador told a Senate subcommittee, such suits sometimes benefit lawyers, who receive fat fees, more than individual consumers, who get paltry settlements.

This was denied by stephen Sussman, a Houston, Texas, lawyer who said he represents several classes of small businesses attempting to recover damages for price rigging.

"I think a counsel who took such a case with the idea he was going to line his pockets with gold ought to be in an insane asylum," Sussman testified.

The bill would create a new type of lawsuit called a "public action" in cases in which at least 200 persons claim damages of not more than \$300 each but totaling \$60,000 or more.

The suite could be filed either by attorneys for the aggrieved parties or by the attorney general, but in either event would be filed in the name of the U.S. government.

If the attorney general filed the suit, it would be up to him whether to allow the parties to be represented also by their own lawyers.

U.S. District Judge Sam C. Pointer Jr. of Birmingham, Ala., suggested that the private attorneys be allowed to enter all cases if their clients wanted them.

"The number of government lawyers skilled and experienced in handling class actions is, in comparison with the number in private practice, rather small," Pointer told the panel.

Roger Bern, chief counsel of the Missouri Antitrust Division, testified that "the whole specter of Justice Department involvement in and inteference with private initiative is offensive."

Sen. Dennis DeConcini, D-Ariz., chairman of the subcommittee on improvements in judicial machinery, said he was concerned about the budgetary impact of the bill but did not believe it would deter private antitrust suits.
