Dear Mr. Chase:

I am responding to your May 25 letter regarding the review of terrorist activity in El Salvador being conducted by the Select Committee on Intelligence.

Officers of the Department met recently with Mr. Eric Newsom and other members of the SSCI staff team to discuss the assistance that the Department will be able to provide. I have outlined below the arrangements we have made to assist the team's effort. In view of the unique character of your inquiry, we are prepared to provide you with document access that goes well beyond that usually provided. This unique access should not be taken as a precedent for future document requests.

We have initiated a comprehensive search of the Department's centralized files through the Foreign Affairs Information Management (FAIM) system, to include messages captioned for control by the Department's Executive Secretariat, from which listings of documents will be developed. Office space will be provided within the Office of Central American Affairs, Bureau of Inter-American Affairs. The team will also have access to Department of State materials held by Department offices bearing on the subject of the review.

The FAIM listings, themselves classified documents, will be provided to the team so that it may select the documents it wishes to view. In the case of material captioned for control by the Department's Executive Secretariat, and because the FAIM search will likely identify material with little or no bearing upon the subject of the review, the Department will first review the documents to ensure their relevance and suitability to the team's purpose. The team will be informed in the event we conclude that any document should not be made available. The team will be able to review all other documents, but we will ask to review any notes made of classified documents. The team will not be authorized to remove copies or notes of material without the Department's prior concurrence. The Department is not in a position to provide information originating from, or under the control of, other U.S. government agencies, but will identify other agencies having materials in our files.

Dear Ambassador Bennett:

Thank you for your assurance on behalf of the Secretary of the full cooperation of the State Department in connection with the review by the Select Committee on Intelligence of information relating to death squad or leftist terrorist activities in El Salvador. The Committee is appreciative of the Department's readiness to assist in our task.

A team of SSCI staff, led by Eric Newsom and comprised of Stephen Ward, Charles Andreae, Robin Cleveland and Edward Levine will review information in the State Department. They have made an initial contact with Mr. Richard Holwill in the Bureau of Inter-American Affairs, and matters with ARA appear to be proceeding satisfactorily. However, it will also be necessary for the team to examine documents in several Department bureaus and offices, and to interview a number of Department officials with current or past responsibilities involving El Salvador. Accordingly, it would be most helpful to our efforts if a central point of contact and coordination in the State Department could be named.

In order to assist the Department in responding to our needs, the attached preliminary work program might be helpful. Naturally, as the team progresses in its review, additional repositories of relevant material in the Department may be identified, as well as other employees who might possess information which should be reviewed.



Dear George:

On Tuesday, March 26, 1984, Senator Kennedy introduced Amendment #2836 to the Urgent Supplemental for the Fiscal Year 1984 PL-480 Program [H.J.Res. 492]. At that time, Senator Kennedy said his amendment was based on his concern that there have been "persistent allegations that high Salvadoran officials are deeply involved in the death squads, possibly with the complicity or acquiescence of the CIA." Kennedy's amendment stated the following:

"The Senate and House Select Committees on Intelligence, in coordination with the Senate Foreign Relations Committee and the House Foreign Affairs Committee, shall conduct a full investigation of death squads in El Salvador and shall report to the Senate and the House of Representatives by May 31, 1984, on the extent of death squad activity, responsibility for organizing, directing and carrying out death squad killings, and progress in prosecuting those responsible for such killings."

The Senate Select Committee on Intelligence routinely does reports on its own recognizance or if requested by other Committees or Members of the Senate. So on April 3, 1984, we agreed in a colloquy on the Floor of the Senate to hold a series of hearings on the death squads in response to Senator Kennedy's concern. We further agreed to investigate the matter of these allegations and to make the record of that investigation known to the extent that it can be published. On the basis of our commitments to Senator Kennedy, the Staff Director and Minority Staff Director of the Committee have established a Death Squad Working Group which is being coordinated by Larry Kettlewell and Steve Ward.




