Employees

Richard Darman has asked for comments on the above-referenced proposed Executive Order by close of business December 7. The Executive Order simply adds the Secretary of HHS to the membership list of the Interagency Committee on Handicapped Employees. The Committee, as established by 29 U.S.C. § 791(a), was composed of named officers, including the Secretary of HEW as co-chairman, and other members "as the President may select." The membership of the Committee, including both the statutory members and additional members selected by the President, was designated in Executive Order 11830 (January 9, 1975). The responsibilities of the Secretary of HEW under 29 U.S.C. § 791(a) were, however, transferred to the Secretary of Education by 20 U.S.C. § 3441(a)(4)(A), although Executive Order 11830, listing the Secretary of HEW and not the Secretary of Education, was not changed. This explains why the decision to add the Secretary of HHS to the Committee is accomplished rather circuitously by amending the old Executive Order to change "Secretary of HEW" to "Secretary of Education" and adding "Secretary of HHS" as an additional member.

The Office of Legal Counsel has approved the proposed Executive Order as to form and legality, and OMB recommends that the President sign it. I have reviewed the proposed Executive Order and the accompanying materials, and see no objections.

SUMMARY. This memorandum forwards for your consideration a proposed Executive order which would designate the Secretary of Health and Human Services as an additional member of the Interagency Committee on Handicapped Employees.

BACKGROUND. Section 501(a) of the Rehabilitation Act of 1973 created the Committee, designated its original members, and empowered the President to designate additional agencies as members of the Committee. When the Department of Education was created in 1980, it assumed the position on the Committee formerly held by the Department of Health, Education and Welfare. The proposed order would further amend Executive Order No. 11830 of January 9, 1975 by adding the Secretary of Health and Human Services (HHS) as a member of the Committee. The participation of HHS is justified by its statutory responsibilities concerning the handicapped.

None of the affected agencies has objected to the proposed Executive order.

RECOMMENDATION. I recommend that you sign the proposed Executive order.

The attached proposed Executive order was submitted by the Department of Education. It has been forwarded for the consideration of this Department as to form and legality by the Office of Management and Budget with the approval of the Director.

The proposed Executive order would, by amending Executive Order No. 11830, add the name of the Secretary of Health and Human Services to the list of persons serving on the Interagency Committee on Handicapped Employees, as well as make certain other technical corrections to that Executive order. The Committee was established by the Rehabilitation Act of 1973 (the Act), Pub. L. 93-112, § 501, 87 Stat. 390, in order, among other things, to "review on a periodic basis . . . the adequacy of hiring, placement, and advancement practices with respect to handicapped individuals, by each department, agency, and instrumentality in the executive branch of Government, and to insure the special needs of such individuals are being met . . . ." The Act also designated the Committee's original members, making the Secretary of Health, Education and Welfare its Co-Chairman, and empowered the President to designate additional members, which he did in Executive Order No. 11830. Subsequent to the passage of the Act, however, the Department of Education Organization Act, Pub. L. No. 96-88, § 301(a)(4)(A), 93 Stat. 668, 678 (1979), which created the Department of Education, transferred all of the functions of the Secretary of Health, Education and Welfare under the Rehabilitation Act of 1973 to the Secretary of Education. In order to reflect this change, the proposed Executive order would replace the name of the Secretary of Health, Education and Welfare in Executive Order No. 11830 with that of the Secretary of Education, and, in response to a request from the Secretary of Education, add the Secretary of Health and Human Services to the Committee.

The proposed Executive order is acceptable as to form and legality.

Richard Darman has asked for comments by noon December 22 on the above-referenced proposed executive order. The order would delegate to the Secretary of State the President's obligation to submit monthly reports to Congress explaining why it is in the national interest for the United States to make payments under loan guarantees and extend credit to Poland without declaring Poland in default on its debt. This obligation was first imposed in 1982 and was continued for fiscal year 1984 by the Continuing Resolution, Public Law 98-151. The proposed executive order cites the delegation statute, 3 U.S.C. § 301, and extends the delegation to any similar obligation imposed on the President by future legislation. The executive order specifies that the Secretary of State shall consult with the Secretary of the Treasury and such other agencies as may be appropriate.

The proposed order was submitted by State and has been approved by OMB and, as to form and legality, by the Office of Legal Counsel. I have reviewed the draft order and the related materials and have no objections.

SUMMARY. Enclosed for your consideration is a proposed Executive order delegating to the Secretary of State the obligation to report to the Congress on the manner in which the national interest had been served by Government payments under guarantees of loans made to Poland.

BACKGROUND. Section 101(d) of the Continuing Resolution (Public Law 98-151) extends to fiscal year 1984 certain obligations, first imposed by the FY 1982 Supplemental Appropriations Act, which require the President to report monthly to Congress why it is in the national interest to make payments under United States loan guarantees of credits to Poland without first requiring the lenders to declare Poland in default. This reporting function was delegated to the Secretary of State for FY 1983 by Executive Order No. 12390 of October 25, 1982. The proposed order would delegate the function to the Secretary for FY 1984 and any subsequent periods for which such reports are required.

None of the affected agencies objects to the proposed order.

RECOMMENDATION. I recommend that you sign the proposed Executive order.

The attached proposed Executive order was submitted by the Department of State. It has been forwarded for the consideration of this Department as to form and legality by the Office of Management and Budget with the approval of the Director. Changes requested by this Office were made by the Office of Management and Budget with the approval of the Department of State.

The proposed Executive order would delegate to the Secretary of State the President's obligation to prepare certain reports for Congress pursuant to § 620 of the Agriculture, Rural Development and Related Agencies Appropriations Act, 1984 (H.R. 3233), which was enacted into law by the 1984 Continuing Resolution, Pub. L. No. 98-151. Under this provision, the President must submit periodic reports to Congress as a condition for the payment of United States funds in satisfaction of guarantees or assurances given by the United States with respect to loans made and credits extended to the Polish People's Republic. An identical obligation under the 1982 Supplemental Appropriations Act of 1982, § 306, Pub. L. No. 97-257, was delegated for fiscal year 1983 in Executive Order No. 12390. Because there may well be similar requirements under future appropriations acts, the proposed Executive order would also delegate any such obligation contained in future legislation to the Secretary of State.
