SUBJECT: Year of the Bible Fundraising

John A. Hash, President and Editor of the monthly magazine "Bible Pathway," has written the President, applauding his "Year of the Bible" proclamation. Hash also sent a copy of this month's issue, which features the President on the cover (no problem) and a message on the inside cover from Hash to his readers concerning the proclamation. In that message Hash offers to send readers a copy of the President's proclamation and a cassette tape of his address in return for a "gift" of \$12.

I do not think there is much we can do as a legal matter about the use of these materials in fundraising, unless the promotion and/or the materials convey a false impression of Presidential endorsement. The proclamation and the speech -- whether reproduced on paper or on tape -- are in the public domain and cannot be copyrighted. Hash's message does not, in my mind, suggest that the President is participating in or has endorsed his particular appeal for funds. Hash simply offers copies of a Presidential proclamation and a speech, accurately identifying them as such.

If the proclamation "sold" by Hash is a copy of the ceremonial proclamation, however, with the Presidential Seal, the use of the seal in the commercial effort could constitute a violation of 18 U.S.C. § 713(b). If Hash is copying and selling the ceremonial proclamation, he is also reproducing and selling the seal. It is not clear whether the proclamation provided by Hash to his donors is the ceremonial one or simply a text produced by him.

I would be happy to call or write Hash to determine if he is using the seal in his fundraising, and advise him to cease doing so if he is. I could also raise the general concern to avoid the appearance of Presidential endorsement of his effort, and make certain that he does not suggest such endorsement in any of his material. Unless you think differently, however, I do not see any basis for halting Hash's fundraising scheme. I await your guidance.

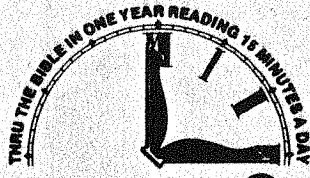



It is particularly difficult to adhere to this policy when the request is made on behalf of such a good cause, but I trust you will understand why we must do so.

I am sorry that our response could not be more positive. Best of luck with the auction.

SUBJECT: Inquiry from Kathy Osborne Concerning  
Private Fundraising Invitation

Kathy Osborne has asked for your views on an invitation she has received from the St. Joseph's Parish Council of Wilton, California. In connection with the parish's annual fundraising effort, Robert Koetitz, the President of the Parish Council, would like to have Osborne to dinner and auction off invitations to the dinner to 4-6 other couples. Koetitz expects such an affair would net \$1000 for the parish.

Osborne states that her "inclination is to say no -- that they are trying to use me." I tend to agree, and would advise her that we generally avoid involving the White House in private fundraising efforts. Here the parish is trying to "cash in" on Osborne's position, something we should not encourage.

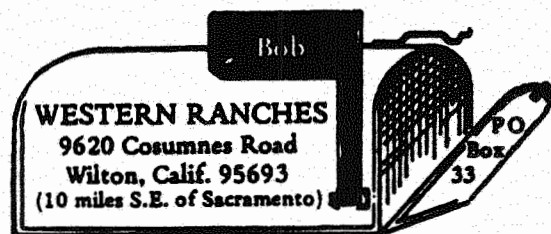

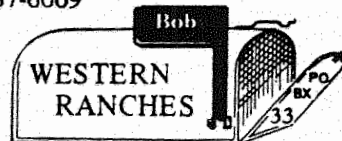

SUBJECT: Use of the President's Name in

Judy Enright conceived, produced and distributed the attached invitations to her father's seventieth birthday party. The front of the invitation was intended to and does in fact appear to be an invitation from the President and Mrs. Reagan, complete with Presidential Seal. Only upon opening the invitation does the recipient discover that this was merely a "joke" and that the invitation is actually to the birthday party in New Hampshire, not to the White House. (Invitees may have been tipped off that the front page was a hoax, since the invitations arrived in envelopes with a New Hampshire return address.)

Mrs. Enright herself sent the President a copy of the invitation, along with a letter asking the President to acknowledge her father's birthday. That request is OBE, since the birthday was November 4. Enright's letter was not sent until October 31. In her letter Enright writes: "I do hope you won't be offended at the liberties that we've taken with your name and Mrs. Reagan's."

Mrs. Enright's use of the Presidential Seal (complete except for the banner describing it as such) is in technical violation of 18 U.S.C. § 713(b), and of course we would never have approved her use of the President's and First Lady's names had we known about it in advance. On the other hand, as Secretary Watt once put it, "if they can't take a joke..." The invitation strikes me as fairly clever and, on the whole, harmless. None of the invitees were deceived into thinking that it was actually from the White House for more than a heartbeat, and Mrs. Enright hardly undertook the project with mens rea. Accordingly, while a letter to Mrs. Enright is necessary, in my view, as a matter of principle and consistency and to ensure she does not do it again, the attached draft is less stern than might otherwise be expected.

That request is OBE, since the birthday was November 4. Enright's letter was not sent until October 31. In her letter Enright writes: "I do hope you won't be offended at the liberties that we've taken with your name and Mrs. Reagan's."

Mrs. Enright's use of the Presidential Seal (complete except for the banner describing it as such) is in technical violation of 18 U.S.C. § 713(b), and of course we would never have approved her use of the President's and First Lady's names had we known about it in advance. On the other hand, as Secretary Watt once put it, "if they can't take a joke..." The invitation strikes me as fairly clever and, on the whole, harmless. None of the invitees were deceived into thinking that it was actually from the White House for more than a heartbeat, and Mrs. Enright hardly undertook the project with mens rea. Accordingly, while a letter to Mrs. Enright is necessary, in my view, as a matter of principle and consistency and to ensure she does not do it again, the attached draft is less stern than might otherwise be expected.

Thank you for your letter of October 31 to the President. Along with that letter you sent one of the invitations to the party you arranged to celebrate your father's seventieth birthday.

In your letter you requested that the President acknowledge your father's birthday. As you feared might happen, we did not receive your letter until after November 4. We were, accordingly, not able to comply with your request.

Although we are certain you did not intend to do anything improper, we must point out that the President's name, the First Lady's name, and the Seal of the President should not be used, even in jest, except as authorized in connection with official activities. The permitted uses of the Seal of the President are in fact regulated by statute and executive order, copies of which are enclosed for your information. It is unfortunate, but a surprising number of individuals misuse the Seal of the President and the President's name for commercial or other objectionable purposes. This recurring problem compels us to be scrupulous in objecting to any unauthorized use of the Seal, the President's name, or the First Lady's name, even when, as in your case, the unauthorized use proceeded from the best of motives, with no invidious purpose.

I trust you will understand our concerns and avoid any imitations of White House invitations in the future. We appreciate the kind and supportive sentiments expressed in your letter, and trust that the birthday party was a great success. Please convey our belated congratulations to your father on his seventieth birthday, or, in the alternative phrasing the President often employs, the thirty-first anniversary of his thirty-ninth birthday.

(a) Whoever knowingly displays any printed or other likeness of the great seal of the United States, or of the seals of the President or the Vice President of the United States, or any facsimile thereof, in, or in connection with, any advertisement, poster, circular, book, pamphlet, or other publication, public meeting, play, motion picture, telecast, or other production, or on any building, monument, or stationery, for the purpose of conveying, or in a manner reasonably calculated to convey, a false impression of sponsorship or approval by the Government of the United States or by any department, agency, or instrumentality thereof, shall be fined not more than \$250 or imprisoned not more than six months, or both.

(b) Whoever, except as authorized under regulations promulgated by the President and published in the Federal Register, knowingly manufactures, reproduces, sells, or purchases for resale, either separately or appended to any article manufactured or sold, any likeness of the seals of the President or Vice President, or any substantial part thereof, except for manufacture or sale of the article for the official use of the Government of the United States, shall be fined not more than \$250 or imprisoned not more than six months, or both.

(c) A violation of subsection (a) or (b) of this section may be enjoined at the suit of the Attorney General upon complaint by any authorized representative of any department or agency of the United States.

(d) Use as an architectural embellishment in libraries, museums, or archives

established to house the papers or effects of former Presidents or Vice Presidents;

(e) Use on a monument to a former President or Vice President;

(f) Use by way of photographic or electronic visual reproduction in pictures, moving pictures, or telecasts of bona fide news content;

(g) Such other uses for exceptional historical, educational, or newsworthy purposes as may be authorized in writing by the Counsel to the President.

**Sec. 2.** The manufacture, reproduction, sale, or purchase for resale, either separately or appended to any article manufactured or sold, of the Seals of the President or Vice President, or any likeness or substantial part thereof, except as provided in this Order or as otherwise provided by law, is prohibited.

I'm sorry to be so late in sending along the enclosed but I kept waiting for the right moment which, with Beirut and Grenada, never seems to have materialized.



On February 22, 1984, you wrote General Daniel O. Graham, advising him not to use a letter from the President in fundraising solicitations for High Frontier. You recently received a solicitation from Graham identical to the one that prompted your February 22 letter, except that the "matching gift check" is dated April 6, 1984 rather than January 30, 1984, indicating that the package was prepared well after Graham received your letter. I do know that Graham did receive your letter, since an aide to Graham telephoned you about it shortly after it was sent. The call was referred to me, and in response to the aide's question I assured him that the policy against the President endorsing fundraising projects was applied in a uniform fashion.

The attached draft letter to Graham reiterates your advice of February 22, and asks for a response from Graham concerning whether he intends to comply with that advice.

Dear General Graham:

On February 22, 1984, I wrote you concerning fundraising solicitations for High Frontier that contained copies of the President's letter of June 3, 1983, thanking you for dedicating your book to him. In my letter I alerted you to the President's policy of generally refraining from endorsing particular fundraising projects, and advised you that the inclusion of the President's letter in the solicitation for High Frontier was likely to be construed as an endorsement of the fundraising in violation of this policy. As I noted in my letter, the President's letter "was not written for use in fundraising and should not be used for that purpose."

It has come to our attention that High Frontier fundraising solicitations containing the President's letter -- in apparent disregard of my letter of February 22 -- are still being distributed. I recently received such a solicitation with the "matching gift check" dated April 6, 1984, well after your receipt of my letter. Please advise me at your earliest opportunity whether the latest distribution of fundraising material containing the President's letter was inadvertent or whether you have decided to disregard my letter of February 22.

The last time I wrote to you, I enclosed a book that I am sure you remember well.

You see, it is up to you to decide whether we can use this check to help President Reagan win for all of us that potent yet long-smothered missile defense system.

Defense scientists assure our High Frontier group that this part of the system alone would wipe out 80% of any mass ICBM attack while it is still over Soviet territory!

What about the other 20%? With modern radar, a chain of carefully placed non-nuclear ground launched projectiles would easily destroy almost all of these remaining ICBMs.

Naturally, once the Soviets are faced with such a fool-proof anti-missile shield, they will start looking for ways to overpower it.

Even as we are getting the first two parts into place, we would be working on a "second generation" of anti-missile satellites. 



You staffed this item to me for direct response, and I have prepared and signed the attached proposed response. Mr. Pyle of Jackson, Mississippi wrote the President to note his objection to representations about America's defenses in fundraising material distributed by High Frontier. You will recall that the material in question contained a copy of the supportive letter from the President to High Frontier's leader, General Daniel Graham, and that by letter dated February 22, 1984, you objected to use of this Presidential letter in fundraising by High Frontier. It seemed appropriate to point out in my response to Mr. Pyle that our office had objected to High Frontier's use of the Presidential letter, since Mr. Pyle could well assume, on the basis of the letter, that the White House was in some sense affiliated with High Frontier. Before sending the response to Pyle, however, I wanted to make certain you had no objection to the reference to our earlier letter to Graham.


Dear Mr. Pyle:

Thank you for your letter to the President concerning fundraising material sent to you by High Frontier. That letter was only recently referred to this office. Along with that letter you enclosed a copy of a letter you wrote to General Daniel O. Graham of High Frontier, objecting to certain statements in the material distributed by High Frontier.

High Frontier is an independent organization and is not affiliated with the President or the White House. The representations in its literature are its own. Indeed, you may be interested to learn that this office recently advised High Frontier to cease using a letter the President wrote to General Graham about his book in fundraising material for High Frontier. As we stated in our letter to High Frontier, the President adheres to a policy of generally not endorsing particular fundraising projects, no matter how laudable the objectives of the organization benefitting from the fundraising. We were concerned that the unauthorized inclusion of the letter from the President in the fundraising materials would create the false impression that the President had endorsed the appeal for funds.

Thank you for the supportive comments in your letter.



Dear General Graham:

I am in receipt of your mailing which was obviously prepared many months ago, but it bears no date. Among other things it contains a lot of language about such things as "We have no defense whatsoever against any long-range nuclear missile attack!", and a petition to The President with the language, "Yet the shocking truth is that the United States has no defense, in fact it is literally helpless, against a Russian nuclear missile attack." It is my feeling as an ordinary, extremely patriotic American citizen that this kind of language in documentation being used for the purpose of soliciting funds for the operation of your good-will mission under the name of HIGH FRONTIER is extremely unfortunate. 
