#### Dear Jonathan:

Your kind letter has just come to my attention, and I want to thank you for your warm words of friendship and support. I'm sorry for the delay in this reply, but mail sometimes takes awhile to reach my desk.

You raised some good points in your letter about the 22nd Amendment and, as you can imagine, I don't mind the context in which you chose to discuss this subject even though I've made my decision clear about this being my last goround. As a rule, I've given my views about amendments to our Constitution only when an issue was under active consideration in the Congress, and then only with a clear recognition that the President plays no direct role in the proposal or ratification of such amendments.

I can, however, speak directly about my own intentions. As I've said on a number of occasions, I look forward to my remaining time in office as an opportunity to cement in place our agenda for a Second American Revolution. For our guidepost, we have looked unsbashedly at the principles of the first American Revolution — a revolution which took place in the Americas but which was truly a revolution for the entire world and for all time.

Our goals are profoundly simple, for they rely for their complexity not on the bureaucratic machinations and hedged guesses of government but on the myriad and miraculous workings of the human spirit. I've expressed it often as three short words: Trust the people. If we accomplish nothing else during my Administration than a real expansion of individual freedom — the ability to dream, to work, to build and plan a better future, and to acquire by one's labora the means to fulfill that dream — then I will count our efforts a success and content myself with the judgment of history.

Jonathan, there may come a time when Congress carefully considers whether it is advisable to remove the limitation on the number of terms a President may serve. For now, I am confident that our people will choose their leader wisely when it comes time for decision in 1988 and that they will choose on the basis of the fundamental principle which has guided our nation so well since its birth — that love of liberty, as Lincoln said, which God has planted in us.

Your message confirms my faith in our nation's future. May God bless you and fill your life with every good fortune.

Judge Oliver Gasch is a lifelong Republican who was appointed to the Federal District Court for D.C. by Lyndon Johnson (who wished to make a non-partisan appointment) in 1965. The Judge was born in 1906 to a family of English origins and long-time D.C. residence (he is related on his mother's side to Cardinal Manning, the 19th century English prelate and contemporary of Newman). His father was in real estate, and his firm still exists. The Judge's brother, Manning Gasch, was active in the firm. The Judge still lives in D.C.

Judge Gasch is a graduate of Princeton (A.B. 1928) and put himself through George Washington University Law School's night program (L.L.B. 1932). Until 1937, he served in the general counsel's office of the local transit system (then called Capitol Transit). From 1937-1942, Judge Gasch was assistant D.C. Corporation Counsel, a position that he resumed after World War II (1946-1953). During World War II, Judge Gasch served in the Army Judge Advocate General Corps where he eventually rose to the rank of lieutenant colonel. He served overseas in the Pacific theater (including the Philippines).

From 1953 to 1956, Judge Gasch was principal assistant
United States Attorney for the District of Columbia. President
Eisenhower appointed him U.S. Attorney for D.C. in 1956, and he
held that position until 1961. Judge Gasch is generally regarded
as being greatly responsible for the high standards of professionalism
maintained by the local U.S. Attorney over the past 25 years.
From 1961 to 1965, Judge Gasch was in private practice in D. C.

The Judge is married and has one son (Michael). His wife, Sylvia, is the former principal harpist of the National Symphony Orchestra. The Judge has been very active in bar, professional and veterans' groups (short biography attached). He is an Episcopalian and former chancellor and vicepresident of the executive council of the Washington diocese.

Among his most colorful associations is that with the Military Order of the Carabao. The carabao is a Philippine water buffalo, a dull and stupid beast. The Order is open only to U.S. military personnel who have served in the Philippines. It was originally set up by an "old Army" regiment serving there as a satire on the pretensions of a "military order" founded by a regiment serving in old China. The annual gatherings are known as "wallows." The most important officer's sole power is to command "wet down the herd" to require immediate drinking if any serious business is broached. The Judge has faithfully attended the wallows for many years.

The Judge has served on the bench with distinction for 20 years. He is generally regarded as a lawyer's Judge, and a consummate legal craftsman. He provides written opinions on virtually every action taken. Although personnally conservative, he feels strongly his obligation to follow the law as laid down by statute or higher courts as best he can discern it. He took senior status in 1981 but has maintained practically a full caseload and also agreed to serve on the railroad reorganization court.

DONALD T. REGAN:

Attached at Tab A is a letter the President wrote to the editor of the Orange County Register, which he wanted to discuss with you before it was sent. The President wrote the letter using budget figures Jim Miller had provided to him in a memo on January 13. The numbers have since been updated, and a revised letter from the President reflecting those new numbers is attached at Tab B. Miller's memo updating the numbers is found at Tab C.

Dear Mr. Editor:

On December 26, 1985 a Register editorial stated that, "contrary to popular mythology," we had not slowed the rate of Federal spending in our years here in Washington. Then, citing 1984 figures and those for the first five months of '85, you had the rate of growth in spending triple the rate under the previous administration. Your conclusion was that if we are conservatives, then conservatives have no interest in cutting back government.

I have debated as to whether I should reply and my final decision was that I should -- hence, this letter.

Between 1977 and 1981 the average rate of growth in total Federal spending was 13.5% nominal, or 4.5% adjusted for inflation. By comparison, the average rate of growth between 1981 and 1985 was 8.7% nominal or 2.9% in real terms. The figures are quite different if you separate out defense. In the Carter years, defense grew at an average rate of 3.9% in real terms vs. 6.6% during my first term. For domestic spending, it was 3.6% during the previous administration vs. 0.8% in my first term.

True, there was a single year upsurge between '84 and '85. Part of that was increased payments to farmers through the Commodity Credit Corporation, an increase in defense spending in outlay terms and a one-time write-off in Public Housing Authority loans.

There was a substantial increase in Social Security payments, and, of course, an increase in interest payments on the national debt, which will be true every year until we balance the budget. In general, however, the rate of growth in Federal spending has been reduced considerably and government employment is down by about 78,000 on the domestic side.

Federal Spending

Don Regan indicated to me you expressed an interest in an Orange County Register editorial which charged you have not succeeded in slowing the rate of growth in Federal spending (see attached.)

As indicated in the attached table, the editorial is in error. Between 1977 and 1981 (the Carter years), the average rate of growth in total Federal spending was 13.5 percent nominal, or 4.5 percent adjusted for inflation. By comparison, the average rate of growth between 1981 and 1985 was 8.7 percent nominal, or 2.9 percent in real terms. The figures are even more dramatic when you separate out defense and domestic ("all other") spending. Under President Carter, defense grew at an average rate of 3.9 percent in real terms vs. 6.6 percent during your first term. For domestic spending, it was 3.6 percent under President Carter versus 0.8 percent during your first term.

Thus, the numbers clearly indicate that you have succeeded in slowing the rate of growth in overall Federal spending, increased our defense strength, and cut growth in domestic spending by two-thirds.

Don expressed some consternation about an apparent increase in the rate of growth in spending between 1984 and 1985, relative to the earlier years. Essentially, there are four causes for the more rapid 1984-1985 growth: (1) increased payments to farmers through the Commodity Credit Corporation; (2) a one-time write-off in Federal housing loans; (3) an increase in the rate of growth of defense spending (in outlay terms); and (4) increased interest payments on the National debt.

Of course, I will be happy to provide any further information that would be helpful to you.


